## CONSEQUENTIAL AMENDMENTS

- 1 In section 44(3) of the Electricity (Supply) Act 1926 (protection of ancient monuments from prejudicial effect of placing electric lines above ground), for the words "the Ancient Monuments Consolidation and Amendment Act 1913 " there shall be substituted the words " the Ancient Monuments and Archaeological Areas Act 1979 ".
- 2 In section 47(d) of the Coast Protection Act 1949 (saving for law relating to ancient monuments), for the words " the Ancient Monuments Acts 1913 to 1931 " there shall be substituted the words " the Ancient Monuments and Archaeological Areas Act 1979 ".

  - (a) for the words from " a list" to " 1913 " there shall be substituted the words " the Schedule compiled and maintained under section 1 of the Ancient Monuments and Archaeological Areas Act 1979 "; and
  - (b) the words from " or which " to " 1953 " shall cease to have effect, except in relation to a monument to which paragraph 1(1) of Schedule 3 to this Act applies.
  - In section 17(2) of the Building (Scotland) Act 1959 (requirements with respect to operations under that Act to be subject to special controls for ancient monuments and historic buildings)—

- (a) for paragraph (a) there shall be substituted the following paragraph—
  - "(a) a building which is for the time being included in the Schedule of monuments compiled and maintained under
