9 **Abolition of Employment Service Agency and Training Services Agency.**

- (1) The Employment Service Agency and the Training Services Agency shall cease to exist.
- (2) The provisions of Schedule 2 to this Act, Part I of which contains provisions supplementary to the abolition of the said Agencies and Part II of which contains amendments consequential on their abolition, shall have effect.

- (1) Any sums received by a body to which this section applies shall be paid into the Consolidated Fund except to such extent as the Secretary of State and the Treasury agree to their retention by that body.
