U.K.

An Act to make further provision in respect of the registration of small ships and the appointment of registrars at ports. [11th April 1983]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—
