 - (b) from the taking effect of any such transfer of the operation of the parking place, the order designating the parking place shall have effect subject to such modifications (if any) appearing to the [F²national authority] to be requisite in consequence of the transfer as [F³the national authority] may direct; and

- (c) the provisions of sections 45 to ^{F4}[49] and section 55 of this Act shall thereafter apply as if the parking place had been designated under section 45 by an order made by ^{F5}. . . the local authority ^{F5}. . .

(2) In this paragraph “local authority” has the meaning assigned to it by section 45(7) of this Act.
