1984 CHAPTER 5

An Act to make provision for the service of improvement notices and prohibition notices in connection with statutory provisions relating to the safety of ships and other matters; to make further provision with respect to the ascertainment of ships' tonnages for the purposes of section 503 of the Merchant Shipping Act 1894 and section 4 of the Merchant Shipping (Oil Pollution) Act 1971; and for connected purposes. [13th March 1984]
