GENERAL

Regulations, orders and schemes

[^{F1}143A “Developments of national significance” etc.: special procedure

- (1) [^{F2}Subject to subsection (4), subsection (3) applies to any] —
- (a) ^{F3}... order under section 5 of this Act directing that a road proposed to be constructed shall be a trunk road and the construction of the road would constitute a national development;
 - (b) ^{F4}... scheme under section 7 of this Act [^{F5}(or any instrument confirming such a scheme)] which authorises the carrying out of work which would constitute a national development; or
 - (c) [^{F6}subordinate legislation which] is the subject of a direction by the Scottish Ministers under this paragraph.
- (2) In subsection (1) above, the references to a “national development” are to any development (within the meaning of the Town and Country Planning (Scotland) Act 1997) for the time being designated under section 3A(4)(b) of that Act as a national development.
- [^{F7}(3) The legislation is subject to the affirmative procedure.]
- (4) Unless the Scottish Ministers otherwise direct, [^{F8}any subordinate legislation] which revokes, amends or re-enacts [^{F9}any legislation which was subject to the affirmative procedure by virtue] of subsection (3) above is not subject to the procedure in that subsection.]
