82 Part VIII— interpretation.

(1) In this Part of this Act—

“confession”, includes any statement wholly or partly adverse to the person who made it, whether made to a person in authority or not and whether made in words or otherwise;

“proceedings” means criminal proceedings, including [^{F2}service proceedings;]

“Service court” means [^{F3}the Court Martial or the Service Civilian Court].

[^{F4}(1A) In subsection (1) “service proceedings” means proceedings before a court (other than a civilian court) in respect of a service offence; and “service offence” and “civilian court” here have the same meanings as in the Armed Forces Act 2006.]

(2) ^{F5}

(3) Nothing in this Part of this Act shall prejudice any power of a court to exclude evidence (whether by preventing questions from being put or otherwise) at its discretion.
