[F1 THE HOUSING CORPORATION][F1 SOCIAL HOUSING IN WALES]

[FIFunctions of the Welsh Ministers] and other general matters

77 Advisory service.

- (1) The [FIWelsh Ministers] may provide an advisory service for the purpose of giving advice on legal, architectural and other technical matters to [F2 registered social landlords or unregistered housing associations] and to persons who are forming a housing association or are interested in the possibility of doing so.
- (2) The [F3Welsh Ministers] may make charges for the service.
- [^{F4}(3) The powers conferred on the Welsh Ministers by subsections (1) and (2) may be exercised by the Welsh Ministers acting jointly with the Regulator of Social Housing.]
