In the M3Visiting Forces (British Commonwealth) Act 1933 section 4 (attachment of personnel and mutual powers of command) shall apply in relation to forces raised in Pakistan as it applies to forces raised in Dominions within the meaning of the M4Statute of Westminster 1931.

The operation of the <sup>M9</sup>Reciprocal Enforcement of Judgments (Pakistan) Order 1958 shall not be affected by any change in the status of Pakistan since the making of that Order; and, for the purposes of any further Order in relation to Pakistan under Part I of the <sup>M10</sup>Foreign Judgments (Reciprocal Enforcement) Act 1933, section 7 of that Act and any Order in Council under that section (application of Part I to Her Majesty's dominions outside the United Kingdom) shall have effect as if references to Her Majesty's dominions outside the United Kingdom included references to any Commonwealth country.
