#### 15 Interpretation of Part I, regulations and orders.

(9) Nothing in this Part of this Act, except section 1, shall affect<sup>F2</sup>—

- (a) any educational endowment within the meaning of section 122(1) of the <sup>M1</sup>Education (Scotland) Act 1980<sup>F3</sup>; or
- (b) any body entered in the Scottish Charity Register.]

(10) The <sup>M2</sup>War Charities Act 1940 shall cease to have effect as regards Scotland; but nothing in this subsection shall affect any prosecution for an offence under that Act which has been instituted before the commencement of this section.

- (11) Any power in this Part of this Act of the Secretary of State to make regulations or orders shall be exercisable by statutory instrument subject to annulment in pursuance of a resolution of either House of Parliament.
