General

122 Interpretation etc.

- (1) In this Act "the Taxes Act 1988 means the MI Income and Corporation Taxes Act 1988.
- (2) Part II of this Act, so far as it relates to capital gains tax, shall be construed as one with the M2 Capital Gains Tax Act 1979.
- (3) Part III of this Act shall be construed as one with Part I of the M3Oil Taxation Act 1975 and in that Part of this Act "the principal Act means that Act.
