2 In the definition of “Commonwealth force” in section 225(1) of the ^{M1}Army Act 1955 and section 223(1) of the ^{M2}Air Force Act 1955 and in the definition of “Commonwealth country” in section 135(1) of the ^{M3}Naval Discipline Act 1957 at the end there shall be added the words “ or Namibia ”.

3 In the ^{M4}Visiting Forces (British Commonwealth) Act 1933 section 4 (attachment of personnel and mutual powers of command) shall apply in relation to forces raised in Namibia as it applies to forces raised in Dominions within the meaning of the ^{M5}Statute of Westminster 1931.

4 In the ^{M6}Visiting Forces Act 1952, in section 1(1)(a) (countries to which the Act applies) at the end there shall be added the words “ Namibia, or ”; and any Order in Council under section 8 of that Act for the time being in force (applying to visiting forces the law relating to home forces) shall be deemed to apply to the visiting forces of Namibia until express provision with respect to that country is made under that section.
