Interpretation of Part II

- 13 References in this Part of this Schedule to the statutory accounts of the successor company are references to—
- (a) any accounts prepared by that company for the purposes of any provision of [^{F1}the Companies Act 2006], including group accounts but excluding any accounts so prepared by virtue of any provision of the scheme made under paragraph 11 above; and
 - (b) any statement of accounts prepared by that company under section 42 of the ^{M1}Harbours Act 1964.
