# **1993 CHAPTER 43**

An Act to provide for the appointment and functions of a Rail Regulator and a Director of Passenger Rail Franchising and of users' consultative committees for the railway industry and for certain ferry services; to make new provision with respect to the provision of railway services and the persons by whom they are to be provided or who are to secure their provision; to make provision for and in connection with the grant and acquisition of rights over, and the disposal or other transfer and vesting of, any property, rights or liabilities by means of which railway services are, or are to be, provided; to amend the functions of the British Railways Board; to make provision with respect to the safety of railways and the protection of railway employees and members of the public from personal injury and other risks arising from the construction or operation of railways; to make further provision with respect to transport police; to make provision with respect to certain railway pension schemes; to make provision for and in connection with the payment of grants and subsidies in connection with railways and in connection with the provision of facilities for freight haulage by inland waterway; to make provision in relation to tramways and other guided transport systems; and for connected purposes. 

# 4 General duties of the Secretary of State and [F5 the Office of Rail and Road]

- (1) [F5The Office of Rail and Road][F6shall] have a duty to exercise the functions assigned or transferred to [F7it] under or by virtue of this Part [F8 or the Railways Act 2005 that are not safety functions] in the manner which [F7it] considers best calculated—
  - [F9(zb) to promote improvements in railway service performance;
    - (a) otherwise to protect the interests of users of railway services;
    - (b) to promote the use of the railway network in Great Britain for the carriage of passengers and goods, and the development of that railway network, to the greatest extent that [F7] it] considers economically practicable;
  - [F10(ba) to contribute to the development of an integrated system of transport of passengers and goods;
    - (bb) to contribute to the achievement of sustainable development;
      - (c) to promote efficiency and economy on the part of persons providing railway services;
      - (d) to promote competition in the provision of railway services [F11 for the benefit of users of railway services];
      - (e) to promote measures designed to facilitate the making by passengers of journeys which involve use of the services of more than one passenger service operator;
      - (f) to impose on the operators of railway services the minimum restrictions which are consistent with the performance of [F12its] functions under this Part [F13 or the Railways Act 2005 that are not safety functions];
      - (g) to enable persons providing railway services to plan the future of their businesses with a reasonable degree of assurance.
- (2) Without prejudice to the generality of subsection (1)(a) above, [F5the Office of Rail and Road][F14shall] have a duty, in particular, to exercise the functions assigned or transferred to [F7it] under or by virtue of this Part [F8 or the Railways Act 2005 that are not safety functions] in the manner which [F7it] considers is best calculated to protect—
  - (a) the interests of users and potential users of services for the carriage of passengers by railway provided by a private sector operator otherwise than under a franchise agreement, in respect of—
    - (i) the prices charged for travel by means of those services, and
    - (ii) the quality of the service provided,

- (b) the interests of persons providing services for the carriage of passengers or goods by railway in their use of any railway facilities which are for the time being vested in a private sector operator, in respect of—
  - (i) the prices charged for such use; and
  - (ii) the quality of the service provided.
- (3) [F5The Office of Rail and Road][F16 shall] be under a duty in exercising the functions assigned or transferred to [F7it] under or by virtue of this Part [F8] or the Railways Act 2005 that are not safety functions]—
  - (a) to take into account the need to protect all persons from dangers arising from the operation of railways, F17. . . ; and
  - (b) to have regard to the effect on the environment of activities connected with the provision of railway services.

- [F18(3A) Subsections (1) to (3) above shall have effect in relation to the Secretary of State as in relation to [F5the Office of Rail and Road] except that in their application to the Secretary of State—
  - (a) F19 .....
  - (b) the references in each of the subsections to the functions transferred or assigned to the Secretary of State under or by virtue of this Part include only the functions transferred or assigned to him under or by virtue of sections 6 to 22 F20... below [F21] and
  - (c) the references in each of the subsections to the functions transferred or assigned under or by virtue of the Railways Act 2005 include only the functions transferred or assigned to the Secretary of State under or by virtue of the provisions of Part 4 of that Act other than section 39.]
- [F22(3B) Subsections (1) to (3) above shall have effect in relation to the Scottish Ministers as in relation to [F5the Office of Rail and Road] except that, in relation to those Ministers—
  - (a) the references in each of the subsections to functions transferred or assigned to those Ministers under or by virtue of Part 1 of this Act include only the functions transferred or assigned under or by virtue of sections 16A to 16G of this Act; and
  - (b) the references in each of the subsections to the functions transferred or assigned under or by virtue of the Railways Act 2005 include only the functions transferred or assigned to those Ministers under or by virtue of Part 4 of that Act.
  - (3C) Subsections (1) to (3) above shall have effect in relation to [F23] the Welsh Ministers] as in relation to [F5] the Office of Rail and Road] except that, in relation to [F24] the Welsh Ministers], the references in each of the subsections to functions transferred or assigned under or by virtue of Part 1 of this Act or the Railways Act 2005 include only the functions transferred or assigned to [F25] the Welsh Ministers] under or by virtue of the provisions of Part 4 of that Act of 2005 other than section 39.]
- [F26(3D)] The reference in subsection (3C) to functions transferred to the Welsh Ministers under or by virtue of Part 4 of the Railways Act 2005 includes a reference to functions which were transferred to the National Assembly for Wales under or by virtue of that Part and which became functions of the Welsh Ministers by virtue of paragraph 30 of Schedule 11 to the Government of Wales Act 2006.]
  - (4) The Secretary of State shall also be under a duty, in exercising the functions assigned or transferred to him under or by virtue of this Part [F27] or the Railways Act 2005], to promote the award of franchise agreements to companies in which qualifying railway employees have a substantial interest, "qualifying railway employees" meaning for this purpose persons who are or have been employed in an undertaking which provides or provided the services to which the franchise agreement in question relates at a time before those services begin to be provided under that franchise agreement.
  - (5) [F5The Office of Rail and Road] shall also be under a duty in exercising the functions assigned or transferred to [F7it] under this Part [F28] or the Railways Act 2005 that are not safety functions]—
    - [F29(a) to have regard to any general guidance given to [F7it] by the Secretary of State about railway services or other matters relating to railways;
    - [ to have regard to any general guidance given to it by the Scottish Ministers about railway services wholly or partly in Scotland or about other matters in or as regards Scotland that relate to railways;

- (ab) in having regard to any guidance falling within paragraph (aa), to give what appears to it to be appropriate weight to the extent (if any) to which the guidance relates to matters in respect of which expenditure is to be or has been incurred by the Scottish Ministers;
- (b) to act in a manner which [F7it] considers will not render it unduly difficult for persons who are holders of network licences to finance any activities or proposed activities of theirs in relation to which [F5the Office of Rail and Road] has functions under or by virtue of this Part [F31] or that Act] (whether or not the activities in question are, or are to be, carried on by those persons in their capacity as holders of such licences); F32...
- [F33(c) to have regard to the funds available to the Secretary of State for the purposes of his functions in relation to railways and railway services;
  - (ca) to have regard to any notified strategies and policies of [F34the Welsh Ministers], so far as they relate to Welsh services or to any other matter in or as regards Wales that concerns railways or railway services;
  - (cb) to have regard to the ability of [F35the Welsh Ministers] to carry out the functions conferred or imposed on [F36them] by or under any enactment;]
- [F37(d) to have regard to the ability of the Mayor of London, F38. . . and Transport for London to carry out the functions conferred or imposed on them by or under any enactment]
- [F39(5A) Before giving any guidance for the purposes of subsection (5)(a) above the Secretary of State must consult [F40the Welsh Ministers].
  - (5B) In exercising its safety functions, other than its functions as an enforcing authority for the purposes of the Health and Safety at Work etc. Act 1974, [F5the Office of Rail and Road] shall be under a duty to have regard to any general guidance given to it by the Secretary of State.
  - (5C) In performing its duties under subsections (1) to (5A) above in relation to—
    - (a) any matter affecting the interests of users or potential users of railway services,
    - (b) any matter affecting the interests of persons providing railway services, or
    - (c) any matter not falling within paragraph (a) or (b) but falling within subsection (5D),

[F5the Office of Rail and Road] must have regard, in particular, to the interests, in securing value for money, of the persons mentioned in paragraphs (a) and (b) above, of the persons who make available the resources and other funds mentioned in that subsection and of the general public.

- (5D) A matter falls within this subsection if [F5the Office of Rail and Road] has been informed that—
  - (a) public financial resources (within the meaning of paragraph 1D of Schedule 4A to this Act), or
  - (b) funds that do not comprise such resources but are provided in whole or in part by Transport for London, [F41the Welsh Ministers], a Passenger Transport Executive or any other body in receipt of such resources,

are or are likely to become available to be applied for purposes connected with that matter.]

(6) In performing [F12 its] duty under subsection (1)(a) above so far as relating to services for the carriage of passengers by railway or to station services, [F5 the Office of Rail and Road] shall have regard, in particular, to the interests of persons who are disabled.

- (7) Without prejudice to the generality of paragraph (e) of subsection (1) above, any arrangements for the issue and use of through tickets shall be regarded as a measure falling within that paragraph.
- [F42(7ZA)] Where any general guidance is given to [F5the Office of Rail and Road] for the purposes of subsection (5)(a) or (aa) or (5B)—
  - (a) it may be varied or revoked by the person giving it at any time; and
  - (b) the guidance, and any variation or revocation of the guidance, must be published by that person in such manner as he considers appropriate.]

(9) In this section—

[F46": the environment" means all, or any, of the following media, namely, the air, water and land (and the medium of air includes the air within buildings and the air within other natural or man-made structures above or below ground);

[F<sup>47</sup>"notified strategies and policies", in relation to [F<sup>48</sup>the Welsh Ministers], means the strategies and policies of [F<sup>49</sup>the Welsh Ministers] that have been notified by [F<sup>50</sup>them] for the purposes of this section to [F<sup>5</sup>the Office of Rail and Road];]

"the passenger transport market" means the market for the supply of services for the carriage of passengers, whether by railway or any other means of transport;

# 6 Prohibition on unauthorised operators of railway assets.

- (1) Any person who acts as the operator of a railway asset is guilty of an offence unless—
  - (a) he is authorised to be the operator of that railway asset by a licence; or
  - (b) he is exempt, by virtue of section 7 below, from the requirement to be so authorised.

# 7 Exemptions from section 6.

- (1) The Secretary of State may, after consultation with [F62]the Office of Rail and Road [F63]..., by order grant exemption from the requirement to be authorised by licence to be the operator of such railway assets, or of railway assets of such a class or description, as may be specified in the order, but subject to compliance with such conditions (if any) as may be so specified.
- (2) A licence exemption under subsection (1) above may be granted either—
  - (a) to persons of a particular class or description; or
  - (b) to a particular person;

and a licence exemption granted to persons of a particular class or description shall be published in such manner as the Secretary of State considers appropriate for bringing it to the attention of persons of that class or description.

# 9 Conditions of licences: general.

- (1) A licence may include—
  - (a) such conditions (whether or not relating to the licence holder's being the operator of railway assets under the authorisation of the licence) as appear to the grantor to be requisite or expedient having regard to the duties imposed by section 4 above; and
  - (b) conditions requiring the rendering to—
    - (i) the Secretary of State,
    - (ii) [F85the Office of Rail and Road], or
    - (iii) any other person, or any other person of a class or description, specified in the licence, except a Minister of the Crown or Government department,

of a payment on the grant of the licence, or payments during the currency of the licence, or both, of such amount or amounts as may be determined by or under the licence.

- (2) Conditions included in a licence by virtue of subsection (1)(a) above—
  - (a) may require the licence holder to enter into any agreement with any person for such purposes as may be specified in the conditions; and
  - (b) may include provision for determining the terms on which such agreements are to be entered into.
- (3) Conditions included in a licence by virtue of subsection (1)(a) above may require the licence holder—
  - (a) to comply with any requirements from time to time imposed by a qualified person with respect to such matters as are specified in the licence or are of a description so specified;
  - (b) except in so far as a qualified person consents to his doing or not doing them, not to do or to do such things as are specified in the licence or are of a description so specified;
  - (c) to refer for determination by a qualified person such questions arising under the licence as are specified in the licence or are of a description so specified;
  - (d) to refer for approval by a qualified person such things falling to be done under the licence as are specified in the licence or are of a description so specified;
  - (e) to furnish to a qualified person such documents or other information as he may require for the purpose of exercising any functions conferred or imposed on him under or by virtue of the licence;
  - (f) to furnish to the Secretary of State or [F85]the Office of Rail and Road] such documents or other information as he [F86]or it] may require for the purpose of exercising the functions assigned or transferred to him [F86]or it] under or by virtue of this Part [F87]or Part 4 of the Railways Act 2005].
- [F88(3A) Conditions included in a licence by virtue of subsection (1)(a) above may include provision about any matter which is dealt with (whether in the same or a different manner) by an access agreement.]

# 10 Conditions of licences: activities carried on by virtue of a licence exemption.

- (1) If and so long as a person is a licence exempt operator—
  - (a) there shall not be included in any licence granted to him any condition which relates to his licence exempt activities, except to the extent permitted by virtue of subsection (2) below; and
  - (b) any such condition which is included in a licence which has been granted to him shall, except to that extent, be of no effect so far as so relating.
- (2) A condition which relates to both—
  - (a) a licensed activity carried on by a person ("the licensee"), and
  - (b) a licence exempt activity carried on by him,

may be included in a licence, but only if and to the extent that, in the opinion of the person granting the licence, the condition must, in consequence of the licensee's carrying on of a mixed activity, necessarily have effect in relation to the whole, or some part, of so much of the mixed activity as consists of the licence exempt activity if the condition is to have full effect in relation to so much of the mixed activity as consists of the licensed activity.

- (3) There shall not be included in a licence any condition relating to the fares that may be charged in respect of train journeys involving licence exempt travel, other than train journeys which also involve—
  - (a) licensed travel; and
  - (b) at least two consecutive scheduled calls at stations during any one continuous spell of licensed operation.
- (4) For the purposes of subsection (3) above and this subsection—

"licence exempt travel" means travel by means of a train whose operator is, by virtue of a licence exemption, exempt from the requirement to be authorised by licence to be the operator of that train for the whole, or for some part, of the train journey in question;

"licensed travel" means travel by means of a train whose operator is authorised by licence to be the operator of that train for some part of the train journey in question;

"spell of licensed operation", in the case of any train journey, means any part of the journey throughout which the operator of the train in question lawfully acts as such by virtue only of holding one or more licences;

"train journey" means a journey between any two stations which is scheduled to be made by means of one train (irrespective of where the train in question begins or ends its journey).

- (5) Subsection (3) above has effect notwithstanding anything in subsection (1) or (2) above; and section 9 above is subject to the provisions of this section.
- (6) In this section—

"licence exempt activity" means any activity which a person carries on in his capacity as a licence exempt operator;

"licence exempt operator" means an operator of railway assets, or railway assets of a class or description, who is, by virtue of a licence exemption, exempt from the requirement to be authorised by licence to be the operator of those railway assets or of railway assets of that class or description;

"licensed activity" means any activity which a person carries on in his capacity as a licence holder;

"mixed activity" means any activity which is carried on by a person who is both a licence holder and a licence exempt operator and which is carried on by him in part as a licensed activity and in part as a licence exempt activity.

# 11 Assignment of licences.

- (1) A licence shall be capable of being assigned, but only if it includes a condition authorising assignment.
- (2) A licence shall not be capable of being assigned except with the consent of—

(1) In making a report on a reference under section 13 above, the [F134CMA]—

- (a) shall include in the report definite conclusions on the questions comprised in the reference together with such an account of their reasons for those conclusions as in their opinion is expedient for facilitating a proper understanding of those questions and of their conclusions;
- (b) where they conclude that any of the matters specified in the reference operate, or may be expected to operate, against the public interest, shall specify in the report the effects adverse to the public interest which those matters have or may be expected to have; and
- (c) where they conclude that any adverse effects so specified could be remedied or prevented by modifications of the conditions of the licence, shall specify in the report modifications by which those effects could be remedied or prevented.

    - (g) section 115 (recovery of penalties); and
    - (h) section 116 (statement of policy).

# 16 Modification by order under other enactments.

- [F192(1)] Where the [F193CMA] or (as the case may be) the Secretary of State (in this section "the relevant authority") makes a relevant order, the order may also provide for the modification of the conditions of a licence to such extent as may appear to the relevant authority to be requisite or expedient for the purpose of giving effect to, or taking account of, any provision made by the order.

# F200 16A Provision, improvement and development of railway facilities.

- (1) [F201 The Office of Rail and Road] may, on an application—
  - (a) made by the [F202 appropriate facilities authority], or
  - (b) made by any other person with the consent of the  $[F^{202}]$  appropriate facilities authority],

give to the operator of a network, station or light maintenance depot a direction to provide a new railway facility if [F201] the Office of Rail and Road] considers him to be an appropriate person to provide the new railway facility.

- (2) [F201 The Office of Rail and Road] may, on an application—
  - (a) made by the [F202 appropriate facilities authority], or
  - (b) made by any other person with the consent of the  $I^{F202}$  appropriate facilities authority],

give to a person who has an estate or interest in, or right over, an existing railway facility a direction to improve or develop the railway facility if [F201] the Office of Rail and Road] considers him to be an appropriate person to improve or develop the railway facility.

- (3) The [F203 consent of the appropriate facilities authority] to the making by any other person of an application under subsection (1) or (2) above may be given subject to compliance with conditions (and may be withdrawn if any condition is not complied with before [F201 the Office of Rail and Road] decides whether to give the direction).

## F205 16B Exemption of railway facilities from section 16A.

- (1) The [F206 appropriate facilities authority] may, after consultation with [F207 the Office of Rail and Road], by order grant exemption from subsection (1) or (2) of section 16A above (or from both of those subsections) in respect of such railway facilities as may be specified in the order, but subject to compliance with such conditions (if any) as may be so specified.
- (2) An exemption under subsection (1) above may be granted in respect of—
  - (a) railway facilities of a particular class or description, or
  - (b) a particular railway facility,
  - or in respect of part only of railway facilities of a particular class or description or a particular railway facility.
- (3) An exemption under subsection (1) above may be granted generally, to persons of a particular class or description or to a particular person.
- (4) If a person fails to comply with any condition subject to compliance with which an exemption was granted, the [F208 appropriate facilities authority] may give a direction declaring that the exemption is revoked, so far as relating to that person, to such extent and as from such date as may be specified in the direction.
- (5) Subject to subsection (4) above, an exemption, unless previously revoked in accordance with any term contained in the exemption, shall continue in force for such period as may be specified in, or determined by or under, the exemption.
- (6) Exemptions may make different provision, or be granted subject to compliance with different conditions, for different cases.

# F210 16C Making of applications for directions.

- (1) An application for a direction under section 16A above must be made to [F211 the Office of Rail and Road] in writing.
- (2) The application must—
  - (a) specify the person to whom the direction would be given;
  - (b) state what it would require him to do; and
  - (c) give the applicant's reasons for considering that person to be an appropriate person to do what the direction would require him to do.
- (3) The applicant may at any time vary what the direction would require that person to do by giving to [F211 the Office of Rail and Road] notice in writing of the variation; but if the applicant is a person other than the [F212 appropriate facilities authority] such a notice may only be given with the consent of the Authority.

# F213 16D Procedure for considering applications.

- (1) When [F214the Office of Rail and Road] has received the application or notice of a variation, [F215it]
  - (a) send a copy to the person specified in the application, the [F216 appropriate facilities authority] (if it is not the applicant) and any other persons who [F214 the Office of Rail and Road] considers ought to be sent one; and
  - (b) invite them to make written representations within a period specified in the invitation.
- (2) If the person specified in the application makes representations that he is not an appropriate person to do what the direction would require him to do, [F214] the Office

of Rail and Road] must decide that issue in advance of considering any other matters which may be relevant in deciding whether to give the direction.

- (3) If that person makes such representations but [F214the Office of Rail and Road] decides that he is an appropriate person to do what the direction would require him to do, [F214the Office of Rail and Road] must—
  - (a) notify him of that decision; and
  - (b) invite him to make written representations within a period specified in the invitation about any other matters which may be relevant in deciding whether to give the direction.
- (4) [F214The Office of Rail and Road] must—
  - (a) send the applicant a copy of any representations received by [F215it] in response to any invitation under subsection (1) or (3) above; and
  - (b) invite him to make further written representations within a period specified in the invitation.
- (5) Subject to subsection (6) below, [F214the Office of Rail and Road] may substitute as the applicant any other person if—
  - (a) the applicant,
  - (b) the other person, and
  - (c) the [F216 appropriate facilities authority] (if it is neither the applicant nor the other person),

consent to the substitution.

- (6) The applicant may, by giving notice in writing to [F214the Office of Rail and Road], withdraw or suspend the application at any time before [F214the Office of Rail and Road] decides whether to give the direction.

## F217 16E Decisions on applications: adequate reward.

- (1) [F218 The Office of Rail and Road] may only give a direction to a person under section 16A above to provide, improve or develop a railway facility if he is satisfied that the person will be adequately rewarded for providing, improving or developing the railway facility in accordance with the direction.
- (2) In considering whether he is so satisfied [F218the Office of Rail and Road] shall take into account (in particular)—
  - (a) any receipts obtained or likely to be obtained by the person (from the [F219] appropriate facilities authority], passengers, operators of railway services or any other persons) in connection with, or as a result of, the provision, improvement or development of the railway facility; and
  - (b) any other benefit obtained or likely to be obtained by him in consequence of its provision, improvement or development.
- (3) Representations made by the applicant for a direction—
  - (a) under section 16C(4) above, or
  - (b) in response to an invitation under section 16D(4) above,

may, in particular, include representations as to matters which he considers [F218the Office of Rail and Road] should take into account in deciding whether the person to whom the direction would be given would be adequately rewarded for doing what it would require him to do.

## F225 16G Directions: compliance, variation and revocation.

- (1) A person shall not be regarded as failing to comply with a direction under section 16A above if he has done everything which it is reasonably practicable to do in order to comply with the direction.
- (2) If a person is unable to comply with such a direction because he does not have the necessary powers or rights (including rights over land), he shall not be taken to have done everything which it is reasonably practicable to do in order to comply with the direction unless he has done everything which it is reasonably practicable to do in order to obtain those powers or rights.
- (3) A direction under section 16A above may only be revoked or varied by [F226the Office of Rail and Road]
  - (a) on the application of the person to whom the direction was given, the applicant for the direction or the Authority (if it was not the applicant); and

- (b) after consultation with the other persons with power to apply for a revocation or variation.
- (4) Such a direction may only be varied on an application by the applicant for the direction or the [F227] appropriate facilities authority] if [F226] the Office of Rail and Road] is satisfied that the person to whom the direction was given will be adequately rewarded for providing, improving or developing the railway facility in accordance with the varied direction, taking into account (in particular) the matters specified in section 16E(2) above.
- (5) [F226] The Office of Rail and Road] may grant an application for the variation or revocation of a direction under section 16A above by the applicant for the direction or the [F227] appropriate facilities authority] on condition that he or it secures that any such compensation as [F226] the Office of Rail and Road] may specify is paid to the person to whom the direction was given in respect of any liabilities incurred, or other things done, by him in complying with the direction.

# 17 Access agreements: directions requiring facility owners to enter into contracts for the use of their railway facilities.

- (1) [F234The Office of Rail and Road] may, on the application of any person, give directions to a facility owner requiring him to enter into an access contract with the applicant for the purpose specified in subsection (2) below; but no such directions shall be given if and to the extent that—
  - (a) the facility owner's railway facility is, by virtue of section 20 below, an exempt facility;
  - (b) performance of the access contract, if entered into, would necessarily involve the facility owner in being in breach of an access agreement  $^{F235}$ ...;  $^{F236}$ ...
  - (c) as a result of an obligation or duty owed by the facility owner which arose before the coming into force of this section, the consent of some other person is required by the facility owner before he may enter into the access contract; F238

- (2) The purpose for which directions may be given is that of enabling the beneficiary to obtain (whether for himself alone or for himself and, so far as may be applicable, associates of his)—
  - (a) from a facility owner whose railway facility is track, permission to use that track for the purpose of the operation of trains on that track by the beneficiary;
  - (b) from a facility owner whose railway facility is a station, permission to use that station for or in connection with the operation of trains by the beneficiary;
  - (c) from a facility owner whose railway facility is a light maintenance depot, permission to use that light maintenance depot for the purpose of obtaining light maintenance services for or in connection with the operation of trains by the beneficiary, whether the facility owner is to provide those services himself or to secure their provision by another;

- (d) from any facility owner, permission to use the facility owner's railway facility for the purpose of stabling, or otherwise temporarily holding, rolling stock in connection with the operation of trains on any track by the beneficiary; or
- (e) from any facility owner, permission to use the facility owner's railway facility for or in connection with the operation of a network, station or light maintenance depot by the beneficiary;

but this subsection is subject to the limitations imposed by subsection (3) below.

- (3) In subsection (2) above—
  - (a) paragraph (a) does not extend to obtaining permission to use track for the purpose of providing network services on that track;
  - (b) paragraph (b) does not extend to obtaining permission to use a station for the purpose of operating that station;
  - (c) paragraph (c) does not extend to obtaining permission to use a light maintenance depot for the purpose of enabling the beneficiary to carry out light maintenance;
  - (d) if and to the extent that the railway facility mentioned in paragraph (e) is track, that paragraph does not extend to obtaining permission to use that track for the purpose—
    - (i) of providing network services on that track, or
    - (ii) of operating any network in which that track is comprised,
    - except where the purpose for which directions are sought is to enable the beneficiary to operate on behalf of [F239] the Secretary of State] a network in which the track in question is comprised;
  - (e) if and to the extent that the railway facility mentioned in that paragraph is a station, that paragraph does not extend to obtaining permission to use that station for the purpose—
    - (i) of providing station services at that station, or
    - (ii) of operating that station,
    - except where the purpose for which directions are sought is to enable the beneficiary to operate the station on behalf of [F239] the Secretary of State];
  - (f) if and to the extent that the railway facility mentioned in that paragraph is a light maintenance depot, that paragraph does not extend to obtaining permission to use that light maintenance depot for the purpose—
    - (i) of carrying out light maintenance at that light maintenance depot, or
    - (ii) of operating that light maintenance depot.
    - except where the purpose for which directions are sought is to enable the beneficiary to operate the light maintenance depot on behalf of the [F240] Authority].
- (4) Any reference in this section to a person operating a network, station or light maintenance depot "on behalf of the [F241 Secretary of State][F242, the Welsh Ministers] is a reference to his operating the network, station or light maintenance depot in pursuance of any agreement or other arrangements made by the [F243 Secretary of State or the Scottish Ministers] for the purpose of performing a duty imposed upon [F244 him or them], or exercising a power conferred upon [F244 him or them], under or by virtue of this Part [F245 or Part 4 of the Railways Act 2005 (network modifications etc.)] to secure the operation of that network, station or light maintenance depot.

- (5) Nothing in this section authorises [F234the Office of Rail and Road] to give directions to any person requiring him to grant a lease of the whole or any part of a railway facility.
- (6) In this Part—

"access contract" means—

- (a) a contract under which—
- (i) a person (whether or not the applicant), and
- (ii) so far as may be appropriate, any associate of that person,

obtains permission from a facility owner to use the facility owner's railway facility; or

- (b) a contract conferring an option, whether exercisable by the applicant or some other person, to require a facility owner to secure that—
- (i) a person (whether or not the applicant or that other), and
- (ii) so far as may be appropriate, any associate of that person,

obtains permission from the facility owner to use his railway facility;

and any reference to an "access option" is a reference to an option falling within paragraph (b) above;

"facility owner" means any person—

- (a) who has an estate or interest in, or right over, a railway facility; and
- (b) whose permission to use that railway facility is needed by another before that other may use it;

[F246but also includes a person before he becomes a facility owner;]

and any reference to a facility owner's railway facility is a reference to the railway facility by reference to which he is a facility owner.

(7) In this section—

"the applicant" means the person making the application for directions; "associate", in relation to any person, includes—

- (a) any servant, agent or independent contractor of his;
- (b) any passenger of his;
- (c) any person engaged in the provision of goods or services to or for him; and
- (d) any other person who deals or has business with him;

"the beneficiary" means the person mentioned in paragraph (a)(i) or, as the case may be, paragraph (b)(i) of the definition of "access contract" in subsection (6) above, according to the description of access contract in question;

# Access agreements: contracts requiring the approval of [F250] the Office of Rail and Road].

- (1) A facility owner shall not enter into an access contract to which this section applies unless—
  - (a) he does so pursuant to directions under section 17 above; F251...
  - (b) [F<sup>250</sup>the Office of Rail and Road] has approved the terms of the access contract and the facility owner enters into the contract pursuant to directions under this section; [F<sup>252</sup>or
  - (c) the access contract is of a class or description specified in a general approval given by [F250] the Office of Rail and Road];]

and any access contract to which this section applies [F253 shall be void unless one of the conditions in paragraphs (a) to (c) above is satisfied.]

- (2) The access contracts to which this section applies are those under which the beneficiary obtains, or, in the case of an access contract conferring an access option, may obtain, (whether for himself alone or for himself and associates of his)—
  - (a) from a facility owner whose railway facility is track, permission to use that track for the purpose of the operation of trains on that track by the beneficiary;
  - (b) from a facility owner whose railway facility is a station, permission to use that station, for or in connection with the operation of trains by the beneficiary;
  - from a facility owner whose railway facility is a light maintenance depot, permission to use that light maintenance depot for the purpose of obtaining light maintenance services for or in connection with the operation of trains by the beneficiary, whether the facility owner is to provide those services himself or to secure their provision by another;
  - (d) from any facility owner, permission to use the facility owner's railway facility for the purpose of stabling, or otherwise temporarily holding, rolling stock in connection with the operation of trains on any track by the beneficiary; or
  - (e) from any facility owner, permission to use the facility owner's railway facility for or in connection with the operation of a network, station or light maintenance depot by the beneficiary;

but this subsection is subject to subsections (3) and (4) below.

- (3) This section does not apply to an access contract—
  - (a) if and to the extent that the railway facility to which the access contract relates is, by virtue of section 20 below, an exempt facility; F254...

## (4) In subsection (2) above—

  - (i) of carrying out light maintenance at that light maintenance depot, or
  - (ii) of operating that light maintenance depot,

unless the purpose of entering into the access contract is to enable the beneficiary to operate the light maintenance depot on behalf of [F255] the Secretary of State].

#### (5) In any case where—

- (a) a facility owner and another person (the "other party") have agreed the terms on which they propose to enter into an access contract to which this section applies, but
- (b) the circumstances are such that, by virtue of subsection (1)(b) above, those terms must be approved, and directions must be given, by the Regulator before the facility owner may enter into the proposed access contract,

it shall be for the facility owner to submit the proposed access contract to [F250the Office of Rail and Road] for approval of its terms.

- (6) If, on the submission of a proposed access contract pursuant to subsection (5) above, [F250] the Office of Rail and Road] approves its terms, [F256] shall issue directions to the facility owner—
  - (a) requiring him to enter into the proposed access contract within such period as may be specified for the purpose in the directions; but

(b) releasing him from his duty to do so if the other party fails to enter into the proposed access contract within such period as may be specified for the purpose in the directions;

# Access agreements: contracts for the use, on behalf of [F263] the Secretary of State], of installations comprised in a network.

- (1) [F264] The Office of Rail and Road] may, on the application of any person, give directions to an installation owner requiring him to enter into an installation access contract with the applicant for the purpose of enabling the beneficiary to obtain (whether for himself alone or for himself and, so far as may be applicable, associates of his) permission to use the installation owner's network installation for the purpose of operating, on behalf of [F263] the Secretary of State], the network in which the network installation is comprised.
- (2) Directions shall not be given under subsection (1) above in the case of any network installation if and to the extent that, as a result of an obligation or duty owed by the installation owner which arose before the coming into force of this section, the consent

of some other person is required by the installation owner before he may enter into the installation access contract.

- (3) An installation owner shall not enter into an installation access contract to which this subsection applies unless—
  - (a) he does so pursuant to directions under subsection (1) above; F265...
  - (b) [F264the Office of Rail and Road] has approved the terms of the installation access contract and the installation owner enters into the contract pursuant to directions given by virtue of subsection (5) below; [F266] or
  - (c) the installation access contract is of a class or description specified in a general approval given by the Regulator;

and any installation access contract to which this subsection applies [F267] shall be void unless one of the conditions in paragraphs (a) to (c) above is satisfied.]

- (4) The installation access contracts to which subsection (3) above applies are those under which the beneficiary obtains (whether for himself alone or for himself and associates of his) from an installation owner permission to use the installation owner's network installation for the purpose of operating, on behalf of [F263] the Secretary of State], the network in which the network installation is comprised.
- (5) Subsections (5) to (7) of section 18 above shall apply in relation to installation access contracts to which subsection (3) of this section applies as they apply in relation to access contracts to which that section applies, but with the following modifications, that is to say—
  - (a) for any reference to a facility owner there shall be substituted a reference to an installation owner;
  - (b) for any reference to an access contract to which that section applies there shall be substituted a reference to an installation access contract to which subsection (3) above applies;
  - (c) for the reference to subsection (1)(b) of that section there shall be substituted a reference to subsection (3)(b) of this section.

- (8) Any reference in this section to obtaining permission to use a network installation includes—
  - (a) a reference to obtaining, in connection with any such permission, power to obtain the provision of ancillary services relating to that network installation, whether the installation owner in question is to provide those services himself or to secure their provision by another; and
  - (b) a reference to obtaining permission—
    - (i) to enter upon the installation land, with or without vehicles,
    - (ii) to bring things on to that land and keep them there,
    - (iii) to carry out works on that land, and
    - (iv) to use and maintain any things kept, or buildings or other works constructed, on that land (whether by the beneficiary or another) or any amenities situated on that land;

and in paragraph (b) above "installation land" means the land which constitutes the network installation in question.

## (9) In this Part—

"installation access contract" means a contract under which—

- (a) a person (whether or not the applicant), and
- (b) so far as may be appropriate, any associate of that person,

obtains permission from an installation owner to use the installation owner's network installation;

"installation owner" means any person-

- (a) who has an estate or interest in, or right over, a network installation; and
- (b) whose permission to use that network installation is needed by another before that other may use it;

[F272] but also includes a person before he becomes an installation owner;

and any reference to an installation owner's network installation is a reference to the network installation by reference to which he is an installation owner.

## (10) In this section—

"ancillary service" means any service which is necessary or expedient for giving full effect to any permission or right which a person may have to use a network installation:

"the applicant" means the person making the application for directions under subsection (1) above;

"associate" has the meaning given by section 17(7) above;

"the beneficiary" means the person mentioned in paragraph (a) of the definition of "installation access contract" in subsection (9) above;

"lease" includes an underlease or sublease and an agreement for a lease, underlease or sublease:

"network installation" means any installation (other than track) which is comprised in a network.

(11) Any reference in this section to a network installation includes a reference to a part of a network installation [F273] and to one which is proposed to be constructed or is in the course of construction.].

- (12) Schedule 4 to this Act shall have effect with respect to applications for directions under subsection (1) above as it has effect with respect to applications for directions under section 17 above, but with the following modifications, that is to say—
  - (a) for any reference to an access contract, there shall be substituted a reference to an installation access contract;

# 20 Exemption of railway facilities from sections 17 [F277, 18 and 22A].

- (1) The Secretary of State may, after consultation with [F278] the Office of Rail and Road], by order grant exemption from sections 17 and 18 above [F279] and section 22A below] in respect of such railway facilities as may be specified in the order, but subject to compliance with such conditions (if any) as may be so specified.
- (2) A facility exemption under subsection (1) above may be granted—
  - (a) to persons of a particular class or description or to a particular person; and
  - (b) in respect of railway facilities of a particular class or description or a particular railway facility, or in respect of part only of any such railway facilities or facility;

- (3) If a facility owner makes an application under this subsection to [F278the Office of Rail and Road] for the grant of an exemption from sections 17 and 18 above [F279] and section 22A below] in respect of the whole or any part of his railway facility, [F278] the Office of Rail and Road], after consultation with the Secretary of State—
  - (a) may either grant or refuse the exemption, whether wholly or to such extent as  $[^{F281}it]$  may specify in the exemption; and
  - (b) if and to the extent that [F281 it] grants [F282 the exemption], may do so subject to compliance with such conditions (if any) as [F281 it] may so specify.
- (4) Before granting a facility exemption under subsection (3) above, [F278the Office of Rail and Road] shall give notice—

- (b) is the facility owner in the case of the railway facility in relation to which the broken condition is not complied with.

### 22 Amendment of access agreements.

- (1) Any amendment, or purported amendment, of an access agreement shall be void unless the amendment has been approved by [F289] the Office of Rail and Road][F290] or is made pursuant to directions under section 22A or 22C below or Schedule 4A to this Act].

## Franchising of passenger services

## 23 Passenger services to be subject to franchise agreements.

- (1) It shall be the duty of the [F<sup>304</sup>appropriate designating authority] from time to time to designate [F<sup>305</sup>such services for the carriage of passengers by railway (other than services which are, by virtue of section 24 below, exempt from designation under this subsection) as it considers ought to be provided under franchise agreements.].
- (2) The [F304] appropriate designating authority] may perform [F306] its] duty under subsection (1) above by designating particular services or services of a class or description.
- [F307(2ZA) Where the Scottish Ministers designate Scotland-only services, they may also designate cross-border services which—
  - (a) they consider should be provided under the same franchise agreement as particular Scotland-only services or a particular class of them; and
  - (b) are not exempt from designation under subsection (1) by virtue of section 24.
  - (2ZB) Nothing in this section requires the Secretary of State to designate a cross-border service already designated by the Scottish Ministers.
  - (2ZC) Before the Secretary of State or the Scottish Ministers designate a cross-border service he or they must consult the other.]
- [F308(2ZD)] Where the Welsh Ministers designate Wales-only services, they may also designate Welsh components of Welsh services which—
  - (a) they consider should be provided under the same franchise agreement as particular Wales-only services or a particular class of Wales-only services; and
  - (b) are not exempt from designation under subsection (1) by virtue of section 24.
  - (2ZE) Nothing in this section requires the Secretary of State to designate a Welsh service so far as already designated by the Welsh Ministers.]
  - [F309(2A) A designation may be varied or revoked; but a variation or revocation of the designation of particular services, or services of a class or description, shall not affect

any franchise agreement previously entered into with respect to those services or services of that class or description.

(3) In this Part—

[F311"the appropriate designating authority"—

- (a) in relation to Scotland-only services, means the Scottish Ministers; F312...
- (aa) [F313 in relation to Wales-only services, means the Welsh Ministers; and]
- (b) in relation to all other services, means the Secretary of State;

"the appropriate franchising authority"—

- (a) in relation to a Scottish franchise agreement, means the Scottish Ministers; F314...

- (ab) in relation to a Welsh franchise agreement to the extent that the franchised services under it are services other than Wales-only services or Welsh components of Welsh services, means the Secretary of State;
- (b) in relation to any other franchise agreement, means the Secretary of State;]

"franchise agreement" means an agreement [F316 to which the Secretary of State, the Scottish Ministers or the Welsh Ministers is or are party], under which another party undertakes either—

- (a) to provide, or
- (b) to secure that a wholly owned subsidiary of his provides,

throughout the franchise term those services for the carriage of passengers by railway to which the agreement relates;

"franchise operator", in relation to any franchise agreement, means the person (whether the franchisee or, as the case may be, the wholly owned subsidiary of the franchisee) who is to provide the franchised services;

"franchise period", in relation to any franchise agreement, means the franchise term, except where the franchise agreement is terminated before the end of that term, in which case it means so much of that term as ends with that termination; "franchise term", in relation to any franchise agreement, means the period specified in the franchise agreement as the period throughout which the franchise is to provide, or secure that a wholly owned subsidiary of his provides, the franchised services, and includes any such extension of that period as is mentioned in section 29(3) below;

"franchised services", in relation to any franchise agreement, means the services for the carriage of passengers by railway which are to be provided under that franchise agreement;

"franchisee" means-

- (a) in relation to a franchise agreement under which a party undertakes to secure that a wholly owned subsidiary of his provides the franchised services, the party so undertaking; or
- (b) in relation to any other franchise agreement, the person who is to provide the franchised services.

(4) Any reference in this Part to the provision of services under a franchise agreement is a reference to the provision of those services by the franchise operator; and where the franchise operator is, or is to be, a wholly owned subsidiary of the franchisee, any reference to the provision of services by the franchisee under a franchise agreement shall accordingly be construed as a reference to his securing their provision by the franchise operator.

## **Exemption of passenger services from section 23(1).**

- (1) The [F317] appropriate designating authority] may by order grant exemption from designation under section 23(1) above in respect of such services for the carriage of passengers by railway as may be specified in the order, but subject to compliance with such conditions (if any) as may be so specified.
- (2) A franchise exemption under subsection (1) above may be granted—
  - (a) to persons of a particular class or description or to a particular person; and
  - (b) in respect of services generally, services of a particular class or description or a particular service, or in respect of part only of any such services or service; and a franchise exemption granted to persons of a particular class or description shall be published in such manner as the [F317] appropriate designating authority] considers
- (3) If a person who provides, or who proposes to introduce, services for the carriage of passengers by railway makes an application to the [F317] appropriate designating authority] under this subsection for the grant of an exemption from designation under section 23(1) above in respect of any such service which he provides or proposes to introduce, the [F317] appropriate designating authority], after consultation with [F318] the Office of Rail and Road [F319]...—

appropriate for bringing it to the attention of persons of that class or description.

- (a) may either grant or refuse the exemption, whether wholly or to such extent as [F320] the appropriate designating authority] may specify in the exemption; and
- (b) if and to the extent that [F320] the appropriate designating authority] grants it, may do so subject to compliance with such conditions (if any) as [F320] the appropriate designating authority] may so specify.
- [F321(3A) Before granting a franchise exemption in respect of a cross-border service, the Secretary of State must consult the Scottish Ministers.]
- [F322(3B) Before granting a franchise exemption in respect of a Welsh service, the Secretary of State must consult the Welsh Ministers.]
  - (4) Before granting a franchise exemption under subsection (3) above, the [F317] appropriate designating authority] shall give notice—

    - (b) stating the reasons why [F323it] proposes to grant the franchise exemption, and
    - (c) specifying the time (not being less than 28 days from the date of publication of the notice) within which representations or objections with respect to the proposed franchise exemption may be made,

and shall consider any representations or objections which are duly made and not withdrawn.

- (5) A notice under subsection (4) above shall be given by publishing the notice in such manner as the [F317] appropriate designating authority] considers appropriate for bringing it to the attention of persons likely to be affected by the grant of the franchise exemption.
- (6) If any condition (the "broken condition") of a franchise exemption [F324] granted by the appropriate designating authority is not complied with, it] may give to any relevant person a direction declaring that the franchise exemption is revoked, so far as relating to that person, to such extent and as from such date as may be specified in the direction.
- (7) For the purposes of subsection (6) above—

"condition", in relation to a franchise exemption, means any condition subject to compliance with which the franchise exemption was granted;

"relevant person", in the case of any franchise exemption, means a person who has the benefit of the franchise exemption and who—

- (a) is a person who failed to comply with the broken condition or with respect to whom the broken condition is not complied with; or
- (b) provides any of the services in relation to which the broken condition is not complied with.
- (8) Subject to subsection (6) above, a franchise exemption, unless previously revoked in accordance with any term contained in the franchise exemption, shall continue in force for such period as may be specified in, or determined by or under, the franchise exemption.
- (9) Any application for a franchise exemption under subsection (3) above must be made in writing; and where any such application is made, the [F317] appropriate designating authority] may require the applicant to furnish [F325] with such information as the [F317] appropriate designating authority] may consider necessary to enable [F325] to decide whether to grant or refuse the franchise exemption.
- (10) Any franchise exemption granted under subsection (3) above shall be in writing.
- (11) Subsections (1) and (3) above apply in relation to the grant of a franchise exemption whether it is to become effective on, or after, the day on which section 23(1) above comes into force.
- (12) Franchise exemptions may make different provision for different cases.

- (1) Conditions specified in an order under section 24 made by the Secretary of State [F330] or the Welsh Ministers] may, in particular, include conditions which are to apply to any person providing services under an operator agreement.
- (2) An order under section 24 made by the Secretary of State [F331] or the Welsh Ministers] may include provision which, subject to any modifications that the Secretary of State considers appropriate [F332] or (as the case may be) that the Welsh Ministers consider appropriate], has an effect in connection with operator agreements which corresponds or is similar to the effect of the following provisions in connection with franchise agreements—
  - (a) section 27(3) of this Act (restrictions on transfer or creation of security over assets);
  - (b) section 27(5) of this Act (transactions entered into in breach of restrictions to be void);
  - (c) section 27(6) and (7) of this Act (no execution or other legal process etc in respect of assets);
  - (d) section 31 of this Act (disapplication of legislation: security of tenure of business premises);
  - (e) sections 55 to 58 of this Act (enforcement);
  - (f) section 12 of, and Schedule 2 to, the Railways Act 2005 (transfer schemes), subject to subsection (4) below.
- (3) Provision included in an order by virtue of subsection (2) may be made by applying the provision in question, subject to any modifications that the Secretary of State considers appropriate [F333] or (as the case may be) that the Welsh Ministers consider appropriate].

#### 26 Invitations to tender for franchises.

- (1) [F354]The appropriate franchising authority may select the person who is to be the franchisee in relation to a franchise agreement] from among those who submit tenders in response to an invitation to tender under this section for the right to provide, or to secure that a wholly owned subsidiary provides, services for the carriage of passengers by railway under that franchise agreement.
- (2) The [F355] appropriate franchising authority] shall prepare any such invitation to tender and shall issue that invitation to such persons as [F356] may, after consultation with [F357] the Office of Rail and Road], think fit.
- (3) The [F355 appropriate franchising authority] shall not issue an invitation to tender under this section to (or entertain such a tender from) any person unless [F356 it] is of the opinion that the person has, or is likely by the commencement of the franchise term to have, an appropriate financial position and managerial competence, and is otherwise a suitable person, to be the franchisee.

## [F36726ZNo adequate tender for franchise received.

- (1) This section applies in the case of an invitation to tender under section 26 for the provision of services if—
  - (a) the appropriate franchising authority receives no tender in response to the invitation; or
  - (b) it receives a tender but considers that the services would be provided more economically and efficiently if they were provided otherwise than under a franchise agreement entered into in response to the tender.

- (2) The appropriate franchising authority may
  - (a) issue a new invitation to tender under section 26 for the provision of the services;
  - (b) decide to secure the provision of the services under a franchise agreement with a person who did not submit a tender; or
  - (c) decide not to seek to secure the provision of the services under a franchise agreement.
- (3) Nothing in this section prevents the appropriate franchising authority, where it has decided not to seek to secure the provision of services under a franchise agreement, from subsequently making a decision to issue a new invitation to tender for the provision of those services.]

#### 27 Transfer of franchise assets and shares.

- (1) It shall be the duty of the [F370 responsible authority] before entering into a franchise agreement to satisfy [F371 itself] that if the franchise agreement is entered into—
  - (a) the initial franchise assets (if any) for that franchise agreement will be vested in the person who is to be the franchise operator; and
  - (b) if the franchise agreement is to be one under which the franchisee undertakes to secure that a wholly owned subsidiary of his provides the franchised services, that the franchise operator will be a wholly owned subsidiary of the franchisee.
- (2) After a franchise agreement has been entered into, it shall be the duty of the [F370 responsible authority], before any property, rights or liabilities are subsequently designated as franchise assets in accordance with the terms of, or by amendment to, the franchise agreement, to satisfy [F371 itself] that, if the property, rights or liabilities in question are so designated, they will be vested in the franchise operator.
- (3) Without the consent of the [F370 responsible authority], the franchise operator shall not—
  - (a) if and to the extent that the franchise assets are property or rights—
    - (i) transfer or agree to transfer, or create or agree to create any security over, any franchise assets or any interest in, or right over, any franchise assets: or
    - (ii) create or extinguish, or agree to create or extinguish, any interest in, or right over, any franchise assets; and
  - (b) if and to the extent that the franchise assets are liabilities, shall not enter into any agreement under which any such liability is released or discharged, or transferred to some other person.

- (4) Where the franchise agreement is one under which the franchisee undertakes to secure that a wholly owned subsidiary of his provides the franchised services, the franchisee shall not, without the consent of the [F370 responsible authority], take any action which would result in the franchise operator ceasing to be a wholly owned subsidiary of his.
- (5) Any transaction which is entered into in contravention of subsection (3) or (4) above shall be void.
- (6) In England and Wales, no execution or other legal process may be commenced or continued, and no distress may be levied [F372] and no power to use the procedure in Schedule 12 to the Tribunals, Courts and Enforcement Act 2007 may be exercised], against any property which is, or rights which are, franchise assets in the case of any franchise agreement.
- (7) In Scotland, no diligence or other legal process may be carried out or continued against any property which is, or rights which are, franchise assets in the case of any franchise agreement.
- (8) In any case where—
  - (a) there are to be initial franchise assets in relation to a franchise agreement,
  - (b) a franchise agreement is to be one which provides for subsequent designation of property, rights or liabilities as franchise assets, or
  - (c) property, rights or liabilities are to be designated as franchise assets by an amendment made to a franchise agreement,

the [F373] responsible authority] shall ensure that the franchise agreement includes provision specifying, or providing for the determination of, amounts to be paid in respect of the property, rights and liabilities which, immediately before the end of the franchise period, constitute the franchise assets in relation to that franchise agreement if and to the extent that they are transferred by [F374] a scheme under [F375] section 12 of the Railways Act 2005]] at or after the end of that period.

- (9) Without prejudice to the generality of the provisions that may be included in a franchise agreement with respect to the acquisition, provision, disposal or other transfer of property, rights or liabilities (whether franchise assets or not), the [F373 responsible authority] may undertake in a franchise agreement to exercise [F376 its] powers under [F375 section 12 of the Railways Act 2005] to transfer franchise assets to [F376 itself] or another in such circumstances as may be specified in the franchise agreement.
- (10) The [F373 responsible authority] shall ensure that every franchise agreement includes such provision (if any) as [F377 it] may consider appropriate in the particular case for the purpose of securing—
  - (a) that the franchise assets are adequately maintained, protected and preserved; and
  - (b) that, at the end of the franchise period, possession of such of the franchise assets as may be specified for the purpose in the agreement, or by the Franchising Director in accordance with the agreement, is delivered up to the Franchising Director or such other person as may be so specified.

# Fares and approved discount fare schemes.

- (1) A franchise agreement may include provision with respect to the fares to be charged for travel by means of the franchised services.
- (2) Subject to the other provisions of this Act, if it appears to the [F380] appropriate franchising authority] that the interests of persons who use, or who are likely to use, franchised services so require, [F381] shall ensure that the franchise agreement in question contains any such provision as [F381] may consider necessary for the purpose of securing that any fares, or any fares of a class or description, which are to be charged are, in [F381] opinion, reasonable in all the circumstances of the case.
- (3) Every franchise agreement shall include provision requiring the franchise operator—
  - (a) to participate in every approved discount fare scheme,
  - (b) to charge fares, in cases to which such a scheme applies, at rates which are not in excess of the levels or, as the case may be, the maximum levels set by the scheme, and
  - (c) otherwise to comply with the requirements of every such scheme,
  - if and to the extent that the franchised services are services, or services of a class or description, in relation to which the approved discount fare scheme in question applies.
- (4) The discount fare schemes which are to be regarded [F382, in relation to a franchise agreement,] for the purposes of this section as "approved" are those which are from time to time approved for the purposes of this section by the [F383] appropriate franchising authority].
- (5) In this section—
  - "discount fare scheme" means any scheme for enabling persons who are young, elderly or disabled to travel by railway at discounted fares, subject to compliance with such conditions (if any) as may be imposed by or under the scheme;
  - "discounted fare" means a lower fare than the standard fare for the journey in question;
    - "scheme" includes any agreement or arrangements.

# Other terms and conditions of franchise agreements.

  - (a) to operate any additional railway asset; or
  - (b) to secure the operation of any additional railway asset by the franchise operator or any other wholly owned subsidiary of the franchisee.
- (3) A franchise agreement shall include provision specifying the franchise term and may include provision enabling that term to be extended by such further term as may be specified in the franchise agreement.
- (4) Without prejudice to the generality of the provisions relating to property, rights and liabilities that may be included in a franchise agreement, a franchise agreement may include provision requiring the franchise operator—
  - (a) to acquire from such person as may be specified in the franchise agreement, and to use, such property or rights as may be so specified; or
  - (b) to undertake such liabilities as may be so specified.
- (5) Subject to any requirements imposed by or under this Act, a franchise agreement may contain any such provisions as the [F384] appropriate franchising authority] may think fit.

    - (b) preclude it from [F397] making a proposal to which section 24 of the Railways Act 2005 (proposals to discontinue franchised or secured services) applies] in relation to any of the services, in which case its duty under this section to secure the provision of the services to which the [F398] proposal] relates will (subject to [F399] subsections (7) and (8) of that section) terminate on [F400] the date for the discontinuance of services specified in the proposal]; or]
    - (c) preclude it from ceasing to provide or secure the provision of any of the services in any case falling within any of paragraphs (a) to (d) of [F401] subsection (3)] of that section.

# 31 Leases granted in pursuance of franchise agreements: no security of tenure.

- (1) In any case where—
  - (a) a franchise agreement makes provision for the franchisee, the franchise operator or a wholly owned subsidiary of the franchisee to enter into an agreement ("the contemplated agreement") with a person who has an interest in a network or a railway facility,
  - (b) the network or railway facility is to be used for or in connection with the provision of any of the franchised services, and
  - (c) the contemplated agreement creates a tenancy of any property which (whether in whole or in part) constitutes, or is comprised in, the network or railway facility,

neither Part II of the <sup>M3</sup>Landlord and Tenant Act 1954 (security of tenure of business premises) nor the <sup>M4</sup>Tenancy of Shops (Scotland) Act 1949 (security of tenure of shop premises in Scotland) shall apply to that tenancy.

- (2) For the purposes of this section, a person shall be regarded as having an interest in a network or railway facility if he has an estate or interest in, or right over, any of the property which constitutes, or is comprised in, the network or railway facility.
- (3) Any reference in this section to a network or a railway facility includes a reference to any part of a network or railway facility.
- (4) In this section—

"agreement" includes a lease, underlease or sublease (as well as a tenancy agreement or an agreement for a lease, underlease or sublease);

"tenancy" has the same meaning as it has in Part II of the M5Landlord and Tenant Act 1954 or, in Scotland, as it has in the M6Tenancy of Shops (Scotland) Act 1949.

  - (viiic) with the approval of the Authority, to enter into and carry out agreements with the owner of any locomotive or other rolling stock concerning the persons to whom, or the terms on which, the locomotive or other rolling stock may be let on hire;".



# **Exercise of functions for purpose of encouraging investment in the railways.**

- (1) The [F436] Secretary of State [F437], the Welsh Ministers] or the Scottish Ministers]—

# 55 Orders for securing compliance.

- (1) Subject to subsections (2) to [F<sup>452</sup>(5C)] and section 56 below, where the appropriate [F<sup>453</sup>authority] is satisfied that a relevant operator is contravening, or is likely to contravene, any relevant condition or requirement, [F<sup>453</sup>it] shall by a final order make such provision as is requisite for the purpose of securing compliance with that condition or requirement.
- (2) Subject to [F454] subsections (5) to [F452 (5C)] below, where it appears to the appropriate [F453] authority]—
  - (a) that a relevant operator is contravening, or is likely to contravene, any relevant condition or requirement, and
  - (b) that it is requisite that a provisional order be made,
  - [<sup>F453</sup>it] shall (instead of taking steps towards the making of a final order) by a provisional order make such provision as appears to [F453it] requisite for the purpose of securing compliance with that condition or requirement.
- (3) In determining for the purposes of subsection (2)(b) above whether it is requisite that a provisional order be made, the appropriate [F453 authority] shall have regard, in particular, to the extent to which any person is likely to sustain loss or damage in consequence of anything which, in contravention of the relevant condition or requirement, is likely to be done, or omitted to be done, before a final order may be made.
- (4) Subject to [F454] subsections (5) to [F452] and section 56 below, the appropriate [F453] authority] shall confirm a provisional order, with or without modifications, if—
  - (a) [F453 it] is satisfied that the relevant operator to whom the order relates is contravening, or is likely to contravene, any relevant condition or requirement; and
  - (b) the provision made by the order (with any modifications) is requisite for the purpose of securing compliance with that condition or requirement.
- (5) The appropriate [F453] authority] shall not make a final order, or make or confirm a provisional order, in relation to a relevant operator if [F453] it] is satisfied—
  (a) that the duties imposed on [F453] it] by section 4 [F455] above F456...] preclude the making or, as the case may be, the confirmation of the order;

# 56 Procedural requirements [F498 for section 55 orders].

- (1) Before [F499it] makes a final order or confirms a provisional order, the appropriate [F500] authority] shall give notice—
  - (a) stating that [F499it] proposes to make or confirm the order and setting out its effect.
  - (b) setting out—
    - (i) the relevant condition or requirement for the purpose of securing compliance with which the order is to be made or confirmed,
    - (ii) the acts or omissions which, in [F501its] opinion, constitute or would constitute contraventions of that condition or requirement, and
    - (iii) the other facts which, in [F501 its] opinion, justify the making or confirmation of the order, and
  - (c) specifying the period (not being less than [F50221] days from the date of publication of the notice) within which representations or objections with respect to the proposed order or proposed confirmation may be made,

and shall consider any representations or objections which are duly made and not withdrawn.

- (2) A notice under subsection (1) above shall be given—
  - (a) by publishing the notice in such manner as the appropriate [F500] authority] considers appropriate for the purpose of bringing the matters to which the notice relates to the attention of persons likely to be affected by them; and

- (b) by serving a copy of the notice, and a copy of the proposed order or of the order proposed to be confirmed, on the relevant operator to whom the order relates.
- [F503(2A) Where [F504the Office of Rail and Road] serves a copy of a notice under subsection (1) above on a licence holder, he shall also serve a copy on the [F505Secretary of State and on the Scottish Ministers][F506] and the Welsh Ministers].]
  - (3) The appropriate [F500 authority] shall not make a final order with modifications, or confirm a provisional order with modifications, except—
    - (a) with the consent to the modifications of the relevant operator to whom the order relates; or
    - (b) after complying with the requirements of subsection (4) below.
  - (4) The requirements mentioned in subsection (3) above are that the appropriate [F500] authority] shall—
    - (a) serve on the relevant operator to whom the order relates such notice as appears to him requisite of [F501 its] proposal to make or confirm the order with modifications;
    - (b) [F507 unless the proposed modifications are trivial, in that notice specify a period (not being less than seven] from the date of service of the notice) within which representations or objections with respect to the proposed modifications may be made; and
    - (c) consider any representations or objections which are duly made and not withdrawn.
  - (5) As soon as practicable after making a final order or making or confirming a provisional order, the appropriate [F500] authority] shall—
    - (a) serve a copy of the order on the relevant operator to whom the order relates;
    - (b) publish the order in such manner as [F499it] considers appropriate for the purpose of bringing it to the attention of persons likely to be affected by it.
  - (6) Before revoking a final order or a provisional order which has been confirmed, the appropriate [F500] authority] shall give notice—
    - (a) stating that [F499it] proposes to revoke the order and setting out the effect of its revocation, and
    - (b) specifying the period (not being less than [F50821] days from the date of publication of the notice) within which representations or objections with respect to the proposed revocation may be made,

and shall consider any representations or objections which are duly made and not withdrawn.

- (7) If, after giving notice under subsection (6) above, the appropriate [F500] authority] decides not to revoke the order to which the notice relates, [F499] it] shall give notice of [F501] its] decision.
- (8) A notice under subsection (6) or (7) above shall be given—
  - (a) by publishing the notice in such manner as the appropriate [F500] authority] considers appropriate for the purpose of bringing the matters to which the notice relates to the attention of persons likely to be affected by them; and
  - (b) by serving a copy of the notice on the relevant operator to whom the order relates.

# 57 Validity and effect of [F509 section 55] orders.

- (1) If the relevant operator to whom a final or provisional order relates is aggrieved by the order and desires to question its validity on the ground—
  - (a) that its making or confirmation was not within the powers of section 55 above, or
  - (b) that any of the requirements of section 56 above have not been complied with in relation to it,

he may, within 42 days from the date of service on him of a copy of the order, make an application to the court under this section.

- (2) On any such application the court, if satisfied that the making or confirmation of the order was not within those powers or that the interests of the relevant operator have been substantially prejudiced by a failure to comply with those requirements—
  - (a) may quash the order or any provision of the order; F510...

- [F512](2A) If such an application is made in relation to a provision of an order requiring the payment of a sum in the event of a contravention and the sum would be payable before the time when the application is determined, it need not be paid until that time.
  - (2B) Where such an application is so made the court, if satisfied as mentioned in subsection (2) above, may (instead of quashing the order or the provision of the order) make provision under either or both of paragraphs (a) and (b) of subsection (2C) below.

    - (5) Where a duty is owed by virtue of subsection (4) above to any person, any breach of the duty which causes that person to sustain loss or damage shall be actionable at the suit or instance of that person.
    - (6) In any proceedings brought against a relevant operator in pursuance of subsection (5) above, it shall be a defence for him to prove that he took all reasonable steps and exercised all due diligence to avoid contravening the order.
    - (7) Without prejudice to any right which any person may have by virtue of subsection (5) above to bring civil proceedings in respect of any contravention or apprehended contravention of a final or provisional order, compliance with any such order shall be enforceable by civil proceedings by the appropriate [F513] authority] for an injunction or for interdict or for any other appropriate relief or remedy.
    - (8) Where a relevant operator to whom a final or provisional order relates has made an application pursuant to subsection (1) above questioning the validity of that order, the making of that application shall not affect—
      - (a) his obligation to comply with the order, or

# [F51557A Penalties.

- (1) If the appropriate authority is satisfied that a relevant operator has contravened or is contravening—
  - (a) a relevant condition or requirement, or
  - (b) a final or provisional order made by the appropriate authority, the appropriate authority may impose on the relevant operator a penalty of such amount as is reasonable.
- (2) A penalty is payable

# F52757B Statement of policy.

- (1) The [F528]Secretary of State, the Scottish Ministers][F529], the Welsh Ministers] and [F530] the Office of Rail and Road] shall each prepare and publish a statement of policy with respect to the imposition of penalties and the determination of their amount.
- (2) A statement of policy may include provision for a decision whether to impose a penalty, or the determination of the amount of any penalty, in respect of the contravention of any relevant condition or requirement or order to be influenced by—
  - (a) the desirability of securing compliance with that relevant condition or requirement or order;
  - (b) the consequences or likely consequences of anything which has been or is being done or omitted to be done in contravention of that relevant condition or requirement or order; and
  - (c) the desirability of deterring contraventions of relevant conditions and requirements and final and provisional orders.
- (3) In deciding whether to impose a penalty, and in determining the amount of any penalty, in respect of a contravention the [F528 Secretary of State, the Scottish Ministers] [F531, the Welsh Ministers] and Regulator shall have regard to any statement of [F532 his, their or] its F533... policy published at the time when the contravention occurred.
- (4) The [F528 Secretary of State, the Scottish Ministers][F531, the Welsh Ministers] and [F530 the Office of Rail and Road]
  - (a) may at any time alter or replace a statement of [F532his, their or]F534. . . its policy; and
  - (b) shall publish the altered or replacement statement.
- (5) The [F528] Secretary of State, the Scottish Ministers] [F531], the Welsh Ministers] and [F530] the Office of Rail and Road] shall undertake appropriate consultation when preparing, altering or replacing a statement of policy.

# F53557C Procedural requirements for penalties.

- (1) Before it imposes a penalty on a relevant operator, the appropriate authority shall give notice—
  - (a) stating that it proposes to impose a penalty on the relevant operator and the amount of the penalty proposed,
  - (b) setting out the relevant condition or requirement or order in question,
  - (c) specifying the acts or omissions which, in its opinion, constitute contraventions of that condition or requirement or order and the other facts which, in its opinion, justify the imposition of a penalty and the amount of the penalty proposed,
  - (d) specifying the manner in which, and place at which, it is proposed to require the penalty to be paid, and
  - (e) specifying the period (not being less than 21 days from the date of publication of the notice) within which representations or objections with respect to the proposed penalty may be made,

and shall consider any representations or objections which are duly made and not withdrawn.

- (2) A notice under subsection (1) above shall be given—
  - (a) by publishing the notice in such manner as the appropriate authority considers appropriate; and
  - (b) by serving a copy of the notice on the relevant operator.
- (3) Where [F536] the Office of Rail and Road] serves a copy of a notice under subsection (1) above on a licence holder, he shall also serve a copy on the [F537] Secretary of State and on the Scottish Ministers] [F538] and the Welsh Ministers].
- (4) The appropriate authority shall not modify a proposal to impose a penalty except—
  - (a) with the consent of the relevant operator;
  - (b) where the modifications consist of a reduction of the amount of the penalty or a deferral of the date by which it is to be paid; or
  - (c) after complying with the requirements of subsection (5) below.
- (5) The requirements mentioned in subsection (4)(c) above are that the appropriate authority shall—
  - (a) give to the relevant operator such notice as appears to it requisite of its modified proposal;

  - (c) consider any representations or objections which are duly made and not withdrawn.

  - (a) stating that it has imposed a penalty on the relevant operator and its amount;
  - (b) setting out the relevant condition or requirement or order in question;
  - (c) specifying the acts or omissions which, in its opinion, constitute contraventions of that condition or requirement or order and the other facts which, in its opinion, justify the imposition of the penalty and its amount;
  - (d) specifying the manner in which, and place at which, the penalty is to be paid; and
  - (e) specifying the date (not being less than fourteen days from the date of publication of the notice) by which the penalty is to be paid.
- (7) A notice under subsection (6) above shall be given—
  - (a) by publishing the notice in such manner as the appropriate authority considers appropriate; and
  - (b) by serving a copy of the notice on the relevant operator.
- (8) The relevant operator may, within 21 days of the date of service on him of the notice under subsection (6) above, make an application to the appropriate authority for it to specify different dates by which different portions of the penalty are to be paid.

# F53957D Time limits.

- (1) No penalty may be imposed in respect of a contravention by a relevant operator—
  - (a) by virtue of paragraph (a) of subsection (1) of section 57A above in a case where no final or provisional order has been made in relation to the contravention, or

# F54157F Validity and effect of penalties.

- (1) If the relevant operator to whom a [F542 penalty notice] relates is aggrieved by a penalty and desires to question its validity on the ground—
  - (a) that it was not within the powers of section 57A above,
  - (b) that any of the requirements of section 57C above have not been complied with in relation to it and his interests have been substantially prejudiced by the non-compliance, or
  - (c) that it was unreasonable of the appropriate authority not to grant an application under section 57C(8) above;

he may make an application to the court under this section.

- (2) An application under this section by a person shall be made—
  - (a) where it is on the ground mentioned in subsection (1)(c) above, within 42 days from the date on which he is notified of the decision not to grant the application under section 57C(8) above, and
  - (b) in any other case, within 42 days from the date of service on him of the notice under section 57C(6) above.

- (3) If an application is made under this section in relation to a penalty, the penalty need not be paid until the application has been determined.
- (4) On an application under this section on the ground mentioned in subsection (1)(a) or (b) above the court, if satisfied that the ground is established, may quash the penalty or (instead of quashing it) make provision under either or both of paragraphs (a) and (b) of subsection (5) below.
- (5) The provision referred to in subsection (4) above is—
  - (a) provision substituting a penalty of such lesser amount as the court considers appropriate in all the circumstances of the case; and
  - (b) provision substituting as the date by which the penalty, or any portion of the penalty, is to be paid a date later than that specified in the notice under section 57C(6) above.
- (6) On an application under this section on the ground mentioned in subsection (1)(c) above the court, if satisfied that the ground is established, may specify different dates by which different portions of the penalty are to be paid.
- (7) Where the court substitutes a penalty of a lesser amount it may require the payment of interest on the substituted penalty at such rate, and from such date, as it determines; and where it specifies as the date by which the penalty, or a portion of the penalty, is to be paid a date before the determination of the application it may require the payment of interest on the penalty, or portion, from that date at such rate as it determines.
- (8) Except as provided by this section, the validity of a penalty shall not be questioned by any legal proceedings whatever.

# Power to require information etc [F543 for purposes of sections 55 and 57A].

- (1) Where it appears to the appropriate [F544] authority] that a relevant operator [F545] may have contravened or be contravening—
  - (a) a relevant condition or requirement, or
  - (b) a final or provisional order made by the appropriate authority.
  - the] appropriate [F544] authority] may, for any purpose connected with such of [F544] its] functions under section 55 [F546] or 57A] above as are exercisable in relation to that matter, serve a notice under subsection (2) below on any person.

- (2) A notice under this subsection is a notice signed by the appropriate [F547 authority] and—
  - (a) requiring the person on whom it is served to produce, at a time and place specified in the notice, to the appropriate [F547authority] or to any person appointed by the appropriate [F547authority] for the purpose, any documents which are specified or described in the notice and are in that person's custody or under his control; or
  - (b) requiring that person, if he is carrying on a business, to furnish, at a time and place and in the form and manner specified in the notice, to the appropriate [F547] authority] such information as may be specified or described in the notice.
- (3) No person shall be required under this section to produce any documents which he could not be compelled to produce in civil proceedings in the court or, in complying with any requirement for the furnishing of information, to give any information which he could not be compelled to give in evidence in any such proceedings.
- (4) A person who without reasonable excuse fails to do anything required of him by notice under subsection (2) above is guilty of an offence and shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale.
- (5) A person who intentionally alters, suppresses or destroys any document which he has been required by any notice under subsection (2) above to produce is guilty of an offence and shall be liable—
  - (a) on summary conviction, to a fine not exceeding the statutory maximum;
  - (b) on conviction on indictment, to a fine.

Railway administration orders, winding up and insolvency

# 59 Meaning and effect of railway administration order.

- (1) A "railway administration order" is an order of the court made in accordance with section 60, 61 or 62 below in relation to a protected railway company and directing that, during the period for which the order is in force, the affairs, business and property of the company shall be managed, by a person appointed by the court,—
  - (a) for the achievement of the purposes of such an order; and
  - (b) in a manner which protects the respective interests of the members and creditors of the company.
- (2) The purposes of a railway administration order made in relation to any company shall be—
  - (a) the transfer to another company, or (as respects different parts of its undertaking) to two or more different companies, as a going concern, of so much of the company's undertaking as it is necessary to transfer in order to ensure that the relevant activities may be properly carried on; and
  - (b) the carrying on of those relevant activities pending the making of the transfer.
- (3) Schedule 6 to this Act shall have effect for applying provisions of the M13 Insolvency Act 1986 where a railway administration order is made.
- (4) Schedule 7 to this Act shall have effect for enabling provision to be made with respect to cases in which, in pursuance of a railway administration order, another company is to carry on all or any of the relevant activities of a protected railway company in place of that company.

## Railway administration orders made on special petitions.

- [F557(1) If, on an application relating to a protected railway company] the court is satisfied that either or both of the grounds specified in subsection (2) below is satisfied in relation to that protected railway company, the court may make a railway administration order in relation to that company.

  - (4) Subsections (4) and (5) of section 9 of the 1986 Act (powers on application for administration order) shall apply on the hearing of the petition for a railway administration order in relation to any company as they apply on the hearing of a petition for an administration order.
  - (5) Subsections (1), (2), (4) and (5) of section 10 of the 1986 Act (effect of petition) shall apply in the case of a petition for a railway administration order in relation to any company as if—
    - (a) the reference in subsection (1) to an administration order were a reference to a railway administration order;
    - (b) paragraph (b) of that subsection did require the leave of the court for the taking of any of the steps mentioned in paragraphs (b) and (c) of subsection (2) (appointment of, and exercise of functions by, administrative receiver); and
    - (c) the reference in paragraph (c) of subsection (1) to proceedings included a reference to any proceedings under or for the purposes of section 55 [F558 or 57A] above.

- (6) For the purposes of this section a company is unable to pay its debts if—
  - (a) it is a company which is deemed to be so unable under section 123 of the 1986 Act (definition of inability to pay debts); or
  - (b) it is an unregistered company, within the meaning of Part V of the 1986 Act, which is deemed, by virtue of any of sections 222 to 224 of that Act, to be so unable for the purposes of section 221 of that Act (winding up of unregistered companies).

#### 62 Restrictions on voluntary winding up and insolvency proceedings in the case of protected railway companies.

#### 63 Government financial assistance where railway administration orders made.

- (1) Where a railway administration order is for the time being in force in relation to a company [F568] other than a Scottish protected railway company [F569] or a Welsh protected railway company], the Secretary of State may, with the consent of the
  - make to the company grants or loans of such sums as appear to him to be appropriate for the purpose of facilitating the achievement of the purposes of the order;

  - is a company in relation to which a railway administration order is in force at the time when the guarantee is given; and

### 64 Guarantees under section 63.

- (1) This section applies in relation to any guarantee given by the Secretary of State under section 63 above.
- (2) Immediately after a guarantee to which this section applies is given, the Secretary of State shall lay a statement of the guarantee before each House of Parliament.
- (3) Where any sum is paid out for fulfilling a guarantee to which this section applies, the Secretary of State shall, as soon as possible after the end of each financial year (beginning with that in which the sum is paid out and ending with that in which all liability in respect of the principal of the sum and in respect of the interest thereon is finally discharged), lay before each House of Parliament a statement relating to that sum.
- (4) Any sums required by the Secretary of State for fulfilling a guarantee to which this section applies shall be paid out of money provided by Parliament.
- (5) Without prejudice to any provision applied in relation to the relevant company by Schedule 6 to this Act, if any sums are paid out in fulfilment of a guarantee to which this section applies, the relevant company shall make to the Secretary of State, at such times and in such manner as the Secretary of State may from time to time direct—
  - (a) payments of such amounts as the Secretary of State may so direct in or towards repayment of the sums so paid out; and
  - (b) payments of interest, at such rate as the Secretary of State may so direct, on what is outstanding for the time being in respect of sums so paid out;

and the consent of the Treasury shall be required for the giving of a direction under this subsection.

- (6) Any sums received by the Secretary of State under subsection (5) above shall be paid into the Consolidated Fund.

- (1) Where a railway administration order is for the time being in force in relation to a Scottish protected railway company [F579] or a Welsh protected railway company, the Scottish Ministers or the Welsh Ministers (as the case may be)] may—
  - (a) make grants or loans to the company of such sums as appear to them to be appropriate for the purpose of facilitating the achievement of the purposes of the order; or
  - (b) agree to indemnify a relevant person in respect of—
    - (i) liabilities incurred by that person in connection with the carrying out by the railway administrator of his functions under the order; and
    - (ii) loss or damage incurred by that person in that connection.
- (2) The Scottish Ministers [F580 or the Welsh Ministers (as the case may be)] may guarantee—
  - (a) the repayment of the principal of any sum borrowed by a Scottish protected railway company [FSSI or Welsh protected railway company] in relation to which a railway administration order is in force when the guarantee is given;
  - (b) the payment of interest on a sum so borrowed; and
  - (c) the discharge of any other financial obligation in relation to a sum so borrowed.
- (3) A grant, loan, indemnity or guarantee under this section may be made or given in whatever manner, and on whatever terms and subject to whatever conditions, the Scottish Ministers [F582] or the Welsh Ministers (as the case may be)] consider appropriate.
- (4) The terms on which a grant may be made under this section include, in particular, terms requiring the whole or a part of the grant to be repaid to the Scottish Ministers [F583] or the Welsh Ministers (as the case may be)] if there is a contravention of the other terms on which the grant is made.
- (5) The terms on which a loan may be made under this section include, in particular, terms requiring—
  - (a) the loan to be repaid at such times and by such methods, and
  - (b) interest to be paid on the loan at such rates and at such times, as the Scottish Ministers [F584] or the Welsh Ministers (as the case may be)] may from time to time direct.

  - (b) includes power to agree to indemnify persons (whether or not they are identified or identifiable at the time of the agreement) who subsequently become relevant persons.

- (7) A person is a relevant person for the purposes of this section if he is—
  - (a) the railway administrator;
  - (b) an employee of the railway administrator;
  - (c) a member or employee of a firm of which the railway administrator is a member;
  - (d) a member or employee of a firm of which the railway administrator is an employee;
  - (e) a member of a firm of which the railway administrator was an employee or member at a time when the order was in force;
  - (f) a body corporate which is the employer of the railway administrator; or
  - (g) an officer, employee or member of such a body corporate.

### (8) In this section—

- (a) references to the railway administrator, in relation to a railway administration order, are references to the person appointed to achieve the purposes of the order and, where two or more persons are so appointed, are to be construed as references to any one or more of them; and
- (b) the references to a firm of which a person was a member or employee at a particular time include references to a firm which holds itself out to be the successor of a firm of which he was a member or employee at that time.
- (9) If sums are paid out by the Scottish Ministers [F586] or the Welsh Ministers] in respect of an indemnity or guarantee under this section, the company in relation to which the indemnity or guarantee was given must pay [F587] the Scottish Ministers or the Welsh Ministers (as the case may be)]
  - (a) such amounts in or towards the repayment to them of those sums as they may direct; and
  - (b) interest, at such rates as they may direct, on amounts outstanding under this subsection.
- (10) Payments to the Scottish Ministers [F588] or the Welsh Ministers] under subsection (9) must be made at such times and in such manner as they may determine.
- (11) Subsection (9) does not apply in the case of a sum paid by the Scottish Ministers [F589] or the Welsh Ministers [for indemnifying a person in respect of a liability to the company in relation to which the railway administration order in question was made.]

# Meaning of "company" and application of provisions to unregistered, foreign and other companies.

- [F590(1) In the railway administration order provisions of this Act—
  - "company" means-
  - (a) a company registered under the Companies Act 2006, or
  - (b) an unregistered company; and
  - "unregistered company" means a company that is not registered under that Act.]
  - (2) In the application of section 59(1) above in a case where the protected railway company there mentioned is a foreign company, the reference to the affairs, business and property of the company shall be taken as a reference to the affairs and business of the company, so far as carried on in Great Britain, and the property of the company within Great Britain.
  - (3) In the application of section 9(5) of the 1986 Act by virtue of subsection (4) of section 60 above or subsection (3) of section 61 above where the petition mentioned in the subsection in question relates to a company which is a foreign company, the reference to restricting the exercise of any powers of the directors or of the company shall be taken as a reference to restricting—
    - (a) the exercise within Great Britain of the powers of the directors or of the company; or
    - (b) any exercise of those powers so far as relating to the affairs, business or property of the company in Great Britain.
  - (4) In the application of provisions in section 10 of the 1986 Act by virtue of subsection (5) of section 60 above where the company mentioned in that subsection is a foreign company—
    - (a) paragraph (a) of subsection (1) shall be omitted;
    - (b) any reference in paragraph (b) or (c) of that subsection to property or goods shall be taken as a reference to property or (as the case may be) goods for the time being situated within Great Britain;
    - (c) in paragraph (c) of that subsection—

- (i) the reference to the commencement or continuation of proceedings shall be taken as a reference to the commencement or continuation of proceedings in Great Britain; and
- (ii) the reference to the levying of distress against the company shall be taken as a reference to the levying of distress against the foreign company to the extent of its property in England and Wales; and
- (d) any reference in subsection (2) to an administrative receiver shall be taken to include a reference to any person performing, in relation to the foreign company, functions equivalent to those of an administrative receiver, within the meaning of section 251 of the 1986 Act.
- (5) Subsections (1) to (4) of section 62 above shall not have effect in relation to a protected railway company which is a foreign company.
- (6) In the application of subsection (7) of that section where the protected railway company there mentioned is a foreign company, the reference to the company's property shall be taken as a reference to such of its property as is for the time being situated in Great Britain.
- (7) In this section—

"the 1986 Act" means the M24 Insolvency Act 1986;

"foreign company" means a company incorporated outside Great Britain;

"the railway administration order provisions of this Act" means sections 59 to 64 above, this section and Schedules 6 and 7 to this Act.

# 81 Meaning of "railway".

- (1) Subject to subsection (2) below, the definition of "railway" in section 67(1) of the M26Transport and Works Act 1992 shall have effect for the purposes of this Part as it has effect for the purposes of that Act, and cognate expressions shall be construed accordingly.
- (2) Where it is stated for the purposes of any provision of this Part that railway has its wider meaning, "railway" shall be taken, for the purposes of that provision, to mean—
  - (a) a railway,
  - (b) a tramway, or
  - (c) a transport system which uses another mode of guided transport but which is not a trolley vehicle system,

and cognate expressions shall be construed accordingly.

(3) In paragraphs (a) to (c) of subsection (2) above "guided transport", "railway", "tramway" and "trolley vehicle system" have the meaning given by section 67(1) of the M27 Transport and Works Act 1992.

# 82 Meaning of "railway services" etc.

- (1) In this Part, "railway services" means services of any of the following descriptions, that is to say—
  - (a) services for the carriage of passengers by railway;
  - (b) services for the carriage of goods by railway;
  - (c) light maintenance services;
  - (d) station services;
  - (e) network services.
- (2) In this Part—

"light maintenance services" means services of any of the following descriptions, that is to say—

- (a) the refuelling, or the cleaning of the exterior, of locomotives or other rolling stock;
- (b) the carrying out to locomotives or other rolling stock of maintenance work of a kind which is normally carried out at regular intervals of twelve months or less to prepare the locomotives or other rolling stock for service;

"network services" means any service which consists of, or is comprised in, the provision or operation of a network (or of any of the track or other installations comprised in a network), but does not include any service which falls within paragraphs (a) to (d) of subsection (1) above;

"services for the carriage of passengers by railway" includes services for and in connection with the carriage of luggage, parcels or mail on trains which at the time are available, and primarily intended, for use by passengers; and references to carrying, or to the carriage of, passengers by railway shall be construed accordingly;

"station services" means any service which consists of, or is comprised in, the provision or operation of a station;

and, for the purposes of the above definitions of "network services" and "station services", where a person permits another to use any land or other property comprised in a network or station he shall be regarded as providing a service which falls within the meaning of "network services" or "station services", as the case may be.

- (3) Without prejudice to the generality of the definition in subsection (2) above, "network services" includes services of any of the following descriptions, that is to say—
  - (a) the construction, maintenance, re-alignment, re-configuration or renewal of track,
  - (b) the installation, operation, maintenance or renewal of a railway signalling system or of any other railway communication equipment,
  - (c) the construction, control, maintenance or renewal of electrical conductor rails or overhead lines, of any supports for such rails or lines, and of any electrical substations or power connections used or to be used in connection therewith, and the provision of electrical power by means thereof,

- (d) the provision and operation of services for the recovery or repair of locomotives or other rolling stock in connection with any accident, malfunction or mechanical or electrical failure,
- (e) the provision and operation of services for keeping track free from, or serviceable notwithstanding, obstruction (whether by snow, ice, water, fallen leaves or any other natural or artificial obstacle or hindrance) or for removing any such obstruction,
- (f) the provision, operation, maintenance and renewal of any plant, equipment or machinery used in carrying on any of the activities specified in paragraphs (a) to (e) above,
- (g) the exercise of day to day control over train movements over or along any track comprised in the network,
- (h) the preparation of a timetable for the purposes of such control as is referred to in paragraph (g) above,

and it is immaterial for the purposes of this subsection and that subsection whether or not the person who provides the service in question also provides or operates a network, or any of the track or other installations comprised in a network, or provides the service on behalf of a person who does so.

- (4) In determining whether any service is a station service, it is immaterial whether or not the person who provides the service also provides or operates a station, or any part of a station, or provides the service on behalf of a person who does so.
- (5) In this section, "maintenance" includes the detection and rectification of any faults.
- (6) "Railway" has its wider meaning in the application of this section in relation to any provision of this Part for the purposes of which "railway" has that meaning.

New companies, transfer schemes and disposals

## 84 Powers of the Board to form companies.

- (1) The Board shall have power to form, or take part in forming, companies—
  - (a) for the purposes of the Board's business;
  - (b) for the purpose of facilitating the disposal of—
    - (i) the whole or any part of the undertaking, or any property, rights or liabilities, of the Board or of any wholly owned subsidiary of the Board; or
    - (ii) without prejudice to the generality of sub-paragraph (i) above, any securities of any subsidiary of the Board;
  - (c) for the purpose of facilitating the performance by the Franchising Director of his functions under sections 23 to 36 above;
  - (d) for such other purposes as may be specified by the Secretary of State in a direction to the Board.
- (2) The Secretary of State may, after consultation with the Board, direct the Board to exercise any power conferred by paragraph (a), (b), (c) or (d) of subsection (1) above; and, if he so directs, he may also give the Board directions with respect to—
  - (a) the nature and objects of the company which is to be formed;
  - (b) the manner in which, and time within which, it is to be formed.
- (3) The Board shall not exercise any power conferred by subsection (1) above, except—
  - (a) in the case of the power conferred by paragraph (a), with the consent of, or pursuant to a direction given under subsection (2) above by, the Secretary of State; or
  - (b) in any other case, pursuant to such a direction.
- (4) Each of the powers conferred on the Board by this section—

- (a) is in addition to, and not in derogation from, any other powers of the Board;and
- (b) relates only to the capacity of the Board as a statutory corporation; and nothing in this section shall be construed as authorising the disregard by the Board of any enactment or rule of law.

#### 85 Powers of the Board to make transfer schemes.

- (1) The Board shall have power to make schemes for the transfer of the whole or any part of the undertaking, or any property, rights or liabilities, of—
  - (a) the Board.
  - (b) any wholly owned subsidiary of the Board,
  - (c) any publicly owned railway company,
  - (d) the Franchising Director, or
  - (e) any company which is wholly owned by the Franchising Director,

to any other person falling within paragraphs (a) to (e) above or to a franchise company.

- (2) In relation to the transfer or disposal (or the proposed transfer or disposal) of the whole or any part of an undertaking, any reference in this Part to property, rights or liabilities includes a reference to the undertaking or part (and, accordingly, to the property, rights and liabilities comprised in that undertaking or part).
- (3) The powers conferred on the Board by subsection (1) above shall only be exercisable—
  - (a) for the purposes of the Board's business, or to facilitate a disposal in the ordinary course of that business;
  - (b) for the purpose of effecting or facilitating the disposal of such property, rights or liabilities as the Secretary of State may direct; or
  - (c) for the purpose of facilitating the performance by the Franchising Director of his functions under sections 23 to 36 above,

and paragraph (a) above accordingly applies only in relation to transfers between the Board and any of its wholly owned subsidiaries or between two or more of its wholly owned subsidiaries.

- (4) The Secretary of State may, after consultation with the Board, direct the Board to exercise any power conferred by subsection (1) above; and, if he does so, he may also give the Board directions with respect to—
  - (a) the manner in which, and time within which, the power is to be exercised;
  - (b) the property, rights or liabilities to be transferred;
  - (c) the person to whom the transfer is to be made.
- (5) The Board shall not exercise the power conferred by subsection (1) above—
  - (a) for a purpose falling within paragraph (a) of subsection (3) above, except with the consent of, or pursuant to a direction given under subsection (4) above by, the Secretary of State; or
  - (b) for a purpose specified in paragraph (b) or (c) of subsection (3) above, except pursuant to such a direction.
- (6) Subject to the following provisions of this Part, on the day on which a scheme under subsection (1) above comes into force (in this Part referred to as the "transfer date")

the property, rights and liabilities affected by the scheme shall, subject to section 97 below, be transferred and vest by virtue of, and in accordance with, the scheme.

- (7) Each of the powers conferred on the Board by this section—
  - (a) is in addition to, and not in derogation from, the other powers so conferred and the other powers of the Board; and
  - (b) relates only to the capacity of the Board as a statutory corporation; and nothing in this section shall be construed as authorising the disregard by the Board of any enactment or rule of law.
- (8) In this Part, "franchise company" means any body corporate which is, or is to be, the franchise or the franchise operator under a franchise agreement.
- (9) Expressions used in subsection (8) above and in Part I above have the same meaning in that subsection as they have in that Part.

## 86 Powers of the Franchising Director to make transfer schemes.

- (1) The Franchising Director shall have power to make schemes for the transfer, at or after the end of the franchise period, of property, rights and liabilities which, immediately before the end of that period, are for the time being designated as franchise assets for the purposes of the franchise agreement in question to—
  - (a) the Franchising Director;
  - (b) a company which is wholly owned by the Franchising Director; or
  - (c) a franchise company.
- (2) In the following provisions of this section—
  - (a) the "transferor" means the person from whom any such property, rights or liabilities as are mentioned in subsection (1) above are transferred by a scheme under this section; and
  - (b) the "transferee" means the person to whom any such property, rights or liabilities are so transferred.
- (3) Subject to any contrary agreement or arrangements which may be made between the transferor and the transferee, where any property, rights or liabilities are transferred by a scheme under this section, there shall be paid by the transferee to the transferor or, as the case may require, by the transferor to the transferee, on the day on which the scheme comes into force such sums as may be specified in, or determined in accordance with, the franchise agreement mentioned in subsection (1) above.
- (4) Subject to the following provisions of this Part, on the day on which a scheme under this section comes into force, the property, rights and liabilities affected by the scheme shall, subject to section 97 below, be transferred and vest by virtue of and in accordance with the scheme.
- (5) Except as otherwise provided by this Act—
  - (a) any reference in this Act to a "transfer scheme" shall be taken as including a reference to a scheme under this section;

- (b) in the application of any provision of this Act in relation to a scheme under this section, any reference to the "transfer date" shall be taken as a reference to the date on which the scheme comes into force.
- (6) In this section "franchise agreement", "franchise period" and "designated as franchise assets" have the same meaning as they have in Part I above.
- (7) Any sums required by the Franchising Director for the purpose of making payments in respect of property, rights or liabilities transferred by a scheme under this section shall be paid by the Secretary of State out of money provided by Parliament.
- (8) Any sums received by the Franchising Director in respect of property, rights or liabilities so transferred shall be paid into the Consolidated Fund.

# 87 Transfer to the Secretary of State or the Franchising Director of the Board's function of making transfer schemes.

- (1) The Secretary of State may by order transfer any functions of the Board under section 85 above to himself or to the Franchising Director.
- (2) An order under this section may provide for the transfer of the function in question for all purposes or for such purposes as may be specified in the order.
- (3) Where any function is transferred to the Franchising Director under this section, the Secretary of State may, after consultation with the Franchising Director, direct the Franchising Director to exercise the function by making a scheme for the transfer of an undertaking or part of an undertaking, or any property, rights or liabilities, to a publicly owned railway company, a company wholly owned by the Franchising Director or a franchise company; and, if the Secretary of State gives such a direction, he may also—
  - (a) give the Franchising Director directions with respect to any matter specified in paragraph (a), (b) or (c) of section 85(4) above; or
  - (b) if the transfer is directed to be made to a publicly owned railway company which has not yet been formed, direct the Franchising Director to form, or take part in forming, a company for the purpose.
- (4) In relation to any function transferred to the Franchising Director under this section, subsection (3) above shall have effect in substitution for subsection (4) of section 85 above and any reference in this Act to a direction under the said subsection (4) shall be construed accordingly.
- (5) An order under this section may make such modifications of this Part as may be consequential upon, or incidental or supplemental to, the transfer effected by the order.

# 88 Transfers of interests in certain companies: provisions supplemental to sections 84 to 87.

(1) Where the Secretary of State gives the Board directions—

- (a) under section 84 above, with respect to the formation of a wholly owned subsidiary of the Board, and
- (b) under section 85 above, with respect to the making of a scheme for the transfer of anything to that wholly owned subsidiary,

the wholly owned subsidiary of the Board shall remain such until the transfer under the scheme has taken effect.

- (2) Where the Secretary of State gives the Board directions under section 85 above with respect to the making of a scheme for the transfer of anything to a company which is wholly owned by the Crown, that company shall remain wholly owned by the Crown until the transfer under the scheme has taken effect.
- (3) Where the Secretary of State gives the Franchising Director directions under or by virtue of section 87 above with respect to the making of a scheme for the transfer of anything to a publicly owned railway company, that company shall remain a publicly owned railway company until the transfer under the scheme has taken effect.
- (4) Where a wholly owned subsidiary of the Board is formed pursuant to a direction under section 84 above, none of the following persons, that is to say, the Board, any wholly owned subsidiary of the Board or any person acting on behalf of the Board or its wholly owned subsidiaries, shall dispose of any interests in that subsidiary except—
  - (a) with the consent of the Secretary of State and subject to compliance with such conditions (if any) as he may impose in connection with that consent; or
  - (b) pursuant to a direction of the Secretary of State under subsection (6) below or section 89 below.
- (5) None of the following persons, that is to say, the Franchising Director, any company which is wholly owned by the Franchising Director or any person acting on behalf of the Franchising Director or any such company, shall dispose of any interests in a company which is wholly owned by the Franchising Director except—
  - (a) with the consent of the Secretary of State and subject to compliance with such conditions (if any) as he may impose in connection with that consent; or
  - (b) pursuant to a direction of the Secretary of State under subsection (7) below.
- (6) The Secretary of State may at any time direct the Board to transfer, or arrange for there to be transferred, to him or such other person as may be specified in the direction any interests in a company so specified, being a wholly owned subsidiary of the Board formed pursuant to a direction under section 84 above, which are for the time being held by or on behalf of the Board.
- (7) The Secretary of State may at any time direct the Franchising Director to transfer, or arrange for there to be transferred, to the Secretary of State or such other person as may be specified in the direction any interests in any company so specified which are for the time being held by the Franchising Director, any company which is wholly owned by the Franchising Director or any person acting on behalf of the Franchising Director or any such company.
- (8) Where the Secretary of State gives a direction under subsection (6) or (7) above, it shall be the duty of the Board or, as the case may be, the Franchising Director to secure that the interests in question are transferred in accordance with the terms of the direction in such manner, and on or before such date, as may be specified for the purpose in the direction, and notwithstanding any duty imposed upon the Board by section 3(1) of the M30 Transport Act 1962.

# 89 Disposals by the Board and its subsidiaries.

- (1) If the Secretary of State, after consultation with the Board, so directs, the Board shall dispose or secure the disposal (whether by way of sale, lease or exchange and, if by way of sale or lease, whether for nominal or valuable consideration) of—
  - (a) the whole or any part of the undertaking, or any property, rights or liabilities, of the Board or of any wholly owned subsidiary of the Board; or
  - (b) without prejudice to paragraph (a) above, any securities of any subsidiary of the Board which are held by or on behalf of the Board or any other subsidiary of the Board.
- (2) The directions that may be given under this section by the Secretary of State include directions specifying—
  - (a) the manner in which, and time within which, the disposal is to be effected;
  - (b) that which is to be disposed of;
  - (c) the person to whom the disposal is to be made.
- (3) No disposal shall be made by the Board, or by any subsidiary of the Board, in pursuance of a direction under this section except with the consent of the Secretary of State and subject to compliance with such conditions (if any) as he may impose in connection with that consent.
- (4) The powers of disposal conferred on the Board by virtue of this section are in addition and without prejudice to those conferred by section 14(1)(e) of the M31 Transport Act 1962 (power to dispose of any part of the Board's undertaking, or any property, no longer required for the purposes of the Board's business) which shall accordingly also continue to be exercisable by the Board.
- (5) In section 27 of the M32Transport Act 1962, in subsection (4) (which provides that the Secretary of State may direct the Board and the British Waterways Board to discontinue any of their activities, dispose of any part of their undertaking, dispose of any assets held by them, call in any loan made by them or exercise any power they may possess to revoke any guarantees given by them) the words "dispose of any part of their undertaking, dispose of any assets held by them" shall cease to have effect in so far as relating to the Board.

# Directions to the Board about the exercise of rights conferred by holdings in companies.

(1) The Secretary of State may, after consultation with the Board, give directions to the Board with respect to the exercise of any rights conferred on the Board by the holding of interests in companies.

- (2) A direction under subsection (1) above may be general in character or may relate to the manner in which such rights as are mentioned in that subsection are to be exercised in a particular case.
- (3) In section 27 of the M33 Transport Act 1962, in subsection (1) (which provides that the Secretary of State may give general directions to the Board as to the exercise and performance of their functions in relation to matters appearing to him to affect the national interest, including the exercise of rights conferred by the holding of interests in companies) the words "(including the exercise of rights conferred by the holding of interests in companies)" shall cease to have effect so far as relating to the Board.
- (4) Subsection (5) of that section (which provides that the Secretary of State may, after consultation with the Board, direct the Board to exercise control over a subsidiary of the Board so as to require the subsidiary to discontinue any of their activities, dispose of any part of their undertaking, dispose of any assets held by them, call in any loan made by them or exercise any power they may possess to revoke any guarantees given by them) shall cease to have effect so far as relating to the Board.

Transfer schemes: supplemental provision

#### 91 Transfer schemes: general.

- (1) A transfer scheme may—
  - (a) define the property, rights and liabilities to be transferred to the transferee—
    - (i) by specifying or describing the property, rights and liabilities in question;
    - (ii) by referring to all (or all but so much as may be excepted) of the property, rights and liabilities comprised in a specified part of the transferor's undertaking; or
    - (iii) partly in the one way and partly in the other;
  - (b) provide that any rights or liabilities specified or described in the scheme shall be enforceable either by or against the transferor or transferee (or both of them);
  - (c) impose on the transferor or transferee an obligation to enter into such written agreements with, or execute such other instruments in favour of, the transferor or transferee or such other person as may be specified in the scheme;
  - (d) make such supplemental, incidental, consequential or transitional provision as the maker of the scheme considers appropriate.
- (2) An obligation imposed by a provision included in a transfer scheme by virtue of paragraph (c) of subsection (1) above shall be enforceable by civil proceedings by the transferor or transferee or other person mentioned in that paragraph for an injunction or for interdict or for any other appropriate relief or remedy.
- (3) A transaction of any description which is effected in pursuance of such a provision as is mentioned in subsection (2) above—

- (a) shall have effect subject to the provisions of any enactment which provides for transactions of that description to be registered in any statutory register; but
- (b) subject to that, shall be binding on all other persons, notwithstanding that it would, apart from this subsection, have required the consent or concurrence of any other person.
- (4) No right of reverter (or corresponding right in Scotland), right of pre-emption, right of forfeiture, right of re-entry, right of irritancy, option or similar right affecting land shall operate or become exercisable as a result of any transfer of land—
  - (a) by virtue of a transfer scheme;
  - (b) by or under an agreement or instrument made or executed pursuant to any provision of Schedule 8 to this Act or pursuant to any directions given, or requirement imposed, under that Schedule; or
  - (c) pursuant to an obligation imposed by a provision included in a transfer scheme by virtue of paragraph (c) of subsection (1) above;

and, without prejudice to paragraph 8 of Schedule 8 to this Act, any such right or option shall accordingly have effect in the case of any such transfer as if the transferee in relation to that transfer were the same person in law as the transferor and as if no transfer of the land had taken place.

- (5) Subsection (4) above shall have effect in relation to—
  - (a) the grant or creation of an estate or interest in, or right over, land, or
  - (b) the doing of any other thing in relation to land,

as it has effect in relation to a transfer of land; and any reference in that subsection or in the following provisions of this section to the transferor or the transferee shall be construed accordingly.

- (6) In any case where—
  - (a) any such right or option as is mentioned in subsection (4) above would, apart from that subsection, have operated in favour of, or become exercisable by, a person, but
  - (b) the circumstances are such that, in consequence of the operation of that subsection, the right or option cannot subsequently operate in favour of that person or, as the case may be, become exercisable by him,

such compensation as may be just shall be paid to him by the transferor or the transferee (or by both) in respect of the extinguishment of the right or option.

- (7) Any dispute as to whether any, and (if so) how much, compensation is payable under subsection (6) above, or as to the person to or by whom it shall be paid, shall be referred to and determined by—
  - (a) an arbitrator appointed by the President for the time being of the Royal Institution of Chartered Surveyors; or
  - (b) where the proceedings are to be held in Scotland, an arbiter appointed by the Lord President of the Court of Session; or
  - (c) where the proceedings are to be held in Northern Ireland, an arbitrator appointed by the  $[^{F802}$ Chairman of the Royal Institution of Chartered Surveyors in Northern Ireland].
- (8) If it appears to the transferor that a person is or may be entitled to compensation under subsection (6) above, he shall—
  - (a) notify that person that he is or may be so entitled, and

(b) invite him to make such representations as he wishes to the transferor not later than fourteen days after the date of issue of the document containing the notification required by paragraph (a) above,

or, if the transferor is not aware of the name and address of the person concerned, shall publish, in such manner as he considers appropriate, a notice containing information about the interest affected and inviting any person who thinks that he is or may be entitled to compensation to make such representations to the transferor within such period (being not less than 28 days from the date of publication of the notice) as may be specified in the notice.

# 92 Functions under local or private legislation etc.

- (1) A transfer scheme may provide that any functions of the transferor under a statutory provision—
  - (a) shall be transferred to the transferee;
  - (b) shall be concurrently exercisable by two or more transferees; or
  - (c) shall be concurrently exercisable by the transferor and one or more transferees.
- (2) Subsection (1) above applies in relation to any function under a statutory provision if and to the extent that the statutory provision—
  - (a) relates to any part of the transferor's undertaking, or to any property, which is to be transferred by the scheme; or
  - (b) authorises the carrying out of works designed to be used in connection with any such part of the transferor's undertaking or the acquisition of land for the purpose of carrying out any such works.
- (3) Subsection (1) above does not apply to any function of the Board or of any of the Board's subsidiaries under any provision of this Act or of—
  - (a) the M34 Transport Act 1962;
  - (b) the M35 Transport Act 1968:
  - (c) section 4 of the M36Railways Act 1974; or
  - (d) sections 119 to 124 of the M37 Transport Act 1985.
- (4) A transfer scheme may define any functions of the transferor to be transferred or made concurrently exercisable by the scheme in accordance with subsection (1) above—
  - (a) by specifying the statutory provisions in question;
  - (b) by referring to all the statutory provisions (except those specified in subsection (3) above) which—
    - (i) relate to any part of the transferor's undertaking, or to any property, which is to be transferred by the scheme, or
    - (ii) authorise the carrying out of works designed to be used in connection with any such part of the transferor's undertaking or the acquisition of land for the purpose of carrying out any such works; or

- (c) by referring to all the statutory provisions within paragraph (b) above, but specifying certain excepted provisions.
- (5) In this section "statutory provision" means a provision whether of a general or of a special nature contained in, or in any document made or issued under, any Act, whether of a general or a special nature.

## 93 Assignment of employees to particular parts of undertakings.

- (1) Schemes may be made—
  - (a) assigning such qualifying employees, or qualifying employees of such a class or description, as may be specified in the scheme to such part of their employer's undertaking as may be so specified;
  - (b) modifying the terms and conditions of employment of those employees; and
  - (c) providing for the payment of compensation to any of those employees by his employer in respect of any overall detriment incurred by the employee in consequence of any modifications made by the scheme to his terms and conditions of employment.
- (2) A scheme shall be made only for the purpose of facilitating, or otherwise in contemplation of, or in connection with,—
  - (a) the disposal of the undertaking, or part of the undertaking, of the Board or of a wholly owned subsidiary of the Board;
  - (b) the transfer, by virtue of a transfer scheme, of any property, rights or liabilities—
    - (i) from the Board or a wholly owned subsidiary of the Board to any such subsidiary or to a publicly owned railway company or a company wholly owned by the Franchising Director; or
    - (ii) from a company wholly owned by the Franchising Director to another such company;
  - (c) the provision of railway passenger services, or the operation of additional railway assets, under a franchise agreement, in circumstances where a previous franchise agreement relating to the provision of those services or the operation of those assets comes, or has come, to an end;
  - (d) the performance of any duty imposed on the Franchising Director by any provision of Part I above to secure—
    - (i) the provision of any railway passenger services;
    - (ii) the operation of any network or part of a network;
    - (iii) the operation of any station or light maintenance depot, or any part of a station or light maintenance depot; or
  - (e) the exercise of the power conferred on the Franchising Director by section 30 above to secure the operation of any additional railway assets.

- (3) The power to make a scheme shall be exercisable—
  - (a) by the Board, in respect of employees of the Board or of any wholly owned subsidiary of the Board; or
  - (b) by the Franchising Director, in respect of employees of any company which is wholly owned by the Franchising Director.
- (4) Where a scheme modifies the terms and conditions of employment of any person, the person's terms and conditions of employment after the modification takes effect must overall, and taking account of the amount or value of any compensation payable to him by virtue of subsection (1)(c) above in respect of any such detriment as is there mentioned, be no less favourable to him than his terms and conditions of employment before the modification takes effect.
- (5) The duty imposed on an employer by section 4 of [F803] the Employment Rights Act 1996] (requirement for written statement in respect of certain changes relating to an employee's employment) shall extend to all of the modifications made by a scheme to a qualifying employee's terms and conditions of employment, as if those modifications were changes required to be dealt with in a written statement under that section.
- (6) If any qualifying employee whose terms and conditions of employment are modified by a scheme is aggrieved—
  - (a) at the provisions made by the scheme with respect to the payment of compensation, so far as applicable in his case, or
  - (b) at the fact that the scheme does not make any such provision,

he may make a written complaint to the maker of the scheme not later than twelve weeks after the date of issue of the written statement required by section 4 of [F803] the Employment Rights Act 1996] in consequence of the modifications made by the scheme in the qualifying employee's terms and conditions of employment.

- (7) Any complaint under subsection (6) above shall be referred to, and determined by, such arbitrator as may be agreed by the qualifying employee and the person to whom the complaint was made or, at the request of either of them, by a panel of three arbitrators appointed by the Secretary of State and consisting of—
  - (a) a person who appears to the Secretary of State to be representative of employers in the railway industry;
  - (b) a person who appears to the Secretary of State to be representative of employees in the railway industry; and
  - (c) an independent chairman.
- (8) A scheme may make such incidental, consequential, supplemental or transitional provision as appears necessary or expedient to the person making the scheme.
- (9) A scheme may make different provision for different qualifying employees or for qualifying employees of different classes or descriptions.
- (10) A scheme shall not come into force unless it has been approved by the Secretary of State or until such date as the Secretary of State may, after consultation with the maker of the scheme, specify for the purpose in giving his approval.
- (11) In the application of this section in relation to Scotland, any reference to an arbitrator shall be taken as a reference to an arbiter.
- (12) In the application of this section to Northern Ireland, for any reference to section 4 of [F803]the Employment Rights Act 1996]there shall be substituted a reference to

section 4(4) to (6B) of the M38Contracts of Employment and Redundancy Payments Act (Northern Ireland) 1965.

#### (13) In this section—

"qualifying employee", in the case of any scheme, means a person who, immediately before the coming into force of that scheme—

- (a) is an employee of—
- (i) the Board;
- (ii) a wholly owned subsidiary of the Board; or
- (iii) a company which is wholly owned by the Franchising Director; and
- (b) is not assigned solely to duties in that part of his employer's undertaking to which he is, or is to be, assigned by that scheme;

"scheme" means a scheme under this section;

and expressions used in this section and in Part I above have the same meaning in this section as they have in that Part.

# 94 Accounting provisions.

- (1) This section applies where any property, rights or liabilities are transferred by virtue of a transfer scheme between—
  - (a) the Board and any company which, at the time of the transfer, is either—
    - (i) a wholly owned subsidiary of the Board; or
    - (ii) wholly owned by the Crown; or
  - (b) any two companies which, at the time of the transfer, fall within paragraph (a) above.
- (2) Where this section applies, the transfer scheme may state—
  - (a) the value at which any asset transferred to the transferee by virtue of the scheme is to be entered in the opening accounts of the transferee; or
  - (b) the amount at which any liability so transferred is to be entered in those accounts.
- (3) The value or amount (if any) stated by virtue of subsection (2) above shall be—
  - (a) in a case where the whole of the asset or liability in question is transferred by the transfer scheme, the value or amount at which the asset or liability appeared in the last full accounts of the transferor, or
  - (b) in a case where part only of the asset or liability is so transferred, such part of the value or amount at which the asset or liability appeared in the last full

accounts of the transferor as may be determined by or in accordance with the transfer scheme,

unless the maker of the transfer scheme considers that some other amount or value is appropriate in all the circumstances of the case, in which case the amount or value stated by virtue of subsection (2) above shall be that other amount or value.

- (4) Where this section applies, the transfer scheme may provide that the amount to be included in the opening accounts of the transferee in respect of any item shall be determined as if so much of anything done (or treated as done) by the transferor (whether by way of acquiring, revaluing or disposing of any asset or incurring, revaluing or discharging any liability, or by carrying any amount to any provision or reserve, or otherwise) as may be determined by or in accordance with the transfer scheme had been done by the transferee.
- (5) Without prejudice to the generality of the preceding provisions of this section, where this section applies, the transfer scheme may provide—
  - (a) that the amount to be included from time to time in any reserves of the transferee as representing its accumulated realised profits shall be determined as if such proportion of any profits realised and retained by the transferor as may be determined by or in accordance with the transfer scheme, had been realised and retained by the transferee;
  - (b) that the amount to be included from time to time in the opening accounts and any subsequent statutory accounts of the transferee as representing its accumulated realised losses shall be determined as if such proportion of any accumulated realised losses of the transferor as may be determined by or in accordance with the transfer scheme had been losses realised by the transferee.
- (6) In this section—

"accounting year" means—

- (a) in the case of the Board, the period of twelve months ending with 31st March in any year; and
- (b) in the case of any company, its financial year, within the meaning of [F804]the Companies Act 2006];

"the last full accounts", in connection with any transfer scheme, means—

- (a) where the Board is the transferor, the annual accounts prepared by the Board in accordance with section 24 of the M39 Transport Act 1962 for the accounting year last ended before the making of the transfer scheme; and
- (b) where any other person is the transferor, the statutory accounts of that person for the accounting year last ended before the making of the transfer scheme;

"the opening accounts of the transferee" means any statutory accounts prepared by the transferee for the accounting year next ending after the transfer date;

"statutory accounts" means any accounts prepared by a company for the purpose of any provision of [F805] the Companies Act 2006] (including group accounts).

# Power of the Secretary of State or the Franchising Director to require provision of information in connection with transfer schemes.

- (1) Where, in exercise of any functions conferred on him by section 86 above or transferred to him by an order under section 87 above, the Franchising Director or the Secretary of State (in this section referred to as "the relevant authority") proposes to make a transfer scheme, he may direct any person to whom this section applies—
  - (a) to furnish him with such information as the relevant authority considers necessary to enable him to make the scheme; and
  - (b) to do so within such time (being not less than 28 days from the giving of the direction) as may be specified in the direction;

and the persons to whom this section applies are [F806the Office of Rail and Road], the Board, any wholly owned subsidiary of the Board, any publicly owned railway company, any franchise company and any company which is wholly owned by the Franchising Director.

- (2) If a person fails to comply with a direction under subsection (1) above, the relevant authority may serve a notice under subsection (3) below on that person.
- (3) A notice under this subsection is a notice signed by the relevant authority and—
  - (a) requiring the person on whom it is served to produce, at a time and place specified in the notice, to the relevant authority or to any person appointed by the relevant authority for the purpose, any documents which are specified or described in the notice and are in that person's custody or under his control; or
  - (b) requiring that person to furnish, at a time and place and in the form and manner specified in the notice, to the relevant authority such information as may be specified or described in the notice.
- (4) No person shall be required under this section to produce any documents which he could not be compelled to produce in civil proceedings in the court or, in complying with any requirement for the furnishing of information, to give any information which he could not be compelled to give in evidence in any such proceedings.
- (5) A person who without reasonable excuse fails to do anything required of him by notice under subsection (3) above is guilty of an offence and shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale.
- (6) A person who intentionally alters, suppresses or destroys any document which he has been required by any notice under subsection (3) above to produce is guilty of an offence and shall be liable—
  - (a) on summary conviction, to a fine not exceeding the statutory maximum;
  - (b) on conviction on indictment, to a fine.
- (7) If a person makes default in complying with a notice under subsection (3) above, the court may, on the application of the relevant authority, make such order as the court thinks fit for requiring the default to be made good; and any such order may provide that all the costs or expenses of and incidental to the application shall be borne by

the person in default or by any officers of a company or other association who are responsible for its default.

- (8) Any reference in this section to the production of a document includes a reference to the production of a legible and intelligible copy of information recorded otherwise than in legible form; and the reference to suppressing a document includes a reference to destroying the means of reproducing information recorded otherwise than in legible form
- (9) In this section "the court" means the High Court, in relation to England and Wales, and the Court of Session, in relation to Scotland.

## 96 Functions of the Secretary of State in relation to transfer schemes.

- (1) A transfer scheme made by the Board or the Franchising Director, otherwise than under section 86 above, shall not come into force unless it has been approved by the Secretary of State or until such date as the Secretary of State may specify for the purpose in giving his approval.
- (2) The Secretary of State shall not make a transfer scheme except after consultation with the transferor.
- (3) Before approving a transfer scheme made by the Franchising Director or the Board, the Secretary of State, after consultation with the transferor and, in the case of a scheme made by the Franchising Director, with the Franchising Director, may modify the scheme.
- (4) It shall be the duty of the transferor to provide the Secretary of State with all such information and other assistance as he may require for the purposes of or in connection with the exercise, in relation to a transfer scheme, of any power conferred on him by this section.

# 97 Supplementary provisions as to transfers by transfer scheme.

The provisions of Schedule 8 to this Act shall apply to any transfer by virtue of a transfer scheme; and sections 85(6) and 86(4) above shall have effect subject to the provisions of that Schedule.

Ownership of successor companies

#### 98 Initial share holding in successor companies.

- (1) This section applies where any property, rights or liabilities are vested in accordance with a transfer scheme in a successor company which at the time of the vesting is either—
  - (a) a wholly owned subsidiary of the Board; or
  - (b) Government owned.

- (2) Where this section applies, the successor company shall, as a consequence of the vesting referred to in subsection (1) above, issue to the appropriate person such securities of that company as may from time to time be directed—
  - (a) by the Secretary of State, if the transfer scheme was made in pursuance of a direction given by him; or
  - (b) in any other case, by the Board with the consent of the Secretary of State.
- (3) The "appropriate person" for the purposes of subsection (2) above is—
  - (a) the Board, in a case where the direction under that subsection is given at a time when the successor company is a wholly owned subsidiary of the Board; or
  - (b) the Secretary of State, in a case where the direction under that subsection is given at a time when the successor company is Government owned.
- (4) No direction shall be given under subsection (2) above to the successor company at any time after that company—
  - (a) has ceased to be Government owned, or
  - (b) has ceased to be a wholly owned subsidiary of the Board,

unless, in a case where paragraph (b) above would otherwise apply, the cessation mentioned in that paragraph occurs in consequence of the successor company's becoming Government owned pursuant to a direction under section 88(6) above, in which case directions under subsection (2) above may continue to be given until the company ceases to be Government owned.

- (5) Securities required to be issued in pursuance of a direction under subsection (2) above shall be issued or allotted at such time or times, and on such terms, as may be specified in the direction.
- (6) Shares of the successor company which are issued in pursuance of a direction under subsection (2) above—
  - (a) shall be of such nominal value as the Secretary of State may direct; and
  - (b) shall be issued as fully paid and treated for the purposes of the M40Companies Act 1985 as if they had been paid up by virtue of the payment to that company of their nominal value in cash.
- (7) Any dividends or other sums received by the Treasury or the Secretary of State in right of, or on the disposal of, any securities acquired by virtue of this section shall be paid into the Consolidated Fund.
- (8) In this section, "Government owned", in relation to any successor company, means wholly owned by the Crown, but not wholly owned by the Franchising Director.

## 99 Government investment in securities of successor companies.

- (1) The Treasury or, with the approval of the Treasury, the Secretary of State may at any time acquire securities of a successor company which at that time is—
  - (a) a wholly owned subsidiary of the Board; or
  - (b) wholly owned by the Crown.

- (2) The Secretary of State shall not dispose of any securities acquired under this section without the approval of the Treasury.
- (3) Any expenses incurred by the Treasury or the Secretary of State in consequence of the provisions of this section shall be paid out of money provided by Parliament.
- (4) Any dividends or other sums received by the Treasury or the Secretary of State in right of, or on the disposal of, any securities acquired under this section shall be paid into the Consolidated Fund.

## 100 Exercise of functions through nominees.

- (1) The Treasury or, with the approval of the Treasury, the Secretary of State may, for the purposes of section 98 or 99 above or section 106 below, appoint any person to act as the nominee, or one of the nominees, of the Treasury or the Secretary of State; and—
  - (a) securities of a successor company may be issued under section 98 above or section 106 below to any nominee of the Treasury or the Secretary of State appointed for the purposes of that section, and
  - (b) any such nominee appointed for the purposes of section 99 above may acquire securities under that section,

in accordance with directions given from time to time by the Treasury or, with the consent of the Treasury, by the Secretary of State.

(2) Any person holding any securities as a nominee of the Treasury or the Secretary of State by virtue of subsection (1) above shall hold and deal with them (or any of them) on such terms and in such manner as the Treasury or, with the consent of the Treasury, the Secretary of State may direct.

# Target investment limit for Government shareholding in certain successor companies.

- (1) As soon as he considers expedient and, in any case, not later than six months after any operating company ceases to be a public sector railway company, the Secretary of State shall by order fix a target investment limit in relation to the shares for the time being held in that company by virtue of any provision of this Part by the Treasury and their nominees and by the Secretary of State and his nominees (in this section referred to as "the Government shareholding").
- (2) The target investment limit for the Government shareholding in an operating company shall be expressed as a proportion of the voting rights which are exercisable in all circumstances at general meetings of the company (in this section referred to as "the ordinary voting rights").
- (3) The first target investment limit fixed under this section for the Government shareholding in a particular company shall not exceed, by more than 0.5 per cent. of the ordinary voting rights, the proportion of those rights which is in fact carried by the Government shareholding in that company at the time when the order fixing the limit is made.
- (4) The Secretary of State may from time to time by order fix a new target investment limit for the Government shareholding in an operating company in place of the one previously in force under this section; but—
  - (a) any new limit must be lower than the one it replaces; and

- (b) an order under this section may only be revoked by an order fixing a new limit.
- (5) It shall be the duty of the Treasury and of the Secretary of State so to exercise—
  - (a) their powers under section 99 above and any power to dispose of any shares held by virtue of any provision of this Part, and
  - (b) their power to give directions to their respective nominees,
  - as to secure in relation to each operating company that the Government shareholding in that company does not carry a proportion of the ordinary voting rights exceeding any target investment limit for the time being in force under this section in relation to that company.
- (6) Notwithstanding subsection (5) above but subject to subsection (7) below, the Treasury or the Secretary of State may take up, or direct any nominee of the Treasury or of the Secretary of State to take up, any rights which are for the time being available to them or him, or to the nominee, either—
  - (a) as an existing holder of shares or other securities of an operating company; or
  - (b) by reason of the rescission of any contracts for the sale of such shares or securities.
- (7) If, as a result of anything done under subsection (6) above, the proportion of the ordinary voting rights carried by the Government shareholding in an operating company at any time exceeds the target investment limit for the time being in force under this section in relation to that company, it shall be the duty of the Treasury or, as the case may be, the Secretary of State to comply with subsection (5) above as soon after that time as is reasonably practicable.
- (8) For the purposes of this section the temporary suspension of any of the ordinary voting rights shall be disregarded.
- (9) The Secretary of State shall not exercise any power conferred on him by this section except with the consent of the Treasury.
- (10) In this section—
  - "operating company" means a successor company—
  - (a) which is a company limited by shares and formed and registered under the M41 Companies Act 1985 (or the former Companies Acts, as defined in section 735(1)(c) of that Act);
  - (b) which was a public sector railway company at the time when any property, rights or liabilities of another public sector railway company were vested in it by a transfer scheme;
  - (c) which has since ceased to be a public sector railway company; and
  - (d) which at the time of the vesting referred to in paragraph (b) above was not, and at no time since has been, a franchise company;
  - "public sector railway company" means—
  - (a) the Board;
  - (b) any wholly owned subsidiary of the Board; or
  - (c) any publicly owned railway company.

# Finances of successor companies

# 102 Temporary restrictions on borrowings etc.

- (1) If articles of association of a successor company confer on the Secretary of State powers exercisable with the consent of the Treasury for, or in connection with, restricting the sums of money which may be borrowed or raised by the group during any period, those powers shall be exercisable in the national interest notwithstanding any rule of law and the provisions of any enactment.
- (2) For the purposes of this section an alteration of the articles of association of a successor company shall be disregarded if the alteration—
  - (a) has the effect of conferring or extending any such power as is mentioned in subsection (1) above; and
  - (b) is made at a time when that company is neither a wholly owned subsidiary of the Board nor wholly owned by the Crown.
- (3) In this section "group", in relation to a company, means that company and all of its subsidiaries taken together.

# 103 Government lending to certain successor companies.

- (1) The Secretary of State may, with the approval of the Treasury, make loans of such amounts as he thinks fit to any successor company which is for the time being wholly owned by the Crown.
- (2) Any loans which the Secretary of State makes under this section shall be repaid to him at such times and by such methods, and interest on any such loans shall be paid to him at such rates and at such times, as he may, with the approval of the Treasury, from time to time direct.
- (3) The Treasury may issue out of the National Loans Fund to the Secretary of State such sums as are required by him for making loans under this section.
- (4) Any sums received under subsection (2) above by the Secretary of State shall be paid into the National Loans Fund.
- (5) It shall be the duty of the Secretary of State as respects each financial year—
  - (a) to prepare, in such form as the Treasury may direct, an account of sums issued to him in pursuance of subsection (3) above and of sums received by him under subsection (2) above and of the disposal by him of the sums so issued or received; and
  - (b) to send the account to the Comptroller and Auditor General not later than the end of the month of August in the following financial year;

and the Comptroller and Auditor General shall examine, certify and report on the account and shall lay copies of it and of his report before each House of Parliament.

# 104 Treasury guarantees for loans made to certain successor companies.

(1) The Treasury may guarantee, in such manner and on such terms as they may think fit, the repayment of the principal of, the payment of interest on, and the discharge of any other financial obligation in connection with, any sums which are borrowed from a

- person other than the Secretary of State by any successor company which is for the time being wholly owned by the Crown.
- (2) Immediately after a guarantee is given under this section, the Treasury shall lay a statement of the guarantee before each House of Parliament; and immediately after any sum is issued for fulfilling a guarantee so given, the Treasury shall so lay a statement relating to that sum.
- (3) Any sums required by the Treasury for fulfilling a guarantee under this section shall be charged on and issued out of the Consolidated Fund.
- (4) If any sums are issued in fulfilment of a guarantee given under this section, the company whose obligations are so fulfilled shall make to the Treasury, at such times and in such manner as the Treasury may from time to time direct—
  - (a) payments of such amounts as the Treasury may so direct in or towards repayment of the sums so issued; and
  - (b) payments of interest on what is outstanding for the time being in respect of sums so issued at such rate as the Treasury may so direct.
- (5) Any sums received under subsection (4) above by the Treasury shall be paid into the Consolidated Fund.

## 105 Grants to certain successor companies.

- (1) The Secretary of State may, with the approval of the Treasury, make to any successor company which is for the time being wholly owned by the Crown grants of such amounts, at such times and in such manner, as he may with the approval of the Treasury determine, towards the expenditure of that company.
- (2) Grants under this section may be made subject to such conditions as the Secretary of State with the approval of the Treasury may determine.
- (3) Any sums required by the Secretary of State for making grants under this section shall be paid out of money provided by Parliament.

#### 106 Extinguishment of certain liabilities of successor companies.

- (1) The Secretary of State may by order extinguish all or any of the liabilities of a successor company which is for the time being—
  - (a) a wholly owned subsidiary of the Board, or
  - (b) wholly owned by the Crown,
  - in respect of the principal of such relevant loans as may be specified in the order; and the assets of the National Loans Fund shall accordingly be reduced by amounts corresponding to any liabilities so extinguished.
- (2) Where the Secretary of State has made an order under subsection (1) above and he considers it appropriate to do so, he may from time to time give a direction under this subsection to the company whose liabilities are extinguished by the order, or to a company or companies wholly owning the company whose liabilities are so extinguished; and a company to which such a direction is given shall, as a consequence of the making of the order, issue such securities of the company as may be specified or described in the direction—
  - (a) to the Treasury or the Secretary of State; or

- (b) if it is the company whose liabilities are extinguished by the order, to a company or companies wholly owning that company.
- (3) For the purposes of any statutory accounts of a company to whom securities are issued by virtue of subsection (2)(b) above, the value at the time of its issue of any such security shall be taken—
  - (a) in the case of a share, to have been equal to its nominal value; and
  - (b) in the case of a debenture, to have been equal to the principal sum payable under the debenture,

and such nominal value or principal sum shall be taken in those accounts to be accumulated realised profits.

- (4) In subsection (3) above "statutory accounts of a company" means any accounts prepared by the company for the purpose of any provision of [F807] the Companies Act 2006] (including group accounts).
- (5) The Secretary of State—
  - (a) shall not give a direction under subsection (2) above for the issue of securities except at a time when the company whose liability is extinguished by the order or, as the case may be, the company which is directed to issue securities satisfies the condition in subsection (6) below; and
  - (b) shall not give a direction under paragraph (b) of subsection (2) above except at a time when the company, or each of the companies, to whom the securities are to be issued satisfies that condition.
- (6) The condition referred to in subsection (5) above is that the company is for the time being—
  - (a) a wholly owned subsidiary of the Board; or
  - (b) wholly owned by the Crown.
- (7) Unless the Secretary of State otherwise determines in any particular case, where a company is directed to issue debentures in pursuance of this section—
  - (a) the aggregate of the principal sums payable under the debentures to which the direction relates shall be equal to the aggregate of the sums the liability to repay which is extinguished by the order; and
  - (b) the terms as to the payment of the principal sums payable on the debentures to which the direction relates, and as to the payment of interest on those principal sums, shall be the same as the corresponding terms of the loans specified in the order.
- (8) For the purposes of subsection (7) above, any express or implied terms of a loan shall be disregarded in so far as they relate to the early discharge of liabilities to make repayments of principal and payments of interest.
- (9) Subsections (5) to (7) of section 98 above shall apply for the purposes of this section as they apply for the purposes of that section.
- (10) The Secretary of State shall not exercise any power conferred on him by this section except with the consent of the Treasury.
- (11) In this section "relevant loan", in relation to a successor company, means any loan made to the Board under section 20 of the M42 Transport Act 1962, if and to the extent that the liability to repay that loan is transferred to and vested in that company by virtue of a transfer scheme.

- (12) For the purposes of this section the company or companies wholly owning another company are—
  - (a) any company of which that other is a wholly owned subsidiary, or
  - (b) any two or more companies which between them hold all the issued securities of that other.

## Provisions with respect to flotation

# 107 Responsibility for composite listing particulars of certain licensed successor companies.

- (1) In any case where—
  - (a) the same document contains listing particulars for securities of two or more licensed successor companies, and
  - (b) any person's responsibility for any information included in the document is stated in the document to be confined to its inclusion as part of the listing particulars for securities of any one of those companies,

that person shall not be treated as responsible for that information in so far as it is stated in the document to form part of the listing particulars for securities of any other of those companies.

- (2) Sections 150 and 154 of the 1986 Act (advertisements etc in connection with listing applications) shall have effect in relation to any information issued for purposes connected with any securities of a licensed successor company as if any reference to a person's incurring civil liability included a reference to any other person being entitled, as against that person, to be granted a civil remedy or to rescind or repudiate any contract.
- (3) Subsections (1) and (2) above have effect only in relation to licensed successor companies—
  - (a) which are wholly owned subsidiaries of the Board; or
  - (b) which are wholly owned by the Crown.
- (4) In this section—

"the 1986 Act" means the M43Financial Services Act 1986;

"licensed successor company" means a successor company which is the holder of a licence under section 8 above;

"listing particulars" means any listing particulars or supplementary listing particulars within the meaning of the 1986 Act;

"responsible" means responsible for the purposes of Part IV of the 1986 Act and "responsibility" shall be construed accordingly.

# Application of Trustee Investments Act 1961 in relation to investment in certain licensed successor companies.

- (1) Subsection (2) below shall have effect for the purpose of applying paragraph 3(b) of Part IV of Schedule 1 to the M44 Trustee Investments Act 1961 (which provides that shares and debentures of a company shall not count as wider-range and narrower-range investments respectively within the meaning of that Act unless the company has paid dividends in each of the five years immediately preceding that in which the investment is made) in relation to investment, during the first investment year or any following year, in shares or debentures of a licensed successor company—
  - (a) whose shares or debentures are included in the Official List, within the meaning of Part IV of the M45Financial Services Act 1986, in pursuance of that Part; and
  - (b) which, immediately before its shares or debentures were admitted to that Official List, was—
    - (i) a wholly owned subsidiary of the Board; or
    - (ii) a company wholly owned by the Crown.
- (2) The licensed successor company shall be deemed to have paid a dividend as mentioned in the said paragraph 3(b)—
  - (a) in every year preceding the first investment year which is included in the relevant five years; and
  - (b) in the first investment year, if that year is included in the relevant five years and that company does not in fact pay such a dividend in that year.
- (3) In this section—

"the first investment year", in relation to a licensed successor company means the calendar year in which shares in that company are first issued in pursuance of section 98(2) above;

"licensed successor company" has the same meaning as it has in section 107 above;

"the relevant five years" means the five years immediately preceding the year in which the investment in question is made or proposed to be made.

#### 109 Grants to the Board.

After section 21 of the M46Transport Act 1962 (Treasury guarantees) there shall be inserted—

## "21A Grants to the Railways Board.

178

- (1) The Secretary of State may, with the approval of the Treasury, make to the Railways Board grants of such amounts, at such times and in such manner, as he may with the approval of the Treasury determine—
  - (a) towards the expenditure of that Board; or
  - (b) without prejudice to paragraph (a) of this subsection, for the purpose of enabling that Board to make any payment (whether by way of repayment of principal or payment of interest or of any other description) in respect of any loan made to them under section twenty of this Act.
- (2) Grants under this section may be made subject to such conditions as the Secretary of State may with the approval of the Treasury determine.
- (3) Any sums required by the Secretary of State for making grants under this section shall be paid out of money provided by Parliament.
- (4) This section is without prejudice to any other power to make grants to the Railways Board.".

# Application of sections 19 to 21A of the Transport Act 1962 to wholly owned subsidiaries of the Board.

- (1) If the Secretary of State by order so provides, sections 19 to 21A of the M47Transport Act 1962 (which, among other things, make provision for and in connection with—
  - (a) the borrowing powers of the Board,
  - (b) the making by the Secretary of State of loans to the Board,
  - (c) the giving by the Treasury of guarantees in respect of sums borrowed by the Board from persons other than the Secretary of State, and
  - (d) the making by the Secretary of State of grants to the Board),

shall apply in relation to any wholly owned subsidiary of the Board designated in the order as they apply in relation to the Board, but with such modifications as may be specified in the order.

(2) Without prejudice to the generality of the modifications of those sections that may be specified in an order under this section, any such order may include provision imposing limits on the amounts that may be outstanding at any time in respect of the principal of any money borrowed by wholly owned subsidiaries of the Board under section 19 of the M48 Transport Act 1962 in its application by virtue of this section.

#### 117 Safety of railways and other guided transport systems.

- (1) Part I of the M52Health and Safety at Work etc. Act 1974 ("the 1974 Act") shall have effect as if the provisions mentioned in subsection (4) below (which relate to the proper construction and safe operation of certain transport systems, and of the vehicles used on those systems, and the protection of railway employees or the general public from personal injury and other risks arising therefrom)

- (3) Without prejudice to the generality of subsection (1) of section 15 of the 1974 Act (health and safety regulations), regulations under that section may—

  - (b) in section 58 of that Act (which requires the consent of the Secretary of State or the Director of Public Prosecutions to a prosecution for an offence under Part II of that Act) after the words "offence under this Part" there shall be inserted the words ", other than an offence under section 41 or 43 above,".

  - (a) any railway, tramway or trolley vehicle system; or
  - (b) any transport system using any other mode of guided transport.

#### 118 Control of railways in time of hostilities, severe international tension or great national emergency.

- (1) In time of hostilities, whether actual or imminent, severe international tension or great national emergency, the Secretary of State may give directions under this subsection to such of the following persons as he may consider appropriate, that is to say—
  - (a) [F811 the Office of Rail and Road]:
  - F812(b) .....
    - any person who is the owner or operator of a relevant asset;
    - any person who provides railway services. (d)
- (2) The Secretary of State may at any time give directions under this subsection to any person falling within paragraphs (a) to (d) of subsection (1) above whom he may consider appropriate, requiring that person to participate in the planning of steps that might be taken in time of actual or imminent hostilities, severe international tension or great national emergency.

#### 119 Security: power of Secretary of State to give instructions.

- (1) The Secretary of State may from time to time give—
  - (a) to any person who is the owner or operator of a relevant asset, or
  - (b) to any person who provides railway services,
  - such instructions as the Secretary of State considers appropriate for the purpose of ensuring that relevant assets within Great Britain, or persons or property on or in any such relevant asset, are protected against acts of violence.

- (3) Without prejudice to the generality of subsection (1) above, an instruction may, in particular, require the person to whom it is given ("the recipient")
  - not to cause or permit any persons, or any designated persons, or more than a specified number of persons or designated persons, to enter any relevant asset or any designated relevant asset, or not to cause or permit them to do so unless they submit to a search or unless or until some other specified condition is complied with;
  - not to cause or permit any goods, or any designated goods, or more than a specified quantity of goods or designated goods, to be brought or loaded on to or into any relevant asset or any designated relevant asset, or not to do so unless the goods in question are subjected to a search or unless or until some other specified condition is complied with;

- (c) to run no trains, or to restrict the running of trains, or to run no train unless it is subjected to a search, or unless or until some other specified condition is complied with;
- (d) to secure the carrying out of a search of—
  - (i) any designated relevant assets, or
  - (ii) any persons or designated persons who, or any goods or designated goods which, are on or in any such assets;
- (e) to furnish to the Secretary of State such information as he may require for the purpose mentioned in subsection (1) above;
- (f) to prepare plans specifying action to be taken by the recipient and his servants or agents—
  - (i) in the event that an act of violence of a specified description occurs, or
  - (ii) in times when there is an increased likelihood of such acts occurring, and to conduct, at specified intervals, exercises in connection with the implementation of such plans;
- (g) to employ specified numbers of suitably trained staff for the purpose of preventing the occurrence of acts of violence;
- (h) to meet specified requirements with respect to the construction of, or to make specified modifications to—
  - (i) any relevant assets, or any designated relevant assets, of which the recipient is the owner or operator, or
  - (ii) any apparatus or equipment, or any designated apparatus or equipment, on or in any such assets.
- (4) Where an instruction requires the carrying out of a search, it may also specify—
  - (a) the kind of search which is to be carried out;
  - (b) the manner in which the search is to be carried out; and
  - (c) the persons, or the class or description of persons, who are to carry out the search.
- (5) Where any person refuses to submit himself or any goods in his possession to a search required by an instruction, any person authorised to carry out that search may take any steps that are necessary, including the use of reasonable force—
  - (a) to prevent the person concerned from entering the relevant asset in relation to which the search is being carried out; or
  - (b) to eject him, and any goods in his possession, from that asset;

but this subsection is without prejudice to any other powers of the person carrying out the search.

# 120 Security: enforcement notices.

- (1) Where it appears to the Secretary of State that a person upon whom an instruction has been served has failed, is failing or is likely to fail to comply with that instruction, he may serve on that person a notice (in this section referred to as an "enforcement notice") containing such provision as the Secretary of State may consider requisite for the purpose of ensuring that the person complies with the instruction and specifying, in particular—
  - (a) the things, or the description of things, which the person is required to do, or refrain from doing, in order to comply with the instruction;
  - (b) the time within which, or after which, the person must do, or refrain from doing, those things; and
  - (c) the period during which the person is to do, or refrain from doing, those things.
- (2) The Secretary of State may vary or revoke an enforcement notice, and any reference in this section to an enforcement notice includes a reference to such a notice as varied under this subsection.
- (3) Where the Secretary of State varies or revokes an enforcement notice under subsection (2) above he shall serve notice of the variation or revocation on the person on whom the enforcement notice in question was served.
- (4) A person who without reasonable excuse fails to do anything required of him by an enforcement notice is guilty of an offence and shall be liable—
  - (a) on summary conviction, to a fine not exceeding the statutory maximum; or
  - (b) on conviction on indictment, to a fine or to a term of imprisonment not exceeding two years, or to both.
- (5) No proceedings shall be instituted in England and Wales in respect of an offence under subsection (4) above except by or with the consent of the Secretary of State or the Director of Public Prosecutions.
- (6) Section 119(8) above shall have effect in relation to an enforcement notice as it has effect in relation to an instruction.

(7) Expressions used in this section and in section 119 above have the same meaning in this section as they have in that section.

# 121 Security: inspections.

- (1) For the purpose of enabling the Secretary of State to determine whether to give an instruction to any person, or of ascertaining whether any instruction or enforcement notice is being or has been complied with, a person authorised for the purpose by the Secretary of State in writing (in this section referred to as "an authorised person") shall have power, on production (if required) of his credentials, to inspect any relevant asset.
- (2) An authorised person inspecting a relevant asset under subsection (1) above shall have power—
  - (a) to subject any property found by him on or in the relevant asset, or any apparatus or equipment installed in the relevant asset, to such tests as he considers necessary for the purpose for which the inspection is carried out;
  - (b) to take such steps as he considers necessary for that purpose—
    - (i) to ascertain what practices or procedures are being followed in relation to security; or
    - (ii) to test the effectiveness of any practice or procedure relating to security; or
  - (c) to require the owner or operator of the relevant asset to furnish to him such information as the authorised person considers necessary for that purpose;

but nothing in paragraph (a) above shall entitle an authorised person to subject any rolling stock, or any part of any rolling stock, to any test.

- (3) An authorised person, for the purpose of exercising any power conferred on him by subsection (1) or (2) above in relation to any relevant asset, shall have power—
  - (a) to board any rolling stock and to take all such steps as are necessary to ensure that it is not moved; or
  - (b) to enter any land or other property comprised either in any track or in a network, station or light maintenance depot;

but nothing in this subsection authorises any use of force.

- (4) A person is guilty of an offence if he—
  - (a) intentionally obstructs an authorised person acting in the exercise of any power conferred on him by this section;
  - (b) fails, without reasonable excuse, to comply with a requirement imposed on him under paragraph (c) of subsection (2) above to furnish information to an authorised person; or
  - (c) in furnishing any information required under that paragraph, makes a statement which he knows to be false in a material particular, or recklessly makes a statement which is false in a material particular.
- (5) A person guilty of an offence under subsection (4) above shall be liable—
  - (a) on summary conviction, to a fine not exceeding the statutory maximum;
  - (b) on conviction on indictment, to a fine or to imprisonment for a term not exceeding two years, or to both.

- (6) No proceedings shall be instituted in England and Wales in respect of an offence under subsection (4) above except by or with the consent of the Secretary of State or the Director of Public Prosecutions.
- (7) Expressions used in this section and in section 119 or 120 above have the same meaning in this section as they have in that section.

# [F824121ARailway security services: approved providers

- (1) In this section "railway security service" means a process or activity carried out for the purpose of—
  - (a) complying with a requirement of an instruction under section 119, or
  - (b) facilitating a person's compliance with a requirement of an instruction under section 119.
- (2) Regulations may provide for the Secretary of State to maintain a list of persons who are approved by him for the provision of a particular railway security service.
- (3) The regulations may—
  - (a) prohibit the provision of a railway security service by a person who is not listed in respect of that service;
  - (b) prohibit the use or engagement for the provision of a railway security service of a person who is not listed in respect of that service;
  - (c) create a criminal offence;
  - (d) make provision about application for inclusion in the list (including provision about fees);
  - (e) make provision about the duration and renewal of entries on the list (including provision about fees);
  - (f) make provision about training or qualifications which persons who apply to be listed or who are listed are required to undergo or possess;
  - (g) make provision about removal from the list which shall include provision for appeal;
  - (h) make provision about the inspection of activities carried out by listed persons;
  - (i) confer functions on the Secretary of State or on a specified person;
  - (i) confer jurisdiction on a court.
- (4) Regulations under subsection (3)(c)—
  - (a) may not provide for a penalty on summary conviction greater than a fine not exceeding the statutory maximum,
  - (b) may not provide for a penalty of imprisonment on conviction on indictment greater than imprisonment for a term not exceeding two years (whether or not accompanied by a fine), and
  - (c) may create a criminal offence of purporting, with intent to deceive, to do something as a listed person or of doing something, with intent to deceive, which purports to be done by a listed person.
- (5) An instruction under section 119 may—
  - (a) include a requirement to use a listed person for the provision of a railway security service;
  - (b) provide for all or part of the instruction not to apply or to apply with modified effect where a listed person provides a railway security service.

- (6) Regulations under this section—
  - (a) may make different provision for different cases,
  - (b) may include incidental, supplemental or transitional provision,
  - (c) shall be made by the Secretary of State by statutory instrument,
  - (d) shall not be made unless the Secretary of State has consulted organisations appearing to him to represent persons affected by the regulations, and
  - (e) shall be subject to annulment in pursuance of resolution of either House of Parliament.]

# Statutory authority

# 122 Statutory authority as a defence to actions in nuisance etc.

- (1) Subject to the following provisions of this section—
  - (a) any person shall have authority—
    - (i) to use, or to cause or permit any agent or independent contractor of his to use, rolling stock on any track, or
    - (ii) to use, or to cause or permit any agent or independent contractor of his to use, any land comprised in a network, station or light maintenance depot for or in connection with the provision of network services, station services or light maintenance services, and
  - (b) any person who is the owner or occupier of any land shall have authority to authorise, consent to or acquiesce in—
    - (i) the use by another of rolling stock on any track comprised in that land, or
    - (ii) the use by another of that land for or in connection with the provision of network services, station services or light maintenance services,

if and so long as the qualifying conditions are satisfied in the particular case.

- (2) For the purposes of this section, the "qualifying conditions" are—
  - (a) in relation to any use of rolling stock on track—
    - (i) that the track is comprised in a network, station or light maintenance depot, and
    - (ii) that the operator of that network, station or light maintenance depot is the holder of an appropriate licence or has the benefit of an appropriate licence exemption; and
  - (b) in relation to any use of land for or in connection with the provision of network services, station services or light maintenance services, that the operator of the network, station or light maintenance depot in question is the holder of an appropriate licence or has the benefit of an appropriate licence exemption.
- (3) The authority conferred by this section is conferred only for the purpose of providing a defence of statutory authority—

- (a) in England and Wales—
  - (i) in any proceedings, whether civil or criminal, in nuisance; or
  - (ii) in any civil proceedings, other than proceedings for breach of statutory duty, in respect of the escape of things from land;
- (b) in Scotland, in any civil proceedings on the ground of nuisance where the rule of strict liability applies, other than proceedings for breach of statutory duty.
- (4) Nothing in this section shall be construed as excluding a defence of statutory authority otherwise available under or by virtue of any enactment.
- (5) The owner or occupier of any land shall be regarded for the purposes of this section as "acquiescing" in—
  - (a) any use by another of rolling stock on track comprised in that land, or
  - (b) any use of that land by another for or in connection with the provision of network services, station services or light maintenance services,

notwithstanding that it is not within his power to put an end to that use by that other.

- (6) For the purposes of this section—
  - (a) any reference to the use of rolling stock on track includes a reference to the carriage of any passengers or other persons, or any goods, of any class or description for any purpose on or by means of that rolling stock on that track; and
  - (b) rolling stock shall be regarded as "used" on any track at any time when it is present on that track, irrespective of whether the rolling stock is comprised in a train or not, whether the rolling stock is moving or stationary and, if moving, irrespective of the means by which the motion is caused.
- (7) In this section—

"appropriate licence", in relation to the operator of a network, station or light maintenance depot, means a licence which authorises him to be the operator of that network, station or light maintenance depot;

"appropriate licence exemption", in relation to the operator of a network, station or light maintenance depot, means any such licence exemption as exempts him from the requirement to hold the licence that would otherwise be the appropriate licence in his case;

and expressions used in this section and in Part I above have the same meaning in this section as they have in that Part.



# 130 Penalty fares.

- (1) [F830 The Secretary of State F831, the Welsh Ministers] and the Scottish Ministers shall each have power by regulations to make provision for and in connection with—
  - (a) the imposition of requirements on persons travelling by, present on, or leaving trains or stations to produce, if required to do so in accordance with the regulations, a ticket or other authority authorising them to travel by, be present on, or leave the train or station in question; and
  - (b) the charging of persons in breach of such requirements to financial penalties (in this section referred to as "penalty fares") in such circumstances, and subject to compliance with such conditions (if any), as may be prescribed;

and in this section any reference to a ticket or other authority of any description includes a reference to any other document which, under the regulations, is required to be produced in conjunction with any such ticket or other authority, for the purpose of demonstrating that the ticket or other authority produced by a person is valid in his case.

- [F832] (1ZA) The power of the Welsh Ministers under this section to make provision for and in connection with the imposition of requirements on persons present on or leaving stations is exercisable only in relation to persons present on or leaving relevant Welsh stations in connection with the use of railway passenger services provided under Welsh franchise agreements or secured to any extent by the Welsh Ministers.
  - (1ZB) In subsection (1ZA) "relevant Welsh stations" are stations wholly in Wales that are used for the purposes of railway passenger services provided under Welsh franchise agreements or secured to any extent by the Welsh Ministers.
  - (1ZC) The power of the Welsh Ministers under this section to make provision for and in connection with the imposition of requirements on persons travelling by, present on or leaving trains is exercisable only in relation to persons—

      - (ii) any other railway passenger service provided under a Welsh franchise agreement or secured to any extent by the Welsh Ministers, except where subsection (1ZD) applies; or
    - (b) leaving such trains at stations wholly in Wales.
  - (1ZD) This subsection applies where—
    - (a) the next scheduled call to be made by the service is at a station wholly or partly in England and the previous scheduled call was at a station wholly in Wales (but not where the train is at a scheduled call wholly in Wales); or
    - (b) the next scheduled call to be made by the service is at a station wholly in Wales and the previous scheduled call was at a station wholly or partly in England.
  - (1ZE) The power of the Secretary of State under this section to make provision for and in connection with the imposition of requirements on persons present on or leaving stations is not exercisable in relation to persons falling within subsection (1ZA).

- (1ZF) The power of the Secretary of State under this section to make provision for and in connection with the imposition of requirements on persons travelling by, present on or leaving trains is not exercisable in relation to persons falling within subsection (1ZC).
- [F833(1A) The power of the Scottish Ministers under this section shall be exercisable only in relation to trains and stations used for the purposes of—
  - (a) railway passenger services provided under Scottish franchise agreements; or
  - (b) a railway passenger service not falling within paragraph (a) which is a Scotland-only service or (without being such a service) is a service the provision of which is secured by the Scottish Ministers.]
  - (2) Regulations may make provision for or with respect to—
    - (a) the persons who may be charged penalty fares;
    - (b) the persons by or on behalf of whom penalty fares may be charged;
    - (c) the trains and stations by reference to which penalty fares may be charged;
    - (d) the amount, or the greatest amount, which a person may be charged by way of penalty fare, whether a specified amount or one determined in a prescribed manner;
    - (e) the authorising of persons to be collectors;
    - (f) the manner in which charges to penalty fares may be imposed by collectors, including any requirements to be complied with by or in relation to collectors;
    - (g) the authorising of collectors in prescribed circumstances to require persons on trains or stations to furnish prescribed information;
    - (h) the display of prescribed notices in places of a prescribed description;
    - (j) the manner in which, and the period within which, any penalty fare charged to a person is to be paid;
    - (k) the issue of prescribed documents to persons who are charged, or who have paid, penalty fares;
    - (l) the recovery of any unpaid penalty fare as a civil debt, including provision—
      - (i) for or with respect to defences that are to be available in proceedings for the recovery of an unpaid penalty fare; or
      - (ii) for presumptions of fact to operate, in such proceedings, in favour of the person charged with the penalty fare, but subject to compliance with prescribed procedural requirements;
    - (m) the retention, by persons by or on behalf of whom charges to penalty fares are imposed, of sums paid by way of penalty fare;
    - (n) the remission of liability to pay penalty fares and the repayment of sums paid by way of penalty fare;
    - (o) the prevention of a person's being liable both to payment of a penalty fare and to prosecution for a prescribed offence;
    - [F834(p) the imposition by the Secretary of State[F835, the Welsh Ministers] or the Scottish Ministers of prohibitions on the charging of penalty fares by prescribed persons and in prescribed circumstances.]
  - (3) The documents mentioned in subsection (2)(k) above include any document which consists of or includes—
    - (a) notice of the imposition of a charge to a penalty fare;
    - (b) a receipt for the payment of a penalty fare; or
    - (c) a ticket or other authority to travel by, be present on, or leave a train or station.

- (4) Regulations may impose, or make provision for and in connection with the imposition or enforcement of, prescribed requirements in prescribed circumstances on or against a holder of a passenger licence or station licence or a passenger service operator (whether or not one by or on behalf of whom penalty fares are or are to be charged); and, without prejudice to the generality of the foregoing, any such regulations may make provision with respect to—
  - (a) the display of notices relating to penalty fares;
  - (b) the provision of facilities for the issue of tickets or other authorities to travel by, be present on, or leave trains or stations;
  - (c) the provision of information to prescribed persons or persons of a prescribed class or description.

### Financial provisions

## 136 Grants and subsidies.

(1) The Secretary of State [F860] and the Scottish Ministers shall each] be the competent authority of Great Britain in relation to the railways financial status regulations.

- (2) The Secretary of State[F861, the Scottish Ministers and, to the extent specified in subsection (2A) below, the National Assembly for Wales shall each be] the competent authority of Great Britain, in relation to persons who operate services for the carriage of goods by railway, for the purposes of the public service obligations regulations.
- [F862(2A) For the purposes of subsection (2) above the National Assembly for Wales shall only be the competent authority in relation to services for the carriage of goods by railway which are operated within Wales.]
- [F863(2B) Subsections (2) and (2A) cease to have effect on 3rd December 2012.]

        - (ii) every London borough council and the Common Council of the City of London,

shall each be the competent authority of Great Britain in relation to passenger service operators for the purposes of the public service obligations regulations.

- [F868(3A) For the purposes of subsection (3) above [F869the Welsh Ministers] shall only be the competent authority in relation to services for the carriage of passengers by railway which—
  - (a) are Welsh services (within the meaning of the Railways Act 2005); or
  - (b) are provided under a franchise agreement to which [F870] the Welsh Ministers are a party.]
  - (4) For the purposes of subsection (3) above, a Passenger Transport Executive shall only be the competent authority in relation to those railway passenger services [F871] which the Executive provide, or secure are provided, in exercise of their powers under section 10(1) of the Transport Act 1968 or section 13 of the Railways Act 2005].
  - (5) For the purposes of subsection (3) above—
    - (a) a council falling within paragraph (d)(i) of that subsection shall only be the competent authority in relation to those railway passenger services whose provision the council secures under section 63 of the M73Transport Act 1985 (passenger transport in areas other than [F872integrated transport areas and] passenger transport areas); and
    - (b) a council falling within paragraph (d)(ii) of that subsection shall only be the competent authority in relation to those railway passenger services in respect of which the council enters into and carries out agreements under [F873 section 177 of the Greater London Authority Act 1999] (provision of extra transport services in London).

- (6) The Secretary of State <sup>F874</sup>... [F875 may] F874..., as competent authority by virtue of subsection (3) above, give directions to any passenger service operator imposing on him obligations with respect to the provision or operation of railway passenger services.
- (7) It shall fall to the Secretary of State <sup>F876</sup>... to make any payments of compensation which are required to be made to a passenger service operator by any provision of the public service obligations regulations in respect of any obligations imposed on that operator by directions under subsection (6) above, and the Secretary of State <sup>F876</sup>... may, subject to and in accordance with the provisions of those regulations, determine the manner of calculating, and the conditions applicable to, those payments.
- (8) The power of giving directions under subsection (6) above shall be so exercised that the aggregate amount of any compensation payable under the public service obligations regulations, for periods ending after 1st April 1992, in respect of all obligations imposed by directions under that subsection shall not exceed £3,000 million or such greater sum not exceeding £5,000 million as the Secretary of State may by order specify.
- (9) A statutory instrument containing an order under subsection (8) above shall not be made unless a draft of the instrument has been laid before and approved by a resolution of the House of Commons.
- (10) Without prejudice to any right which the Secretary of State <sup>F876</sup>. . . may have under this Act to bring civil proceedings in respect of any contravention or apprehended contravention of any directions under subsection (6) above, the obligations imposed by any such directions shall not give rise to any form of duty or liability enforceable against a passenger service operator by proceedings before any court to which the passenger service operator would not otherwise be subject.

#### 138 Grants and other payments towards facilities for public passenger transport to and from airports, harbours etc.

(1) Section 56 of the M75 Transport Act 1968 (Ministerial grants and local authority payments towards capital expenditure incurred in the provision, improvement or

# 144 Directions.

- (1) It shall be the duty of any person to whom a direction is given under this Act to comply with and give effect to that direction; F888 . . . F889 . . . .

## 145 General restrictions on disclosure of information.


- (1) Subject to the following provisions of this section, no information with respect to any particular business which—
  - (a) has been obtained under or by virtue of any of the provisions of this Act; and
  - (b) relates to the affairs of any individual or to any particular business,

shall, during the lifetime of that individual or so long as that business continues to be carried on, be disclosed without the consent of that individual or the person for the time being carrying on that business.

- (2) Subsection (1) above does not apply to any disclosure of information which is made—

# 146 Making of false statements etc.

- (1) If any person, in giving any information or making any application under or for the purposes of any provision of this Act, or of any regulations made under this Act, makes any statement which he knows to be false in a material particular, or recklessly makes any statement which is false in a material particular, he is guilty of an offence and shall be liable—
  - (a) on summary conviction, to a fine not exceeding the statutory maximum;
  - (b) on conviction on indictment, to a fine.
- (2) No proceedings shall be instituted in England and Wales in respect of an offence under this section except by or with the consent of the Secretary of State or the Director of Public Prosecutions.

# 147 Offences by bodies corporate or Scottish partnerships.

- (1) Where a body corporate is guilty of an offence under this Act and that offence is proved to have been committed with the consent or connivance of, or to be attributable to any neglect on the part of, any director, manager, secretary or other similar officer of the body corporate or any person who was purporting to act in any such capacity he, as well as the body corporate, shall be guilty of that offence and shall be liable to be proceeded against and punished accordingly.
- (2) Where the affairs of a body corporate are managed by its members, subsection (1) above shall apply in relation to the acts and defaults of a member in connection with his functions of management as if he were a director of the body corporate.
- (3) Where a Scottish partnership is guilty of an offence under this Act in Scotland and that offence is proved to have been committed with the consent or connivance of, or

to be attributable to any neglect on the part of, a partner, he as well as the partnership shall be guilty of that offence and shall be liable to be proceeded against and punished accordingly.

# 148 Proceedings in Scotland.

- (1) Subject to subsection (2) below, summary proceedings for an offence under this Act which is triable either on indictment or summarily may be commenced within a period of six months from the date on which evidence sufficient in the opinion of the procurator fiscal to warrant proceedings came to his knowledge.
- (2) No such proceedings shall be commenced by virtue of this section more than three years after the commission of the offence.
- (3) For the purposes of this section, a certificate signed by or on behalf of the procurator fiscal and stating the date on which evidence sufficient in his opinion to warrant proceedings came to his knowledge shall be conclusive evidence of that fact.
- (4) A certificate stating that matter and purporting to be so signed shall be deemed to be so signed unless the contrary is proved.
- (5) Subsection (3) of [F932] section 136 of the Criminal Procedure (Scotland) Act 1995] (which relates to the date of commencement of proceedings) shall apply for the purposes of this section as it applies for the purposes of that section.
- (6) This section extends to Scotland only.

### 149 Service of documents.

- (1) Any document required or authorised by virtue of this Act to be served (whether the expression "serve" or the expression "give" or "send" or any other expression is used) on any person may be served—
  - (a) by delivering it to him or by leaving it at his proper address or by sending it by post to him at that address; or
  - (b) if the person is a body corporate, by serving it in accordance with paragraph (a) above on the secretary of that body; or
  - (c) if the person is a partnership, by serving it in accordance with paragraph (a) above on a partner or a person having the control or management of the partnership business.
- (2) For the purposes of this section and section 7 of the M92Interpretation Act 1978 (which relates to the service of documents by post) in its application to this section, the proper address of any person on whom a document is to be served shall be his last known address, except that—

- (a) in the case of service on a body corporate or its secretary, it shall be the address of the registered or principal office of the body;
- (b) in the case of service on a partnership or a partner or a person having the control or management of a partnership business, it shall be the address of the principal office of the partnership;

and for the purposes of this subsection the principal office of a company constituted under the law of a country or territory outside the United Kingdom or of a partnership carrying on business outside the United Kingdom is its principal office within the United Kingdom.

- (3) If a person to be served by virtue of this Act with any document by another has specified to that other an address within the United Kingdom other than his proper address (as determined in pursuance of subsection (2) above) as the one at which he or someone on his behalf will accept documents of the same description as that document, then, in relation to that document, that address shall be treated as his proper address for the purposes of this section and for the purposes of the said section 7 in its application to this section, instead of that determined in accordance with subsection (2) above.
- (4) This section shall not apply to any document in relation to the service of which provision is made by rules of court.
- (5) In this section—

"local authority" includes [F933] a metropolitan county passenger transport authority [F933] an Integrated Transport Authority for an integrated transport area in England [F934] F935] and a combined authority established under section 103 of the Local Democracy, Economic Development and Construction Act 2009 [F934], a combined authority established under section 103 of the Local Democracy, Economic Development and Construction Act 2009 and a combined county authority established under section 9(1) of the Levelling-up and Regeneration Act 2023];

# [F936149AService of documents under sections 118 to 120: additional provisions

- (1) Any document required or authorised by virtue of sections 118 to 120 or this section of this Act to be given or served by the Secretary of State to or on any person may also be given or served, where—
  - (a) an address for service using electronic communications has been given by that person and not withdrawn in accordance with subsection (6), and
  - (b) that person has agreed to accept service by electronic communications of documents in a certain form and has not withdrawn that agreement in accordance with that subsection,

by using electronic communications to send the document in that form to that person at that address.

- (2) A document given to or served on a person in accordance with subsection (1) must be in a form sufficiently permanent to be used for subsequent reference.
- (3) Where a document is given to or served on a person in accordance with subsection (1), the document is, unless the contrary is proved, to be deemed to have been given to or served on that person at the time at which the electronic communication is transmitted except where transmission is made outside that person's normal business hours, in which case it is to be taken to have been given or served on the next working day, and in this subsection, "working day" means any day other than—
  - (a) a Saturday or a Sunday;
  - (b) Christmas Day or Good Friday; or
  - (c) a day which is a bank holiday under the Banking and Financial Dealings Act 1971 (c. 80) in any part of the United Kingdom.
- (4) A document required or authorised by virtue of sections 118 to 120 of this Act to be given or served by the Secretary of State is also to be treated as given or served where—
  - (a) that person and the Secretary of State have agreed to his having access to documents of a particular description and in a certain form on a web site (instead of their being given to or served on him in any other way specified in this section or section 149);
  - (b) that person has not withdrawn his agreement in accordance with subsection (7);
  - (c) the document in question is a document to which the agreement applies;
  - (d) the Secretary of State has given that person a notice, in a manner agreed between them for the purpose—
    - (i) stating that the document has been published on a web site maintained by or on behalf of the Secretary of State;
    - (ii) setting out the address of that web site; and
    - (iii) setting out the place on that web site where the document may be accessed and how it may be accessed by that person; and
  - (e) the published document is in a form sufficiently permanent to be used for subsequent reference.
- (5) Where a document is given to or served on a person in accordance with subsection (4), the document is, unless the contrary is proved, to be deemed to have been given to or served on that person at the same time as the notice required to be given under subsection (4)(d) is given.

- (6) A person who has supplied the Secretary of State with an address for service using electronic communications and has agreed to accept service of documents in a certain form in accordance with subsection (1) may give notice to the Secretary of State withdrawing that address or that agreement or both.
- (7) A person who has an agreement with the Secretary of State under subsection (4)(a) may give notice to the Secretary of State withdrawing that agreement.
- (8) A withdrawal under subsection (6) or (7) shall take effect on the later of—
  - (a) the date specified by the person in the notice; and
  - (b) the date which is fourteen days after the date on which the notice is given.
- (9) Oral notice is not sufficient for the purposes of subsection (6) or (7).
- (10) This section shall not apply to any document in relation to the service of which provision is made by the rules of the court.
- (11) In this section—

"address", in relation to electronic communications, means any number or address used for the purposes of such communications;

"electronic communication" has the same meaning as in the Electronic Communications Act 2000 (c. 7).]

### ACCESS AGREEMENTS: APPLICATIONS FOR ACCESS CONTRACTS

### *Interpretation*

1 In this Schedule—

"application for directions" means an application for directions under section 17 of this Act;

"the facility owner" means the facility owner mentioned in section 17(1) of this Act;

"interested person" means any person whose consent is required by the facility owner, as a result of an obligation or duty owed by the facility owner which arose after the coming into force of section 17 of this Act, before the facility owner may enter into the required access contract;

"the required access contract" means the access contract which the applicant seeks to obtain by virtue of the application for directions;

and, subject to that, expressions used in this Schedule and in section 17 of this Act have the same meaning in this Schedule as they have in that section.

# Effect of directions on facility owner and interested persons

6 (1) Any directions given on an application for directions or under this Schedule shall be binding on the person to whom they are given, notwithstanding any obligation or duty he may owe to an interested person and whether or not the interested person has had an opportunity to make representations.

- (2) No interested person, and no successor to an interested person, shall take any step for the purpose of enforcing or exercising any right he may have against the facility owner in respect of, or in consequence of, the facility owner's—
  - (a) entering into an access contract pursuant to directions under section 17 of this Act.
  - (b) performing such a contract in accordance with its terms, or
  - (c) failing to take any step to protect the interests of the interested person in connection with the application for directions, or the making of the access contract,

whether or not the interested person had, or has had, an opportunity to make representations.

- (3) The duty of the facility owner to furnish [F1025] the Office of Rail and Road] with the name and address of every interested person pursuant to a direction under paragraph 4 above is a duty owed to each interested person and (subject to the defences and incidents applying in actions for breach of statutory duty) any contravention of that duty shall be actionable at the suit or instance of the interested person and the facility owner shall be liable for any loss or damage suffered by the interested person as a result of any access contract which is entered into in consequence of the application for directions.
- (4) It shall be a defence in any proceedings brought by virtue of sub-paragraph (3) above for the facility owner to show that he took all reasonable steps, and exercised all due diligence, to avoid contravening the duty in question.

# Scope of review

- 1A (1) Where [F1032the Office of Rail and Road] undertakes such a review, it must, at the same time, review the conditions of every linked licence both—
  - (a) in relation to the matters mentioned in paragraph 1(a) and (b); and
  - (b) in relation to the matters about which that Office is provided with information under paragraph 1D.
  - (2) A review by that Office of both—
    - (a) the terms of an access agreement as to the matters mentioned in paragraph 1(a) and (b), and
    - (b) the conditions of a linked licence.

is referred to in this Schedule as an access charges review.

- (3) An access charges review must include a consideration of—
  - (a) the time at which the next access charges review is to be undertaken in relation to both the access agreement in question and every linked licence; and
  - (b) the circumstances in which it would be appropriate to undertake such a review before that time.

- (4) In this Schedule "linked licence", in relation to an access agreement, means a licence of which the holder is—
  - (a) the facility owner, or installation owner, who is a party to the agreement; or
  - (b) a person other than that owner who has an estate or interest in the railway facility or network installation to which the agreement relates or who has a right over it.

# Response to request to carry out review

### 1B Where—

- (a) the Secretary of State or the Scottish Ministers suggest to [F1032 the Office of Rail and Road] that an access charges review should be carried out in any case, but
- (b) that Office decides not to carry out the suggested review,

that Office must provide the Secretary of State or Scottish Ministers with its reasons for that decision.

# Notice of access charges review

- 1C (1) Before beginning an access charges review, [F1032 the Office of Rail and Road] must give notice of its proposal to undertake the review to each of the following—
  - (a) the Secretary of State;
  - (b) the Scottish Ministers;
  - (c) the Treasury;
  - (d) the parties to the access agreement in question; and
  - (e) such other persons as that Office considers appropriate.
  - (2) No notice is required to be given under sub-paragraph (1) to the Secretary of State or the Scottish Ministers—
    - (a) in the case of the Secretary of State, if the facility or installation to which the relevant agreement relates is situated wholly in Scotland; or
    - (b) in the case of the Scottish Ministers, if the facility or installation to which the relevant agreement relates is situated wholly in England and Wales.
  - (3) A notice under this paragraph must set out—
    - (a) the period to which [F1032the Office of Rail and Road] expects the review to relate ("the review period");
    - (b) the date by which the Secretary of State, the Scottish Ministers or (as the case may be) each of them needs to provide the information that has to be provided under paragraph 1D; and
    - (c) any conditions which that Office requires to be satisfied in the period ending with that date if it is to proceed with the review.
  - (4) The period set out under sub-paragraph (3)(a) must be the one which—
    - (a) begins with the time as from which [F1032] the Office of Rail and Road] expects that any changes resulting from the review would fall to be implemented; and
    - (b) ends with the time as from which it thinks it likely (in the absence of special circumstances making an earlier review appropriate) that any changes resulting from the next access charges review in relation to the same agreement and licence would fall to be implemented.

- (5) The date set out under sub-paragraph (3)(b) must be not less than the following period after the date of the notice—
  - (a) in a case which [F1032 the Office of Rail and Road] is satisfied is a case of urgency, four weeks; and
  - (b) in any other case, three months.
- (6) Before setting out a date under sub-paragraph (3)(b) that is less than three months after the date of the notice, [F1032the Office of Rail and Road] must consult each of the persons to whom the notice is to be given.

# Duty to notify ORR about desired outputs and finances

- 1D (1) Where a notice under paragraph 1C is given to the Secretary of State, he must provide [F1032 the Office of Rail and Road] with—
  - (a) information about what he wants to be achieved by railway activities in Great Britain as a whole during the review period; and
  - (b) such information as it is reasonable for him to provide about the public financial resources that are or are likely to become available to be applied during the review period for purposes that contribute (directly or indirectly) towards the achievement of what he wants.
  - (2) Where a notice under paragraph 1C is given to the Scottish Ministers (whether instead of or as well as to the Secretary of State), they must provide [F1032the Office of Rail and Road] with—
    - (a) information about what they want to be achieved by Scottish railway activities during the review period; and
    - (b) such information as it is reasonable for them to provide about the public financial resources that are or are likely to become available to be applied during that period for purposes that contribute (directly or indirectly) towards the achievement of what they want.
  - (3) The information that may be provided as falling within sub-paragraph (1)(a) or (2)(a) includes objectives and standards to be achieved in the course of carrying on railway activities.
  - (4) Those objectives and standards may include, in particular, objectives and standards with respect to any of the following matters—
    - (a) the capacity (in terms of types and numbers of trains) of networks;
    - (b) the frequency of railway passenger services;
    - (c) journey times;
    - (d) reliability of railway services (both in terms of punctuality and otherwise);
    - (e) the taking of measures to prevent or mitigate overcrowding;
    - (f) levels and types of fares;
    - (g) the quality of information provided to passengers;
    - (h) the accessibility of railway services to people with disabilities;
    - (i) the carrying out of major projects to improve railway services;
    - (j) the protection of persons from dangers arising from the operation of railways.

- (5) In a case where information is also required to be provided by the Scottish Ministers, the information that is required to be provided by the Secretary of State does not include—
  - (a) any information about what he wants to be achieved by Scottish railway activities not relating to cross-border services; or
  - (b) information about any public financial resources so far as they appear to him to be available, or to be likely to become available, to be applied for purposes relating only to such activities.
- (6) An obligation of the Secretary of State or the Scottish Ministers to provide information under this paragraph—
  - (a) must be discharged before the date set out in the notice given under paragraph 1C or, if a later date is fixed under sub-paragraph (7), by that later date; but
  - (b) may be discharged by a notification that refers that Office to information previously provided under this paragraph.
- (7) [F1032The Office of Rail and Road] may at any time, by notice to each of the persons to whom the notice under paragraph 1C was given, fix a later date for the provision of information under this paragraph.
- (8) Neither—
  - (a) the Secretary of State, nor
  - (b) the Scottish Ministers,

are required to provide information for the purposes of a review at any time after a decision has been made by [ $^{F1032}$ the Office of Rail and Road] not to proceed with the review because of an actual or expected failure of the conditions set out under paragraph 1C(3)(c) to be satisfied.

- (9) In this paragraph "railway activities" means activities consisting in, or involving, any of the following—
  - (a) providing railway services;
  - (b) making available railway facilities;
  - (c) making use of such facilities;
  - (d) using railway assets;
  - (e) allowing others to use such assets.
- (10) In this paragraph "Scottish railway activities" means activities which are railway activities by reference only to—
  - (a) railway services which begin and end in Scotland;
  - (b) railway services in relation to which financial assistance is provided by the Scottish Ministers and which (without falling within paragraph (a)) begin or end in Scotland;
  - (c) railway facilities that are situated in Scotland; or
  - (d) railway assets so situated.
- (11) In this paragraph "public financial resources" means any of the following—
  - (a) money charged on and payable out of the Consolidated Fund;
  - (b) money provided by Parliament;
  - (c) money payable out of the Scottish Consolidated Fund.

# Suggestions about future reviews

- Where the Secretary of State or the Scottish Ministers provide [F1032] the Office of Rail and Road] with information under paragraph 1D, he or they may also, at the same time, make a suggestion to that Office setting out his or their opinion about—
  - (a) when the next access charges review should be undertaken in relation to both the access agreement in question and every linked licence; and
  - (b) the circumstances in which it would be appropriate to undertake such a review before that time.

# Revision of outputs and financial information

- 1F (1) If, at any time in the course of an access charges review, it appears to [F1032the Office of Rail and Road] that—
  - (a) the information that has been provided to it by the Secretary of State or the Scottish Ministers under paragraph 1D, or
  - (b) the information, taking it all together, that has been so provided by the Secretary of State and the Scottish Ministers,

shows that the public financial resources that are or are likely to become available will be inadequate to secure the achievement of what he or they, or both of them, want to be achieved, that Office must so notify the Secretary of State or the Scottish Ministers or (as the case may be) each of them.

- (2) [F1032 The Office of Rail and Road] must send a copy of every notification under subparagraph (1) to the Treasury.
- (3) On being notified under sub-paragraph (1), the Secretary of State or the Scottish Ministers or (as the case may be) each of them—
  - (a) may revise any information provided to [F1032the Office of Rail and Road], together with any suggestion made under paragraph 1E; and
  - (b) if the information or such a suggestion is revised, must notify the revisions to that Office.
- (4) Any notification under sub-paragraph (3) must be given within whatever period is specified by [F1032the Office of Rail and Road] when notifying the Secretary of State or Scottish Ministers in accordance with sub-paragraph (1).
- (5) Where [F1032] the Office of Rail and Road] has already given a notification under this paragraph with respect to any information, it is required to give a further notification under this paragraph with respect to that information, or any revision of it, only if—
  - (a) a revision has been made in response to its previous notification; and
  - (b) it has not previously given a notification in respect of an earlier revision of the information.

Notification of likely adverse effect on interests of certain providers of railway services

- (1) If, at any time in the course of an access charges review, it appears to [F1032] the Office of Rail and Road] that it is likely that the implementation of the review will adversely affect the interests of persons providing railway passenger services or of persons providing services for the carriage of goods by railway, that Office must so notify—
  - (a) the Secretary of State, in the case of a review notice of which was given to him under paragraph 1C; and

- (b) the Scottish Ministers, in the case of a review notice of which was given to them under that paragraph.
- (2) Where [F1032] the Office of Rail and Road] gives a notification under sub-paragraph (1) in respect of a review relating to an access agreement to which a facility owner is a party, the notification must include—
  - (a) its assessment of the measures that the facility owner is likely to be required to take, as a consequence of the implementation of the review, in order to meet obligations of his arising under the access agreement in question or under any other access agreement to which he is a party; and
  - (b) its estimate of the cost to the facility owner of taking those measures.
- (3) On being notified under sub-paragraph (1), the Secretary of State or the Scottish Ministers or (as the case may be) each of them—
  - (a) may revise any information provided under paragraph 1D to [F1032] the Office of Rail and Road], together with any suggestion made under paragraph 1E; and
  - (b) if the information or such a suggestion is revised, must notify the revisions to that Office.
- (4) Any notification under sub-paragraph (3) must be given within whatever period is specified by [F1032] the Office of Rail and Road] when notifying the Secretary of State or the Scottish Ministers in accordance with sub-paragraph (1).
- (5) Where [F1032] the Office of Rail and Road] has already given a notification under this paragraph, it is required to give a further notification under this paragraph only if—
  - (a) information provided to it has been revised in response to its notification; and
  - (b) it has not previously given a notification in respect of an earlier revision of that information.

Duty to have regard to information about desired outputs and finances etc.

- 1H (1) [F1032The Office of Rail and Road] must conduct an access charges review in the manner that it considers is most likely to secure that the implementation of the review will make the best and most practicable contribution to the achievement of—
  - (a) what the Secretary of State wants to be achieved by railway activities in Great Britain as a whole; and
  - (b) what the Scottish Ministers want to be achieved by Scottish railway activities.
  - (2) Where in the case of an access charges review [F1032] the Office of Rail and Road] considers (notwithstanding any notification or revision under paragraph 1F or 1G) that the public financial resources that are or are likely to become available will be inadequate to secure the achievement of, as the case may be—
    - (a) everything that the Secretary of State wants to be achieved,
    - (b) everything that the Scottish Ministers want to be achieved, or
    - (c) everything that both the Secretary of State and the Scottish Ministers want to be achieved,

it is to be for that Office to determine, for the purposes of the review, how much of what is wanted should be achieved using (but only for the purposes for which they

may be applied) all the public financial resources that it considers are or are likely to be available.

- (3) In conducting an access charges review [F1032 the Office of Rail and Road] must have regard to the consequences of compliance by a facility owner who is a party to the access agreement in question with any terms—
  - (a) of that agreement, or
  - (b) of any other access agreement to which that facility owner is a party, that it considers are relevant to a matter notified under paragraph 1G (including, in particular, a term requiring the facility owner to pay compensation or to take mitigatory measures).
- (4) In considering the matters mentioned in paragraph 1A(3), [F1032] the Office of Rail and Road] must have regard to any suggestion made under paragraph 1E, and to any revision of that suggestion.
- (5) For the purposes of this paragraph—
  - (a) expressions used in this paragraph and in paragraph 1D have the same meanings in this paragraph as in that;
  - (b) what the Secretary of State or the Scottish Ministers want must be determined in every case in accordance with the information provided in that case under paragraph 1D, and with any revisions notified under paragraph 1F(3)(b) or 1G(3)(b); and
  - (c) [F1032 the Office of Rail and Road] must have regard to the financial information so provided and revised whenever considering what is likely to make the best and most practicable contribution to the achievement of what the Secretary of State or the Scottish Ministers want.]

### Main provisions

- 2 (1) The procedure for the implementation of an access charges review shall be as provided for by paragraphs 4 to 16 of this Schedule.
  - (2) And any procedure relating to the implementation of an access charges review for which the access agreement or any linked licence makes provision shall not apply.

### Review notice

- 4 (1) The implementation of an access charges review shall be initiated by [F1036the Office of Rail and Road] giving notice (a "review notice")—
  - (a) stating [F1037its] conclusions on the access charges review and the reasons why [F1038it] reached those conclusions;
  - (b) specifying the relevant changes which [F1038it] proposes to make for or in connection with giving effect to those conclusions;

- (c) stating, in relation to each of the proposed relevant changes, the date on which [F1038it] proposes that it should come into operation; and
- (d) specifying the period (not being less than six weeks from the date of publication of the notice) within which objections with respect to any of the proposed relevant changes, or the date on which it is proposed that it should come into operation, may be made by a person within sub-paragraph (4)(a) or (b) below.
- (2) In this Schedule "relevant changes", in relation to an access agreement, means—
  - (a) amendments of the access agreement;
  - (b) modifications of the conditions of any linked licence; or
  - (c) both such amendments and such modifications;

and references to the making of relevant changes are, in the case of amendments of the access agreement, references to directing the parties to the access agreement to make the amendments to the access agreement.

- [F1039(2A)] Before giving a review notice specifying modifications of a linked licence that are proposed for purposes connected with securing—
  - (a) what the Secretary of State has informed [F1036the Office of Rail and Road] he wants to be achieved by any railway activities, or
  - (b) what the Scottish Ministers have informed that Office they want to be achieved by any such activities,

that Office must consult the Secretary of State or (as the case may be) those Ministers.]

- (3) The review notice shall be given—
  - (a) by publishing it in such manner as [F1036the Office of Rail and Road] considers appropriate for the purpose of bringing it to the attention of persons likely to be affected by the proposed relevant changes; and
  - (b) by serving a copy on the persons specified in sub-paragraph (4) below.
- (4) The persons referred to in sub-paragraph (3)(b) above are—
- [F1040(za)] if the Secretary of State was given notice of the review under paragraph 1C, the Secretary of State;
  - (zb) if the Scottish Ministers were given notice of the review under that paragraph, those Ministers;
  - (zc) the Treasury;]
  - (a) the facility owner, or installation owner, who is a party to the access agreement;
  - (b) any other person who has an estate or interest in, or right over, the railway facility or network installation to which the access agreement relates and who [F1036] the Office of Rail and Road] considers ought to be given a copy; and
  - (c) the beneficiary.
- (5) In this Schedule "the beneficiary"—
  - (a) in relation to an access contract, has the meaning given by section 17(7) of this Act; and
  - (b) in relation to an installation access contract, has the meaning given by section 19(10) of this Act.

- 5 (1) If no objections are duly made by a person within paragraph 4(4)(a) or (b) above (or any that are so made are withdrawn), [F1036the Office of Rail and Road] shall give notice (a "notice of agreement") stating that fact.

- 6 (1) After a copy of a notice of agreement is served on the beneficiary, he may give notice (a "termination notice") terminating the access agreement.
  - (2) The termination notice shall specify the date on which the access agreement is to terminate.
  - (3) The termination notice shall be given by serving a copy on—
  - [F1041(za)] if the Secretary of State was given notice of the review under paragraph 1C, the Secretary of State;
    - (zb) if the Scottish Ministers were given notice of the review under that paragraph, those Ministers;]
    - (a) the facility owner or installation owner;
    - (b) any other person who has an estate or interest in, or right over, the railway facility or network installation and who received a copy of the review notice; and

## Review implementation notice

- 7 (1) After a copy of a notice of agreement is served on the beneficiary and the time within which a termination notice may be given by him has expired
  - if he has not given a termination notice (or has withdrawn any notice which he has given). [F1036the Office of Rail and Road] shall (unless [F1042it] acts under paragraph 8(2) below) give a review implementation notice; or

# Report on reference

- 11 (1) In making a report on a reference under paragraph 9 above, the [F1067CMA] shall include in the report—
  - (a) definite conclusions on the questions comprised in the reference; and
  - (b) such an account of their reasons for those conclusions as in their opinion is expedient for facilitating a proper understanding of those questions and of their conclusions.
  - (2) Where they conclude that any of the matters specified in the reference operate, or may be expected to operate, against the public interest, they shall specify in the report the effects adverse to the public interest which those matters have or may be expected to have.
  - (3) Where they conclude that any adverse effects so specified could be remedied or prevented by the making of relevant changes, they shall in the report—
    - (a) specify the relevant changes by which those effects could be remedied or prevented; and
    - (b) state, in relation to each of the relevant changes, the date on which it should come into operation.
  - (4) A date stated in the report as that on which a relevant change should come into operation may be a date before the report is made, provided that it is not before the earliest date specified in the review notice for the coming into operation of a relevant change proposed in it.
- [F1068(4A)] For the purposes of paragraphs 12 to 14 below, a conclusion contained in a report of the [F1069CMA] is to be disregarded if the conclusion is not that of at least two-thirds of the members of the group constituted [F1070] by the chair of the CMA for the purpose of carrying out the functions of the CMA with respect to the reference].]

- (5D) The third consideration is the extent to which the disclosure of the information mentioned in sub-paragraph (5C)(a) or (b) above is necessary for the purposes of the report.]
  - (6) A report of the [F1073CMA] on a reference under paragraph 9 above shall be made to [F1074the Office of Rail and Road].
  - (7) [F1074The Office of Rail and Road] shall, on receiving such a report, send a copy of it to the Secretary of State and the Authority.
  - (8) Not less than 14 days after that copy is received by the Secretary of State, [F1074the Office of Rail and Road] shall send a copy to each of the persons on whom a copy of the review notice was served.

- (i) the reference to the commencement or continuation of proceedings shall be taken as a reference to the commencement or continuation of proceedings in Great Britain; and
- (ii) the reference to the levying of distress against the company shall be taken as a reference to the levying of distress against the foreign company to the extent of its property in England and Wales;

and any reference to property or goods shall be taken as a reference to property or (as the case may be) goods for the time being situated within Great Britain.

- (5) Subsections (4) and (5) shall be omitted.
- (6) At the end of that section there shall be added—
  - "(6) Where a railway administration order is in force in relation to a company which is a foreign company within the meaning of section 65 of the Railways Act 1993—
    - (a) any person appointed to perform functions equivalent to those of an administrative receiver, and

    - (b) the property of that company so far as that property is for the time being situated within Great Britain.
  - (3) Subsection (2)(a) shall be omitted.
  - (4) In subsection (4)—

- (a) the reference to any power conferred on the company or its officers shall be taken to include any power conferred on the foreign company or its officers under the law under which the foreign company is incorporated; and
- (b) any reference (however expressed) to the exercise of any power conferred on the company or its officers shall be taken as a reference to the exercise of that power so far as it relates to—
  - (i) the affairs and business of the foreign company so far as carried on in Great Britain, or
  - (ii) the property of that company so far as that property is for the time being situated within Great Britain.

#### Power to deal with charged property

In section 15 of the 1986 Act (power of administrator to deal with charged property etc), as applied by this Part of this Schedule in relation to a foreign company, any reference to property or goods shall be taken as a reference to property or (as the case may be) goods for the time being situated within Great Britain.

#### Duties of special railway administrator

- In section 17 of the 1986 Act (general duties of administrator), as applied by this Part of this Schedule in relation to a foreign company,—
  - (a) in subsection (1), the reference to property shall be taken as a reference to property for the time being situated within Great Britain; and
  - (b) in subsection (2), the reference to the affairs, business and property of the company shall be taken as a reference to—
    - (i) the affairs and business of the foreign company so far as carried on in Great Britain, and
    - (ii) the property of that company so far as that property is for the time being situated within Great Britain.

#### Statement as to company's affairs

In section 22(1) of the 1986 Act (power of administrator to require certain persons to provide him with a statement as to company's affairs), as applied by this Part of this Schedule in relation to a foreign company, the reference to the affairs of the company shall be taken as a reference to the affairs of the foreign company so far as they are carried on in Great Britain, or relate to property of that company for the time being situated within Great Britain.

#### Particular powers of special railway administrator

- 19 (1) The powers conferred on a special railway administrator by virtue of Schedule 1 to the 1986 Act (which sets out certain powers of an administrator), as that Schedule applies by virtue of section 14 of that Act, as applied by this Part of this Schedule in relation to a foreign company, shall be exercisable only in relation to—
  - (a) the affairs and business of that company, so far as carried on in Great Britain;
  - (b) the property of that company, so far as that property is for the time being situated within Great Britain.

- (2) In that Schedule, as it so applies,—
  - (a) without prejudice to sub-paragraph (1) above, references to the property of that company shall be taken as references to that property, so far as that property is for the time being situated within Great Britain; and
  - (b) paragraph 19 shall be omitted.

#### Transfers by scheme

- 3 (1) A scheme under this Schedule for the transfer of the existing appointee's property, rights and liabilities shall come into force on the relevant date and, on coming into force, shall have effect, in accordance with its provisions and without further assurance, so as to transfer the property, rights and liabilities to which the scheme relates to the new appointee.

  - (4) The provision that may be made by virtue of sub-paragraph (2)(b) above includes—

- (a) provision for treating any person who is entitled by virtue of a scheme under this Schedule to possession of a document as having given another person an acknowledgement in writing of the right of that other person to the production of the document and to delivery of copies thereof;
- (b) provision applying section 64 of the MIII Law of Property Act 1925 (production and safe custody of documents) in relation to any case in relation to which provision falling within paragraph (a) above has effect; and
- (c) provision that where a scheme under this Schedule transfers any interest in land or other property situated in Scotland, subsections (1) and (2) of section 16 of the M112Land Registration (Scotland) Act 1979 (omission of certain clauses in deeds) shall have effect in relation to the transfer as if the transfer had been effected by deed and as if from each of those subsections the words "unless specially qualified" were omitted.
- (5) For the avoidance of doubt, it is hereby declared that the transfers authorised by paragraph (a) of sub-paragraph (3) above include transfers which, by virtue of that paragraph, are to take effect as if there were no such contravention, liability or interference with any interest or right as there would be, in the case of a transfer or assignment otherwise than in accordance with a scheme under this Schedule, by reason of any provision having effect (whether under any enactment or agreement or otherwise) in relation to the terms on which the existing appointee is entitled or subject to the property, right or liability in question.

#### Transfer of licences

- 4 (1) A scheme under this Schedule may provide for a licence held by the existing appointee to have effect as if it had been granted to the new appointee.

#### Supplemental provisions of schemes

- 5 (1) A scheme under this Schedule may contain supplemental, consequential and transitional provision for the purposes of, or in connection with, the provision for the transfers or any other provision made by the scheme.
  - (2) Without prejudice to the generality of sub-paragraph (1) above, a scheme under this Schedule may provide—
    - (a) that for purposes connected with any transfers made in accordance with the scheme (including the transfer of rights and liabilities under an enactment) the new appointee is to be treated as the same person in law as the existing appointee;
    - (b) that, so far as may be necessary for the purposes of or in connection with any such transfers, agreements made, transactions effected and other things done by or in relation to the existing appointee are to be treated as made, effected or done by or in relation to the new appointee;
    - (c) that, so far as may be necessary for the purposes of or in connection with any such transfers, references in any agreement (whether or not in writing) or in any deed, bond, instrument or other document to, or to any officer of, the existing appointee are to have effect with such modifications as are specified in the scheme;
    - (d) that proceedings commenced by or against the existing appointee are to be continued by or against the new appointee;
    - (e) that the effect of any transfer under the scheme in relation to contracts of employment with the existing appointee is not to be to terminate any of those contracts but is to be that periods of employment with the existing appointee are to count for all purposes as periods of employment with the new appointee;
    - (f) that disputes as to the effect of the scheme between the existing appointee and the new appointee, between either of them and any other appointee or between different companies which are other appointees are to be referred to such arbitration as may be specified in or determined under the scheme;
    - (g) that determinations on such arbitrations and certificates given jointly by two or more such appointees as are mentioned in paragraph (f) above as to the effect of the scheme as between the companies giving the certificates are to be conclusive for all purposes.

#### Duties of existing appointee after the scheme comes into force

- 6 (1) A scheme under this Schedule may provide for the imposition of duties on the existing appointee and on the new appointee to take all such steps as may be requisite to secure that the vesting in the new appointee, by virtue of the scheme, of any foreign property, right or liability is effective under the relevant foreign law.
  - (2) The provisions of a scheme under this Schedule may require the existing appointee to comply with any directions of the new appointee in performing any duty imposed on the existing appointee by virtue of a provision included in the scheme under subparagraph (1) above.
  - (3) A scheme under this Schedule may provide that, until the vesting of any foreign property, right or liability of the existing appointee in the new appointee is effective under the relevant foreign law, it shall be the duty of the existing appointee to hold

- (4) Nothing in any provision included by virtue of this paragraph in a scheme under this Schedule shall be taken as prejudicing the effect under the law of any part of the United Kingdom of the vesting by virtue of the scheme in the new appointee of any foreign property, right or liability.
- (5) A scheme under this Schedule may provide that, in specified cases, foreign property, rights or liabilities that are acquired or incurred by an existing appointee after the scheme comes into force are immediately to become property, rights or liabilities of the new appointee; and such a scheme may make the same provision in relation to any such property, rights or liabilities as can be made, by virtue of the preceding provisions of this paragraph, in relation to foreign property, rights and liabilities vested in the existing appointee when the scheme comes into force.
- (6) References in this paragraph to any foreign property, right or liability are references to any property, right or liability as respects which any issue arising in any proceedings would have to be determined (in accordance with the rules of private international law) by reference to the law of a country or territory outside the United Kingdom.
- (7) Any expenses incurred by an existing appointee in consequence of any provision included by virtue of this paragraph in a scheme under this Schedule shall be met by the new appointee.
- (8) Duties imposed on a company by virtue of this paragraph shall be enforceable in the same way as if they were imposed by a contract between the existing appointee and the new appointee.

Functions under private and local legislation etc.

- 7 (1) A scheme under this Schedule may provide that any functions of the existing appointee under a statutory provision—
  - (a) shall be transferred to the new appointee or any of the other appointees;
  - (b) shall be concurrently exercisable by two or more companies falling within paragraph (a) above; or
  - shall be concurrently exercisable by the existing appointee and one or more companies falling within paragraph (a) above;

and different schemes under this Schedule may provide for any such functions of the same existing appointee to have effect as mentioned in paragraphs (a) to (c) above in relation to each of the new appointees under those schemes or of all or any of the other appointees.

- (2) Sub-paragraph (1) above applies in relation to any function under a statutory provision if and to the extent that the statutory provision—
  - (a) relates to any part of the existing appointee's undertaking, or to any property, which is to be transferred by the scheme; or
  - (b) authorises the carrying out of works designed to be used in connection with any such part of the existing appointee's undertaking or the acquisition of land for the purpose of carrying out any such works.
- (3) Sub-paragraph (1) above does not apply to any function of the Board or of any of the Board's subsidiaries under any provision of this Act or of—

- (a) the M113 Transport Act 1962;
- (b) the M114 Transport Act 1968;
- (c) section 4 of the M115Railways Act 1974; or
- (d) sections 119 to 124 of the M116 Transport Act 1985.
- (4) A scheme under this Schedule may define any functions of the existing appointee to be transferred or made concurrently exercisable by the scheme in accordance with sub-paragraph (1) above—
  - (a) by specifying the statutory provisions in question;
  - (b) by referring to all the statutory provisions (except those specified in subparagraph (3) above) which—
    - (i) relate to any part of the existing appointee's undertaking, or to any property, which is to be transferred by the scheme, or
    - (ii) authorise the carrying out of works designed to be used in connection with any such part of the existing appointee's undertaking or the acquisition of land for the purpose of carrying out any such works; or
  - (c) by referring to all the statutory provisions within paragraph (b) above, but specifying certain excepted provisions.
- (5) In this paragraph "statutory provision" means a provision whether of a general or of a special nature contained in, or in any document made or issued under, any Act, whether of a general or a special nature.

#### TRANSFERS BY TRANSFER SCHEME

#### Allocation of property, rights and liabilities

- 1 (1) The provisions of this paragraph and paragraph 2 below shall have effect where a transfer to which this Schedule applies is a transfer of all (or of all but so much as may be excepted) of the property, rights and liabilities comprised in a specified part of the transferor's undertaking, but shall not apply to any such rights or liabilities under a contract of employment.
  - (2) Any property, right or liability comprised partly in the part of the transferor's undertaking which is transferred to the transferee and partly in the part of that undertaking which is retained by the transferor shall, where the nature of the property, right or liability permits, be divided or apportioned between the transferor and the transferee in such proportions as may be appropriate; and, where any estate or interest in land falls to be so divided—

- (a) any rent payable under a lease in respect of that estate or interest, and
- (b) any rent charged on that estate or interest,

shall be correspondingly apportioned or divided so that the one part is payable in respect of, or charged on, only one part of the estate or interest and the other part is payable in respect of, or charged on, only the other part of the estate or interest.

- (3) Sub-paragraph (2) above shall apply, with any necessary modifications, in relation to any feuduty payable in respect of an estate or interest in land in Scotland as it applies in relation to any rents charged on an estate or interest in land.
- (4) Any property, right or liability comprised as mentioned in sub-paragraph (2) above the nature of which does not permit its division or apportionment as so mentioned shall be transferred to the transferee or retained by the transferor according to—
  - (a) in the case of an estate or interest in land, whether on the transfer date the transferor or the transferee appears to be in greater need of the security afforded by that estate or interest or, where neither appears to be in greater need of that security, whether on that date the transferor or the transferee appears likely to make use of the land to the greater extent,
  - (b) in the case of any other property or any right or liability, whether on the transfer date the transferor or the transferee appears likely to make use of the property, or as the case may be to be affected by the right or liability, to the greater extent,

subject (in either case) to such arrangements for the protection of the other of them as may be agreed between them.

- 2 (1) It shall be the duty of the transferor and the transferee, whether before or after the transfer date, so far as practicable to arrive at such written agreements and to execute such other instruments as are necessary or expedient to identify or define the property, rights and liabilities transferred to the transferee or retained by the transferor and as will—
  - (a) afford to the transferor and the transferee as against one another such rights and safeguards as they may require for the proper discharge of their respective functions; and
  - (b) make as from such date, not being earlier than the transfer date, as may be specified in the agreement or instrument such clarification and modifications of the division of the transferor's undertaking as will best serve the proper discharge of the respective functions of the transferor and the transferee.
  - (2) Any such agreement shall provide so far as it is expedient—
    - (a) for the granting of leases and for the creation of other liabilities and rights over land whether amounting in law to interests in land or not, and whether involving the surrender of any existing interest or the creation of a new interest or not;
    - (b) for the granting of indemnities in connection with the severance of leases and other matters; and
    - (c) for responsibility for registration of any matter in any statutory register.
  - (3) If the transferor or the transferee represents to the Secretary of State, or if it appears to the Secretary of State without such a representation, that it is unlikely in the case of any matter on which agreement is required under sub-paragraph (1) above that such agreement will be reached, the Secretary of State may, whether before or after the transfer date, give a direction determining that matter and may include in the direction any provision which might have been included in an agreement under sub-

paragraph (1) above; and any property, rights or liabilities required by the direction to be transferred to the transferee shall accordingly be regarded as having been transferred to, and vested in, the transferee by virtue of the scheme.

#### Variation of transfers by agreement

- 3 (1) The provisions of this paragraph shall have effect where a transfer to which this Schedule applies is a transfer by virtue of a transfer scheme made otherwise than under section 86 of this Act.
  - (2) At any time before the end of the period of twelve months beginning with the transfer date, the transferor and the transferee of the specified part may, with the approval of the Secretary of State, agree in writing that—
    - (a) as from such date as may be specified in or determined under the agreement, and
    - (b) in such circumstances (if any) as may be so specified,
    - there shall be transferred from the transferee to, and vested in, the transferor any property, rights and liabilities specified in the agreement; but no such agreement shall have effect in relation to rights and liabilities under a contract of employment unless the employee concerned is a party to the agreement.
  - (3) Subject to sub-paragraphs (4) and (5) below, in the case of an agreement under sub-paragraph (2) above, the property, rights and liabilities in question shall be transferred and vest in accordance with the agreement.
  - (4) Any transfer effected in pursuance of an agreement under sub-paragraph (2) above shall have effect subject to the provisions of any enactment which provides for such transactions to be registered in any statutory register.
  - (5) The following provisions of this Schedule shall have effect as if—
    - (a) any reference to a transfer to which this Schedule applies included a reference to a transfer effected in pursuance of an agreement under subparagraph (2) above;
    - (b) any reference to a transaction effected in pursuance of paragraph 2(1) above or of a direction under paragraph 2(3) above included a reference to such an agreement; and
    - (c) any reference to a vesting by virtue of a transfer scheme included a reference to a vesting by virtue of such an agreement.

#### Right to production of documents of title

- 4 (1) This paragraph applies where, on any transfer to which this Schedule applies, the transferor is entitled to retain possession of any document relating in part to the title to, or to the management of, any land or other property transferred to the transferee.
  - (2) Where the land or other property is situated in England and Wales—
    - (a) the transferor shall be deemed to have given to the transferee an acknowledgement in writing of the right of the transferee to production of that document and to delivery of copies of it; and
    - (b) section 64 of the MII7 Law of Property Act 1925 shall have effect accordingly, and on the basis that the acknowledgement did not contain any such expression of contrary intention as is mentioned in that section.

- (3) Where the land or other property is situated in Scotland, subsections (1) and (2) of section 16 of the MII8 Land Registration (Scotland) Act 1979 (omission of certain clauses in deeds) shall have effect in relation to the transfer as if the transfer had been effected by deed and as if from each of those subsections the words "unless specially qualified" were omitted.
- (4) Where the land or other property is situated in Northern Ireland—
  - (a) the transferor shall be deemed to have given to the transferee an acknowledgement in writing of the right of the transferee to production of that document and to delivery of copies of it; and
  - (b) section 9 of the M119 Conveyancing Act 1881 (which corresponds to section 64 of the M120 Law of Property Act 1925) shall have effect accordingly, and on the basis that the acknowledgement did not contain any such expression of contrary intention as is mentioned in that section.

#### Perfection of vesting of foreign property, rights and liabilities

- 5 (1) This paragraph applies in any case where a transfer scheme provides for the transfer of any foreign property, rights or liabilities.
  - (2) It shall be the duty of the transferor and the transferee to take, as and when the transferee considers appropriate, all such steps as may be requisite to secure that the vesting in the transferee by virtue of the transfer scheme of any foreign property, right or liability is effective under the relevant foreign law.
  - (3) Until the vesting in the transferee by virtue of the transfer scheme of any foreign property, right or liability is effective under the relevant foreign law, it shall be the duty of the transferor to hold that property or right for the benefit of, or to discharge that liability on behalf of, the transferee.
  - (4) Nothing in sub-paragraphs (2) and (3) above shall be taken as prejudicing the effect under the law of the United Kingdom or of any part of the United Kingdom of the vesting in the transferee by virtue of a transfer scheme of any foreign property, right or liability.
  - (5) The transferor shall have all such powers as may be requisite for the performance of his duty under this paragraph, but it shall be the duty of the transferee to act on behalf of the transferor (so far as possible) in performing the duty imposed on the transferor by this paragraph.
  - (6) References in this paragraph to any foreign property, right or liability are references to any property, right or liability as respects which any issue arising in any proceedings would have been determined (in accordance with the rules of private international law) by reference to the law of a country or territory outside the United Kingdom.

- (7) Duties imposed on the transferor or the transferee by this paragraph shall be enforceable in the same way as if the duties were imposed by a contract between the transferor and the transferee.
- (8) Any expenses incurred by the transferor under this paragraph shall be met by the transferee.

#### Proof of title by certificate

- 6 (1) In the case of any transfer to which this Schedule applies, a joint certificate by or on behalf of the transferor and the transferee that—
  - (a) any property specified in the certificate, or
  - (b) any such interest in or right over any such property as may be so specified, or
  - (c) any right or liability so specified,

is property, or (as the case may be) an interest, right or liability which was intended to be, and was vested by virtue of the scheme in such one of them as may be so specified (and, if it is the transferee who is so specified, that the property, interest, right or liability has not been transferred back to the transferor by virtue of an agreement under paragraph 3(2) above) shall be conclusive evidence for all purposes of that fact.

- (2) If on the expiration of one month after a request from either the transferor or the transferee for the preparation of such a joint certificate as respects any property, interest, right or liability they have failed to agree on the terms of the certificate, they shall refer the matter to the Secretary of State and issue the certificate in such terms as he may direct.
- (3) This paragraph is without prejudice to paragraph 14(6) and (7) below.

#### Restrictions on dealing with certain land

- 7 (1) If the Secretary of State is satisfied on the representation of the transferor or the transferee—
  - (a) that, in consequence of a transfer to which this Schedule applies, different interests in land, whether the same or different land, are held by the transferor and by the transferee, and
  - (b) that the circumstances are such that this paragraph should have effect, the Secretary of State may direct that this paragraph shall apply to such of that land as may be specified in the direction.
  - (2) While the direction mentioned in sub-paragraph (1) above remains in force—
    - (a) neither the transferor nor the transferee shall dispose of any interest to which they may respectively be entitled in any of the specified land, except with the consent of the Secretary of State;
    - (b) if, in connection with any proposal to dispose of any interest of either the transferor or the transferee in any of the specified land, it appears to the Secretary of State to be necessary or expedient for the protection of either of them, he may—
      - (i) require either the transferor or the transferee to dispose of any interest to which he may be entitled in any of the specified land to such person and in such manner as may be specified in the requirement;

- (ii) require either the transferor or the transferee to acquire from the other any interest in any of the specified land to which that other is entitled; or
- (iii) consent to the proposed disposal subject to compliance with such conditions as the Secretary of State may see fit to impose.
- (3) A person other than the transferor and the transferee dealing with, or with a person claiming under, either the transferor or the transferee shall not be concerned—
  - (a) to see or enquire whether this paragraph applies, or has applied, in relation to any land to which the dealing relates; or
  - (b) as to whether the provisions of this paragraph have been complied with in connection with that, or any other, dealing with that land;

and no transaction between a person other than the transferor or the transferee on the one hand, and the transferor, the transferee or a person claiming under either of them on the other, shall be invalid by reason of any failure to comply with those provisions.

#### Construction of agreements, statutory provisions and documents

- 8 (1) This paragraph applies where, in the case of any transfer to which this Schedule applies, any rights or liabilities transferred are rights or liabilities under an agreement to which the transferor was a party immediately before the transfer date, whether in writing or not, and whether or not of such nature that rights and liabilities under the agreement could be assigned by the transferor.
  - (2) So far as relating to property, rights or liabilities transferred to the transferee, the agreement shall have effect on and after the transfer date as if—
    - (a) the transferee had been the party to it;
    - (b) for any reference (whether express or implied and, if express, however worded) to the transferor there were substituted, as respects anything falling to be done on or after the transfer date, a reference to the transferee;
    - (c) any reference (whether express or implied and, if express, however worded) to a person employed by, or engaged in the business of, the transferor and holding a specified office or serving in a specified capacity were, as respects anything falling to be done on or after the transfer date, a reference to such a person as the transferee may appoint or, in default of appointment, to a person employed by, or engaged in the business of, the transferee who corresponds as nearly as may be to the first-mentioned person;
    - (d) any reference in general terms (however worded) to persons employed by, persons engaged in the business of, or agents of, the transferor were, as respects anything to be done on or after the transfer date, a reference to persons employed by, persons engaged in the business of, or agents of, the transferee.
- 9 (1) Except as otherwise provided in any provision of this Act (whether expressly or by necessary implication), paragraph 8 above shall, so far as applicable, apply in relation to—
  - (a) any statutory provision,
  - (b) any provision of an agreement to which the transferor was not a party, and
  - (c) any provision of a document other than an agreement,

if and so far as the provision in question relates to any of the transferred property, rights and liabilities, as it applies in relation to an agreement to which the transferor was a party.

- (2) In relation to any such statutory or other provision as is mentioned in sub-paragraph (1) above, references in sub-paragraph (2)(b), (c) and (d) of paragraph 8 above to the transferor and to any persons employed by, persons engaged in the business of, or agents of, the transferor include references made by means of a general reference to a class of persons of which the transferor is one, without the transferor himself being specifically referred to.
- On and after the transfer date for any transfer to which this Schedule applies, any statutory provision to which paragraph 2(3) of Schedule 6 to the M121 Transport Act 1962 applies if and so far as the provision in question relates to any of the transferred property, rights and liabilities, shall have effect as if—
  - (a) any of the references modified by paragraph (a) of the said paragraph 2(3) were, as respects anything falling to be done on or after the transfer date, a reference to such person as the transferee may appoint; and
  - (b) any of the references modified by paragraph (b) of the said paragraph 2(3) were, as respects a period beginning with the transfer date, a reference to so much of the undertaking of the transferee as corresponds as mentioned in the said paragraph (b).

- (1) The transferee under a transfer to which this Schedule applies and any other person shall, as from the transfer date, have the same rights, powers and remedies (and in particular the same rights and powers as to the taking or resisting of legal proceedings or the making or resisting of applications to any authority) for ascertaining, perfecting or enforcing any right or liability vested in the transferee by virtue of the scheme as he would have had if that right or liability had at all times been a right or liability of the transferee.

  - (b) to which the transferee is by virtue of this Act a party,

depends on whether the transferee has power to carry on any activity, it shall be assumed for the purposes of the agreement that any activity which requires the consent of the Secretary of State under the Transport Act 1962 or the M123 Transport Act 1968 has been authorised by such a consent.

#### Third parties affected by vesting provisions

- (1) Without prejudice to the provisions of paragraphs 8 to 13 above, any transaction effected between the transferor and the transferee in pursuance of paragraph 2(1) above or of a direction under paragraph 2(3) above shall be binding on all other persons, and notwithstanding that it would, apart from this sub-paragraph, have required the consent or concurrence of any other person.
  - (2) It shall be the duty of the transferor and the transferee, if they effect any transaction in pursuance of paragraph 2(1) above or a direction under paragraph 2(3) above, to notify any person who has rights or liabilities which thereby become enforceable as to part by or against the transferor and as to part by or against the transferee; and if, within 28 days of being notified, such a person applies to the Secretary of State and satisfies him that the transaction operated unfairly against him, the Secretary of State may give such directions to the transferor and the transferee as appear to him appropriate for varying the transaction.

    - (a) the rights or liabilities of any person other than the transferor and the transferee which are enforceable against or by the transferor become enforceable as to part against or by the transferor and as to part against or by the transferee, and
    - (b) the value of any property or interest of that person is thereby diminished, such compensation as may be just shall be paid to that person by the transferor, the transferee or both.
  - (4) If it appears to the transferor that a person is or may be entitled to compensation under sub-paragraph (3) above, he shall—
    - (a) notify that person that he is or may be so entitled, and
    - (b) invite him to make such representations as he wishes to the transferor not later than fourteen days after the date of issue of the document containing the notification required by paragraph (a) above,

or, if the transferor is not aware of the name and address of the person concerned, shall publish, in such manner as he considers appropriate, a notice containing information about the interest affected and inviting any person who thinks that he is or may be entitled to compensation to make such representations to the transferor within such period (being not less than 28 days from the date of publication of the notice) as may be specified in the notice.

- (5) Any dispute as to whether any, and (if so) how much, compensation is payable under sub-paragraph (3) above, or as to the person to or by whom it shall be paid, shall be referred to and determined by—
  - (a) an arbitrator appointed by the President for the time being of the Royal Institution of Chartered Surveyors, or
  - (b) where the proceedings are to be held in Scotland, an arbiter appointed by the Lord President of the Court of Session, or
  - (c) where the proceedings are to be held in Northern Ireland, an arbitrator appointed by the [F1153Chairman for the time being of the Royal Institution of Chartered Surveyors in Northern Ireland].
- (6) Where, in the case of a transfer to which this Schedule applies, the transferor or the transferee purports by any conveyance or transfer to transfer to some person other than the transferor or the transferee for consideration any land or any other property transferred—
  - (a) which before the transfer date belonged to the transferor, or
  - (b) which is an interest in property which before that date belonged to the transferor,

the conveyance or transfer shall be as effective as if both the transferor and the transferee had been parties to it and had thereby conveyed or transferred all their interests in the property conveyed or transferred.

- (7) Sub-paragraph (6) above applies in relation to the grant of any lease of, or any other estate or interest in, or right over any such land or other property as is there mentioned as it applies in relation to a transfer of any such land or other property; and references in that sub-paragraph to a conveyance or transfer shall be construed accordingly.
- (8) If, in the case of any transfer to which this Schedule applies, it appears to the court at any stage in any court proceedings to which the transferor or the transferee and a person other than the transferor or the transferee are parties that the issues in the proceedings—
  - (a) depend on the identification or definition of any of the property, rights or liabilities transferred which the transferor and the transferee have not yet effected, or
  - (b) raise a question of construction on the relevant provisions of this Act which would not arise if the transferor and the transferee constituted a single person,

the court may, if it thinks fit on the application of a party to the proceedings other than the transferor and the transferee, hear and determine the proceedings on the footing that such one of the transferor and the transferee as is a party to the proceedings represents and is answerable for the other of them, and that the transferor and the transferee constitute a single person, and any judgment or order given by the court shall bind both the transferor and the transferee accordingly.

(9) In the case of any transfer to which this Schedule applies, it shall be the duty of the transferor and the transferee to keep one another informed of any case where either

of them may be prejudiced by sub-paragraph (6), (7) or (8) above, and if either the transferor or the transferee claims that he has been so prejudiced and that the other of them ought to indemnify or make a repayment to him on that account and has unreasonably failed to meet that claim, he may refer the matter to the Secretary of State for determination by him.

#### STAMP DUTY AND STAMP DUTY RESERVE TAX

#### *Interpretation*

1 (1) In this Schedule—

"the Inland Revenue" means the Commissioners of Inland Revenue;

"restructuring scheme" means a transfer scheme, if and to the extent that it provides for the transfer of property, rights or liabilities from a body or person falling within any of paragraphs (a) to (e) of section 85(1) of this Act to another such body or person.

(2) For the purposes of this Schedule a transfer, instrument or agreement shall be regarded as made in pursuance of Schedule 8 to this Act if the making of that transfer, instrument or agreement is required or authorised by or under paragraph 2 or 3 of that Schedule.

#### Stamp duty

- 2 (1) Stamp duty shall not be chargeable on any restructuring scheme which is certified to the Inland Revenue by the Secretary of State as made by him or as made pursuant to a direction given by him under this Act.
  - (2) Stamp duty shall not be chargeable on any instrument or agreement which is certified to the Inland Revenue by the Secretary of State as made in pursuance of Schedule 8 to this Act, in connection with a restructuring scheme made—
    - (a) by the Secretary of State; or
    - (b) pursuant to a direction given by him under this Act.
  - (3) Stamp duty shall not be chargeable on any instrument or agreement which is certified to the Inland Revenue by the Secretary of State—

- (a) as made pursuant to an obligation imposed by any provision included, by virtue of section 91(1)(c) of this Act, in a restructuring scheme made by—
  - (i) the Secretary of State;
  - (ii) the Board, pursuant to a direction given by the Secretary of State under this Act; or
  - (iii) the Franchising Director, pursuant to a direction so given; and
- (b) as operating in favour of no person who does not fall within paragraphs (a) to (e) of section 85(1) of this Act.
- (4) Stamp duty shall not be chargeable on any instrument or agreement which is certified to the Inland Revenue by the Secretary of State as being a transfer, or an agreement for the transfer, to the Board or any of the Board's subsidiaries of property, rights or liabilities of the Board or any such subsidiary, made for the purpose of facilitating a disposal required to be made pursuant to a direction given by him under this Act.
- (5) No restructuring scheme or other instrument or agreement which is certified as mentioned in any of sub-paragraphs (1) to (4) above shall be taken to be duly stamped unless—
  - (a) it is stamped with the duty to which it would be liable, apart from the subparagraph in question; or
  - (b) it has, in accordance with section 12 of the M125 Stamp Act 1891, been stamped with a particular stamp denoting that it is not chargeable with that duty or that it is duly stamped.
- (6) Section 12 of the Finance Act 1895 (collection of stamp duty in cases of property vested by Act or purchased under statutory power) shall not operate to require—
  - (a) the delivery to the Inland Revenue of a copy of this Act, or
  - (b) the payment of stamp duty under that section on any copy of this Act, and shall not apply in relation to any instrument on which, by virtue of the preceding provisions of this paragraph, stamp duty is not chargeable.

#### Stamp duty reserve tax

- 3 (1) An agreement to transfer chargeable securities, as defined in section 99 of the M126Finance Act 1986, to a person falling within paragraphs (a) to (e) of section 85(1) of this Act shall not give rise to a charge to stamp duty reserve tax if the agreement is made for the purposes of, or for purposes connected with, a restructuring scheme made—
  - (a) by the Secretary of State;
  - (b) by the Board, pursuant to a direction given by the Secretary of State under this Act; or
  - (c) by the Franchising Director, pursuant to a direction so given.
  - (2) An agreement shall not give rise to a charge to stamp duty reserve tax if the agreement is made in pursuance of Schedule 8 to this Act in connection with a restructuring scheme made as mentioned in paragraph (a), (b) or (c) of sub-paragraph (1) above.

## Interpretation

1 (1) In this Schedule—

"eligible persons", in the case of any pension scheme, means—

- (a) any person who is an employee of—
- (i) the Board or any subsidiary of the Board, or
  - (ia) F1157 .....
  - (ii) a publicly owned railway company or a [F1158body corporate which is, or is to be, the franchisee or the franchise operator under a franchise agreement], and
  - (b) F1159.....

but does not include any such person as is mentioned in paragraph (a) above who participates in the Transport Police scheme;

"employment" means employment under a contract of service or apprenticeship (whether express or implied and, if express, whether oral or in writing), and cognate expressions shall be construed accordingly;

"existing scheme" means any occupational pension scheme (other than a new scheme)—

- (a) which is a scheme for the provision of pensions for or in respect of persons with service in the railway industry (whether or not pensions may also be provided under the scheme for or in respect of persons without such service); and
- (b) which the Secretary of State by order designates as an existing scheme for the purposes of this Schedule;

"the joint industry scheme" means such occupational pension scheme as the Secretary of State may by order designate as the joint industry scheme for the purposes of this Schedule;

"member", in relation to a pension scheme, means—

- (a) any person who participates in that scheme;
- (b) any pensioner under that scheme; and
- (c) any other person who has pension rights under that scheme;

and "membership" shall be construed accordingly;

"new scheme" means an occupational pension scheme established under paragraph 2 below;

"occupational pension scheme" has the meaning given in section 1 of the M131Pension Schemes Act 1993;

"participant", in relation to a pension scheme or a section of a pension scheme, means a person to whom pension rights are accruing under the scheme or section by virtue of his employment in a class or description of employment to which the scheme or section relates; and cognate expressions shall be construed accordingly;

"pension", in relation to any person, means a pension of any kind payable to or in respect of him, and includes a lump sum, allowance or gratuity so payable and a return of contributions, with or without interest or any other addition:

"pension rights", in relation to any person, includes—

- (a) all forms of right to or eligibility for the present or future payment of a pension to or in respect of him; and
- (b) a right of allocation in respect of the present or future payment of a pension;

"prescribed" means specified in, or determined in accordance with, an order made by the Secretary of State;

"protected person" has the meaning given by paragraph 5 below;

"the Transport Police scheme" means such one of the schemes for the provision of pensions for or in respect of persons with service as officers of the British Transport Police Force (whether or not pensions may also be provided under the scheme for or in respect of persons without such service) as the Secretary of State may by order designate as the Transport Police scheme for the purposes of this Schedule;

"trustees", in relation to any pension scheme, includes a reference to any persons who, under the rules of the scheme, are under a liability to provide pensions or other benefits but who are not trustees of the scheme.

- (2) Any reference in this Schedule to a pension scheme includes a reference to the scheme as amended under or by virtue of this Schedule.
- (3) Any power to make an order under or by virtue of this Schedule in relation to an existing scheme, the joint industry scheme, a new scheme, the Transport Police

scheme, or a designated scheme within the meaning of paragraph 10 below shall be exercisable notwithstanding that the occupational pension scheme in question only becomes such a scheme by virtue of its establishment or designation as such in the instrument which contains the order in question; and references to such schemes shall be construed accordingly.

(4) Subject to sub-paragraph (1) above, expressions used in this Schedule and in Part I F1160... of this Act have the same meaning in this Schedule as they have in that Part.

#### Establishment of new schemes

- 2 (1) The Secretary of State may by order provide for the establishment, administration and management of one or more occupational pension schemes for the provision of pensions and other benefits for or in respect of eligible persons.
  - (2) Without prejudice to the generality of sub-paragraph (1) above, an order under that sub-paragraph may make provision with respect to—
    - (a) the persons who may participate in, or otherwise be members of, the scheme;
    - (b) the making of contributions by persons participating in the scheme;
    - (c) the making of contributions by employers of persons who participate in the scheme;
    - (d) the amendment of the scheme;
    - (e) the winding up of the scheme, whether in whole or in part;
    - (f) the persons by whom any function under or relating to the scheme is to be exercisable.
  - (3) Any occupational pension scheme established under this paragraph shall be treated for all purposes as if it were a pension scheme established under an irrevocable trust.

## Amendment of existing schemes

- 3 (1) The Secretary of State may by order amend—
  - (a) the trust deed of any existing scheme;
  - (b) the rules of any such scheme; or
  - (c) any other instrument relating to the constitution, management or operation of any such scheme;

- and any reference in this Schedule to amending an existing scheme accordingly includes a reference to amending any such trust deed, rules or other instrument.
- (2) Without prejudice to the generality of sub-paragraph (1) above, an order under this paragraph may, in particular, amend an existing scheme so as to alter any provision, or so as to make provision, with respect to any of the matters specified in paragraphs (a) to (f) of paragraph 2(2) above.
- (3) An order under this paragraph shall not make any amendment to a scheme
  - which would prejudice registration of that scheme for the purposes of Part 4 of the Finance Act 2004 (pension schemes etc);
    - (b) which would prevent the scheme from being a contracted-out scheme for the purposes of Part III of the MI32Pension Schemes Act 1993 or Part III of the MI33Pension Schemes (Northern Ireland) Act 1993;
    - (c) which would to any extent deprive a member of the scheme of pension rights which accrued to him under the scheme before the coming into force of the amendment; or
    - (d) which would provide for persons who are not eligible persons to become members of the scheme.
- (4) The Secretary of State shall not make an order under this paragraph except [F1162] with the consent of] the trustees of the occupational pension scheme to which the order relates.

Transfer of pension rights and corresponding assets and liabilities

- 4 (1) Where persons with pension rights under any existing or new scheme ("the transferor scheme") are eligible to be members of another scheme ("the transferee scheme") which is either—
  - (a) an existing or new scheme, or
  - (b) the Transport Police scheme,

the Secretary of State may by order make provision for those persons to be members of the transferee scheme instead of the transferor scheme and for their pension rights under the transferor scheme to be transferred so as to become pension rights under the transferee scheme.

- (2) Where any pension rights are transferred under sub-paragraph (1) above, the Secretary of State may by order make provision for—
  - (a) such of the assets held for the purposes of the transferor scheme, and

(b) such of the liabilities under or in relation to that scheme of any employers or trustees,

as he may consider appropriate in consequence of that transfer to be correspondingly transferred so as to become assets or, as the case may be, liabilities in relation to the transferee scheme.

- (3) Where any pension rights are transferred under sub-paragraph (1) above, the Secretary of State may by order—
  - (a) impose on the trustees of the transferee scheme, or on the employer (if any) of the person whose pension rights are transferred, duties with respect to—
    - (i) the participation of that person or that employer in the scheme, or
    - (ii) the payment of contributions by that employer under the scheme, in accordance with the rules of the scheme; and
  - (b) make provision requiring any person whose approval or consent is necessary in connection with the doing of anything required to be done by virtue of an order under this paragraph to give that approval or consent.
- (4) The Secretary of State may by order make provision for the winding up of the transferor scheme, whether in whole or in part, in connection with, or in consequence of, any transfers under this paragraph.
- (5) The Secretary of State shall not make an order under this paragraph except [F1163] with the consent of] the trustees of the occupational pension schemes which are, or are to be, the transferor scheme and the transferee scheme.

Protection of pension rights: meaning of "protected perso"n

- 5 In this Schedule "protected person" means—
  - (a) any person who immediately before the passing of this Act—
    - (i) is an employee of the Board or of a subsidiary of the Board; and
    - (ii) is participating in an existing scheme;
  - (b) any person not falling within paragraph (a) above—
    - (i) who either is, immediately before the passing of this Act, an employee of the Board or of a subsidiary of the Board or has at some earlier time been such an employee;
    - (ii) who has participated in an existing scheme before the passing of this Act; and
    - (iii) who fulfils prescribed conditions;
  - (c) any person who, immediately before the passing of this Act, has pension rights under an existing scheme but is not participating in that scheme;
  - (d) any person who, after the passing of this Act, acquires pension rights—
    - (i) in consequence of the death of a person falling within paragraph (a), (b) or (c) above, and
    - (ii) by virtue of the participation of that other person in an existing scheme, or in an occupational pension scheme from which pension

rights of that person have been transferred, whether directly or indirectly, to an existing scheme.

# The powers of protection

- 6 (1) The Secretary of State may by order make provision for the purpose of protecting the interests of protected persons in respect of their pension rights.
  - (2) Without prejudice to the generality of sub-paragraph (1) above, an order under that sub-paragraph may make provision for the purpose of securing—
    - (a) that the relevant pension rights of protected persons are no less favourable as a result of—
      - (i) any amendment of an occupational pension scheme,
      - (ii) any transfer of pension rights [F1164] (whether made between occupational pension schemes or sections of an occupational pension scheme or otherwise)], or
      - (iii) any winding up of an occupational pension scheme, in whole or in part,

than they would have been apart from the amendment, transfer or winding up, as the case may be;

- (b) that a person who is a protected person by virtue of paragraph (a) or (b) of paragraph 5 above is not prevented, otherwise than by reason of either of the following events, that is to say—
  - (i) the continuity of his period of employment is broken, or
  - (ii) he voluntarily withdraws from an occupational pension scheme,
  - from participating in some occupational pension scheme and acquiring pension rights under that scheme which are no less favourable than those which would have been provided under his former scheme in accordance with the rules of that scheme as in force immediately before the coming into force of the order; or
- (c) that the employer of a person falling within paragraph (b) above is required to provide an occupational pension scheme in which the person may participate and to which pension rights of his, and assets and liabilities relating to, or representative of, those pension rights, may be transferred;

and in paragraph (b) above "former scheme", in relation to a protected person, means the existing scheme mentioned in paragraph (a) or (b), as the case may be, of paragraph 5 above.

- (3) For the purposes of this paragraph, the "relevant pension rights" of a protected person are so much of his pension rights as consist of or otherwise represent—
  - (a) in the case of a person who is a protected person by virtue of paragraph (a), (b) or (c) of paragraph 5 above, any pension rights which, immediately before the passing of this Act, he had under the existing scheme mentioned in the paragraph in question;
  - (b) in the case of a person who is a protected person by virtue of paragraph 5(a) or (b) above, any pension rights which he acquires, or has acquired, by virtue of his participation in an occupational pension scheme during the protected period in his case; and
  - (c) in the case of a person who is a protected person by virtue of paragraph (d) of paragraph 5 above, any pension rights which he acquires, or has acquired,

after the passing of this Act and in consequence of the death of the other person mentioned in the said paragraph (d) ("the deceased"), being—

- (i) pension rights under the existing scheme mentioned in that paragraph, so far as referable to pension rights which the deceased had under that scheme before the passing of this Act;
- (ii) pension rights under any occupational pension scheme, so far as referable to pension rights which, before the passing of this Act, the deceased had under the existing scheme mentioned in the said paragraph (d) and which have been transferred from that existing scheme, whether directly or indirectly; or
- (iii) pension rights under any occupational pension scheme, so far as referable to the participation of the deceased in that or any other occupational pension scheme during the protected period.
- (4) For the purposes of sub-paragraph (3) above, "the protected period" means—
  - (a) in the case of a person who is a protected person by virtue of paragraph (a) of paragraph 5 above, the period beginning with the passing of this Act and ending with whichever of the following events first occurs, that is to say—
    - (i) the continuity of the person's period of employment is broken; or
    - (ii) he voluntarily withdraws from an occupational pension scheme;
  - (b) in the case of a person who is a protected person by virtue of paragraph (b) of paragraph 5 above, a period beginning at such time as may be prescribed and ending with whichever of the following events first occurs, that is to say—
    - (i) the continuity of the person's period of employment is broken; or
    - (ii) he voluntarily withdraws from an occupational pension scheme; and
  - (c) in the case of a person who is a protected person by virtue of paragraph (d) of paragraph 5 above, the period (if any) which is the protected period in the case of the other person mentioned in the said paragraph (d).
- (5) In determining a person's relevant pension rights for the purposes of this paragraph, where the rules of a pension scheme make provision requiring pension rights which have accrued to a person to be enhanced in consequence of increases in remuneration after the accrual of the pension rights, that provision, and any enhancement resulting from it, shall be treated, so far as relating to any enhancement in consequence of increases in remuneration after the passing of this Act, as pension rights accruing at the time of the increase in remuneration in question.
- (6) An order under this paragraph may make provision for and in connection with the making of elections in a prescribed manner by protected persons for orders under this paragraph (other than orders by virtue of this sub-paragraph) not to have effect with respect to them or their surviving dependants except to such extent (if any) as may be specified in the election or subject to such conditions (if any) as may be so specified.
- (7) In sub-paragraph (6) above "surviving dependant", in relation to a protected person, means any person who may acquire, in consequence of the death of the protected person, pension rights referable to relevant pension rights of the protected person.
- (8) An order under this paragraph may make provision for such orders to cease to have effect in relation to a protected person if—
  - (a) the continuity of his period of employment is broken,
  - (b) he voluntarily withdraws from an occupational pension scheme, or

(c) he requests that his pension rights be transferred from an occupational pension scheme,

except in such circumstances or to such extent as may be prescribed.

- (9) Circumstances may be prescribed in which—
  - (a) a break in the continuity of a person's period of employment, or
  - (b) a person's voluntary withdrawal from an occupational pension scheme, shall be disregarded for prescribed purposes of this paragraph.

# Protection: supplementary provisions

- 7 (1) Without prejudice to the generality of paragraph 6 above, an order under that paragraph may impose on any person falling within sub-paragraph (2) below duties with respect to—
  - (a) the provision of a pension scheme,
  - (b) the terms of any pension scheme required to be provided by virtue of paragraph (a) above,
  - (c) the amendment, or the preservation from amendment, of a pension scheme,
  - (d) the acceptance of protected persons as members of a pension scheme,
  - (e) the acceptance (so as to become included among the property, rights and liabilities held for the purposes of a pension scheme or to which a pension scheme is subject) of property, rights and liabilities relating to, or representative of, pension rights of protected persons,
  - (f) the making or refunding of contributions,
  - (g) the purchase of annuities,
  - (h) the winding up of a pension scheme, in whole or in part,

and may make provision requiring any person whose approval or consent is necessary in connection with the doing of anything required to be done by virtue of such an order, so far as relating to matters specified in paragraphs (a) to (h) above, to give that approval or consent.

- (2) The persons mentioned in sub-paragraph (1) above are—
  - (a) any person who is or has been the employer of a protected person;
  - (b) any person who contributes to a pension scheme as an employer, whether or not he is or has been the employer of a protected person;
  - (c) the trustees of any pension scheme of which a protected person is a member or to which pension rights of a protected person may be transferred;
  - (d) any person who has power to amend or wind up a pension scheme under which a protected person has pension rights.

- (3) An order under paragraph 5 or 6 above may include provision—
  - (a) for disputes arising under the order to be referred to arbitration; or
  - (b) for provisions of the order to be enforceable on an application made to a prescribed court by the Secretary of State or by a prescribed person or a person of a prescribed description.

# Entitlement to participate in the joint industry scheme

- 8 (1) The Secretary of State may by order make provision conferring upon any person to whom this paragraph applies—
  - (a) who is participating, or who at or after the making of the order begins to participate, in the joint industry scheme, and
  - (b) who fulfils the qualifying conditions,

the right to continue to participate in the joint industry scheme, in accordance with the rules of that scheme, unless and until the termination conditions become fulfilled in the case of that person.

- (2) The persons to whom this paragraph applies are—
  - (a) any person who immediately before the passing of this Act—
    - (i) is an employee of the Board or of a subsidiary of the Board; and
    - (ii) is participating in an existing scheme; and
  - (b) any person not falling within paragraph (a) above—
    - (i) who either is, immediately before the passing of this Act, an employee of the Board or of a subsidiary of the Board or has at some earlier time been such an employee;
    - (ii) who has participated in an existing scheme before the passing of this Act; and
    - (iii) who fulfils prescribed conditions.
- (3) For the purposes of this paragraph a person fulfils the "qualifying conditions" if—
  - (a) the continuity of his period of employment has not been broken during the intervening period;
  - (b) he has not withdrawn voluntarily from an occupational pension scheme during that period; and
  - (c) he has at all times during that period been in the employment of an employer engaged in the railway industry.
- (4) In sub-paragraph (3) above, the "intervening period" means the period which begins at the passing of this Act and ends—
  - (a) at the time when the person in question begins to participate in the joint industry scheme, or
  - (b) at the coming into force of the order under this paragraph which confers upon that person the right mentioned in sub-paragraph (1) above (or which would have conferred that right upon him, had he satisfied the qualifying conditions),

whichever is the later.

- (5) The "termination conditions" become fulfilled for the purposes of this paragraph in the case of any person if—
  - (a) the continuity of his period of employment is broken;

- (b) he withdraws voluntarily from the joint industry scheme; or
- (c) he is not in the employment of any employer engaged in the railway industry.
- (6) Circumstances may be prescribed in which—
  - (a) a break in the continuity of a person's period of employment,
  - (b) a person's voluntary withdrawal from an occupational pension scheme, or
  - (c) a period during which a person is not in the employment of an employer engaged in the railway industry,

shall be disregarded for the purpose of determining whether the person fulfils the qualifying conditions or whether the termination conditions have become fulfilled in his case.

- (7) The employers who are to be regarded for the purposes of this paragraph as "engaged in the railway industry" are those who carry on activities of a class or description specified for the purposes of this sub-paragraph by the Secretary of State in an order under this paragraph; and the Secretary of State may so specify any class or description of activity which, in his opinion, falls within, or is related to or connected with, the railway industry.
- (8) An order under this paragraph may—
  - (a) impose on the trustees of the joint industry scheme, or on the employer (if any) of a person for the time being entitled to the right conferred by virtue of sub-paragraph (1) above, duties with respect to—
    - (i) the participation of that person or that employer in the scheme, or
    - (ii) the payment of contributions by that employer under the scheme,

in accordance with the rules of the scheme; and

- (b) make provision requiring any person whose approval or consent is necessary in connection with the doing of anything required to be done by virtue of an order under this paragraph to give that approval or consent.
- (9) An order under this paragraph may make provision for the purpose of preventing a person who would otherwise be entitled to the right conferred by virtue of subparagraph (1) above from continuing to participate in the joint industry scheme in circumstances where his continued participation in that scheme would in the opinion of a prescribed person—
  - (a) prejudice any approval of that scheme for the purposes of Chapter I of Part XIV of the M134 Income and Corporation Taxes Act 1988 (retirement benefit schemes); or
  - (b) prevent the scheme from being a contracted-out scheme for the purposes of Part III of the M135 Pension Schemes Act 1993 or Part III of the M136 Pension Schemes (Northern Ireland) Act 1993.
- (10) An order under this paragraph may include provision—
  - (a) for disputes arising under the order to be referred to arbitration; or
  - (b) for provisions of the order to be enforceable on an application made to a prescribed court by the Secretary of State or by a prescribed person or a person of a prescribed description.
- (11) An order under this paragraph may make provision for and in connection with the making of elections in a prescribed manner by persons who would otherwise be entitled by virtue of sub-paragraph (1) above to the right there mentioned for orders

under this paragraph (other than orders by virtue of this sub-paragraph) not to have effect with respect to them.

(12) Sub-paragraph (10) of paragraph 6 above shall have effect for the purposes of this paragraph as it has effect for the purposes of that paragraph.

Payments in discharge of liabilities under s.52(1) of the Transport Act 1980

- 9 (1) In section 52 of the M137 Transport Act 1980, in subsection (1) (which requires the Secretary of State to make payments each year to B.R. pension schemes in respect of unfunded pension obligations owed by the Board), for the words "Subject to the provisions of this section and section 58," there shall be substituted the words "Subject to the provisions of this section and sections 52A to 52D and 58,".
  - (2) After that section there shall be inserted—

# "52A Power to make payments by way of final discharge of liabilities under s.52(1).

- (1) If the Minister is desirous of making to the persons administering a B.R. pension scheme one or more payments by way of final discharge of his liability to make payments to them under section 52(1) in relation to that scheme, to the extent that that liability relates to so much of the relevant pension obligations as are owed in respect of—
  - (a) all pension rights under the scheme,
  - (b) pension rights of some particular class or description under the scheme, or
  - (c) pension rights of persons of some particular class or description under the scheme,

he may give to the persons administering the scheme a notice identifying the pension rights in question and specifying in relation to those pension rights the matters set out in subsection (2), as determined in accordance with the following provisions of this section.

- (2) The matters mentioned in subsection (1) are—
  - (a) the capital value of the attributable unfunded obligations in question, as at the beginning of the next financial year;
  - (b) the amount or amounts, or the method of determining the amount or amounts, of the payment or payments to be made under this section by way of final discharge of the Minister's liability to make payments under section 52(1), so far as relating to the pension rights identified in the notice under subsection (1); and
  - (c) the date or dates on which that payment or those payments are to be made.

- (3) In making any determination for the purposes of paragraph (b) of subsection (2), the amount or, as the case may be, the aggregate of the amounts mentioned in that paragraph shall be such as to include—
  - (a) a sum equal to the capital value determined under paragraph (a) of that subsection; and
  - (b) interest, payable at such rate as may be determined by the Minister, on so much (if any) of that sum as may from time to time be outstanding after the beginning of the financial year mentioned in the said paragraph (a).
- (4) For the purposes of this section, the capital value mentioned in paragraph (a) of subsection (2) shall either—
  - (a) be determined by the Minister, or
  - (b) if the Minister so requires in the particular case, be determined by the actuary to the scheme in question and approved by the Minister, and it shall be for the Minister to determine the matters mentioned in paragraphs (b) and (c) of that subsection.
- (5) Notice under subsection (1) above shall only be given after consultation—
  - (a) with the persons administering the scheme in question; and
  - (b) with the actuary to that scheme, except in a case where the capital value mentioned in subsection (2)(a) is determined by that actuary pursuant to subsection (4)(b);

and any such notice must be given not less than one month before the beginning of the financial year mentioned in subsection (2)(a).

- (6) The giving of a notice under subsection (1) shall—
  - (a) terminate the liability of the Minister to make payments under section 52(1), so far as relating to the pension rights identified in the notice, for financial years beginning after the giving of the notice; and
  - (b) impose upon the Minister a duty—
    - (i) to make to the persons administering the scheme in question the payment or payments mentioned in subsection (2)(b); and
    - (ii) to do so at the time or times specified in pursuance of subsection (2)(c).
- (7) Where notice has been given under subsection (1), the Minister may—
  - (a) at any time before the expiration of the period of eleven months beginning with the financial year mentioned in subsection (2)(a) as it applies in relation to that notice, and
  - (b) after consultation with the persons administering the scheme in question and the actuary to the scheme,
  - amend that notice by giving notice of the amendment to the persons administering the scheme.
- (8) If notice is given under subsection (7) of an amendment affecting the amount of a payment which has been made pursuant to this section, the Minister may also give notice to the persons administering the scheme in question requiring them—

- (a) to repay to him so much of the payment made as exceeds the amended amount; and
- (b) to pay interest to him, at such rate as he may determine, on the amount to be repaid, as from the date on which the payment in question was made by him;

and where notice is given under paragraph (a) or (b), the amount required to be repaid or, as the case may be, the amount of interest required to be paid from time to time, shall be treated as a debt due from those persons to the Minister.

# (9) In any case where—

- (a) notice has been given under subsection (1), the effect of which (whether taken alone or with other notices under that subsection) is that notice has been given under that subsection in respect of all pension rights under the scheme in question, and
- (b) for that financial year in which the notice mentioned in paragraph (a) is given, the aggregate amount of the payments made under section 52(1) in relation to the scheme requires adjustment for the reason set out in section 52(3)(a) or (b), but
- (c) the required adjustment cannot be made as mentioned in section 52(3), because (in consequence of the notice mentioned in paragraph (a)) no payments under section 52(1) fall to be made in relation to that scheme for subsequent financial years,

payments by way of adjustment, of an amount equal in the aggregate to the amount of the required adjustment, shall instead be made by the Minister to the persons administering the scheme or, as the case may require, by those persons to the Minister, before the expiration of the period of six months beginning with the date on which the amount of the required adjustment is determined.

- (10) The Minister may give a direction to the persons administering a B.R. pension scheme requiring them to furnish to him—
  - (a) information from which the proportion mentioned in section 55(1) (a) can be finally determined for the financial year mentioned in subsection (9)(b) in the case of the scheme; or
  - (b) information about any such unforeseen increase or reduction in the aggregate amount of the pensions, increases and expenses payable under or incurred in connection with the scheme for that financial year as is mentioned in section 52(3)(b).
- (11) Where payments by way of adjustment fall to be made under subsection (9), interest shall be payable from the end of the financial year in which the notice mentioned in subsection (9)(a) is given, by the person liable to make those payments, at such intervals and rates as may be determined by the Minister, on so much of the aggregate amount of the payments in question as for the time being remains unpaid.

#### (12) So much of—

- (a) any payment by way of adjustment under subsection (9) which falls to be made, or
- (b) any interest accrued under subsection (11), as has not been paid shall be treated as a debt due.

- (13) Nothing in this section affects the liability of the Board in respect of any relevant pension obligations.
- (14) For the purposes of this section, the "capital value of the attributable unfunded obligations", in the case of any B.R. pension scheme, means such amount as is, in the opinion of the person determining that capital value pursuant to subsection (4), the capital equivalent of the payments that would, apart from this section, have been expected to be made by the Minister under section 52(1), so far as relating to the pension rights identified in the notice under subsection (1), for the successive financial years beginning with the one mentioned in subsection (2)(a).
- (15) Any sums required for the making of payments under this section by the Minister shall be paid out of money provided by Parliament.".
- (3) After the section 52A inserted by sub-paragraph (2) above, there shall be inserted—

# "52B Power to substitute obligations under this section for liabilities under s.52(1).

- (1) The Minister may make a substitution order in relation to any occupational pension scheme—
  - (a) which is a new scheme, within the meaning of Schedule 11 to the Railways Act 1993;
  - (b) which is designated under paragraph 10(1) of that Schedule (designation of schemes which are to be treated as B.R. pension schemes for certain purposes of this Part); and
  - (c) in relation to which a guarantee has been given by the Secretary of State under paragraph 11 of that Schedule;

and any reference in this section to a "guaranteed pension scheme" is a reference to such an occupational pension scheme.

- (2) The Minister may also make a substitution order in relation to any section of a new scheme, within the meaning of Schedule 11 to the Railways Act 1993, if the section is one—
  - (a) which is designated under paragraph 10(1) of that Schedule; and
  - (b) in relation to which a guarantee has been given by the Secretary of State under paragraph 11 of that Schedule;

and the following provisions of this section (and sections 52C and 52D) shall apply in relation to any such section of a new scheme as if any reference to a guaranteed pension scheme included a reference to such a section.

- (3) For the purposes of this section, a "substitution order" is an order under this section the effect of which is—
  - (a) to terminate, from the termination date, the Minister's liability to make to the persons administering the guaranteed pension scheme in question payments under section 52(1) in relation to the scheme; and
  - (b) to impose on the Minister, in substitution for that liability, an obligation to make to those persons, subject to and in accordance with the following provisions of this section, one or more other payments (the "substitution payments") in relation to that scheme.

- (4) Subject to the following provisions of this section, the amount of the substitution payments to be made in the case of a guaranteed pension scheme shall be equal in the aggregate to the sum of—
  - (a) the amount specified pursuant to subsection (5)(a) as the capital value of the unfunded obligations in the case of the scheme; and
  - (b) the aggregate amount of any interest which is dealt with as mentioned in subsection (8)(b)(ii) in the case of the scheme.
- (5) A substitution order must specify—
  - (a) the capital value of the unfunded obligations in the case of the guaranteed pension scheme in question, as at the termination date; and
  - (b) the date which, for the purposes of this section, is to be the termination date in relation to that scheme, being a date not earlier than one month after the coming into force of the substitution order.
- (6) Any determination for the purposes of this section of the capital value of the unfunded obligations in the case of a guaranteed pension scheme shall either—
  - (a) be made by the Minister; or
  - (b) if the Minister so requires in the particular case, be made by the actuary to the guaranteed pension scheme in question and approved by the Minister.
- (7) A substitution order may specify—
  - (a) the amount or amounts, or the method of determining the amount or amounts, of the substitution payments,
  - (b) the date or dates on which the substitution payments are to be made,
  - (c) circumstances (which may, if the Minister so desires, be defined by reference to the opinion of any person) in which substitution payments are to be made,

and may provide for the obligation to make substitution payments to be discharged if the guaranteed pension scheme in question has, in the opinion of a person specified or described in, or nominated under, the order, been wound up.

- (8) A substitution order must provide—
  - (a) for interest to accrue from the termination date on the outstanding balance of the capital value for the time being at such rate, and at such intervals, as may be specified in, or determined under or in accordance with, the order; and
  - (b) for any such interest which accrues—
    - (i) to be paid to the persons administering the guaranteed pension scheme in question, or
    - (ii) to be added to the outstanding balance of the capital value, (or to be dealt with partly in one of those ways and partly in the other);

and the provision that may be made by virtue of paragraph (a) includes provision for the rate of interest to be calculated by reference to any variable or to be such rate as the Minister may from time to time determine and specify in a notice to the persons administering the scheme in question.

- (9) For the purposes of subsection (8), the "outstanding balance of the capital value", in the case of a guaranteed pension scheme, means the capital value of the unfunded obligations in the case of the scheme, as specified pursuant to subsection (5)(a),—
  - (a) reduced by the amount of any substitution payments made in relation to that scheme; and
  - (b) increased by any additions of accrued interest under or by virtue of subsection (8)(b)(ii) in relation to that scheme.
- (10) Nothing in this section affects the liability of the Board in respect of any relevant pension obligations.
- (11) Any sums required for the making of payments under this section by the Minister shall be paid out of money provided by Parliament.
- (12) In this section—

"the capital value of the unfunded obligations", in the case of any guaranteed pension scheme, means such amount as is, in the opinion of the person determining that capital value pursuant to subsection (6), the capital equivalent of the payments that would, apart from this section, have been expected to be made by the Minister under section 52(1) in relation to that scheme after the termination date in the case of that scheme;

"occupational pension scheme" means an occupational pension scheme as defined in section 1 of the M138 Pension Schemes Act 1993; "the terminal period", in the case of any guaranteed pension scheme, means—

- (a) if a financial year of the scheme ends with the termination date, that financial year; or
- (b) in any other case, so much of the financial year of the scheme in which the termination date falls as ends with that date;

"the termination date", in the case of any guaranteed pension scheme, shall be construed in accordance with subsection (5)(b);

"the termination year", in the case of any guaranteed pension scheme, means the financial year of the scheme which consists of or includes the terminal period;

"trustees", in relation to a guaranteed pension scheme, includes a reference to any persons who, under the rules of the scheme, are under a liability to provide pensions or other benefits but who are not trustees of the scheme.

#### 52C Adjustments arising in connection with orders under s.52B.

- (1) As soon as practicable after the termination date in the case of any guaranteed pension scheme, there shall be determined, for the terminal period, what proportion of the pensions, increases and expenses payable under, or incurred in connection with, the scheme corresponds to the relevant pension obligations.
- (2) Any determination under subsection (1) shall either—
  - (a) be made by the Minister; or

- (b) if the Minister so requires in the particular case, be made by the actuary or auditor to the guaranteed pension scheme in question and approved by the Minister.
- (3) The Minister may give a direction to the persons administering a guaranteed pension scheme requiring them to determine the aggregate amount of the pensions, increases and expenses payable under or incurred in connection with the scheme for the terminal period or the termination year and to notify him in writing of their determination.
- (4) As respects the termination year of a guaranteed pension scheme, the extent of the liability of the Minister to make payments under section 52(1) in relation to that scheme shall be restricted to a liability to make payments of an amount (the "termination year amount") equal in the aggregate to the product of—
  - (a) the proportion determined under section 54(1) for that scheme;
  - (b) the proportion determined pursuant to subsection (1) in the case of that scheme; and
  - (c) the aggregate amount of the pensions, increases and expenses payable under or incurred in connection with that scheme in the terminal period;

and payments by way of adjustment shall be made by the Minister to the persons administering the scheme, or (as the case may be) by those persons to the Minister, before the expiration of the period of six months beginning with the date of the last of the determinations made under subsection (1) or (3) with respect to the scheme.

- (5) Where, in the case of a guaranteed pension scheme, the funding of the relevant pension obligations has, by virtue of subsection (3) of section 54, been left out of account in making a determination under subsection (1) of that section, the termination year amount in the case of that scheme shall be the difference between—
  - (a) what that amount would have been, apart from this subsection; and
  - (b) the amount of any income accruing for the terminal period which may be applied towards the payment of such of the pensions, increases and expenses payable under or incurred in connection with the scheme as correspond to those obligations.
- (6) The Minister may give a direction to the persons administering a guaranteed pension scheme requiring them to determine the amount mentioned in subsection (5)(b) and to notify him in writing of their determination.
- (7) Where payments by way of adjustment fall to be made, interest shall be payable, as from the termination date, by the person liable to make those payments, at the rates and intervals from time to time applicable for the purposes of section 52B(8)(a) in the case of the scheme in question, on so much of the aggregate amount of the payments in question as for the time being remains unpaid.
- (8) So much of—
  - (a) any payment by way of adjustment which falls to be made, or
  - (b) any interest accrued under subsection (7),

as has not been paid shall be treated as a debt due.

- (9) Any sums required for the making of payments under this section by the Minister shall be paid out of money provided by Parliament.
- (10) In this section, "payments by way of adjustment", in the case of a guaranteed pension scheme, means—
  - (a) if the Minister has made payments under section 52(1) in relation to that scheme for the termination year which, in the aggregate, exceed the termination year amount, payment to the Minister by the persons administering the scheme of an amount equal to the excess;
  - (b) if the Minister has made no payments under section 52(1) in relation to that scheme for the termination year, payment by the Minister to those persons of the termination year amount; or
  - (c) if the Minister has made payments under section 52(1) in relation to that scheme for the termination year which, in the aggregate, fall short of the termination year amount, payment by the Minister to those persons of an amount equal to the shortfall.
- (11) Expressions used in this section and in section 52B have the same meaning in this section as they have in that section.

# 52D Orders and directions under sections 52A to 52C: supplemental.

- (1) Any power to make an order under section 52B shall be exercisable by statutory instrument made by the Minister after consultation with the trustees of the guaranteed pension scheme to which the order relates.
- (2) A statutory instrument containing an order under section 52B shall be subject to annulment in pursuance of a resolution of either House of Parliament.
- (3) At the time when a statutory instrument containing an order under section 52B is laid before each House of Parliament pursuant to subsection (2), the Minister shall, if he has not already done so, also lay before each House of Parliament a copy of the guarantee mentioned in subsection (1)(c) of that section; but this subsection is without prejudice to the validity of the order in question.
- (4) Any power to make an order under section 52B includes power, exercisable in the same manner, to make such incidental, supplemental, consequential or transitional provision as may appear necessary or expedient to the Minister.
- (5) Any order under section 52B may make different provision for different cases or for different classes or descriptions of case.
- (6) It shall be the duty of any person to whom a direction is given under section 52A or 52C to comply with and give effect to that direction; and compliance with any such direction shall be enforceable by civil proceedings by the Minister for an injunction or interdict or for any other appropriate relief.
- (7) Any power to give a direction under section 52A or 52C includes power to vary or revoke the direction.
- (8) Any direction under section 52A or 52C shall be given in writing.
- (9) In this section—

# Application and modification of Part III of the 1980 Act

- 10 (1) The Secretary of State may by order designate—
  - (a) any occupational pension scheme which would not, apart from this paragraph, be included among the pension schemes which are B.R. pension schemes for the purposes of Part III of the 1980 Act, or
  - (b) any section of an occupational pension scheme, being a section which would not, apart from this paragraph, be included among those schemes,

as a pension scheme which is to be treated as included among those schemes for the purpose of requiring or enabling him to make to the persons administering the scheme payments under section 52(1), 52A, 52B or 52C of that Act in respect of qualifying pension rights transferred (whether under paragraph 4 above or otherwise) so as to become pension rights under that scheme.

- (2) An order under sub-paragraph (1) above may make provision, in any case where qualifying pension rights of any persons are, or are to be, transferred as mentioned in that sub-paragraph, for treating those persons as constituting a section of the occupational pension scheme to which those qualifying pension rights are, or are to be, so transferred.
- (3) No order shall be made under sub-paragraph (1) above except after consultation with the trustees of the occupational pension scheme to which the qualifying pension rights are, or are to be, transferred.
- (4) Subject to the following provisions of this paragraph, Part III of the 1980 Act shall have effect as if any reference in that Part to a B.R. pension scheme included a reference to a designated scheme.
- (5) Where qualifying pension rights are transferred to a designated scheme as mentioned in sub-paragraph (1) above, the proportion referred to in section 52(1)(a) of the 1980 Act in its application by virtue of this paragraph in relation to the designated scheme shall, instead of being determined under section 54 of that Act, be taken to be the proportion which has been determined under that section in relation to the

- B.R. pension scheme from which the qualifying pension rights are transferred; and references in Part III of that Act to that proportion shall be construed accordingly.
- (6) In the application of Part III of the 1980 Act in relation to a designated scheme, references in that Part to "the relevant pension obligations" shall, in relation to the designated scheme, be construed—
  - (a) as if the reference in section 53(1)(a) of that Act to obligations of the Board which were owed on 1st January 1975 in connection with the scheme were a reference to so much of the obligations of the Board which were owed on that date in connection with a B.R. pension scheme as are obligations in respect of qualifying pension rights transferred to the designated scheme; and
  - (b) as if the reference in section 53(1)(c) of that Act to an obligation F1166... arising after that date to pay or secure the payment of increases payable under the scheme included a reference to so much of any such obligation F1166... in respect of a B.R. pension scheme as is an obligation in respect of qualifying pension rights transferred to the designated scheme.
- (7) In the application of section 55 of the 1980 Act in relation to a designated scheme, paragraph (a) of subsection (1) (which requires the proportion of the scheme's outgoings which corresponds to the relevant pension obligations to be determined before the beginning of each financial year or, in the case of the first financial year, as soon as practicable after the passing of that Act) shall be taken to require the proportion mentioned in that paragraph to be determined—
  - (a) before the beginning of the financial year in question, or
  - (b) as soon as practicable after the coming into force of the order under subparagraph (1) above by virtue of which the scheme in question is a designated scheme,

and paragraph (b) of that subsection shall be construed accordingly.

- (8) The power to give a direction under section 57 of the 1980 Act (which provides for certain determinations to be made as if no transfer had taken place and as if no payment representing the pension rights in question had been made) shall be exercisable in any case where the whole or any part of a person's accrued pension rights under a B.R. pension scheme or a designated scheme are transferred (whether under paragraph 4 above or otherwise) to—
  - (a) a designated scheme, or
  - (b) a pension scheme established by the Board,

as it is in the case of any such transfer as is mentioned in that section.

- (9) Without prejudice to sub-paragraph (8) above, where in any financial year the whole or any part of a person's accrued pension rights under a B.R. pension scheme are transferred to a designated scheme, it shall be assumed, for the purposes of any determination of the aggregate amount of the pensions, increases and expenses payable under or incurred in connection with the B.R. pension scheme in that financial year, that the payment of any sum representing those pension rights had not been made.
- (10) Without prejudice to section 59(1) of the 1980 Act (which provides that the making of payments under section 52(1) does not discharge certain relevant pension obligations), the making of any payment under section 52(1) of the 1980 Act to the persons administering a designated scheme shall not discharge any relevant pension obligation, so far as it is an obligation to pay pensions or increases of pensions

under that or any other designated scheme, or under a B.R. pension scheme, or is an obligation to secure the payment of those pensions or increases.

- (11) Without prejudice to section 59(2) of the 1980 Act (power to amend pension scheme for certain purposes), if the persons administering an occupational pension scheme would not otherwise have power to do so, they may amend the scheme by instrument in writing for the purpose of enabling persons to be admitted as members of the scheme on the basis that payments will fall to be made under Part III of the 1980 Act in respect of qualifying pension rights of theirs which are transferred so as to become pension rights under the scheme.
- (12) Where the persons administering an occupational pension scheme have power, apart from sub-paragraph (11) above, to amend the scheme for the purpose mentioned in that sub-paragraph, they may exercise that power for that purpose without regard to any limitations on the exercise of the power and without compliance with any procedural provisions applicable to its exercise.
- (13) Any reference in Part III of the 1980 Act to a "financial year" shall, in relation to a designated scheme, be taken as a reference—
  - (a) to such period as—
    - (i) begins with the transfer of the qualifying pension rights in question, and
    - (ii) ends with the last day of an accounting year of the scheme, and is a period of not less than twelve months and less than two years; and
  - (b) to each successive accounting year of that scheme.
- (14) Where any provision of Part III of the 1980 Act requires anything to be done in, or in relation to, the first financial year of a B.R. pension scheme, that provision shall (so far as so requiring) be disregarded in the application of that Part in relation to a designated scheme.
- (15) In any case where—
  - (a) the whole or any part of a person's accrued pension rights under a B.R. pension scheme are transferred so as to become pension rights under a designated scheme, and
  - (b) immediately before that transfer takes effect, relevant pension obligations a proportion of which, as determined for the purposes of section 52(1)(a) of the 1980 Act, has not been funded are owed in respect of those pension rights by the [F1167] Authority] to the persons administering the pension scheme from which the pension rights are so transferred,

an order under sub-paragraph (1) above may provide for the benefit of that proportion of so much of those relevant pension obligations as are owed in respect of those pension rights to be transferred, so as to become relevant pension obligations owed by the [FI167] Authority] to the persons administering the pension scheme to which the pension rights are transferred.

(16) Where the benefit of any relevant pension obligations is transferred by virtue of sub-paragraph (15) above, the persons administering the pension scheme to which the benefit of those obligations is transferred shall have, in relation to the relevant pension obligations the benefit of which is so transferred, all the rights of the persons administering the pension scheme from which the benefit of those obligations is transferred.

# (17) In this paragraph—

"the 1980 Act" means the M139 Transport Act 1980;

"designated scheme" means an occupational pension scheme or, as the case may be, a section of any such scheme, which is designated under subparagraph (1) above;

"pension scheme" includes a section of a pension scheme;

"qualifying pension rights" means any pension rights as respects the whole or some part of which there are subsisting relevant pension obligations a proportion of which, as determined for the purposes of section 52(1)(a) of the 1980 Act, has not been funded;

and, subject to that, expressions used in this paragraph and in Part III of the 1980 Act have the same meaning in this paragraph as they have in that Part.

#### Government guarantees to trustees of certain new schemes

- 11 (1) Subject to the following provisions of this paragraph, the Secretary of State—
  - (a) shall give to the trustees of any new scheme which satisfies the conditions in sub-paragraph (3) below, and

- (i) participants in the scheme to whom pension rights under the scheme are accruing by virtue of their employment with a relevant employer; or
- (ii) pensioners or deferred pensioners under the scheme whose pension rights under the scheme derive in whole or in part from their, or some other person's, participation in an occupational pension scheme as an employee of a relevant employer.
- (5) Classes or descriptions of person may be prescribed whose membership of, or participation in, a new scheme is to be disregarded for the purpose of determining whether the new scheme satisfies the conditions in sub-paragraph (3) or (4) above.
- (6) The power to give a guarantee under sub-paragraph (1)(b) above becomes exercisable in the case of any new scheme if the Secretary of State is of the opinion that it is desirable to give such a guarantee for the purpose of ensuring that the trustees of the scheme are, or will be, able to meet their liabilities to make payments in respect of pension rights under the scheme as those liabilities fall to be met.
- (7) The Secretary of State shall consider any representations made by the trustees of a new scheme which satisfies the conditions in sub-paragraph (4) above concerning their ability to meet their liabilities to make payments in respect of pension rights under the scheme.
- (8) Any guarantee under this paragraph shall be given in such manner, and on such terms and conditions, as the Secretary of State may, after consultation with the trustees of, and the actuary to, the scheme in question, think fit; and, without prejudice to the generality of the foregoing provisions of this sub-paragraph, the terms and conditions on which a guarantee under this paragraph may be given include terms and conditions—
  - (a) with respect to any matter relating to payment under the guarantee, including—
    - (i) the circumstances in which payment under the guarantee falls to be made;
    - (ii) the amounts, or the method of determining the amounts, of any payments that fall to be so made;
    - (iii) the persons to whom any such payments are to be made;
  - (b) with respect to any matter relating to the management, affairs or winding up of the scheme, including—
    - (i) the policy to be followed in relation to the investment of assets held for the purposes of the scheme; and
    - (ii) the distribution of any surplus which may arise under the scheme; or
  - (c) requiring or precluding, or otherwise with respect to, amendment of the rules of the scheme;

and the sub-paragraphs of paragraphs (a) and (b) above are without prejudice to the generality of the preceding provisions of the paragraph in question.

    - (b) which are designated by those trustees as comments which they wish the Secretary of State to consider as comments on that order; and
    - (c) which have been received by the Secretary of State before the expiration of such period as has been notified by him to those trustees as being the consultation period in relation to the order in question;

but this sub-paragraph is without prejudice to the validity of the order in question.
