# **1995 CHAPTER 18**

# E+W+S

An Act to provide for a jobseeker's allowance and to make other provision to promote the employment of the unemployed and the assistance of persons without a settled way of life. [28th June 1995]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

# PART I E+W+S

## THE JOBSEEKER'S ALLOWANCE

# Entitlement

# 1 The jobseeker's allowance. E+W+S

- (1) An allowance, to be known as a jobseeker's allowance, shall be payable in accordance with the provisions of this Act.
- (2) Subject to the provisions of this Act, a claimant is entitled to a jobseeker's allowance if he—
  - (a) [F1 is available for employment;]
  - (b) [F2has entered into a jobseeker's agreement which remains in force;]
  - (c) [F3 is actively seeking employment;]
  - $[F^4(d)]$  satisfies the conditions set out in section 2;
    - (e) is not engaged in remunerative work;
  - [F5(f) does not have limited capability for work;]
    - (g) is not receiving relevant education;

- (h) is under pensionable age; and
- (i) is in Great Britain.
- [<sup>F6</sup>(2A) [<sup>F7</sup>Subject to the provisions of this Act, a claimant who is not a member of a joint-claim couple is entitled to a jobseeker's allowance if he satisfies—
  - (a) the conditions set out in paragraphs (a) to (c) and (e) to (i) of subsection (2); and
  - (b) the conditions set out in section 3.]
  - (2B) [F7Subject to the provisions of this Act, a joint-claim couple are entitled to a jobseeker's allowance if—
    - (a) a claim for the allowance is made jointly by the couple;
    - (b) each member of the couple satisfies the conditions set out in paragraphs (a) to (c) and (e) to (i) of subsection (2); and
    - (c) the conditions set out in section 3A are satisfied in relation to the couple.]
  - (2C) [F7Regulations may prescribe circumstances in which subsection (2A) is to apply to a claimant who is a member of a joint-claim couple.]
  - (2D) [F7Regulations may, in respect of cases where a person would (but for the regulations) be a member of two or more joint-claim couples, make provision for only one of those couples to be a joint-claim couple; and the provision which may be so made includes provision for the couple which is to be the joint-claim couple to be nominated—
    - (a) by the persons who are the members of the couples, or
    - (b) in default of one of the couples being so nominated, by the Secretary of State.]]
    - (3) A jobseeker's allowance is payable in respect of a week.
    - (4) [F8 In this Act—

"a contribution-based jobseeker's allowance" means a jobseeker's allowance entitlement to which is based on the claimant's satisfying conditions which include those set out in section 2; <sup>F9</sup>...

"an income-based jobseeker's allowance" means a jobseeker's allowance entitlement to which is based on the claimant's satisfying conditions which include those set out in section 3 [F10 or a joint-claim jobseeker's allowance;]

[F11" a joint-claim couple" means a [F12 couple] who—

- (a) are not members of any family whose members include a person in respect of whom a member of the couple is entitled to child benefit, and
- (b) are of a prescribed description;

"a joint-claim jobseeker's allowance" means a jobseeker's allowance entitlement to which arises by virtue of subsection (2B).]]

# 2 The contribution-based conditions. E+W+S

- (1) The conditions referred to in [F13 section 1(2)(d)] are that the claimant—
  - (a) has actually paid Class 1 contributions in respect of one ("the base year") of the last two complete years before the beginning of the relevant benefit year and satisfies the additional conditions set out in subsection (2);
  - (b) has, in respect of the last two complete years before the beginning of the relevant benefit year, either paid Class 1 contributions or been credited with earnings and satisfies the additional condition set out in subsection (3);
  - (c) does not have earnings in excess of the prescribed amount; and
  - (d) is not entitled to income support.
- (2) The additional conditions mentioned in subsection (1)(a) are that—
  - (a) the contributions have been paid before the week for which the jobseeker's allowance is claimed;
  - [F14(b)] the claimant's relevant earnings for the base year upon which primary Class 1 contributions have been paid or treated as paid are not less than the base year's lower earnings limit multiplied by 26.]
- [F15(2A) Regulations may make provision for the purposes of subsection (2)(b) for determining the claimant's relevant earnings for the base year.
  - (2B) Regulations under subsection (2A) may, in particular, make provision—
    - (a) for making that determination by reference to the amount of a person's earnings for periods comprised in the base year;
    - (b) for determining the amount of a person's earnings for any such period by—
      - (i) first determining the amount of the earnings for the period in accordance with regulations made for the purposes of section 3(2) of the Benefits Act, and
      - (ii) then disregarding so much of the amount found in accordance with sub-paragraph (i) as exceeded the base year's lower earnings limit (or the prescribed equivalent).]
    - (3) The additional condition mentioned in subsection (1)(b) is that the earnings factor derived [F16 from so much of the claimant's earnings as did not exceed the upper earnings limit and] upon which primary Class 1 contributions have been paid or treated as paid or from earnings credited is not less, in each of the two complete years, than the lower earnings limit for the year multiplied by 50.
- [F17(3A) Where primary Class 1 contributions have been paid or treated as paid on any part of a person's earnings, [F18subsection (3)] above shall have effect as if such contributions had been paid or treated as paid on so much of the earnings as did not exceed the upper earnings limit.]

- (3C) In subsection (3B)—

"the first set of conditions" means the condition set out in subsection (1)

(a) and the additional conditions set out in subsection (2);

"benefit" means-

- (za) [F20universal credit,]
- (a) any benefit within the meaning of section 122(1) of the Benefits Act,
- (b) any benefit under Parts 7 to 12 of the Benefits Act,
- (c) credits under regulations under section 22(5) of the Benefits Act,
- (d) a [F21 contribution-based] jobseeker's allowance, and
- (e) working tax credit.]

# The income-based conditions. E+W+S

[F22(1) The conditions referred to in [F23section 1(2A)(b)] are that the claimant—

# 4 Amount payable by way of a jobseeker's allowance. E+W+S

# 5 Duration of a [F43 contribution-based] jobseeker's allowance. E+W+S

- (1) The period for which a person is entitled to a [F44contribution-based] jobseeker's allowance shall not exceed, in the aggregate, 182 days in any period for which his entitlement is established by reference (under section 2(1)(b)) to the same two years.
- (2) The fact that a person's entitlement to a [F45 contribution-based] jobseeker's allowance ("his previous entitlement") has ceased as a result of subsection (1), does not prevent his being entitled to a further [F45 contribution-based] jobseeker's allowance if—
  - (a) he satisfies the contribution-based conditions; and
  - (b) the two years by reference to which he satisfies those conditions includes at least one year which is later than the second of the two years by reference to which his previous entitlement was established.
- (3) Regulations may provide that a person who would be entitled to a [F46contribution-based] jobseeker's allowance but for the operation of prescribed provisions of, or made under, this Act shall be treated as if entitled to the allowance for the purposes of this section.

# [F476A Claimant commitment E+W+S

- (1) A claimant commitment is a record of a claimant's responsibilities in relation to an award of a jobseeker's allowance.
- (2) A claimant commitment is to be prepared by the Secretary of State and may be reviewed and updated as the Secretary of State thinks fit.
- (3) A claimant commitment is to be in such form as the Secretary of State thinks fit.
- (4) A claimant commitment is to include—
  - (a) a record of the requirements that the claimant must comply with under this Act (or such of them as the Secretary of State considers it appropriate to include),
  - (b) any prescribed information, and
  - (c) any other information the Secretary of State considers it appropriate to include.
- (5) For the purposes of this Act a claimant accepts a claimant commitment if, and only if, the claimant accepts the most up-to-date version of it in such manner as may be prescribed.

# 6B Work-focused interview requirement E+W+S

- (1) In this Act a "work-focused interview requirement" is a requirement that a claimant participate in one or more work-focused interviews as specified by the Secretary of State.
- (2) A work-focused interview is an interview for prescribed purposes relating to work or work preparation.
- (3) The purposes which may be prescribed under subsection (2) include in particular that of making it more likely in the opinion of the Secretary of State that the claimant will obtain paid work (or more paid work or better-paid work).
- (4) The Secretary of State may specify how, when and where a work-focused interview is to take place.

# 6C Work preparation requirement E+W+S

- (1) In this Act a "work preparation requirement" is a requirement that a claimant take particular action specified by the Secretary of State for the purpose of making it more likely in the opinion of the Secretary of State that the claimant will obtain paid work (or more paid work or better-paid work).
- (2) The Secretary of State may under subsection (1) specify the time to be devoted to any particular action.
- (3) Action which may be specified under subsection (1) includes in particular—
  - (a) attending a skills assessment;
  - (b) improving personal presentation;
  - (c) participating in training;
  - (d) participating in an employment programme;
  - (e) undertaking work experience or a work placement;
  - (f) developing a business plan;
  - (g) any action prescribed for the purpose in subsection (1).

## 6D Work search requirement E+W+S

- (1) In this Part a "work search requirement" is a requirement that a claimant take—
  - (a) all reasonable action, and
  - (b) any particular action specified by the Secretary of State,

for the purpose of obtaining paid work (or more paid work or better-paid work).

- (2) The Secretary of State may under subsection (1)(b) specify the time to be devoted to any particular action.
- (3) Action which may be specified under subsection (1)(b) includes in particular—
  - (a) carrying out work searches;
  - (b) making applications;
  - (c) creating and maintaining an online profile;
  - (d) registering with an employment agency;
  - (e) seeking references;
  - (f) any other action prescribed for the purpose in subsection (1).

# 6E Work availability requirement E+W+S

- (1) In this Act a "work availability requirement" is a requirement that a claimant be available for work.
- (2) For the purposes of this section "available for work" means able and willing immediately to take up paid work (or more paid work or better-paid work).
- (3) Regulations may impose limitations on a work availability requirement by reference to the work to which it relates; and the Secretary of State may in any particular case specify further such limitations on such a requirement.
- (4) A limitation under subsection (3) may in particular be by reference to—
  - (a) work of a particular nature,
  - (b) work with a particular level of remuneration,
  - (c) work in particular locations, or
  - (d) work available for a certain number of hours per week or at particular times, and may be indefinite or for a particular period.
- (5) Regulations may for the purposes of subsection (2) define what is meant by able and willing immediately to take up work.

# 6F Imposition of work-related requirements E+W+S

- (1) The Secretary of State must, except in prescribed circumstances, impose on a claimant—
  - (a) a work search requirement, and
  - (b) a work availability requirement.
- (2) The Secretary of State may, subject to this Act, impose either or both of the following on a claimant—
  - (a) a work-focused interview requirement;
  - (b) a work preparation requirement.

# 6G Connected requirements E+W+S

- (1) The Secretary of State may require a claimant to participate in an interview for any purpose relating to—
  - (a) the imposition of a work-related requirement on the claimant;
  - (b) verifying the claimant's compliance with a work-related requirement;

  - (a) provide to the Secretary of State information and evidence specified by the Secretary of State in a manner so specified;
  - (b) confirm compliance in a manner so specified.
- (4) The Secretary of State may require a claimant to report to the Secretary of State any specified changes in their circumstances which are relevant to—
  - (a) the imposition of work-related requirements on the claimant;
  - (b) the claimant's compliance with a work-related requirement.

# 6H Imposition of work-related and connected requirements: supplementary E+W

- (1) Regulations may make provision—
  - (a) where the Secretary of State may impose a requirement under the preceding provisions of this Act, as to when the requirement must or must not be imposed;
  - (b) where the Secretary of State may specify any action to be taken in relation to a requirement under the preceding provisions of this Act, as to what action must or must not be specified;
  - (c) where the Secretary of State may specify any other matter in relation to a such requirement, as to what must or must not be specified in respect of that matter.
- (2) Where the Secretary of State may impose a work-focused interview requirement, or specify a particular action under section 6C(1) or 6D(1)(b), the Secretary of State must have regard to such matters as may be prescribed.
- (3) Where the Secretary of State may impose a requirement under the preceding provisions of this Act, or specify any action to be taken in relation to such a requirement, the Secretary of State may revoke or change what has been imposed or specified.
- (4) Notification of a requirement imposed under the preceding provisions of this Act (or any change to or revocation of such a requirement) is, if not included in the claimant commitment, to be in such manner as the Secretary of State may determine.
- (5) Regulations must make provision to secure that, in prescribed circumstances, where a claimant has recently been a victim of domestic violence—
  - (a) a requirement imposed on the claimant under the preceding provisions of this Act ceases to have effect for a period of 13 weeks, and
  - (b) the Secretary of State may not impose any other requirement on the claimant during that period.

# 6I Compliance with work-related and connected requirements E+W+S

Regulations may make provision as to circumstances in which a claimant is to be treated as having—

- (a) complied with or not complied with any requirement imposed under the preceding provisions of this Act or any aspect of such a requirement, or
- (b) taken or not taken any particular action specified by the Secretary of State in relation to such a requirement.

# 6J Higher-level sanctions E+W+S

- (1) The amount of an award of jobseeker's allowance is to be reduced in accordance with this section in the event of a failure by a claimant which is sanctionable under this section.
- (2) It is a failure sanctionable under this section if a claimant—
  - (a) fails for no good reason to comply with a requirement imposed by the Secretary of State under a work preparation requirement to undertake a work placement of a prescribed description;
  - (b) fails for no good reason to comply with a requirement imposed by the Secretary of State under a work search requirement to apply for a particular vacancy for paid work;
  - (c) fails for no good reason to comply with a work availability requirement by not taking up an offer of paid work;
  - (d) by reason of misconduct, or voluntarily and for no good reason, ceases paid work or loses pay.
- (3) It is a failure sanctionable under this section if, at any time before making the claim by reference to which the award is made, the claimant—
  - (a) for no good reason failed to take up an offer of paid work, or
  - (b) by reason of misconduct, or voluntarily and for no good reason, ceased paid work or lost pay.
- (4) For the purposes of subsections (2) and (3) regulations may provide—
  - (a) for circumstances in which ceasing to work or losing pay is to be treated as occurring or not occurring by reason of misconduct or voluntarily;
  - (b) for loss of pay below a prescribed level to be disregarded.
- (5) Regulations are to specify—
  - (a) the amount of a reduction under this section;
  - (b) the period for which such a reduction has effect, not exceeding three years in relation to any failure sanctionable under this section.
- (6) Regulations under subsection (5)(b) may in particular provide for the period of a reduction to depend on either or both of the following—

- (7) A compliance condition specified under subsection (5)(a) may be—
  - (a) revoked or varied by the Secretary of State;
  - (b) notified to the claimant in such manner as the Secretary of State may determine.
- (8) A period fixed under subsection (5)(b) may in particular depend on either or both the following—
  - (a) the number of failures by the claimant sanctionable under this section;
  - (b) the period between such failures.

  - (a) for cases in which no reduction is to be made under this section;

# 6L Delegation and contracting out E+W+S

  - (a) wholly or to a limited extent;

- (4) Anything done or omitted to be done by or in relation to an authorised person (or an employee of that person) in, or in connection with, the exercise or purported exercise of the function concerned is to be treated for all purposes as done or omitted to be done by or in relation to the Secretary of State or (as the case may be) an officer of the Secretary of State.
- (5) Subsection (4) does not apply—
  - (a) for the purposes of so much of any contract made between the authorised person and the Secretary of State as relates to the exercise of the function, or
  - (b) for the purposes of any criminal proceedings brought in respect of anything done or omitted to be done by the authorised person (or an employee of that person).
- (6) Where—
  - (a) the authorisation of an authorised person is revoked, and
  - (b) at the time of the revocation so much of any contract made between the authorised person and the Secretary of State as relates to the exercise of the function is subsisting,

the authorised person is entitled to treat the contract as repudiated by the Secretary of State (and not as frustrated by reason of the revocation).]

- (5) Regulations under subsection (4) may, in particular, provide for a person who is actively seeking employment—
  - (a) only in his usual occupation,
  - (b) only at a level of remuneration not lower than that which he is accustomed to receive, or
  - (c) only in his usual occupation and at a level of remuneration not lower than that which he is accustomed to receive,

to be treated, for the permitted period determined in his case for the purposes of section 6(5), as actively seeking employment during that period.

- (6) Regulations may provide for this section, and any regulations made under it, to have effect in relation to a person who has reached the age of 16 but not the age of 18 as if "employment" included "training".
- (7) Where it has been determined [F52("the first determination")] that a person is to be treated, for the purposes of this Act, as actively seeking employment in any week, the question whether he is actively seeking employment in that week may subsequently be determined [F53 under section 9 or 10 of the Social Security Act 1998].

# [F7911 Jobseeker's agreement: reviews and appeals. E+W+S

(1) Any determination of, or direction given by, an adjudication officer under section 9 or 10 may be reviewed (by a different adjudication officer) on the application of the claimant or of an employment officer.

- (3) The claimant may appeal to a social security appeal tribunal against any determination of, or direction given by, an adjudication officer on a review under this section.
- (4) A social security appeal tribunal determining an appeal under this section may give a direction of a kind which an adjudication officer may give under section 9(7)(b) or (c) or (as the case may be) section 10(6)(b) or (d).
- (5) Where a social security appeal tribunal gives a direction under subsection (4) of a kind which may be given by an adjudication officer under section 10(6)(b)(ii), an adjudication officer may bring the jobseeker's agreement to an end if the claimant fails to comply with the direction within a prescribed period.
- (6) An appropriate person may, on the ground that it was erroneous in point of law, appeal to a Commissioner against the decision of a social security appeal tribunal on an appeal under this section.
- (7) Any of the following is an appropriate person for the purposes of subsection (6)—
  - (a) the claimant;
  - (b) an adjudication officer;
  - (c) in prescribed circumstances, a trade union;
  - (d) in prescribed circumstances, any other association which exists to promote the interests and welfare of its members.
- (8) Subsections (7) to (10) of section 23 of the Administration Act (appeals to Commissioners) shall apply in relation to appeals under this section as they apply in relation to appeals under that section.
- (9) In this section "Commissioner" has the same meaning as in the Administration Act.

## Income and capital

# 12 Income and capital: general. E+W+S

- (1) In relation to a claim for a jobseeker's allowance, the income and capital of a person shall be calculated or estimated in such manner as may be prescribed.
- (2) A person's income in respect of a week shall be calculated in accordance with prescribed rules.

# 13 Income and capital: income-based jobseeker's allowance. E+W+S

- [F80(1)] No person shall be entitled to an income-based jobseeker's allowance if his capital, or a prescribed part of it, exceeds the prescribed amount.
  - (2) Where a person claiming an income-based jobseeker's allowance is a member of a family, the income and capital of any member of that family shall, except in prescribed circumstances, be treated as the income and capital of the claimant.
- [F81(2A) Subsections (1) and (2) do not apply as regards a joint-claim jobseeker's allowance; but a joint-claim couple shall not be entitled to a joint-claim jobseeker's allowance if the couple's capital, or a prescribed part of it, exceeds the prescribed amount.

    - (a) the couple's income and capital includes the separate income and capital of each of them; and
    - (b) the income and capital of any other person who is a member of any family of which the couple are members shall, except in prescribed circumstances, be treated as income and capital of the couple.]
    - (3) Regulations may provide that capital not exceeding the amount prescribed under subsection (1), but exceeding a prescribed lower amount, shall be treated, to a prescribed extent, as if it were income of a prescribed amount.]

# Trade disputes

# 14 Trade disputes. E+W+S

- (1) Where—
  - (a) there is a stoppage of work which causes a person not to be employed on any day, and
  - (b) the stoppage is due to a trade dispute at his place of work,

that person is not entitled to a jobseeker's allowance for the week which includes that day unless he proves that he is not directly interested in the dispute.

- (2) A person who withdraws his labour on any day in furtherance of a trade dispute, but to whom subsection (1) does not apply, is not entitled to a jobseeker's allowance for the week which includes that day.
- (3) If a person who is prevented by subsection (1) from being entitled to a jobseeker's allowance proves that during the stoppage—
  - (a) he became bona fide employed elsewhere;
  - (b) his employment was terminated by reason of redundancy within the meaning of [F82] section 139(1) of the Employment Rights Act 1996], or
  - (c) he bona fide resumed employment with his employer but subsequently left for a reason other than the trade dispute,

subsection (1) shall be taken to have ceased to apply to him on the occurrence of the event referred to in paragraph (a) or (b) or (as the case may be) the first event referred to in paragraph (c).

- (4) In this section "place of work", in relation to any person, means the premises or place at which he was employed.
- (5) Where separate branches of work which are commonly carried on as separate businesses in separate premises or at separate places are in any case carried on in separate departments on the same premises or at the same place, each of those departments shall, for the purposes of subsection (4), be deemed to be separate premises or (as the case may be) a separate place.

# 15 Effect on other claimants. E+W+S

  - (b) where the claimant and A are a [F84 couple], any portion of the applicable amount which is included in respect of them shall be reduced to one half for the period for which this subsection applies to the claimant;
  - (c) except so far as regulations provide otherwise, there shall be treated as the claimant's income—
    - (i) any amount which becomes, or would on an application duly made become, available to A in relation to that period by way of repayment of income tax deducted from A's [F85 taxable earnings (as defined by section 10 of the Income Tax (Earnings and Pensions) Act 2003) under PAYE regulations]; and
    - (ii) any other payment which the claimant or any member of his family receives or is entitled to obtain because A is without employment for that period; and
  - (d) any payment by way of a jobseeker's allowance for that period or any part of it which apart from this paragraph would be made to the claimant—
    - (i) shall not be made, if the weekly rate of payment ("the rate") would be equal to or less than the prescribed sum; and
    - (ii) shall be at a weekly rate equal to the difference between the rate and the prescribed sum, if the rate would be more than the prescribed sum.
- (3) Where a reduction under subsection (2)(b) would not produce a sum which is a multiple of 5p, the reduction shall be to the nearest lower sum which is such a multiple.
- (4) Where A returns to work with the same employer after a period during which subsection (2) applied to the claimant (whether or not his return is before the end of any stoppage of work in relation to which he is, or would be, prevented from being entitled to a jobseeker's allowance), subsection (2) shall cease to apply to the claimant at the commencement of the day on which A returns to work.
- (5) In relation to any period of less than a week, subsection (2) shall have effect subject to such modifications as may be prescribed.
- (6) Subsections (7) to (9) apply where an order made under section 150 of the Administration Act (annual up-rating of benefits) has the effect of increasing the sum prescribed in regulations made under section 4(5) as the personal allowance for a single person aged not less than 25 ("the personal allowance").
- (7) For the sum prescribed in regulations made under subsection (2)(d) there shall be substituted, from the time when the order comes into force, a sum arrived at by increasing the prescribed sum by the percentage by which the personal allowance has been increased by the order.
- (8) If the sum arrived at under subsection (7) is not a multiple of 50p—
  - (a) any remainder of 25p or less shall be disregarded;
  - (b) any remainder of more than 25p shall be rounded up to the nearest 50p.
- (9) The order shall state the sum substituted for the sum prescribed in regulations made under subsection (2)(d).

# 16 Severe hardship. E+W+S

# Recovery of jobseeker's allowance: severe hardship cases.

- (1) Where—
  - (a) a severe hardship direction is revoked; and
  - (b) it is determined by an adjudication officer that—
    - (i) whether fraudulently or otherwise, any person has misrepresented, or failed to disclose, any material fact; and
    - (ii) in consequence of the failure or misrepresentation, payment of a jobseeker's allowance has been made during the relevant period to the person to whom the direction related,

an adjudication officer may determine that the Secretary of State is entitled to recover the amount of the payment.

(2) In this section—

"severe hardship direction" means a direction given under section 16 of the Jobseekers Act 1995; and

"the relevant period" means—

- (a) if the revocation is under section 16(3)(a) of that Act, the period beginning with the date of the change of circumstances and ending with the date of the revocation; and
- (b) if the revocation is under section 16(3)(b) or (c) of that Act, the period during which the direction was in force.
- (3) Where a severe hardship direction is revoked, the Secretary of State may certify whether there has been misrepresentation of a material fact or failure to disclose a material fact.
- (4) If the Secretary of State certifies that there has been such misrepresentation or failure to disclose, he may certify—
  - (a) who made the misrepresentation or failed to make the disclosure; and
  - (b) whether or not a payment of jobseeker's allowance has been made in consequence of the misrepresentation or failure.
- (5) If the Secretary of State certifies that a payment has been made, he may certify the period during which a jobseeker's allowance would not have been paid but for the misrepresentation or failure to disclose.

    - (a) the amount of a reduction under this section;
    - (b) the period for which such a reduction has effect, not exceeding three years in relation to any failure sanctionable under this section.

# 24 Effect of alteration of rates. E+W+S

In the Administration Act, insert after section 159—

# "159A Effect of alteration of rates of a jobseeker's allowance.

- (1) This section applies where—
  - (a) an award of a jobseeker's allowance is in force in favour of any person ("the recipient"); and
  - (b) an alteration—
    - (i) in any component of the allowance, or
    - (ii) in the recipient's benefit income,

affects the amount of the jobseeker's allowance to which he is entitled.

- (3) As from the commencing date, the amount of the jobseeker's allowance payable to or for the recipient under the award shall be the increased or reduced amount, without any further decision of an adjudication officer; and the award shall have effect accordingly.

  - (a) there is an alteration of a kind mentioned in subsection (1)(b); and
  - (b) before the commencing date (but after that date is fixed) an award of a jobseeker's allowance is made in favour of a person,

the award may provide for the jobseeker's allowance to be paid as from the commencing date, in which case the amount of the jobseeker's allowance shall be determined by reference to the components applicable on that date, or may provide for an amount determined by reference to the components applicable at the date of the award.

"alteration" means-

- (a) in relation to any component of a jobseeker's allowance, its alteration by or under any enactment; and
- (b) in relation to a person's benefit income, the alteration of any of the sums referred to in section 150 above by any enactment or by an order under section 150 above, to the extent that any such alteration affects the amount of the recipient's benefit income;

  - (a) a benefit under the Contributions and Benefits Act; or

# The back to work bonus. E+W+S

- [F135(1) Regulations may make provision for the payment, in prescribed circumstances, of sums to or in respect of persons who are or have been entitled to a jobseeker's allowance or to income support.
  - (2) A sum payable under the regulations shall be known as "a back to work bonus".

    - (d) enabling amounts to be calculated by reference to periods of entitlement to a jobseeker's allowance and periods of entitlement to income support;
    - (e) treating a bonus as payable wholly by way of income support or wholly by way of a jobseeker's allowance, in a case where amounts have been calculated in accordance with provision made by virtue of paragraph (d);
    - (f) keeping persons who may be entitled to a bonus informed of the amounts calculated in accordance with any provision of the regulations made by virtue of paragraph (c);
    - (g) the amount of a bonus not to exceed a prescribed maximum;
    - (h) a bonus not to be payable if the amount of the bonus which would otherwise be payable is less than the prescribed minimum;
    - (i) prescribed periods to be disregarded for prescribed purposes;
    - (j) a bonus which has been paid to a person to be treated, in prescribed circumstances and for prescribed purposes, as income or capital of his or of any other member of his family;
    - (k) treating the whole or a prescribed part of an amount which has accrued towards a person's bonus—
      - (i) as not having accrued towards his bonus; but
      - (ii) as having accrued towards the bonus of another person;
    - (l) the whole or a prescribed part of a back to work bonus to be payable, in such circumstances as may be prescribed, to such person, other than the person who is or had been entitled to a jobseeker's allowance or to income support, as may be determined in accordance with the regulations.]

# Employment of long-term unemployed: deductions by employers. E+W+S

- (1) An employee is a "qualifying employee" in relation to his employer for the purposes of this section if, immediately before beginning his employment with that employer, he had been entitled to a jobseeker's allowance for a continuous period of not less than two years.
- (2) An employee is also a "qualifying employee" in relation to his employer for the purposes of this section if—
  - (a) immediately before beginning his employment with that employer, he had been unemployed for a continuous period of not less than two years;
  - (b) he is under pensionable age; and
  - (c) he falls within a prescribed description of person.
- (3) Regulations may make provision for any employer who employs a person who is a qualifying employee in relation to him, to make deductions from the employer's contributions payments in accordance with the regulations and in prescribed circumstances.
- (4) Those regulations may, in particular, make provision as to the period for which deductions may be made by an employer.
- (5) Regulations may provide, in relation to cases where an employee is a qualifying employee in relation to more than one employer at the same time, for the right to make deductions to be confined to one employer—
  - (a) determined in accordance with the regulations; and
  - (b) certified by the [F137Commissioners of Inland Revenue], in accordance with the regulations, to be the employer entitled to make those deductions.

## (6) Regulations may—

(a) provide that, in prescribed circumstances, a person who would not otherwise satisfy the condition in subsection (1) is to be treated as satisfying it;

  - (a) paid (on such date as may be determined in accordance with the regulations); and
  - (b) received by the [F137Commissioners of Inland Revenue], towards discharging the employer's liability in respect of such contributions.

# 38 General financial arrangements. E+W+S

- (1) There shall be paid out of money provided by Parliament—
  - (a) any sums paid by the Secretary of State by way of jobseeker's allowance; and
  - (b) any expenditure incurred by the Secretary of State [F191] or the Commissioners of Inland Revenuel under or by virtue of this Act.
- (2) The expenditure mentioned in subsection (1)(b) includes expenditure incurred in connection with any inquiry undertaken on behalf of the Secretary of State [F192] or the Commissioners of Inland Revenue] with a view to obtaining statistics relating to the operation of any provision of this Act relating to a jobseeker's allowance.
- (3) There shall be paid out of the National Insurance Fund and into the Consolidated Fund sums estimated by the Secretary of State to balance payments made by him by way of [F193] contribution-based] jobseeker's allowance.
- (4) The Secretary of State shall pay into the National Insurance Fund sums estimated by him to balance sums recovered by him in connection with payments of [F193] contribution-based] jobseeker's allowance.
- (5) The [F194Commissioners of Inland Revenue] shall pay into the National Insurance Fund sums estimated by [F195them] to be equal to the aggregate of the amounts deducted by employers in accordance with regulations under section 27.

# 40 Transitional provisions. E+W+S

- (1) The Secretary of State may by regulations make such transitional provision, consequential provision or savings as he considers necessary or expedient for the purposes of or in connection with—




