MISCELLANEOUS STATUTORY FUNCTIONS OF NATIONAL PARK AUTHORITIES

Footpaths and bridleways

- 11 ^{M1}The following provisions of the Highways Act 1980, that is to say—
- (a) sections 25 to 29 (footpaths and bridleways),
 - (b) section 72(2) (widening of public paths),
 - [^{F1}(c) sections 118 to 121E (stopping up and diversion of public paths, etc.), except sections 118B and 119B (stopping up and diversion for purposes of crime prevention, etc.), and]
 - (d) Schedule 6 (procedure for orders),
- shall have effect as if references in those sections to a local authority or council included references to a National Park authority and as if the relevant Park were the authority’s area.
