



Children (Scotland) Act 1995

1995 CHAPTER 36

U.K.

An Act to reform the law of Scotland relating to children, to the adoption of children and to young persons who as children have been looked after by a local authority; to make new provision as respects the relationship between parent and child and guardian and child in the law of Scotland; to make provision as respects residential establishments for children and certain other residential establishments; and for connected purposes. [19th July 1995]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

PART I S

PARENTS, CHILDREN AND GUARDIANS

Parental responsibilities and parental rights

1 Parental responsibilities. S

- (1) Subject to section 3(1)(b) and (3) of this Act, a parent has in relation to his child the responsibility—
- (a) to safeguard and promote the child's health, development and welfare;
 - (b) to provide, in a manner appropriate to the stage of development of the child—
 - (i) direction;
 - (ii) guidance,to the child;

- (c) if the child is not living with the parent, to maintain personal relations and direct contact with the child on a regular basis; and
 - (d) to act as the child’s legal representative,
- but only in so far as compliance with this section is practicable and in the interests of the child.
- (2) “Child” means for the purposes of—
- (a) paragraphs (a), (b)(i), (c) and (d) of subsection (1) above, a person under the age of sixteen years;
 - (b) paragraph (b)(ii) of that subsection, a person under the age of eighteen years.
- (3) The responsibilities mentioned in paragraphs (a) to (d) of subsection (1) above are in this Act referred to as “parental responsibilities”; and the child, or any person acting on his behalf, shall have title to sue, or to defend, in any proceedings as respects those responsibilities.
- (4) The parental responsibilities supersede any analogous duties imposed on a parent at common law; but this section is without prejudice to any other duty so imposed on him or to any duty imposed on him by, under or by virtue of any other provision of this Act or of any other enactment.

2 Parental rights. **S**

- (1) Subject to section 3(1)(b) and (3) of this Act, a parent, in order to enable him to fulfil his parental responsibilities in relation to his child, has the right—
- (a) to have the child living with him or otherwise to regulate the child’s residence;
 - (b) to control, direct or guide, in a manner appropriate to the stage of development of the child, the child’s upbringing;
 - (c) if the child is not living with him, to maintain personal relations and direct contact with the child on a regular basis; and
 - (d) to act as the child’s legal representative.
- (2) Subject to subsection (3) below, where two or more persons have a parental right as respects a child, each of them may exercise that right without the consent of the other or, as the case may be, of any of the others, unless any decree or deed conferring the right, or regulating its exercise, otherwise provides.
- (3) Without prejudice to any court order, no person shall be entitled to remove a child habitually resident in Scotland from, or to retain any such child outwith, the United Kingdom without the consent of a person described in subsection (6) below.
- (4) The rights mentioned in paragraphs (a) to (d) of subsection (1) above are in this Act referred to as “parental rights”; and a parent, or any person acting on his behalf, shall have title to sue, or to defend, in any proceedings as respects those rights.

- (5) The parental rights supersede any analogous rights enjoyed by a parent at common law; but this section is without prejudice to any other right so enjoyed by him or to any right enjoyed by him by, under or by virtue of any other provision of this Act or of any other enactment.
- (6) The description of a person referred to in subsection (3) above is a person (whether or not a parent of the child) who for the time being has and is exercising in relation to him a right mentioned in paragraph (a) or (c) of subsection (1) above; except that, where both the child's parents are persons so described, the consent required for his removal or retention shall be that of them both.
- (7) In this section, "child" means a person under the age of sixteen years.

3 Provisions relating both to parental responsibilities and to parental rights. **S**

- (1) Notwithstanding section 1(1) of the ^{M1}Law Reform (Parent and Child) (Scotland) Act 1986 (provision for disregarding whether a person's parents are not, or have not been, married to one another in establishing the legal relationship between him and any other person)—
 - (a) a child's mother has parental responsibilities and parental rights in relation to him whether or not she is or has been married to his father; and
 - (b) without prejudice to any arrangements which may be made under subsection (5) below and subject to any agreement which may be made under section 4 of this Act, his father has such responsibilities and rights in relation to him only if married to the mother at the time of the child's conception or subsequently.
- (2) For the purposes of subsection (1)(b) above, the father shall be regarded as having been married to the mother at any time when he was a party to a purported marriage with her which was—
 - (a) voidable; or
 - (b) void but believed by them (whether by error of fact or of law) in good faith at that time to be valid.
- (3) Subsection (1) above is without prejudice to any order made under section 11 of this Act or section 3(1) of the said Act of 1986 (provision analogous to the said section 11 but repealed by this Act) or to any other order, disposal or resolution affecting parental responsibilities or parental rights; and nothing in subsection (1) above or in this Part of this Act shall affect any other—
 - (a) enactment (including any other provision of this Act or of that Act); or
 - (b) rule of law,by, under or by virtue of which a person may have imposed on him (or be relieved of) parental responsibilities or may be granted (or be deprived of) parental rights.
- (4) The fact that a person has parental responsibilities or parental rights in relation to a child shall not entitle that person to act in any way which would be incompatible with any court order relating to the child or the child's property, or with any supervision requirement made under section 70 of this Act.
- (5) Without prejudice to section 4(1) of this Act, a person who has parental responsibilities or parental rights in relation to a child shall not abdicate those responsibilities or rights to anyone else but may arrange for some or all of them to be fulfilled or exercised on his behalf; and without prejudice to that generality any such arrangement may be made

- (6) The making of an arrangement under subsection (5) above shall not affect any liability arising from a failure to fulfil parental responsibilities; and where any arrangements so made are such that the child is a foster child for the purposes of the ^{M2}Foster Children (Scotland) Act 1984, those arrangements are subject to the provisions of that Act.

4 Acquisition of parental rights and responsibilities by natural father. S

- (1) Where a child’s mother has not been deprived of some or all of the parental responsibilities and parental rights in relation to him and, by virtue of subsection (1) (b) of section 3 of this Act, his father has no parental responsibilities or parental rights in relation to him, the father and mother, whatever age they may be, may by agreement provide that, as from the appropriate date, the father shall have the parental responsibilities and parental rights which (in the absence of any order under section 11 of this Act affecting those responsibilities and rights) he would have if married to the mother.
- (2) No agreement under subsection (1) above shall have effect unless—
- (a) in a form prescribed by the Secretary of State; and
 - (b) registered in the Books of Council and Session while the mother still has the parental responsibilities and parental rights which she had when the agreement was made.
- (3) The date on which such registration as is mentioned in subsection (2)(b) above takes place shall be the “appropriate date” for the purposes of subsection (1) above.
- (4) An agreement which has effect by virtue of subsection (2) above shall, subject only to section 11(11) of this Act, be irrevocable.

[^{F1}4A Acquisition of parental responsibilities and parental rights by second female parent by agreement with mother S

(1) Where—

- (a) a child's mother has not been deprived of some or all of the parental responsibilities and parental rights in relation to the child; and
- (b) the child has a parent by virtue of section 43 of the Human Fertilisation and Embryology Act 2008 and that parent is not registered as such under any of the enactments mentioned in section 3(3A),

the mother and the other parent may by agreement provide that, as from the appropriate date, the other parent shall have the parental responsibilities and rights (in the absence of any order under section 11 of this Act affecting responsibilities and rights) as if the other parent were treated as a parent by virtue of section 42 of that Act of 2008.

(2) Section 4(2), (3) and (4) applies in relation to an agreement under subsection (1) of this section as it applies in relation to an agreement under subsection (1) of section 4.]

5 Care or control of child by person without parental responsibilities or parental rights. S

(1) Subject to subsection (2) below, it shall be the responsibility of a person who has attained the age of sixteen years and who has care or control of a child under that age, but in relation to him either has no parental responsibilities or parental rights or does not have the parental responsibility mentioned in section 1(1)(a) of this Act, to do what is reasonable in all the circumstances to safeguard the child's health, development and welfare; and in fulfilling his responsibility under this section the person may in particular, even though he does not have the parental right mentioned in section 2(1)(d) of this Act, give consent to any surgical, medical or dental treatment or procedure where—

- (a) the child is not able to give such consent on his own behalf; and
- (b) it is not within the knowledge of the person that a parent of the child would refuse to give the consent in question.

(2) Nothing in this section shall apply to a person in so far as he has care or control of a child in a school ("school" having the meaning given by section 135(1) of the ^{M3}Education (Scotland) Act 1980).

6 Views of children. **S**

- (1) A person shall, in reaching any major decision which involves—
 - (a) his fulfilling a parental responsibility or the responsibility mentioned in section 5(1) of this Act; or
 - (b) his exercising a parental right or giving consent by virtue of that section,
 have regard so far as practicable to the views (if he wishes to express them) of the child concerned, taking account of the child's age and maturity, and to those of any other person who has parental responsibilities or parental rights in relation to the child (and wishes to express those views); and without prejudice to the generality of this subsection a child twelve years of age or more shall be presumed to be of sufficient age and maturity to form a view.
- (2) A transaction entered into in good faith by a third party and a person acting as legal representative of a child shall not be challengeable on the ground only that the child, or a person with parental responsibilities or parental rights in relation to the child, was not consulted or that due regard was not given to his views before the transaction was entered into.

Guardianship

7 Appointment of guardians. **S**

- (1) A child's parent may appoint a person to be guardian of the child in the event of the parent's death; but—
 - (a) such appointment shall be of no effect unless—
 - (i) in writing and signed by the parent; and
 - (ii) the parent, at the time of death, was entitled to act as legal representative of the child (or would have been so entitled if he had survived until after the birth of the child); and
 - (b) any parental responsibilities or parental rights (or the right to appoint a further guardian under this section) which a surviving parent has in relation to the child shall subsist with those which, by, under or by virtue of this Part of this Act, the appointee so has.
- (2) A guardian of a child may appoint a person to take his place as guardian in the event of the guardian's death; but such appointment shall be of no effect unless in writing and signed by the person making it.
- (3) An appointment as guardian shall not take effect until accepted, either expressly or impliedly by acts which are not consistent with any other intention.
- (4) If two or more persons are appointed as guardians, any one or more of them shall, unless the appointment expressly provides otherwise, be entitled to accept office even if both or all of them do not accept office.
- (5) Subject to any order under section 11 or 86 of this Act, a person appointed as a child's guardian under this section shall have, in respect of the child, the responsibilities imposed, and the rights conferred, on a parent by sections 1 and 2 of this Act respectively; and sections 1 and 2 of this Act shall apply in relation to a guardian as they apply in relation to a parent.

- (6) Without prejudice to the generality of subsection (1) of section 6 of this Act, a decision as to the appointment of a guardian under subsection (1) or (2) above shall be regarded for the purposes of that section (or of that section as applied by subsection (5) above) as a major decision which involves exercising a parental right.

8 Revocation and other termination of appointment. S

- (1) An appointment made under section 7(1) or (2) of this Act revokes an earlier such appointment (including one made in an unrevoked will or codicil) made by the same person in respect of the same child, unless it is clear (whether as a result of an express provision in the later appointment or by any necessary implication) that the purpose of the later appointment is to appoint an additional guardian.
- (2) Subject to subsections (3) and (4) below, the revocation of an appointment made under section 7(1) or (2) of this Act (including one made in an unrevoked will or codicil) shall not take effect unless the revocation is in writing and is signed by the person making the revocation.
- (3) An appointment under section 7(1) or (2) of this Act (other than one made in a will or codicil) is revoked if, with the intention of revoking the appointment, the person who made it—
- (a) destroys the document by which it was made; or
 - (b) has some other person destroy that document in his presence.
- (4) For the avoidance of doubt, an appointment made under section 7(1) or (2) of this Act in a will or codicil is revoked if the will or codicil is revoked.
- (5) Once an appointment of a guardian has taken effect under section 7 of this Act, then, unless the terms of the appointment provide for earlier termination, it shall terminate only by virtue of—
- (a) the child concerned attaining the age of eighteen years;
 - (b) the death of the child or the guardian; or
 - (c) the termination of the appointment by a court order under section 11 of this Act.

Administration of child's property

9 Safeguarding of child's property. S

- (1) Subject to section 13 of this Act, this section applies where—
- (a) property is owned by or due to a child;
 - (b) the property is held by a person other than a parent or guardian of the child; and
 - (c) but for this section, the property would be required to be transferred to a parent having parental responsibilities in relation to the child or to a guardian for administration by that parent or guardian on behalf of the child.

- (2) Subject to subsection (4) below, where this section applies and the person holding the property is an executor or trustee, then—
 - (a) if the value of the property exceeds £20,000, he shall; or
 - (b) if that value is not less than £5,000 and does not exceed £20,000, he may, apply to the Accountant of Court for a direction as to the administration of the property.
- (3) Subject to subsection (4) below, where this section applies and the person holding the property is a person other than an executor or trustee, then, if the value of the property is not less than £5,000, that person may apply to the Accountant of Court for a direction as to the administration of the property.
- (4) Where the parent or guardian mentioned in subsection (1)(c) above has been appointed a trustee under a trust deed to administer the property concerned, subsections (2) and (3) above shall not apply, and the person holding the property shall transfer it to the parent or guardian.
- (5) On receipt of an application under subsection (2) or (3) above, the Accountant of Court may do one, or (in so far as the context admits) more than one, of the following—
 - (a) apply to the court for the appointment of a judicial factor (whether or not the parent or guardian mentioned in subsection (1)(c) above) to administer all or part of the property concerned and in the event of the court making such an appointment shall direct that the property, or as the case may be part, concerned be transferred to the factor;
 - (b) direct that all or part of the property concerned be transferred to himself;
 - (c) direct that all or, in a case where the parent or guardian so mentioned has not been appointed by virtue of paragraph (a) above, part of the property concerned be transferred to the parent or guardian, to be administered on behalf of the child.
- (6) A direction under subsection (5)(c) above may include such conditions as the Accountant of Court considers appropriate, including in particular a condition—
 - (a) that in relation to the property concerned no capital expenditure shall be incurred without his approval; or
 - (b) that there shall be exhibited annually to him the securities and bank books which represent the capital of the estate.
- (7) A person who has applied under subsection (2) or (3) above for a direction shall not thereafter transfer the property concerned except in accordance with a direction under subsection (5) above.
- (8) The Secretary of State may from time to time prescribe a variation in any sum referred to in subsections (2) and (3) above.
- (9) In this section “child” means a person under the age of sixteen years who is habitually resident in Scotland.

10 **Obligations and rights of person administering child’s property.** S

- (1) A person acting as a child’s legal representative in relation to the administration of the child’s property—
 - (a) shall be required to act as a reasonable and prudent person would act on his own behalf; and

(b) subject to any order made under section 11 of this Act, shall be entitled to do anything which the child, if of full age and capacity, could do in relation to that property;

and subject to subsection (2) below, on ceasing to act as legal representative, shall be liable to account to the child for his intromissions with the child's property.

(2) No liability shall be incurred by virtue of subsection (1) above in respect of funds which have been used in the proper discharge of the person's responsibility to safeguard and promote the child's health, development and welfare.

Court Orders

11 Court orders relating to parental responsibilities etc. **S**

(1) In the relevant circumstances in proceedings in the Court of Session or sheriff court, whether those proceedings are or are not independent of any other action, an order may be made under this subsection in relation to—

- (a) parental responsibilities;
- (b) parental rights;
- (c) guardianship; or
- (d) subject to section 14(1) and (2) of this Act, the administration of a child's property.

(2) The court may make such order under subsection (1) above as it thinks fit; and without prejudice to the generality of that subsection may in particular so make any of the following orders—

- (a) an order depriving a person of some or all of his parental responsibilities or parental rights in relation to a child;
- (b) an order—
 - (i) imposing upon a person (provided he is at least sixteen years of age or is a parent of the child) such responsibilities; and
 - (ii) giving that person such rights;
- (c) an order regulating the arrangements as to—
 - (i) with whom; or
 - (ii) if with different persons alternately or periodically, with whom during what periods,

a child under the age of sixteen years is to live (any such order being known as a “residence order”);

- (d) an order regulating the arrangements for maintaining personal relations and direct contact between a child under that age and a person with whom the child is not, or will not be, living (any such order being known as a “contact order”);
- (e) an order regulating any specific question which has arisen, or may arise, in connection with any of the matters mentioned in paragraphs (a) to (d) of subsection (1) of this section (any such order being known as a “specific issue order”);
- (f) an interdict prohibiting the taking of any step of a kind specified in the interdict in the fulfillment of parental responsibilities or the exercise of parental rights relating to a child or in the administration of a child's property;

- (g) an order appointing a judicial factor to manage a child’s property or remitting the matter to the Accountant of Court to report on suitable arrangements for the future management of the property; or
 - (h) an order appointing or removing a person as guardian of the child.
- (3) The relevant circumstances mentioned in subsection (1) above are—
- (a) that application for an order under that subsection is made by a person who—
 - (i) not having, and never having had, parental responsibilities or parental rights in relation to the child, claims an interest;
 - (ii) has parental responsibilities or parental rights in relation to the child;
 - (iii) has had, but for a reason other than is mentioned in subsection (4) below no longer has, parental responsibilities or parental rights in relation to the child; or
 - (b) that although no such application has been made, the court (even if it declines to make any other order) considers it should make such an order.
- (4) The reasons referred to in subsection (3)(a)(iii) above are that the parental responsibilities or parental rights have been—
- (a) extinguished on the making of an adoption order;
 - (b) transferred to an adoption agency on the making of an order declaring the child free for adoption;
 - (c) extinguished by virtue of subsection (9) of section 30 of the ^{M4}Human Fertilisation and Embryology Act 1990 (provision for enactments about adoption to have effect with modifications) on the making of a parental order under subsection (1) of that section; or
 - (d) transferred to a local authority by a parental responsibilities order.
- (5) In subsection (3)(a) above “person” includes (without prejudice to the generality of that subsection) the child concerned; but it does not include a local authority.
- (6) In subsection (4) above—
- “adoption agency” and “adoption order” have the same meanings as they are given, in section 18 of the ^{M5}Adoption (Scotland) Act 1978, by section 65(1) of that Act; and
 - “parental responsibilities order” has the meaning given by section 86(1) of this Act.
- (7) Subject to subsection (8) below, in considering whether or not to make an order under subsection (1) above and what order to make, the court—
- (a) shall regard the welfare of the child concerned as its paramount consideration and shall not make any such order unless it considers that it would be better for the child that the order be made than that none should be made at all; and
 - (b) taking account of the child’s age and maturity, shall so far as practicable—
 - (i) give him an opportunity to indicate whether he wishes to express his views;
 - (ii) if he does so wish, give him an opportunity to express them; and
 - (iii) have regard to such views as he may express.
- (8) The court shall, notwithstanding subsection (7) above, endeavour to ensure that any order which it makes, or any determination by it not to make an order, does not adversely affect the position of a person who has, in good faith and for value, acquired any property of the child concerned, or any right or interest in such property.

- (9) Nothing in paragraph (b) of subsection (7) above requires a child to be legally represented, if he does not wish to be, in proceedings in the course of which the court implements that paragraph.
- (10) Without prejudice to the generality of paragraph (b) of subsection (7) above, a child twelve years of age or more shall be presumed to be of sufficient age and maturity to form a view for the purposes both of that paragraph and of subsection (9) above.

- (12) Where the court makes a residence order which requires that a child live with a person who, immediately before the order is made does not have in relation to the child all the parental responsibilities mentioned in paragraphs (a), (b) and (d) of section 1(1), and the parental rights mentioned in paragraphs (b) and (d) of section 2(1), of this Act (those which he does not so have being in this subsection referred to as the “relevant responsibilities and rights”) that person shall, subject to the provisions of the order or of any other order made under subsection (1) above, have the relevant responsibilities and rights while the residence order remains in force.
- (13) Any reference in this section to an order includes a reference to an interim order or to an order varying or discharging an order.

12 Restrictions on decrees for divorce, separation or annulment affecting children. **S**

- (1) In any action for divorce, judicial separation or declarator of nullity of marriage, the court shall, where this section applies, consider (in the light of such information as is before the court as to the arrangements which have been, or are proposed to be, made for the upbringing of each child by virtue of which it applies) whether to exercise with respect to him the powers conferred by section 11 or 54 of this Act.
- (2) Where, in any case to which this section applies, the court is of the opinion that—
 - (a) the circumstances of the case require, or are likely to require, it to exercise any power under section 11 or 54 of this Act with respect to the child concerned;
 - (b) it is not in a position to exercise that power without giving further consideration to the case; and
 - (c) there are exceptional circumstances which make it desirable in the interests of that child that it should not grant decree in the action until it is in a position to exercise such a power,
 it shall postpone its decision on the granting of decree in the action until it is in such a position.

14 Jurisdiction and choice of law in relation to certain matters. S

- (1) The Court of Session shall have jurisdiction to entertain an application for an order relating to the administration of a child's property if the child is habitually resident in, or the property is situated in, Scotland.

Introductory

16 Welfare of child and consideration of his views. S

- (1) Where under or by virtue of this Part of this Act, a children’s hearing decide, or a court determines, any matter with respect to a child the welfare of that child throughout his childhood shall be their or its paramount consideration.
- (2) In the circumstances mentioned in subsection (4) below, a children’s hearing or as the case may be the sheriff, taking account of the age and maturity of the child concerned, shall so far as practicable—
 - (a) give him an opportunity to indicate whether he wishes to express his views;
 - (b) if he does so wish, give him an opportunity to express them; and
 - (c) have regard to such views as he may express;
 and without prejudice to the generality of this subsection a child twelve years of age or more shall be presumed to be of sufficient age and maturity to form a view.
- (3) In the circumstances mentioned in subsection (4)(a)(i) or (ii) or (b) of this section, no requirement or order so mentioned shall be made with respect to the child concerned unless the children’s hearing consider, or as the case may be the sheriff considers, that it would be better for the child that the requirement or order be made than that none should be made at all.
- (4) The circumstances to which subsection (2) above refers are that—
 - (a) the children’s hearing—
 - (i) are considering whether to make, or are reviewing, a supervision requirement;
 - (ii) are considering whether to grant a warrant under subsection (1) of section 66, or subsection (4) or (7) of section 69, of this Act or to provide under subsection (5) of the said section 66 for the continuation of a warrant;
 - (iii) are engaged in providing advice under section 60(10) of this Act; or
 - (iv) are drawing up a report under section 73(13) of this Act;
 - (b) the sheriff is considering—
 - (i) whether to make, vary or discharge a parental responsibilities order, a child assessment order or an exclusion order;

17 **Duty of local authority to child looked after by them.** S

- (1) Where a child is looked after by a local authority they shall, in such manner as the Secretary of State may prescribe—
- (a) safeguard and promote his welfare (which shall, in the exercise of their duty to him be their paramount concern);
 - (b) make such use of services available for children cared for by their own parents as appear to the authority reasonable in his case; and
 - (c) take such steps to promote, on a regular basis, personal relations and direct contact between the child and any person with parental responsibilities in relation to him as appear to them to be, having regard to their duty to him under paragraph (a) above, both practicable and appropriate.
- (2) The duty under paragraph (a) of subsection (1) above includes, without prejudice to that paragraph’s generality, the duty of providing advice and assistance with a view to preparing the child for when he is no longer looked after by a local authority.
- (3) Before making any decision with respect to a child whom they are looking after, or proposing to look after, a local authority shall, so far as is reasonably practicable, ascertain the views of—
- (a) the child;
 - (b) his parents;
 - (c) any person who is not a parent of his but who has parental rights in relation to him; and
 - (d) any other person whose views the authority consider to be relevant,
- regarding the matter to be decided.
- (4) In making any such decision a local authority shall have regard so far as practicable—
- (a) to the views (if he wishes to express them) of the child concerned, taking account of his age and maturity;
 - (b) to such views of any person mentioned in subsection (3)(b) to (d) above as they have been able to ascertain; and

- (6) Any reference in this Chapter of this Part to a child who is “looked after” by a local authority, is to a child—
- (a) for whom they are providing accommodation under section 25 of this Act;
 - (b) who is subject to a supervision requirement and in respect of whom they are the relevant local authority;
 - (c) who is subject to an order made, or authorisation or warrant granted, by virtue of Chapter 2, 3 or 4 of this Part of this Act, being an order, authorisation or warrant in accordance with which they have responsibilities as respects the child; or
 - (d) who is subject to an order in accordance with which, by virtue of regulations made under section 33(1) of this Act, they have such responsibilities.
- (7) Regulations made by the Secretary of State under subsection (1) above may, without prejudice to the generality of that subsection, include—
- (a) provision as to the circumstances in which the child may be cared for by the child’s own parents; and
 - (b) procedures which shall be followed in the event of the child’s death.

18 Duty of persons with parental responsibilities to notify change of address to local authority looking after child. **U.K.**

20 Publication of information about services for children. **S**

22 Promotion of welfare of children in need. **S**

- (1) A local authority shall—
 - (a) safeguard and promote the welfare of children in their area who are in need; and
 - (b) so far as is consistent with that duty, promote the upbringing of such children by their families,
 by providing a range and level of services appropriate to the children’s needs.

23 Children affected by disability. **S**

24 Assessment of ability of carers to provide care for disabled children. **S**

for a period which does not exceed the relevant period;

- (b) to a person who carries on a residential establishment in respect of which the person is for the time being registered (as mentioned in section 61(2) of that Act), or to any person for the time being employed in the management of that establishment, to be at risk of harm, the person to whom the child so appears may at the child’s request provide him with refuge, for a period which does not exceed the relevant period, in the establishment but shall do so only if and to the extent that the local authority within whose area the establishment is situated have given their approval to the use of the establishment (or a part of the establishment) for the purposes of this paragraph.

(2) The Secretary of State may by regulations make provision as to—

- (a) designation, for the purposes of paragraph (a) of subsection (1) above, of establishments and households;
- (b) application for, the giving of and the withdrawal of, approval under paragraph (b) of subsection (1) above;
- (c) requirements (if any) which must be complied with while any such approval remains in force;
- (d) the performance by a person mentioned in the said paragraph (b) of anything to be done by him under that paragraph;
- (e) the performance by a local authority of their functions under this section; and
- (f) the giving, to such persons or classes of person as may be specified in the regulations, of notice as to the whereabouts of a child provided with refuge under this section,

and regulations made under this subsection may include such incidental and supplementary provisions as he thinks fit.

(3) While a child is being provided with refuge under, and in accordance with regulations made under, this section, none of the enactments mentioned in subsection (4) below shall apply in relation to him unless the commencement of the period of refuge has followed within two days of the termination of a prior period of refuge so provided to him by any person.

(4) The enactments are—

- (a) section 89 of this Act and, so far as it applies in relation to anything done in Scotland, section 83 of this Act; and
- (b) section 32(3) of the ^{M38}Children and Young Persons Act 1969 (compelling, persuading, inciting or assisting any person to be absent from detention etc.), so far as it applies in relation to anything done in Scotland.

Constitution of children’s hearings

39 Formation of children’s panel and children’s hearings. S

- (1) For every local government area there shall be a children’s panel for the purposes of this Act, and any other enactment conferring powers on a children’s hearing (or on such a panel).
- (2) Schedule 1 to this Act shall have effect with respect to the recruitment, appointment, training and expenses of members of a children’s panel and the establishment of Children’s Panel Advisory Committees and joint advisory committees.
- (3) Sittings of members of the children’s panel (to be known as “children’s hearings”) shall be constituted from the panel in accordance with subsection (5) below.

Qualifications, employment and duties of reporters

40 Qualification and employment of reporters. S

Safeguards for children

41 Safeguarding child’s interests in proceedings. S

- (1) Subject to subsection (2) below, in any proceedings under this Chapter or Chapter 3 of this Part of this Act either at a children’s hearing or before the sheriff, the hearing or, as the case may be, the sheriff—
 - (a) shall consider if it is necessary to appoint a person to safeguard the interests of the child in the proceedings; and

42 Power of Secretary of State to make rules governing procedure at children’s hearing etc. S

43 Privacy of proceedings at and right to attend children’s hearing. **S**

- (1) Subject to subsection (3) below, a children’s hearing shall be conducted in private, and, subject to any rules made under section 42 of this Act, no person other than a person whose presence is necessary for the proper consideration of the case which is being heard, or whose presence is permitted by the chairman, shall be present.
- (2) The chairman shall take all reasonable steps to ensure that the number of persons present at a children’s hearing at any one time is kept to a minimum.

- (3) It shall be a defence in proceedings for an offence under this section for the accused to prove that he did not know, and had no reason to suspect, that the published matter was intended, or was likely, to identify the child or, as the case may be, the address or school.
- (4) In this section “to publish” includes, without prejudice to the generality of that expression,—
- (a) to publish matter in a programme service, as defined by section 201 of the ^{M42}Broadcasting Act 1990 (definition of programme service); and
 - (b) to cause matter to be published.
- (5) The requirements of subsection (1) above may, in the interests of justice, be dispensed with by—
- (a) the sheriff in any proceedings before him;
 - (b) the Court of Session in any appeal under section 51(11) of this Act; or

45 **Attendance of child and relevant person at children’s hearing.** S

 - (b) in any case, that it would be detrimental to the interests of the child for him to be present at the hearing of his case,

- (3) Subject to subsection (2) above, the Principal Reporter shall be responsible for securing the attendance of the child at the hearing of his case by a children’s hearing (and at any subsequent hearing to which the case is continued under section 69(1)(a) of this Act).
- (4) On the application of the Principal Reporter, a children’s hearing, if satisfied on cause shown that it is necessary for them to do so, may issue, for the purposes of subsection (3) above, a warrant under this subsection to find the child, to keep him in a place of safety and to bring him before a children’s hearing.
- (5) Where a child has failed to attend a children’s hearing in accordance with such notice as is mentioned in subsection (1) above, they may, either on the application of the Principal Reporter or of their own motion, issue a warrant under this subsection, which shall have the same effect as a warrant under subsection (4) above.
- (6) A child who has been taken to a place of safety under a warrant granted under this section shall not be kept there after whichever is the earlier of—
- (a) the expiry of seven days beginning on the day he was first so taken there; or
 - (b) the day on which a children’s hearing first sit to consider his case in accordance with subsection (7) below.
- (7) Where a child has been found in pursuance of a warrant under this section and he cannot immediately be brought before a children’s hearing, the Principal Reporter shall, wherever practicable, arrange a children’s hearing to sit on the first working day after the child was so found.
- (8) Subject to section 46 of this Act, a person who is a relevant person as respects a child shall, where a children’s hearing are considering the case of the child—
- (a) have the right to attend at all stages of the hearing; and
 - (b) be obliged to attend at all stages of the hearing unless the hearing are satisfied that it would be unreasonable to require his attendance or that his attendance is unnecessary for the proper consideration of the case.
- (9) Any person who fails to attend a hearing which, under subsection (8)(b) above, he is obliged to attend shall be guilty of an offence and shall be liable on summary conviction to a fine not exceeding level 3 on the standard scale.

46 Power to exclude relevant person from children’s hearing. **S**

- (1) Where a children’s hearing are considering the case of a child in respect of whom a person is a relevant person, they may exclude that person, or that person and any representative of his, or any such representative, from any part or parts of the hearing for so long as is necessary in the interests of the child, where they are satisfied that—
 - (a) they must do so in order to obtain the views of the child in relation to the case before the hearing; or

51 Appeal against decision of children’s hearing or sheriff. S

- (1) Subject to subsection (15) below, a child or a relevant person (or relevant persons) or both (or all)—
 - (a) may, within a period of three weeks beginning with the date of any decision of a children’s hearing, appeal to the sheriff against that decision; and
 - (b) where such an appeal is made, shall be heard by the sheriff.
- (2) The Principal Reporter shall, in respect of any appeal under subsection (1) above, ensure that all reports and statements available to the hearing, along with the reports of their proceedings and the reasons for the decision, are lodged with the sheriff clerk.

- (8) An appeal under subsection (1) above in respect of the issue of a warrant by a children’s hearing shall be disposed of within three days of the lodging of the appeal; and failing such disposal the warrant shall cease to have effect at the end of that period.
- (9) Where a child or a relevant person appeals under subsection (1) above against a decision of a children’s hearing in relation to a supervision requirement, the child or the relevant person may make application to a children’s hearing for the suspension of the requirement appealed against.
- (10) It shall be the duty of the Principal Reporter forthwith to arrange a children’s hearing to consider the application under subsection (9) above, and that hearing may grant or refuse the application.

52 **Children requiring compulsory measures of supervision.** S

 - (a) is beyond the control of any relevant person;
 - (b) is falling into bad associations or is exposed to moral danger;
 - (c) is likely—
 - (i) to suffer unnecessarily; or
 - (ii) be impaired seriously in his health or development, due to a lack of parental care;
 - (d) is a child in respect of whom any of the offences mentioned in [^{F8}Schedule 1 of the Criminal Procedure (Scotland) Act 1995] (offences against children to which special provisions apply) has been committed;
 - (e) is, or is likely to become, a member of the same household as a child in respect of whom any of the offences referred to in paragraph (d) above has been committed;
 - (f) is, or is likely to become, a member of the same household as a person who has committed any of the offences referred in paragraph (d) above;
 - (g) is, or is likely to become, a member of the same household as a person in respect of whom an offence under [^{F9}sections 1 to 3 of the Criminal Law (Consolidation)(Scotland) Act 1995] (incest and intercourse with a child by step-parent or person in position of trust) has been committed by a member of that household;
 - (h) has failed to attend school regularly without reasonable excuse;
 - (i) has committed an offence;
 - (j) has misused alcohol or any drug, whether or not a controlled drug within the meaning of the ^{M43}Misuse of Drugs Act 1971;

53 Provision of information to the Principal Reporter. S

55 Child assessment orders. **S**

- (1) A sheriff may grant an order under this section for an assessment of the state of a child’s health or development, or of the way in which he has been treated (to be known as a “child assessment order”), on the application of a local authority if he is satisfied that—
- (a) the local authority have reasonable cause to suspect that the child in respect of whom the order is sought is being so treated (or neglected) that he is suffering, or is likely to suffer, significant harm;
 - (b) such assessment of the child is required in order to establish whether or not there is reasonable cause to believe that the child is so treated (or neglected); and
 - (c) such assessment is unlikely to be carried out, or be carried out satisfactorily, unless the order is granted.
- (2) Where—
- (a) an application has been made under subsection (1) above; and

- he shall make such an order under that section as if the application had been duly made by the local authority under that section rather than this section.
- (3) A child assessment order shall—
- (a) specify the date on which the assessment is to begin;
 - (b) have effect for such period as is specified in the order, not exceeding seven days beginning with the date specified by virtue of paragraph (a) above;
 - (c) require any person in a position to produce the child to—
 - (i) produce him to any authorised person;
 - (ii) permit that person or any other authorised person to carry out an assessment in accordance with the order; and
 - (iii) comply with any other conditions of the order; and
 - (d) be carried out by an authorised person in accordance with the terms of the order.
- (4) A child assessment order may—
- (a) where necessary, permit the taking of the child concerned to any place for the purposes of the assessment; and

56 Initial investigation by the Principal Reporter. S

- (1) Where the Principal Reporter receives information from any source about a case which may require a children’s hearing to be arranged he shall, after making such initial investigation as he thinks necessary, proceed with the case in accordance with subsection (4) or (6) below.

Measures for the emergency protection of children

57 Child protection orders. S

- (1) Where the sheriff, on an application by any person, is satisfied that—
 - (a) there are reasonable grounds to believe that a child—
 - (i) is being so treated (or neglected) that he is suffering significant harm;
 - or
 - (ii) will suffer such harm if he is not removed to and kept in a place of safety, or if he does not remain in the place where he is then being accommodated (whether or not he is resident there); and
 - (b) an order under this section is necessary to protect that child from such harm (or such further harm),

he may make an order under this section (to be known as a “child protection order”).
- (2) Without prejudice to subsection (1) above, where the sheriff on an application by a local authority is satisfied—
 - (a) that they have reasonable grounds to suspect that a child is being or will be so treated (or neglected) that he is suffering or will suffer significant harm;
 - (b) that they are making or causing to be made enquiries to allow them to decide whether they should take any action to safeguard the welfare of the child; and
 - (c) that those enquiries are being frustrated by access to the child being unreasonably denied, the authority having reasonable cause to believe that such access is required as a matter of urgency,

he may make a child protection order.
- (3) Without prejudice to any additional requirement imposed by rules made by virtue of section 91 of this Act, an application for a child protection order shall—

 - (i) the applicant; and

58 **Directions in relation to contact and exercise of parental responsibilities and parental rights.** **S**

- (1) When the sheriff makes a child protection order, he shall at that time consider whether it is necessary to give a direction to the applicant for the order as to contact with the child for—
- (a) any parent of the child;
 - (b) any person with parental responsibilities in relation to the child; and
 - (c) any other specified person or class of persons;
- and if he determines that there is such a necessity he may give such a direction.
- (2) Without prejudice to the generality of subsection (1) above, a direction under that subsection may—
- (a) prohibit contact with the child for any person mentioned in paragraphs (a) to (c) of that subsection;

60 Duration, recall or variation of child protection order. S

- (1) Where, by the end of twenty-four hours of a child protection order being made (other than by virtue of section 57(4)(c) of this Act), the applicant has made no attempt to implement the order it shall cease to have effect.
- (2) Where an application made under subsection (7) below has not been determined timeously in accordance with subsection (8) below, the order to which the application relates shall cease to have effect.

 - (a) kept in a place of safety under a child protection order;

 - (b) that it is not practicable in the circumstances for an application for such an order to be made to the sheriff or for the sheriff to consider such an application, he may grant an authorisation under this section.

- (a) require any person in a position to do so to produce the child to the applicant;
 - (b) prevent any person from removing a child from a place where he is then being accommodated;

63 Review of case of child arrested by police. S

Business meeting preparatory to children’s hearing

64 Business meeting preparatory to children’s hearing. S

- (1) At any time prior to the commencement of proceedings at the children’s hearing, the Principal Reporter may arrange a meeting with members of the children’s panel from which the children’s hearing is to be constituted under section 39(4) of this Act for those proceedings (any such meeting being, in this Part of this Act referred to as a “business meeting”).

- (1) Where a child is being kept in a place of safety by virtue of a warrant granted under section 66 of this Act or under this subsection, the Principal Reporter at any time prior to the expiry of that warrant may apply to the sheriff for a warrant to keep the child in that place after the warrant granted under the said section 66 or, as the case may be, this subsection has expired.

69 Continuation or disposal of referral by children’s hearing. **S**

- (1) Where the grounds of referral of the child’s case stated by the Principal Reporter are accepted or are established in accordance with section 68 or section 85 of this Act, the children’s hearing shall consider those grounds, any report obtained under section 56(7) of this Act and any other relevant information available to them and shall—

77 Effect of, and orders etc. ancillary to, exclusion order. **S**

- (1) An exclusion order shall, in respect of the home to which it relates, have the effect of suspending the named person’s rights of occupancy (if any) and shall prevent him from entering the home, except with the express permission of the local authority which applied for the order.

Implementation of authorisations etc.

84 Implementation of authorisations etc. **S**

Where an order, authorisation or warrant under this Chapter or Chapter 2 of this Part of this Act grants power to find a child and to keep him in a place of safety, such order, authorisation or warrant may be implemented as if it were a warrant for the apprehension of an accused person issued by a court of summary jurisdiction; and any enactment or rule of law applying to such a warrant shall, subject to the provisions of this Act, apply in like manner to the order, authorisation or warrant.

 - (a) none of the grounds of referral in the original application to which the application relates is established, he shall allow the application, discharge the referral to the children’s hearing in respect of those grounds and proceed in accordance with subsection (7) below in relation to any supervision requirement made in respect of the child (whether or not varied under section 73 of this Act) in so far as it relates to any such ground; or
 - (b) any ground of referral in the original application to which the application relates is established, he may proceed in accordance with section 68(10) of this Act.
- (7) Where the sheriff is satisfied as is mentioned in subsection (6)(a) above, he may—
 - (a) order that any supervision requirement so mentioned shall terminate—
 - (i) immediately; or
 - (ii) on such date as he may specify; or
 - (b) if he is satisfied that there is evidence sufficient to establish any ground of referral, being a ground which was not stated in the original application, find such ground established and proceed in accordance with section 68(10) of this Act in relation to that ground.
- (8) Where the sheriff specifies a date for the termination of a supervision requirement in accordance with subsection (7)(a)(ii) above, he may, before such termination, order a variation of that requirement, of any requirement imposed under subsection (6) of section 70 of this Act, or of any determination made under subsection (7) of that section; and such variation may take effect—
 - (a) immediately; or
 - (b) on such date as he may specify.
- (9) Where the sheriff orders the termination of a supervision requirement in accordance with subsection (7)(a) above, he shall consider whether, after such termination, the child concerned will still require supervision or guidance; and where he considers that such supervision or guidance will be necessary he shall direct a local authority to provide it in accordance with subsection (10) below.
- (10) Where a sheriff has given a direction under subsection (9) above, it shall be the duty of the local authority to comply with that direction; but that duty shall be regarded as discharged where they offer such supervision or guidance to the child and he, being a child of sufficient age and maturity to understand what is being offered, is unwilling to accept it.

Parental responsibilities orders

86 Parental responsibilities order: general. S

- (1) On the application of a local authority the sheriff may make an order transferring (but only during such period as the order remains in force) the appropriate parental rights and responsibilities relating to a child to them; and any such order shall be known as a “parental responsibilities order”.
- (2) A parental responsibilities order shall not be made unless the sheriff is satisfied that each relevant person either—
 - (a) freely, and with full understanding of what is involved, agrees unconditionally that the order be made; or
 - (b) is a person who—
 - (i) is not known, cannot be found or is incapable of giving agreement;
 - (ii) is withholding such agreement unreasonably;
 - (iii) has persistently failed, without reasonable cause, to fulfil one or other of the following parental responsibilities in relation to the child, that is to say the responsibility to safeguard and promote the child’s health, development and welfare or, if the child is not living with him, the responsibility to maintain personal relations and direct contact with the child on a regular basis; or
 - (iv) has seriously ill-treated the child, whose reintegration into the same household as that person is, because of the serious ill-treatment or for other reasons, unlikely.
- (3) The reference in subsection (1) above to the appropriate parental rights and responsibilities relating to the child is to all parental rights and responsibilities except any right to agree, or decline to agree—
 - (a) to the making of an application in relation to the child under section 18 (freeing for adoption or 55 (adoptions abroad) of the ^{M52}Adoption Act 1976, under section 18 or 49 of the ^{M53}Adoption (Scotland) Act 1978 or under Article 17, 18 or 57 of the ^{M54}Adoption (Northern Ireland) Order 1987 (corresponding provision for Scotland and Northern Ireland); or
 - (b) to the making of an adoption order.
- (4) A person is a relevant person for the purposes of this section if he is a parent of the child or a person who for the time being has parental rights in relation to the child.
- (5) The sheriff may, in an order under this section impose such conditions as he considers appropriate; and he may vary or discharge such an order on the application of the local authority, of the child, of any person who immediately before the making of the order is a relevant person or of any other person claiming an interest.

- (1) This section applies where a parental responsibilities order is being made, or as the case may be is in force, as respects a child.

 - (b) any person in whom parental responsibilities or rights are vested by, under or by virtue of this Act; and
 - (c) any person who appears to be a person who ordinarily (and other than by reason only of his employment) has charge of, or control over, the child.
- (3) Where, in the course of any proceedings under Chapter 2 or 3 of this Part, a child ceases to be a child within the meaning of subsection (2) above the provisions of those Chapters of this Part and of any statutory instrument made under those provisions, shall continue to apply to him as if he had not so ceased to be a child.
- (4) Any reference in this Part of this Act to a child—
- (a) being “in need”, is to his being in need of care and attention because—
 - (i) he is unlikely to achieve or maintain, or to have the opportunity of achieving or maintaining, a reasonable standard of health or development unless there are provided for him, under or by virtue of this Part, services by a local authority;
 - (ii) his health or development is likely significantly to be impaired, or further impaired, unless such services are so provided;
 - (iii) he is disabled; or
 - (iv) he is affected adversely by the disability of any other person in his family;
 - (b) who is “looked after” by a local authority, shall be construed in accordance with section 17(6) of this Act.
- (5) Any reference to any proceedings under this Part of this Act, whether on an application or on appeal, being heard by the sheriff, shall be construed as a reference to such proceedings being heard by the sheriff in chambers.

94 Approval of adoption society for specific services. S

(1) In section 3 of the 1978 Act (approval of adoption societies)—

(a) for subsections (1) and (2) substitute—

“(1) Subject to any regulations made under section 9(1), a body which is a voluntary organisation may apply to the Secretary of State for his approval to its acting, or as the case may be continuing to act, as an adoption society, whether functioning generally or in relation to some service maintained, or to be maintained, as part of the Scottish Adoption Service and specified in the application (the service so specified being in this section and in section 4 referred to as the body’s “specified service”).

(1A) Application under subsection (1) shall be in such manner as may be specified in regulations made by the Secretary of State under this section.

(2) In considering an application under subsection (1), the Secretary of State shall take into account the matters relating to the applicant specified in subsections (3) to (5) and any other matters which appear to him to be relevant; and if, but only if, he is satisfied that, as the case may be, the applicant is likely to make, or is making, an effective contribution to the Scottish Adoption Service or to the applicant’s specified service, he shall by notice to the applicant give the approval sought.

(2A) Approval under subsection (2) shall operate from such date as may be specified in the notice or, in the case of a renewal of approval, from the date of the notice.”;

(b) in subsection (3)(a), the words “, including in particular its ability to make provision for children who are free for adoption” shall cease to have effect;

(c) in subsection (5), for the words “areas within which” substitute “ geographical areas within which, the services as respects which ”;

(d) in subsection (6), after the word “Service” insert “ , or as the case may be to the applicant’s specified service ”; and

(e) in subsection (7)—

(i) for the words “a period of” substitute “ such period not exceeding ”; and

(ii) after the word “operative” insert “ as the Secretary of State may specify in the approval. ”.

(2) In section 4 of that Act (withdrawal of approval), after the word “Service” insert “ , or as the case may be to the body’s specified service, ”.

(3) In section 65(1) of that Act (interpretation), in the definition of “adoption society”, after the word “for” insert “ , or in connection with, ”.

CHILDREN’S PANELS

Appointment

- 1 The Secretary of State shall, for each local government area, appoint such number of members of children’s panels as he considers appropriate and from among that number appoint a chairman and a deputy chairman.
- 2 A member of a children’s panel shall hold office for such period as is specified by the Secretary of State, but may be removed from office by the Secretary of State at any time.

Children’s Panel Advisory Committees

- 3 Subject to paragraph 8 below, each local authority shall form a body (to be known as a “Children’s Panel Advisory Committee”) consisting of two members nominated by the local authority and three members nominated by the Secretary of State.
- 4 The Secretary of State may at the request of the local authority provide for an increase in the membership of the Children’s Panel Advisory Committee appointed under paragraph 3 above by such number, not exceeding five, of additional members as the authority specify in relation to their request, the additional members to be nominated as follows—
 - (a) the first, and any second or fourth additional member, by the Secretary of State;
 - (b) any third or fifth additional member, by the local authority.
- 5 The chairman of the Children’s Panel Advisory Committee shall be appointed by the Secretary of State from among such of the members he has nominated as are resident in the local government area for which the panel is appointed.
- 6 It shall be the duty of the Children’s Panel Advisory Committee—
 - (a) to submit names of possible panel members to the Secretary of State;
 - (b) to advise the Secretary of State, in so far as he requires advice, on the suitability of persons referred to him as potential panel members; and
 - (c) to advise the Secretary of State on such matters relating to the general administration of the panels as he may refer to them.
- 7 The Children’s Panel Advisory Committee shall have power—
 - (a) to appoint sub-committees;
 - (b) to appoint to any such sub-committee a person who is not a member of the Children’s Panel Advisory Committee; and
 - (c) to refer all or any of the duties set out in paragraph 6 above to any such sub-committee for their advice.

- 8 (1) Two or more local authorities may, instead of each acting under paragraph 3 above, make arrangements to form a Children’s Panel Advisory Committee for their areas (a “joint advisory committee”).
- (2) A joint advisory committee shall not be formed in pursuance of arrangements made under sub-paragraph (1) above unless the authorities concerned have obtained the consent in writing of the Secretary of State.
- (3) The Secretary of State may give a direction, in any case where a joint advisory committee has not been formed, to two or more local authorities requiring them to form a joint advisory committee; and they shall comply with any such direction.
- (4) Paragraphs 3 to 7, 10(a) and 11(b) of this Schedule shall apply to a joint advisory committee as they apply in respect of a Children’s Panel Advisory Committee and, for the purposes of those paragraphs the local authorities acting under sub-paragraph (1) above shall be regarded as a single local authority.

Recruitment and training of panel members

- 9 The Secretary of State may make such arrangements as he considers appropriate to recruit and train members, or possible members, of the children’s panels.
- 10 Each local authority shall make such arrangements as they consider appropriate—
- (a) to enable the Children’s Panel Advisory Committee to obtain names for submission to the Secretary of State as potential panel members; and
 - (b) to train panel members or potential panel members.

Expenses of panel members

- 11 A local authority may pay—
- (a) to a member or a potential member of a children’s panel,
 - (b) to a member of the Children’s Panel Advisory Committee,
 - (c) to any person appointed under paragraph 7 above,
- such allowances as may be determined by the Secretary of State; and he may determine differently in relation to different cases or different classes of case.

Publication of list of members of children’s panel

- 12 Each local authority shall publish a list of names and addresses of members of the children’s panel for their area, and that list shall be open for public inspection at the principal offices of the local authority, and at any place where an electors list for the local government area is available for inspection.

 - prepare a scheme (in this section and in section 51B referred to as an “adoption allowances scheme”) for the payment by the agency of allowances to any person who has adopted, or intends to adopt, a child in any case where arrangements for the adoption were made, or as the case may be are to be made, by the agency.
- (2) The Secretary of State may make regulations as respects adoption allowances schemes; and without prejudice to the generality of this subsection such regulations may in particular make provision as to—
- (a) the procedure to be followed by an agency in determining whether a person should be paid an allowance;
 - (b) the circumstances in which an allowance may be paid;
 - (c) the factors to be taken into account in determining the amount of an allowance;
 - (d) the procedure for review, variation and termination of allowances;
 - (e) the information about allowances which is to be supplied by an agency to a person who intends to adopt a child; and
 - (f) the procedure to be followed by an agency in drawing up, in making alterations to, or in revoking and replacing, an adoption allowances scheme.
- (3) Section 51(1) shall not apply to any payment made in accordance with an adoption allowances scheme (including any such payment made by virtue of section 51B).

51B Transitional provisions as respects adoption allowances.

After the coming into force of section 51A—

- (a) no scheme for the payment of allowances shall be submissible under subsection (5) of section 51; and
- (b) a scheme which has been approved under that subsection of that section shall forthwith be revoked under subsection (6)(b) of that section, so however that where a person was before its revocation receiving payments made in accordance with that scheme he may continue to receive payments so made which, had there been no revocation, would have fallen to be made to him or he may agree to receive, instead of the continued payments, payments made in accordance with an adoption allowances scheme.”.
