



# Atomic Energy Authority Act 1995

## 1995 CHAPTER 37

An Act to make provision for the transfer of property, rights and liabilities of the United Kingdom Atomic Energy Authority to other persons; and for connected purposes. [8th November 1995]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

**11** **Membership of the Authority.**

- (1) Section 1 of the <sup>M1</sup>Atomic Energy Authority Act 1954 shall be amended as follows.
- (2) In subsection (2) (which provides that the Authority shall consist of a chairman and not less than seven nor more than fifteen other members) for “seven” there shall be substituted “ four ”.
