1995 CHAPTER 46

An Act to consolidate certain enactments relating to criminal procedure in Scotland. [8th November 1995]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—
