^{F1}18 Supply of goods and services.

- (1) Subsections (1) to (3) of section 1 of the Local Authorities (Goods and Services) Act 1970 (c. 39)(supply of goods and services by local authorities)—
- ^{F2}(a)
- (b) [^{F3}shall,] in their application to the Common Council of the City of London in its capacity as the police authority for the City of London police force [^{F4}, apply with the modification set out in subsection (2)].
- (2) The modification is that references in those subsections to a public body shall be read as references to any person.
- ^{F5}(3) [^{F6}The Common Council in its capacity as police authority] may not enter into an agreement with [^{F7}another local policing body] under section 1 of the 1970 Act in respect of a matter which could be the subject of [^{F8}force collaboration provision in a collaboration agreement].]]
