- <sup>F1</sup>13 (1) If after the [<sup>F2</sup>making of an order] dissolving or annulling a marriage either spouse remarries or forms a civil partnership, that spouse is not entitled to apply, by reference to the [<sup>F2</sup>making of that order,] for a Part II order.
- (2) If after the making of a dissolution or nullity order either civil partner forms a subsequent civil partnership or marries, that civil partner is not entitled to apply, by reference to the making of that order, for a Part II order.
- (3) In sub-paragraphs (1) and (2)—
- the references to remarrying and marrying include references to cases where the marriage is by law void or voidable, and
  - the references to forming a civil partnership include references to cases where the civil partnership is by law void or voidable.]
