### ANCILLARY FUNCTIONS OF GOVERNING BODIES

Provision of services

# 533 [<sup>F1</sup>Functions] of governing bodies of maintained schools with respect to provision of school meals etc.

- (1) The governing body of any school maintained by a [F<sup>2</sup>local authority] shall—
  - (a) afford the authority such facilities as they require to enable them to perform their functions under section 512, and
  - (b) allow the authority to make such use of the premises and equipment of the school, and such alterations to the school buildings, as the authority consider necessary for that purpose.
- (2) Nothing in subsection (1) shall require the governing body of [<sup>F3</sup>any such] school to incur any expenditure.
- (3) Where the governing body of a school which has a delegated budget (within the meaning of Part II [<sup>F4</sup>of the School Standards and Framework Act 1998]) provide pupils or other persons who receive education at the school with milk, meals or other refreshment, they [<sup>F5</sup>may charge for anything so provided.]
- [<sup>F6</sup>(3A) Where the governing body of a school [<sup>F7</sup>in England] exercise the power to charge under subsection (3), the price they charge for an item must not exceed the cost of providing that item.]
