# 8 Audit reviews.

(1) In this Act "an audit review" means-

- (a) an application or appeal under [<sup>F1</sup>section 28 of the Local Audit and Accountability Act 2014][<sup>F2</sup>or section 32 of the Public Audit (Wales) Act 2004] (application by auditor, or appeal by person objecting to accounts, for declaration as to unlawful item of account),
- <sup>F3</sup>(b) .....

  - (d) consideration by the Controller of Audit of whether to make a special report to the Accounts Commission for Scotland under section 102(3) of the <sup>M1</sup>Local Government (Scotland) Act 1973 (reports to Commission by Controller of Audit),
  - (e) consideration by the Accounts Commission for Scotland of whether to send a special report to the Secretary of State under section 103(3) of that Act (action by Commission on reports by Controller of Audit), or
