#### MISCELLANEOUS AND GENERAL

Remuneration of members of the Parliament and [FI Government]

## **82** Limits on salaries of members of the Parliament.

- (1) The Parliament shall ensure that the amount of salary payable to a member of the Parliament in accordance with section 81 is reduced if any salary is payable to him—
  - [FI(za) under section 4 of the Parliamentary Standards Act 2009 (salaries of members of the House of Commons), [FI] FI or [
    - (a) pursuant to a resolution (or combination of resolutions) of [F3the House of Lords] relating to the remuneration of members of that House, F4...
- (2) The Parliament shall ensure that the amount of salary is reduced—
  - (a) to a particular proportion of what it would otherwise be or to a particular amount, or
  - (b) by the amount of any salary payable to the member as mentioned in subsection  $[^{F5}(1)(za) \text{ or } (a)]$ , by a particular proportion of that amount or by some other particular amount.
