1998 CHAPTER 47

U.K.

An Act to make new provision for the government of Northern Ireland for the purpose of implementing the agreement reached at multi-party talks on Northern Ireland set out in Command Paper 3883. [19th November 1998]

Be it enacted by the Queen's most Excellent Majesty, by and with the advice and consent of the Lords Spiritual and Temporal, and Commons, in this present Parliament assembled, and by the authority of the same, as follows:—

PRELIMINARY

1 Status of Northern Ireland. U.K.

- (1) It is hereby declared that Northern Ireland in its entirety remains part of the United Kingdom and shall not cease to be so without the consent of a majority of the people of Northern Ireland voting in a poll held for the purposes of this section in accordance with Schedule 1.
- (2) But if the wish expressed by a majority in such a poll is that Northern Ireland should cease to be part of the United Kingdom and form part of a united Ireland, the Secretary of State shall lay before Parliament such proposals to give effect to that wish as may be agreed between Her Majesty's Government in the United Kingdom and the Government of Ireland.

2 Previous enactments. U.K.

The MIGovernment of Ireland Act 1920 is repealed; and this Act shall have effect notwithstanding any other previous enactment.

3 Devolution order. U.K.

- (1) If it appears to the Secretary of State that sufficient progress has been made in implementing the Belfast Agreement, he shall lay before Parliament the draft of an Order in Council appointing a day for the commencement of Parts II and III ("the appointed day").
- (2) If the draft Order laid before Parliament under subsection (1) is approved by resolution of each House of Parliament, the Secretary of State shall submit it to Her Majesty in Council and Her Majesty in Council may make the Order.

4 Transferred, excepted and reserved matters. U.K.

(1) In this Act—

"excepted matter" means any matter falling within a description specified in Schedule 2;

"reserved matter" means any matter falling within a description specified in Schedule 3;

"transferred matter" means any matter which is not an excepted or reserved matter.

- (2) If at any time after the appointed day it appears to the Secretary of State—
 - (a) that any reserved matter should become a transferred matter; or
 - (b) that any transferred matter should become a reserved matter,

he may, subject to $[^{F1}$ subsections (2A) $[^{F2}$ to (3D)]], lay before Parliament the draft of an Order in Council amending Schedule 3 so that the matter ceases to be or, as the case may be, becomes a reserved matter with effect from such date as may be specified in the Order.

- [F3(2A) The Secretary of State shall not lay before Parliament under subsection (2) the draft of an Order amending Schedule 3 so that a policing and justice matter ceases to be a reserved matter unless—
 - (a) a motion for a resolution praying that the matter should cease to be a reserved matter is tabled by the First Minister and the deputy First Minister acting jointly; and
 - (b) the resolution is passed by the Assembly with the support of a majority of the members voting on the motion, a majority of the designated Nationalists voting and a majority of the designated Unionists voting.]
 - (3) The Secretary of State shall not lay [F4before Parliament under subsection (2) the draft of any other Order] unless the Assembly has passed with cross-community support a resolution praying that the matter concerned should cease to be or, as the case may be, should become a reserved matter.
- [F5(3A) The Secretary of State shall not lay before Parliament under subsection (2) the draft of an Order amending paragraph 16 of Schedule 3 (Civil Service Commissioners for Northern Ireland) unless the Secretary of State has, at least three months before laying the draft, laid a report before Parliament.
 - (3B) The report under subsection (3A) must set out the Secretary of State's view of the effect (if any) that the Order would have on—
 - (a) the independence of the Civil Service Commissioners for Northern Ireland;
 - (b) the application of the principle that persons should be selected for appointment to the Northern Ireland Civil Service on merit on the basis of fair and open competition; and
 - (c) the impartiality of the Northern Ireland Civil Service.]
- [F6(3C)] The Secretary of State shall not lay before Parliament under subsection (2) the draft of an Order amending paragraph 42(aa) of Schedule 3 (Northern Ireland Human Rights Commission) unless the Secretary of State has, at least three months before laying the draft, laid a report before Parliament.
 - (3D) The report under subsection (3C) must set out the Secretary of State's view of the effect (if any) that the Order would have on—
 - (a) the independence of the Northern Ireland Human Rights Commission;
 - (b) the application of internationally accepted principles relating to national human rights institutions; and
 - (c) the relationship between the Northern Ireland Human Rights Commission and the Assembly.]
 - (4) If the draft of an Order laid before Parliament under subsection (2) is approved by resolution of each House of Parliament, the Secretary of State shall submit it to Her Majesty in Council and Her Majesty in Council may make the Order.

(5) In this Act—

"the Assembly" means the New Northern Ireland Assembly, which after the appointed day shall be known as the Northern Ireland Assembly;

"cross-community support", in relation to a vote on any matter, means—

- (a) the support of a majority of the members voting, a majority of the designated Nationalists voting and a majority of the designated Unionists voting; or
- (b) the support of 60 per cent of the members voting, 40 per cent of the designated Nationalists voting and 40 per cent of the designated Unionists voting;

"designated Nationalist" means a member designated as a Nationalist in accordance with standing orders of the Assembly and "designated Unionist" shall be construed accordingly.

- [F7(5A) Standing orders of the Assembly shall provide that a member of the Assembly designated in accordance with the standing orders as a Nationalist, as a Unionist or as Other may change his designation only if—
 - (a) (being a member of a political party) he becomes a member of a different political party or he ceases to be a member of any political party;
 - (b) (not being a member of any political party) he becomes a member of a political party.]

General

5 Acts of the Northern Ireland Assembly. U.K.

- (1) Subject to sections 6 to 8, the Assembly may make laws, to be known as Acts.
- (2) A Bill shall become an Act when it has been passed by the Assembly and has received Royal Assent.
- (3) A Bill receives Royal Assent at the beginning of the day on which Letters Patent under the Great Seal of Northern Ireland signed with Her Majesty's own hand signifying Her Assent are notified to the Presiding Officer.
- (4) The date of Royal Assent shall be written on the Act by the Presiding Officer, and shall form part of the Act.
- (5) The validity of any proceedings leading to the enactment of an Act of the Assembly shall not be called into question in any legal proceedings.
- (6) This section does not affect the power of the Parliament of the United Kingdom to make laws for Northern Ireland, but an Act of the Assembly may modify any provision made by or under an Act of Parliament in so far as it is part of the law of Northern Ireland.

6 Legislative competence. U.K.

- (1) A provision of an Act is not law if it is outside the legislative competence of the Assembly.
- (2) A provision is outside that competence if any of the following paragraphs apply—
 - (a) it would form part of the law of a country or territory other than Northern Ireland, or confer or remove functions exercisable otherwise than in or as regards Northern Ireland;
 - (b) it deals with an excepted matter and is not ancillary to other provisions (whether in the Act or previously enacted) dealing with reserved or transferred matters;
 - (c) it is incompatible with any of the Convention rights;
 - [F9(ca) it is incompatible with Article 2(1) of the Protocol on Ireland/Northern Ireland in the EU withdrawal agreement (rights of individuals);

- (e) it discriminates against any person or class of person on the ground of religious belief or political opinion;
- (f) it modifies an enactment in breach of section 7.
- (3) For the purposes of this Act, a provision is ancillary to other provisions if it is a provision—
 - (a) which provides for the enforcement of those other provisions or is otherwise necessary or expedient for making those other provisions effective; or
 - (b) which is otherwise incidental to, or consequential on, those provisions; and references in this Act to provisions previously enacted are references to provisions contained in, or in any instrument made under, other Northern Ireland legislation or an Act of Parliament.
- (4) Her Majesty may by Order in Council specify functions which are to be treated, for such purposes of this Act as may be specified, as being, or as not being, functions which are exercisable in or as regards Northern Ireland.
- (5) No recommendation shall be made to Her Majesty to make an Order in Council under subsection (4) unless a draft of the Order has been laid before and approved by resolution of each House of Parliament.

[F257A Cross-community support required for Bill altering size of Assembly U.K.

- (1) The Assembly shall not pass a relevant Bill without cross-community support.
- (2) In this section—

"pass", in relation to a Bill, means pass at the stage in the Assembly's proceedings at which the Bill falls finally to be passed or rejected;

"relevant Bill" means a Bill containing a provision which deals with a matter falling within a description specified in paragraph 7A of Schedule 3 (size of Assembly).]

8 Consent of Secretary of State required in certain cases. U.K.

The consent of the Secretary of State shall be required in relation to a Bill which contains—

- (a) a provision which deals with an excepted matter and is ancillary to other provisions (whether in the Bill or previously enacted) dealing with reserved or transferred matters; or
- (b) a provision which deals with a reserved matter.

Scrutiny and stages of Bills

9 Scrutiny by Ministers. U.K.

- (1) A Minister in charge of a Bill shall, on or before introduction of it in the Assembly, make a statement to the effect that in his view the Bill would be within the legislative competence of the Assembly.
- (2) The statement shall be in writing and shall be published in such manner as the Minister making the statement considers appropriate.

10 Scrutiny by Presiding Officer. U.K.

- (1) Standing orders shall ensure that a Bill is not introduced in the Assembly if the Presiding Officer decides that any provision of it would not be within the legislative competence of the Assembly.
- (2) Subject to subsection (3)—
 - (a) the Presiding Officer shall consider a Bill both on its introduction and before the Assembly enters on its final stage; and
 - (b) if he considers that the Bill contains—
 - (i) any provision which deals with an excepted matter and is ancillary to other provisions (whether in the Bill or previously enacted) dealing with reserved or transferred matters; or
 - (ii) any provision which deals with a reserved matter,

he shall refer it to the Secretary of State; and

- (c) the Assembly shall not proceed with the Bill or, as the case may be, enter on its final stage unless—
 - (i) the Secretary of State's consent to the consideration of the Bill by the Assembly is signified; or
 - (ii) the Assembly is informed that in his opinion the Bill does not contain any such provision as is mentioned in paragraph (b)(i) or (ii).
- (3) Subsection (2)(b) and (c) shall not apply—
 - (a) where, in the opinion of the Presiding Officer, each provision of the Bill which deals with an excepted or reserved matter is ancillary to other provisions (whether in the Bill or previously enacted) dealing with transferred matters only; or
 - (b) on the introduction of a Bill, where the Bill has been endorsed with a statement that the Secretary of State has consented to the Assembly considering the Bill.
- (4) In this section and section 14 "final stage", in relation to a Bill, means the stage in the Assembly's proceedings at which the Bill falls finally to be passed or rejected.

11 Scrutiny by the [F26Supreme Court]. U.K.

- (1) The [F27]Advocate General for Northern Ireland or the Attorney General for Northern Ireland may refer the question of whether a provision of a Bill would be within the legislative competence of the Assembly to the [F28]Supreme Court] for decision.
- (2) Subject to subsection (3), he may make a reference in relation to a provision of a Bill at any time during—

- (a) the period of four weeks beginning with the passing of the Bill; and
- (b) the period of four weeks beginning with any subsequent approval of the Bill in accordance with standing orders made by virtue of section 13(6).
- (3) If he notifies the Presiding Officer that he does not intend to make a reference in relation to a provision of a Bill, he shall not make such a reference unless, after the notification, the Bill is approved as mentioned in subsection (2)(b).
- (4) If the [F29]Supreme Court decides] that any provision of a Bill would be within the legislative competence of the Assembly, [F30]its decision] shall be taken as applying also to that provision if contained in the Act when enacted.

13 Stages of Bills. U.K.

- (1) Standing orders shall include provision—
 - (a) for general debate on a Bill with an opportunity for members to vote on its general principles;
 - (b) for the consideration of, and an opportunity for members to vote on, the details of a Bill; and
 - (c) for a final stage at which a Bill can be passed or rejected but not amended.

22 Statutory functions. U.K.

- (1) An Act of the Assembly or other enactment may confer functions on a Minister (but not a junior Minister) or a Northern Ireland department by name.
- (2) Functions conferred on a Northern Ireland department by an enactment passed or made before the appointed day shall, except as provided by an Act of the Assembly or other subsequent enactment, continue to be exercisable by that department.

23 Prerogative and executive powers. U.K.

- (1) The executive power in Northern Ireland shall continue to be vested in Her Majesty.
- (2) As respects transferred matters, the prerogative and other executive powers of Her Majesty in relation to Northern Ireland shall, subject to [F81 subsections (2A) and (3)], be exercisable on Her Majesty's behalf by any Minister or Northern Ireland department.
- [F82(2A) So far as the Royal prerogative of mercy is exercisable on Her Majesty's behalf under subsection (2), it is exercisable only by the Minister in charge of the Department of Justice.]
 - (3) As respects the Northern Ireland Civil Service and the Commissioner for Public Appointments for Northern Ireland, the prerogative and other executive powers of Her

Majesty in relation to Northern Ireland shall be exercisable on Her Majesty's behalf by the First Minister and the deputy First Minister acting jointly.

(4) The First Minister and deputy First Minister acting jointly may by prerogative order under subsection (3) direct that such of the powers mentioned in that subsection as are specified in the order shall be exercisable on Her Majesty's behalf by a Northern Ireland Minister or Northern Ireland department so specified.

25 Excepted and reserved matters. U.K.

- (1) If any subordinate legislation made, confirmed or approved by a Minister or Northern Ireland department contains a provision dealing with an excepted or reserved matter, the Secretary of State may by order revoke the legislation.
- (2) An order made under subsection (1) shall recite the reasons for revoking the legislation and may make provision having retrospective effect.

26 International obligations. U.K.

- (1) If the Secretary of State considers that any action proposed to be taken by a Minister or Northern Ireland department would be incompatible with any international obligations, with the interests of defence or national security or with the protection of public safety or public order, he may by order direct that the proposed action shall not be taken.
- (2) If the Secretary of State considers that any action capable of being taken by a Minister or Northern Ireland department is required for the purpose of giving effect to any international obligations, of safeguarding the interests of defence or national security or of protecting public safety or public order, he may by order direct that the action shall be taken.
- (3) In subsections (1) and (2), "action" includes making, confirming or approving subordinate legislation and, in subsection (2), includes introducing a Bill in the Assembly.
- (4) If any subordinate legislation made, confirmed or approved by a Minister or Northern Ireland department contains a provision which the Secretary of State considers—
 - (a) would be incompatible with any international obligations, with the interests of defence or national security or with the protection of public safety or public order; or
 - (b) would have an adverse effect on the operation of the single market in goods and services within the United Kingdom,

the Secretary of State may by order revoke the legislation.

(5) An order under this section shall recite the reasons for making the order and may make provision having retrospective effect.

Quotas for purposes of international etc obligations. U.K.

- (1) A Minister of the Crown may make an order containing provision such as is specified in subsection (2) where—
 - (a) an international obligation or [F89[F90] an assimilated] obligation] is an obligation to achieve a result defined by reference to a quantity (whether expressed as an amount, proportion or ratio or otherwise); and
 - (b) the quantity relates to the United Kingdom (or to an area including the United Kingdom or to an area consisting of a part of the United Kingdom which is or includes the whole or part of Northern Ireland).
- (2) The provision referred to in subsection (1) is provision for the achievement by a Minister or Northern Ireland department (in the exercise of his or its functions) of so much of the result to be achieved under the international obligation or [^{F91}[^{F92}assimilated] obligation] as is specified in the order.
- (3) The order may specify the time by which any part of the result to be achieved by the Minister or department is to be achieved.
- (4) Where an order under subsection (1) is in force in relation to an international obligation F93..., the obligation shall have effect for the purposes of this Act as if it were an obligation to achieve so much of the result to be achieved under the obligation as is specified in the order by the time or times so specified.

28 Agency arrangements between UK and NI departments. U.K.

- (1) Arrangements may be made between—
 - (a) any department of the Government of the United Kingdom or any public body, or holder of a public office, in the United Kingdom; and
 - (b) any Northern Ireland department,

for any functions of one of them to be discharged by, or by officers of, the other.

- (2) No such arrangements shall affect the responsibility of the person on whose behalf any functions are discharged.
- (3) In this section—
 - (a) references to a department of the Government of the United Kingdom include references to any Minister of the Crown; and
 - (b) references to a Northern Ireland department include references to a Minister.

28A Ministerial Code U.K.

- (1) Without prejudice to the operation of section 24, a Minister or junior Minister shall act in accordance with the provisions of the Ministerial Code.
- (2) In this section "the Ministerial Code" means—
 - (a) the Ministerial Code that becomes the Ministerial Code for the purposes of this section by virtue of paragraph 4 of Schedule 1 to the Northern Ireland (St Andrews Agreement) Act 2006 (as from time to time amended in accordance with this section); or
 - (b) any replacement Ministerial Code prepared and approved in accordance with this section (as from time to time amended in accordance with this section).
- (3) If at any time the Executive Committee—
 - (a) prepares draft amendments to the Ministerial Code; or
 - (b) prepares a draft Ministerial Code to replace the Ministerial Code,

the First Minister and deputy First Minister acting jointly shall lay the draft amendments or the draft Code before the Assembly for approval.

- (4) A draft Ministerial Code or a draft amendment to the Code—
 - (a) shall not be approved by the Assembly without cross-community support; and
 - (b) shall not take effect until so approved.
- (5) The Ministerial Code must include provision for requiring Ministers or junior Ministers to bring to the attention of the Executive Committee any matter that ought, by virtue of section 20(3) or (4), to be considered by the Committee.
- (6) The Ministerial Code must include provision for a procedure to enable any Minister or junior Minister to ask the Executive Committee to determine whether any decision that he is proposing to take, or has taken, relates to a matter that ought, by virtue of section 20(3) or (4), to be considered by the Committee.
- (7) The Ministerial Code must also include provision as to the procedures of the Executive Committee with respect to—
 - (a) the taking of decisions; and
 - (b) consideration by the Committee of decision papers that are to be considered by the North-South Ministerial Council or the British-Irish Council.
- (8) The Ministerial Code must in particular provide—
 - (a) that it is the duty of the chairmen of the Executive Committee to seek to secure that decisions of the Executive Committee are reached by consensus wherever possible;
 - (b) that, if consensus cannot be reached, a vote may be taken; and

- (c) that, if any three members of the Executive Committee require the vote on a particular matter which is to be voted on by the Executive Committee to require cross-community support, any vote on that matter in the Executive Committee shall require cross-community support in the Executive Committee
- (9) The Ministerial Code may include such other provisions as the Executive Committee thinks fit.

28B Power to refer Ministerial decision to Executive Committee U.K.

- (1) This section applies if 30 members petition the Assembly expressing concern that a decision taken by a Minister or junior Minister ("the Ministerial decision")—
 - (a) may have been taken in contravention of section 28A(1); or
 - (b) relates to a matter of public importance.
- (2) But this section does not apply if the Ministerial decision has previously been the subject of a reference under this section.
- (3) If the Presiding Officer, after consulting the political parties whose members hold seats in the Assembly, certifies that the Ministerial decision relates to a matter of public importance, he shall refer the decision to the Executive Committee for its consideration.

 - (b) whether or not the decision relates, in its view, to a significant or controversial matter; and
 - (c) as to any action that the Executive Committee proposes to take, or has taken, in relation to the decision.
- (5) No reference may be made under this section after the end of the period of seven days beginning with—
 - (a) the day on which the Ministerial decision was taken; or

29 Statutory committees. U.K.

- (1) Standing orders shall make provision—
 - (a) for establishing committees of members of the Assembly ("statutory committees")
 - [F101(i) to advise and assist the First Minister and the deputy First Minister in the formulation of policy with respect to matters within their responsibilities as Ministers jointly in charge of the Office of the First Minister and deputy First Minister, and
 - (ii) Ito advise and assist each Northern Ireland Minister in the formulation of policy with respect to matters within his responsibilities as a Minister;
 - (b) for enabling a committee to be so established either in relation to a single Northern Ireland Minister or in relation to more than one; and
 - (c) conferring on the committees the powers described in paragraph 9 of Strand One of the Belfast Agreement.
- (2) Standing orders shall provide that—
 - (a) the nominating officer of the political party for which the formula in subsection (3) gives the highest figure may select a statutory committee and nominate as its chairman or deputy chairman a person who is a member of the party and of the Assembly;
 - (b) if the nominating officer does not exercise the power conferred by paragraph (a) within a period specified in standing orders, or the nominated person does not take up the selected office within that period, that power shall be exercisable instead by the nominating officer of the political party for which the formula in subsection (3) gives the next highest figure; and
 - (c) paragraphs (a) and (b) shall be applied as many times as may be necessary to secure that a chairman and deputy chairman are nominated for each of the statutory committees.
- (3) The formula is—

$$\frac{S}{1+C}$$

where-

S = the number of seats in the Assembly which were held by members of the party on the day on which the Assembly first met following its election;

C = the number of chairmen and deputy chairmen of statutory committees (if any) who are members of the party.

- (4) Standing orders shall provide that, where the figures given by the formula for two or more political parties are equal, each of those figures shall be recalculated with S being equal to the number of first preference votes cast for the party at the last general election of members of the Assembly.
- (5) Standing orders shall provide that—
 - (a) a Minister or junior Minister may not be the chairman or deputy chairman of a statutory committee; and
 - (b) in making a selection under the provision made by virtue of subsection (2)(a), a nominating officer shall prefer a committee in which he does not have a party interest to one in which he does.

34 Elections and franchise. U.K.

- (1) This section applies to elections of members of the Assembly, including by-elections.
- (2) Each vote in the poll at an election shall be a single transferable vote.

37 Effect of disqualification and provision for relief. U.K.

- (1) Subject to any order made by the Assembly under this section—
 - (a) if any person disqualified by virtue of [F144]the Northern Ireland Assembly Disqualification Act 1975 or] section 36 is returned as a member of the Assembly, his return shall be void; and
 - (b) if any person being a member of the Assembly becomes disqualified by virtue of [F145that Act or] that section, his seat shall be vacated.
- (2) If, in a case which falls or is alleged to fall within subsection (1) otherwise than by virtue of section 36(4), it appears to the Assembly—
 - (a) that the grounds of disqualification or alleged disqualification which subsisted or arose at the material time have been removed; and
 - (b) that it is otherwise proper so to do,
 - the Assembly may by order direct that any such disqualification incurred on those grounds at that time shall be disregarded for the purposes of this section.
- (3) No order under subsection (2) shall affect the proceedings on any election petition or any determination of an election court.

38 Disqualification: judicial proceedings. U.K.

- (1) Any person who claims that a person purporting to be a member of the Assembly—
 - (a) is disqualified; or
 - (b) was disqualified when, or at any time since, he was returned, may apply to the High Court of Justice in Northern Ireland for a declaration to that effect.
- (2) On an application—
 - (a) the person in respect of whom the application is made shall be the respondent;
 - (b) the applicant shall give such security for costs, not exceeding £5,000, as the court may direct; and
 - (c) the decision of the court shall be final.
- (3) A declaration made in accordance with this section shall be certified in writing to the Secretary of State by the court.
- (4) No such declaration shall be made in respect of a person on any grounds if an order has been made by the Assembly under subsection (2) of section 37 directing that any disqualification incurred by him on those grounds shall be disregarded for the purposes of that section.
- (5) No declaration shall be made in respect of any person on grounds which subsisted when he was elected if an election petition is pending or has been tried in which his disqualification on those grounds is or was in issue.
- (6) The Secretary of State may by order substitute for the amount specified in subsection (2)(b) such other amount as may be specified in the order.

Presiding Officer and Commission

39 Presiding Officer. U.K.

- (1) Each Assembly shall as its first business elect from among its members a Presiding Officer and deputies.
- (2) A person elected Presiding Officer or deputy shall hold office until the conclusion of the next election for Presiding Officer under subsection (1) unless—

- (1) There shall be a body corporate, to be known as the Northern Ireland Assembly Commission ("the Commission"), to perform—
 - (a) the functions conferred on the Commission by virtue of any enactment; and
 - (b) any functions conferred on the Commission by resolution of the Assembly.
- (2) The members of the Commission shall be—
 - (a) the Presiding Officer; and
 - (b) the prescribed number of members of the Assembly appointed in accordance with standing orders.

- (6) Proceedings by or against the Assembly (other than proceedings on the Crown side of the Queen's Bench Division) shall be instituted by or against the Commission on behalf of the Assembly.
- (7) Any property or liabilities acquired or incurred in relation to matters within the general responsibility of the Commission to which (apart from this subsection) the Assembly would be entitled or subject shall be treated for all purposes as property or liabilities of the Commission.
- (8) Any expenses of the Commission shall be defrayed out of money appropriated by Act of the Assembly.

- (9) Any sums received by the Commission shall be paid into the Consolidated Fund of Northern Ireland, subject to any provision made by Act of the Assembly for the disposal of or accounting for such sums.
- (10) Schedule 5 (which makes further provision about the Commission) shall have effect.

- (2) Standing orders shall not be made, amended or repealed without cross-community support.
- (3) Schedule 6 (which makes provision as to how certain matters are to be dealt with by standing orders) shall have effect.

[F15142 Petitions of concern. U.K.

- (1) If a petition expressing concern about a matter which is to be voted on by the Assembly is—
 - (a) presented to the Assembly by 30 members, and
 - (b) on the day after the consideration period, confirmed by 30 members, the vote on that matter requires cross-community support.
- (2) If such a petition is presented, the vote on the matter to which it relates may not take place until after the day mentioned in subsection (1)(b).

- (b) provide that the matter to which a petition under this section relates may be referred, in accordance with paragraphs 11 and 13 of Strand One of the Belfast Agreement, to the committee established under section 13(3)(a);
- (c) specify further matters that may not be the subject of a petition under this section, for the purposes of fully implementing paragraph 2.2.4 of Annex B of Part 2 of The New Decade, New Approach Deal;

43 Members' interests. U.K.

 - (b) for withdrawing his rights and privileges as a member for the period of his exclusion.

[F155(4A) That power is not exercisable in relation to a person mentioned in subsection (4) in connection with the discharge, during a relevant period, of a function which relates to a matter which is a transferred matter by virtue of an Order under section 4.

For this purpose "relevant period" means a period when the matter was not a transferred matter.

 - (a) the time and place at which the person is to attend and the particular matters relating to which he is required to give evidence; or
 - (b) the documents, or types of documents, which he is to produce, the date by which he is to produce them and the particular matters to which they are to relate.
- (8) Such notice shall be given—
 - (a) in the case of an individual, by sending it, by registered post or the recorded delivery service, addressed to him at his usual or last known address or, where he has given an address for service, at that address;
 - (b) in any other case, by sending it, by registered post or the recorded delivery service, addressed to the person at the person's registered or principal office.

Witnesses and documents: offences. U.K.

- (1) Subject to subsection (9) of section 44, any person to whom a notice under subsection (7) of that section has been given who—
 - (a) refuses or fails to attend proceedings as required by the notice;
 - (b) refuses or fails, when attending proceedings as required by the notice, to answer any question relating to the matters specified in the notice;

- (1) The First Minister and the deputy First Minister acting jointly shall, as far in advance of each meeting of the North-South Ministerial Council or the British-Irish Council as is reasonably practicable, give to the Executive Committee and to the Assembly the following information in relation to the meeting—
 - (a) the date;
 - (b) the agenda; and
 - (c) (once determined under this section) the names of the Ministers or junior Ministers who are to attend the meeting.
- (2) Each Minister or junior Minister who has responsibility (whether or not with another Minister or junior Minister) in relation to any matter included in the agenda for a meeting of either Council ("appropriate Minister") shall be entitled—
 - (a) to attend the meeting; and
 - (b) to participate (see section 52C) in the meeting so far as it relates to that matter.
- (3) An appropriate Minister may nominate another Minister or junior Minister—
 - (a) to attend the meeting in place of the appropriate Minister; and

 - (c) he does not intend to attend the meeting and he does not intend, or has not been able, to make such a nomination,

and a notification under paragraph (b) shall include the name of the person nominated.

Consolidated Fund

57 Consolidated Fund of Northern Ireland. U.K.

- (1) The Consolidated Fund of Northern Ireland shall continue to exist.
- (2) Sums forming part of the Fund—
 - (a) shall be appropriated to the public service of Northern Ireland by Act of the Assembly; and
 - (b) shall not be applied for any purpose for which they are not appropriated.
- (3) Subsection (2) is subject to section 59 and to any provision which charges sums on the Fund and is made—
 - (a) by or under an Act of Parliament; or
 - (b) by an Act of the Assembly or other Northern Ireland legislation.

Payments into the Fund. U.K.

The Secretary of State shall from time to time make payments into the Consolidated Fund of Northern Ireland out of money provided by Parliament of such amounts as he may determine.

59 Payments out of Fund without appropriation Act. U.K.

- (1) If an Act is not passed at least three working days before the end of a financial year ("year 1") authorising the issue out of the Consolidated Fund of Northern Ireland of sums for the service of the next financial year ("year 2")—
 - (a) the authorised officer of the Department of Finance and Personnel may, subject to any Act subsequently passed, authorise the issue of sums out of that Fund for the service of year 2; and
 - (b) the sums so issued shall be appropriated for such services and purposes as the officer may direct.
- (2) The aggregate of the sums issued under subsection (1) for the service of year 2 shall not exceed 75 per cent of the total amount appropriated by Act for the service of year 1.
- (3) If an Act is not passed before the end of July in any financial year authorising the issue out of the Consolidated Fund of Northern Ireland of sums for the service of the year—
 - (a) the authorised officer of the Department of Finance and Personnel may, subject to any Act subsequently passed, authorise the issue of sums out of that Fund for the service of the year; and
 - (b) the sums so issued shall be appropriated for such services and purposes as the officer may direct.
- (4) The aggregate of the sums issued under subsection (3), and (where applicable) the sums issued under subsection (1), for the service of any financial year shall not exceed 95 per cent of the total amount appropriated by Act for the service of the preceding financial year.
- (5) In this section—

"Act" means an Act of the Assembly or, in relation to any time before the appointed day, an Order in Council under Schedule 1 to the MII Northern Ireland Act 1974;

"authorised officer", in relation to the Department of Finance and Personnel, means the Permanent Secretary or such other officer as may be nominated by him for the purpose.

60 Financial control, accounts and audit. U.K.

- (1) In so far as such provision has not been made, an Act of the Assembly or other Northern Ireland legislation shall make provision—
 - (a) for proper accounts to be prepared by the Northern Ireland departments, and by other persons to whom sums are paid directly out of the Consolidated Fund of Northern Ireland, of their expenditure and receipts;
 - (b) for the Department of Finance and Personnel to prepare an account of payments into and out of the Fund;
 - (c) for the Comptroller and Auditor General for Northern Ireland to exercise, or ensure the exercise by other persons of, the functions mentioned in subsection (2);

- (d) for access by persons exercising those functions to such documents as they may reasonably require;
- (e) for members of the Northern Ireland Civil Service designated for the purpose to be answerable to the Assembly in respect of the expenditure and receipts of each of the Northern Ireland departments; and
- (f) for the publication of accounts prepared in pursuance of paragraphs (a) and (b), and of reports on such accounts, and for the laying of such accounts and reports before the Assembly.
- (2) The functions referred to in subsection (1)(c) are—
 - (a) issuing credits for the payment of sums out of the Fund;
 - (b) examining accounts prepared in pursuance of subsection (1)(a) and (b) (which includes determining whether sums paid out of the Fund have been paid out and applied in accordance with section 57), and certifying and reporting on them;
 - (c) carrying out examinations into the economy, efficiency and effectiveness with which the Northern Ireland departments have used their resources in discharging their functions; and
 - (d) carrying out examinations into the economy, efficiency and effectiveness with which other persons determined under Northern Ireland legislation to whom sums are paid directly out of the Fund have used those sums in discharging their functions.
- (3) Standing orders shall make provision for establishing a committee of members of the Assembly to consider accounts, and reports on accounts, laid before the Assembly in pursuance of this section or any other enactment.
- (4) Persons (other than the Comptroller and Auditor General for Northern Ireland) charged with the exercise of any function under subsection (2) or other like function conferred by Northern Ireland legislation shall not, in the exercise of that or any ancillary function, be subject to the direction or control of any Minister or Northern Ireland department or of the Assembly.
- (5) Subsection (2)(b) does not apply to accounts prepared by the Comptroller and Auditor General for Northern Ireland.

Advances

61 Advances by Secretary of State. U.K.

- (1) The Secretary of State may advance to the Department of Finance and Personnel sums required for the purpose of—
 - (a) meeting a temporary excess of sums to be paid out of the Consolidated Fund of Northern Ireland over sums paid into the Fund; or
 - (b) providing a working balance in the Fund.
- (2) The Treasury may issue to the Secretary of State out of the National Loans Fund any sum which he requires for the making of an advance under this section.
- (3) The aggregate at any time outstanding in respect of the principal of sums advanced under this section shall not exceed £250 million.

- (4) Sums advanced under this section shall be repaid to the Secretary of State at such times and by such methods, and interest on them shall be paid to him at such rates and at such times, as the Treasury may determine.
- (5) Sums received by the Secretary of State under subsection (4) shall be paid into the National Loans Fund.
- (6) Amounts required for the repayment of, or the payment of interest on, sums advanced under this section shall be charged on the Consolidated Fund of Northern Ireland.
- (7) The Secretary of State may by order, with the consent of the Treasury, substitute for the amount specified in subsection (3) such increased amount as may be specified in the order.

 - (a) prepare, in such form and manner as the Treasury may direct, an account of sums paid and received by him under section 61; and
 - (b) send the account to the Comptroller and Auditor General not later than the end of November in the following financial year.

- [F199(1A) At least 14 days before laying a draft budget for a financial year, the Minister of Finance and Personnel must lay before the Assembly a statement specifying the amount of UK funding for that year notified to the Minister by the Secretary of State.
 - (1B) At the same time as laying a draft budget for a financial year, the Minister of Finance and Personnel must lay before the Assembly a statement showing that the amount of UK funding required by the draft budget does not exceed the amount specified under subsection (1A) for that year.
 - (1C) Subsection (1D) applies if, after a draft budget for a financial year has been laid before the Assembly, the Secretary of State notifies the Minister of Finance and Personnel that the amount of UK funding for that year has been revised to the amount specified in the notification.

The Northern Ireland Human Rights Commission. U.K.

- (1) There shall be a body corporate to be known as the Northern Ireland Human Rights Commission.
- (2) The Commission shall consist of a Chief Commissioner and other Commissioners appointed by the Secretary of State.

- (1) The Commission shall keep under review the adequacy and effectiveness in Northern Ireland of law and practice relating to the protection of human rights.
- (2) The Commission shall, before the end of the period of two years beginning with the commencement of this section, make to the Secretary of State such recommendations as it thinks fit for improving—
 - (a) its effectiveness;
 - (b) the adequacy and effectiveness of the functions conferred on it by this Part; and

 - (b) educational activities.
- (7) The Secretary of State shall request the Commission to provide advice of the kind referred to in paragraph 4 of the Human Rights section of the Belfast Agreement.

 - (f) to make a disclosure of information relating to the Police Service of Northern Ireland which would prejudice the interests of national security.
- (2) Where in response to a notice under section 69A(1) a person gives a notice to the Commission under subsection (1) above—
 - (a) section 69A(7) and (8) shall not apply in relation to that part of the notice under section 69A(1) to which the notice under subsection (1) above relates,
 - (b) the Commission may apply to the tribunal established by section 65 of the Regulation of Investigatory Powers Act 2000 (c. 23) for an order requiring the person to take such steps as may be specified in the order to comply with the notice.

 - (g) a removal centre[F209, a short-term holding facility or pre-departure accommodation] within the meaning of section 147 of the Immigration and Asylum Act 1999 (c. 33), and

- (h) any accommodation (including accommodation in a hospital) provided for the purpose of detention under the Mental Health (Northern Ireland) Order 1986 (S.I. 1986/595 (N.I. 4)).
- (4) The Commission may specify a place of detention in the terms of reference of an investigation only if it has—
 - (a) considered whether the matter in respect of which the place is specified has already been sufficiently investigated by another person, and
 - (b) concluded that it has not.
- (5) The power under subsection (1) may not be exercised—
 - (a) during the period of 15 days beginning with that on which copies of the terms of reference of the investigation are provided in accordance with section 69D(1)(b), or
 - (b) while an application under subsection (6), made during that period, has not yet been determined.
- (6) A county court may, on the application of a person who appears to the court to be responsible for a place of detention specified in terms of reference—
 - (a) order that the power under subsection (1) may not be used to enter the place of detention;
 - (b) impose restrictions on the exercise of the power in relation to the place of detention;
 - (c) require the Commission to amend the terms of reference.
- (7) An order may be made under subsection (6) only if the court thinks that—
 - (a) access to the place of detention is unnecessary having regard to the purpose of the investigation,
 - (b) it would be unreasonable to allow the Commission access to the place of detention, or
 - (c) the Commission has failed to comply with subsection (4) or section 69D.
- (8) In considering whether to make an order under subsection (6), and in considering the terms of an order under subsection (6)(b), the court shall have regard, in particular, to the likely impact of the use of the power under subsection (1) on the operation of the place of detention.

- (10) A person commits an offence if without reasonable excuse he fails to comply with an order under subsection (9).

76 Discrimination by public authorities. U.K.

77 Unlawful oaths etc. U.K.

 - (a) provide, or arrange for the provision of, legal advice;
 - (b) arrange for the provision of legal representation;
 - (c) provide any other assistance which it thinks appropriate.
- (4) Arrangements made under this section for the provision of assistance to a person may include provision for recovery of expenses from the person in certain circumstances.

- (2) The "national and cultural identity principles" are—
 - (a) the principle that everybody in Northern Ireland is free to—
 - (i) choose, affirm, maintain and develop their national and cultural identity, and
 - (ii) express and celebrate that identity in a manner that takes account of the sensitivities of those with different national and cultural identities and respects the rule of law, and
 - (b) the principle that public authorities should encourage and promote reconciliation, tolerance and meaningful dialogue between those with different national and cultural identities with a view to promoting parity of esteem, mutual respect and understanding, and cooperation.
- (3) In this Part, a reference to a person's national and cultural identity is a reference to a person's religious belief, political opinion or racial group.
- (4) In this section—

"public authority" means an authority listed in Schedule 3 to the Public Services Ombudsman Act (Northern Ireland) 2016 (c. 4 (N.I.)), but does not include—

- (a) a body referred to in note 2 to Schedule 3 but not listed in that Schedule;
- (b) the Office of Identity and Cultural Expression (see section 78G);

"racial group" has the same meaning as in the Race Relations (Northern Ireland) Order 1997.

- (5) The First Minister and deputy First Minister acting jointly may by regulations modify this section for the purpose of adding authorities to or removing authorities from the definition of "public authority".
- (6) Regulations under subsection (5) may—
 - (a) add an authority only if the provision adding the authority—
 - (i) would be within the legislative competence of the Assembly if it were contained in an Act of the Assembly, and
 - (ii) would not, if it were contained in a Bill of the Assembly, result in that Bill requiring the consent of the Secretary of State;
 - (b) add or remove an authority for a particular purpose, or in relation to particular functions:
 - (c) include transitional or supplementary provision.

78G The Office of Identity and Cultural Expression U.K.

- (1) A body corporate to be known as the Office of Identity and Cultural Expression is established.
- (2) In this Part "the Office" means the Office of Identity and Cultural Expression.
- (3) Schedule 9A contains provision about the Office.


78H Functions of the Office of Identity and Cultural Expression U.K.

- (1) The principal aims of the Office in exercising functions under this section are—
 - (a) to promote cultural pluralism and respect for diversity in Northern Ireland;
 - (b) to promote social cohesion and reconciliation between those with different national and cultural identities;
 - (c) to increase the capacity and resilience of people in Northern Ireland to address issues related to differences in national and cultural identity;
 - (d) to support, and promote the celebration of, the cultural and linguistic heritage of all people living in Northern Ireland.
- (2) The Office must—
 - (a) promote awareness of the national and cultural identity principles,
 - (b) monitor and promote compliance with the duty under section 78F(1), and
 - (c) report to the Assembly about compliance with that duty.
- (3) In carrying out the functions in subsection (2), the Office may in particular—
 - (a) publish, and revise, guidance about—
 - (i) the duty under section 78F(1), including best practice for complying with that duty, and

- (ii) other matters relating to national and cultural identity in Northern Ireland;
- (b) undertake, commission or support research into matters relating to national and cultural identity in Northern Ireland (including at the request of the Irish Language Commissioner or the Commissioner for the Ulster Scots and the Ulster British tradition);
- (c) provide, commission or support educational programmes, engagement and training on matters relating to national and cultural identity in Northern Ireland;
- (d) provide grants to persons with aims like those described in subsection (1);
- (e) cooperate with persons with aims like those described in subsection (1) (whether or not relating to Northern Ireland).
- (4) The First Minister and deputy First Minister acting jointly may direct the Office in relation to the exercise of its functions.

78I Further functions: establishing the Castlereagh Foundation U.K.

- (1) The Office may—
 - (a) establish a body corporate or other organisation to be known as the Castlereagh Foundation, or
 - (b) provide grants for the establishment of such a body or organisation by another person.
- (2) A body or other organisation established or funded under subsection (1) must—
 - (a) have as its principal objective the funding and support of academic research into identity, including national and cultural identity and shifting patterns of identity, in Northern Ireland, and
 - (b) be operationally and financially independent from the Office (though this does not affect the Office's functions under section 78H).
- (3) The Office may dispose of any interest in the Castlereagh Foundation.

78J Recognition of the status of the Irish language U.K.

- (1) The purpose of this Part is to provide official recognition of the status of the Irish language in Northern Ireland by—
 - (a) providing for the appointment of an Irish Language Commissioner,
 - (b) providing for the development of standards of best practice relating to the use of the Irish language by public authorities, and
 - (c) requiring public authorities to have due regard to such standards.

- (2) This is in addition to any other official recognition of the status of the Irish language including, for example, in—
 - (a) section 28D,
 - (b) the North/South Co-operation (Implementation Bodies) (Northern Ireland) Order 1999 (S.I. 1999/859), and
 - (c) provision relating to Irish-medium education.
- (3) Nothing in this Part affects the status of the English language.

78K The Irish Language Commissioner U.K.

- (1) The First Minister and deputy First Minister acting jointly must appoint an Irish Language Commissioner.
- (2) The person for the time being holding office as Irish Language Commissioner is by that name a corporation sole.
- (3) In this Part, "the Commissioner" means the Irish Language Commissioner.
- (4) Schedule 9B contains provision about the Commissioner.

78L Functions of the Commissioner U.K.

- (1) The principal aim of the Commissioner in exercising functions under this Part is to enhance and protect the use of the Irish language by public authorities in the provision of services to the public or a section of the public in Northern Ireland.
- (2) The Commissioner must—
 - (a) prepare and publish, in accordance with sections 78M and 78N, standards of best practice relating to the use of the Irish language by public authorities,
 - (b) monitor and promote compliance with those standards, and
 - (c) investigate complaints in accordance with section 78P.
- (3) The Commissioner may provide advice, support and guidance to public authorities in relation to the use of the Irish language and the standards of best practice.
- (4) The First Minister and deputy First Minister acting jointly may direct the Commissioner in relation to the exercise of the Commissioner's functions.
- (5) In this Part, a reference to services is a reference to services whether provided for payment or not.

78M Irish language best practice standards U.K.

- (1) The Commissioner must—
 - (a) prepare written standards of best practice relating to the use of the Irish language by public authorities in the provision of services to the public or a section of the public in Northern Ireland ("best practice standards"), and
 - (b) submit them to the First Minister and deputy First Minister.
- (2) The First Minister and deputy First Minister acting jointly may approve best practice standards submitted under subsection (1) with or without modifications.

- (3) The Commissioner must publish best practice standards approved under subsection (2).
- (4) In preparing best practice standards, the Commissioner must—
 - (a) have due regard to any guidance of the First Minister and deputy First Minister acting jointly, and
 - (b) consult such public authorities or other persons as the Commissioner considers appropriate.
- (5) Best practice standards—
 - (a) must state the date or dates from which they are to be applicable, and
 - (b) may make different provision for different public authorities or different descriptions of public authority.

78N Review and revision of best practice standards U.K.

- (1) The Commissioner must, within the period of five years beginning with the day on which best practice standards were last published, review the operation of those standards.
- (2) The Commissioner may revise or withdraw best practice standards—
 - (a) following a review under subsection (1), or
 - (b) at any other time, if the Commissioner considers it necessary or desirable to do so.
- (3) The Commissioner must submit any revised best practice standards to the First Minister and deputy First Minister.
- (4) Subsections (2) to (5) of section 78M apply to revised best practice standards as they apply to best practice standards prepared under section 78M(1).

780 Duty to have regard to best practice standards U.K.

- (1) A public authority must, in providing services to the public or a section of the public in Northern Ireland, have due regard to any published best practice standards.
- (2) A public authority must prepare and publish a plan setting out the steps it proposes to take to comply with the duty in subsection (1).
- (3) A public authority—
 - (a) may revise and re-publish the plan if the authority considers it necessary or desirable to do so, and
 - (b) must revise and re-publish the plan if relevant revised best practice standards are published in accordance with section 78N.
- (4) In preparing or revising a plan under this section, a public authority must consult the Commissioner.

78P Complaints U.K.

(1) Subsection (2) applies in relation to a complaint to the effect that a public authority has failed to comply with its obligations under section 780 if—

- (a) the complaint is made by a person claiming to have been directly affected by the failure,
- (b) the complaint is made in writing to the Commissioner within the period of three months beginning with the day on which the complainant first knew of the matters raised in the complaint, and
- (c) the Commissioner is satisfied that the complainant has notified the public authority of the matters raised in the complaint and the authority has had reasonable opportunity to consider them and respond.
- (2) The Commissioner must—
 - (a) investigate the complaint, or
 - (b) provide the complainant with a written statement of the Commissioner's reasons for not investigating the complaint.
- (3) If investigating the complaint, the Commissioner must—
 - (a) notify the complainant and public authority in writing of that fact.
 - (b) afford the public authority reasonable opportunity to comment on matters raised in the complaint, and
 - (c) give the complainant and public authority a report setting out the Commissioner's findings.
- (4) If the Commissioner finds that the public authority failed to comply with its obligations under section 78O, the Commissioner—
 - (a) may include in the report under subsection (3) recommendations as to how the public authority might remedy its failure and avoid future failures, and
 - (b) must lay the report before the Assembly.
- (5) An investigation under this section may be carried out in private if the Commissioner considers it appropriate.

78Q Meaning of "public authority" U.K.

- (1) In this Part "public authority" means an authority listed in Schedule 3 to the Public Services Ombudsman Act (Northern Ireland) 2016 (c. 4 (N.I.)), but does not include—
 - (a) the Commissioner;
 - (b) the Office of Identity and Cultural Expression;

78S Functions of the Commissioner U.K.

- (2) The Commissioner must—
 - (a) promote awareness of Ulster Scots services provided by public authorities to the public or a section of the public in Northern Ireland;
 - (b) provide or publish such advice, support and guidance as the Commissioner considers appropriate to public authorities in relation to—
 - (i) developing and encouraging the relevant language, arts and literature (including in relation to facilitating the use of Ulster Scots in the provision of services to the public or a section of the public in Northern Ireland);
 - (ii) the effect and implementation of the international instruments specified in subsection (3) in relation to the relevant language, arts and literature;
 - (c) investigate complaints in accordance with section 78T.
- (3) The specified international instruments are—
 - (a) the Council of Europe's Charter for Regional or Minority Languages opened for signature on 5 November 1992,

- (b) the Council of Europe's Framework Convention for the Protection of National Minorities opened for signature on 1 February 1995, and
- (c) the Convention on the Rights of the Child adopted by the General Assembly of the United Nations on 20 November 1989,

including any protocols which are in force in relation to the United Kingdom, but subject to any reservations, objections or interpretative declarations by the United Kingdom for the time being in force.

- (4) In preparing guidance for publication, the Commissioner must consult with such public authorities and other persons as the Commissioner considers appropriate.
- (5) The First Minister and deputy First Minister acting jointly may direct the Commissioner in relation to the exercise of the Commissioner's functions.
- (6) In subsection (2)(a), "Ulster Scots services" means services provided in Ulster Scots or likely to be of particular interest to those with an interest in the relevant language, arts and literature.
- (7) In this Part, a reference to services is a reference to services whether provided for payment or not.
- (8) Nothing in this Part affects the status of the English language.

78T Complaints U.K.

- (1) Subsection (2) applies in relation to a complaint to the effect that a public authority did not have due regard to published facilitation guidance if—
 - (a) the complaint is made by a person claiming to have been directly affected by the failure,
 - (b) the complaint is made in writing to the Commissioner within the period of three months beginning with the day on which the complainant first knew of the matters raised in the complaint, and
 - (c) the Commissioner is satisfied that the complainant has notified the public authority of the matters raised in the complaint and the authority has had reasonable opportunity to consider and respond.
- (2) The Commissioner must—

- (5) An investigation under this section may be carried out in private if the Commissioner considers it appropriate.
- (6) In this section "published facilitation guidance" means guidance published under section 78S(2)(b)(i) in relation to facilitating the use of Ulster Scots in the provision of services to the public or a section of the public in Northern Ireland.

78U Meaning of "public authority" U.K.

- (1) In this Part "public authority" means an authority listed in Schedule 3 to the Public Services Ombudsman Act (Northern Ireland) 2016 (c. 4 (N.I.)) but does not include—

80 Legislative power to remedy ultra vires acts. U.K.

- (1) The Secretary of State may by order make such provision as he considers necessary or expedient in consequence of—
 - (a) any provision of an Act of the Assembly which is not, or may not be, within the legislative competence of the Assembly; or
 - (b) any purported exercise by a Minister or Northern Ireland department of his or its functions which is not, or may not be, a valid exercise of those functions.
- (2) An order under this section may—
 - (a) make provision having retrospective effect;
 - (b) make consequential or supplementary provision, including provision amending or repealing any Northern Ireland legislation, or any instrument made under such legislation;
 - (c) make transitional or saving provision.

Powers of courts or tribunals to vary retrospective decisions. U.K.

- (1) This section applies where any court or tribunal decides that—
 - (a) any provision of an Act of the Assembly is not within the legislative competence of the Assembly; or
 - (b) a Minister or Northern Ireland department does not have the power to make, confirm or approve a provision of subordinate legislation that he or it has purported to make, confirm or approve.
- (2) The court or tribunal may make an order—
 - (a) removing or limiting any retrospective effect of the decision; or
 - (b) suspending the effect of the decision for any period and on any conditions to allow the defect to be corrected.
- (3) In deciding whether to make an order under this section, the court or tribunal shall (among other things) have regard to the extent to which persons who are not parties to the proceedings would otherwise be adversely affected.
- (4) Where a court or tribunal is considering whether to make an order under this section, it shall order notice of that fact to be given to—
 - (a) the Attorney General for Northern Ireland; and
 - (b) where the decision mentioned in subsection (1) relates to a devolution issue (within the meaning of Schedule 10), the appropriate authority,

unless the person to whom the notice would be given is a party to the proceedings.

- (5) A person to whom notice is given under subsection (4) or, where such notice is given to the First Minister and the deputy First Minister, those Ministers acting jointly may take part as a party in the proceedings so far as they relate to the making of the order.
- (6) Paragraphs 37 and 38 of Schedule 10 apply with necessary modifications for the purposes of subsections (4) and (5) as they apply for the purposes of that Schedule.
- (7) In this section "the appropriate authority" means—
 - (a) in relation to proceedings in Northern Ireland, the [F248]Advocate General for Northern Ireland and];
 - (b) in relation to proceedings in England and Wales, the Attorney General;

(c) in relation to proceedings in Scotland, the Lord Advocate and the Advocate General for Scotland.

83 Interpretation of Acts of the Assembly etc. U.K.

- (1) This section applies where—
 - (a) any provision of an Act of the Assembly, or of a Bill for such an Act, could be read either—
 - (i) in such a way as to be within the legislative competence of the Assembly; or
 - (ii) in such a way as to be outside that competence; or
 - (b) any provision of subordinate legislation made, confirmed or approved, or purporting to be made, confirmed or approved, by a Northern Ireland authority could be read either—
 - (i) in such a way as not to be invalid by reason of section 24 or, as the case may be, section 76; or
 - (ii) in such a way as to be invalid by reason of that section.
- (2) The provision shall be read in the way which makes it within that competence or, as the case may be, does not make it invalid by reason of that section, and shall have effect accordingly.

85 Provision dealing with certain reserved matters. U.K.

- (1) Her Majesty may by Order in Council make provision dealing with any matter falling within a description specified in any of paragraphs 9 to 17 of Schedule 3 (a "relevant matter"), including—
 - (a) provision having retrospective effect;
 - (b) provision for the delegation of functions;
 - (c) provision amending or repealing any provision made by or under any Act of Parliament or Northern Ireland legislation.
- (2) An Order in Council under this section may—
 - (a) make provision ancillary to provisions (whether in the Order or previously enacted) which deal with any relevant matter;

- (b) make such consequential, incidental, supplemental, or transitional provision as appears to Her Majesty to be necessary or expedient.
- (3) No recommendation shall be made to Her Majesty to make an Order in Council under this section unless a draft of the Order has been laid before and approved by resolution of each House of Parliament.
- (4) No draft may be laid under subsection (3) unless—
 - (a) the Secretary of State has laid before Parliament a document which contains a draft of the proposed Order;
 - (b) the Secretary of State has referred the document to the Assembly for its consideration; and
 - (c) the period of 60 days beginning with the day on which the document was laid before Parliament has ended.
- (5) The Assembly may report to the Secretary of State the views expressed in the Assembly on the proposed Order and shall do so if the Secretary of State so requests.
- (6) The draft laid under subsection (3) must be accompanied—
 - (a) if representations have been made during the period mentioned in subsection (4), by a statement containing a summary of the representations;
 - (b) if a report has been made to the Secretary of State under subsection (5) during that period, by a copy of the report; and
 - (c) if, as a result of any representations or report so made, the proposed Order has been changed, by a statement containing details of the changes.
- (7) Subsection (3) does not apply to an Order in Council which declares that it has been made to appear to Her Majesty that by reason of urgency the Order requires to be made without a draft having been approved as mentioned in that subsection.
- (8) Where an Order in Council contains a declaration such as is mentioned in subsection (7)—
 - (a) the Order shall be laid before Parliament after being made; and
 - (b) if at the end of the period of 40 days after the date on which the Order is made it has not been approved by resolution of each House, it shall then cease to have effect (but without prejudice to anything previously done under it or to the making of a new Order).
- (9) In reckoning the periods mentioned in subsections (4) and (8), no account shall be taken of any time during which Parliament is dissolved or prorogued or during which both Houses are adjourned for more than four days.
- (10) References to Acts of the Assembly in any enactment or instrument shall, so far as the context permits, be deemed to include references to Orders in Council under this section.
- (11) Orders in Council under this section may be omitted from any annual edition of statutory instruments made by virtue of section 8 of the M20 Statutory Instruments Act 1946.

87 Consultation and co-ordination. U.K.

(1) The Secretary of State and the Northern Ireland Minister having responsibility for social security ("the Northern Ireland Minister") shall from time to time consult one another with a view to securing that, to the extent agreed between them, the legislation to which this section applies provides single systems of social security, child support and pensions for the United Kingdom.

88 The Joint Authority. U.K.

- (1) The Joint Authority continued in being by section 177(2) of the Social Security Administration Act 1992—

Discrimination: certificates by Secretary of State

90 Effect of certificates. U.K.

- (1) This section applies where in any proceedings—
 - (a) a person claims that an act discriminated against him in contravention of section 24 or 76; and
 - (b) the person against whom the claim is made proposes to rely on a certificate purporting to be signed by or on behalf of the Secretary of State and certifying—
 - (i) that an act specified in the certificate was done for the purpose of safeguarding national security or protecting public safety or public order; and
 - (ii) that the doing of the act was justified by that purpose.
- (2) The claimant may, in accordance with rules [F266 made under section 91], appeal against the certificate to the Tribunal, that is to say, the tribunal established under section 91.
- (3) If on an appeal under subsection (2) the Tribunal determines—
 - (a) that the act specified in the certificate was done for the certified purpose; and
 - (b) that the doing of the act was justified by that purpose,

the Tribunal shall uphold the certificate; in any other case, the Tribunal shall quash the certificate.

 - (a) the claimant does not appeal against the certificate; or
 - (b) the certificate is upheld on appeal,

the certificate shall be conclusive evidence of the matters certified by it.

- (1) There shall be a tribunal in relation to which Schedule 11 shall have effect.

94 Land purchase annuities etc. U.K.

 - (c) he is dismissed by the First Minister and the deputy First Minister acting jointly and the Presiding Officer is notified of his dismissal; or
 - (d) where consent to his nomination was required under sub-paragraph (3A), he is dismissed by the nominating officer who consented (or that officer's successor) and the Presiding Officer is notified of his dismissal.
- (10) If the relevant Minister ceases to hold office at any time, otherwise than by virtue of sub-paragraph (1), the relevant Ministerial office shall be filled by applying sub-paragraphs (3) to (6) within a period specified in standing orders.
- (10A) If, as a result of the relevant Minister ("the former Minister") ceasing to hold office and the relevant Ministerial office being filled by virtue of sub-paragraph (10),—
 - (a) the total number of Ministerial offices held by members of a political party increases; or

- (9) The relevant Minister or the relevant junior Minister shall cease to hold office if—
 - (a) he resigns by notice in writing to the First Minister and the deputy First Minister;
 - (b) he ceases to be a member of the Assembly otherwise than by virtue of a dissolution; or
 - (c) he is dismissed by the First Minister and the deputy First Minister acting jointly and the Presiding Officer is notified of his dismissal; or
 - (d) where consent to his nomination was required under sub-paragraph (3A), he is dismissed by the nominating officer who consented (or that officer's successor) and the Presiding Officer is notified of his dismissal.

- (10) Sub-paragraph (11) applies if the relevant Minister or the relevant junior Minister ceases to hold office at any time, otherwise than—
 - (a) by virtue of sub-paragraph (1); or
 - (b) by virtue of the rotation of the persons holding those offices in accordance with provision referred to in paragraph 8(1)(b)(ii).
- (11) Where this sub-paragraph applies—
 - (a) the other shall also cease to hold office at that time; and
 - (b) the relevant Ministerial office and the relevant junior Ministerial office shall be filled by applying sub-paragraphs (3) to (6) within a period specified in standing orders.
- (11A) If, as a result of the relevant Minister ("the former Minister") and the relevant junior Minister ("the former junior Minister") ceasing to hold office and the relevant Ministerial office and the relevant junior Ministerial office being filled by virtue of sub-paragraph (11)(b),—
 - (a) the total number of Ministerial offices or junior Ministerial offices held by members of a political party increases; or
 - (b) the total number of Ministerial offices or junior Ministerial offices held by members of a political party decreases,

all other Northern Ireland Ministers shall cease to hold office and those Ministerial offices shall be filled by applying section 18(2) to (6) within a period specified in standing orders.

- (11B) But sub-paragraph (11A) shall not apply if—
 - (a) the former Minister or the former junior Minister ceased to hold office by virtue of being dismissed by a nominating officer under sub-paragraph (9) (d); and
 - (b) before the relevant Ministerial office and the relevant junior Ministerial office were filled, either of the conditions in sub-paragraph (11C) was satisfied in relation to each member of the Assembly who was a member of the political party of the nominating officer concerned.
- (11C) The conditions are that—
 - (a) the First Minister and the deputy First Minister sought to nominate the member under sub-paragraph (3) for the appropriate office, but consent to his nomination was not given in accordance with sub-paragraph (3A); or
 - (b) the member was nominated under sub-paragraph (3) for the appropriate office and the nomination took effect within the period specified in standing orders by virtue of sub-paragraph (5)(a), but the member did not take up the office within that period.
- (11D) In sub-paragraph (11C) "the appropriate office" means—
 - (a) in relation to a person who was a member of the political party of the nominating officer who dismissed the former Minister, the relevant Ministerial office;
 - (b) in relation to a person who was a member of the political party of the nominating officer who dismissed the former junior Minister, the relevant junior Ministerial office.
 - (12) Where—

- (a) the Assembly has resolved under section 30(2) that a political party does not enjoy its confidence; and
- (b) the party's period of exclusion under that provision has not come to an end, no member of that party may be nominated under sub-paragraph (3).

- (14) In this paragraph, a reference to a period of exclusion ^{F374}... is, in the case of a period of exclusion ^{F374}... which has been extended, a reference to that period as extended.
- (15) In this paragraph "nominating officer" has the same meaning as in section 18.

DEPARTMENT IN THE CHARGE OF MINISTER AND DEPUTY MINISTER

Introduction

- 11A (1) This Part of this Schedule has effect in relation to a Northern Ireland department—
 - (a) the functions of which consist wholly or mainly of devolved policing and justice functions; and
 - (b) in relation to which an Act of the Assembly provides, by virtue of section 21A(5A)—
 - (i) for it to be in the charge of a Northern Ireland Minister (the "relevant Minister") elected by the Assembly; and
 - (ii) for that Minister to be supported by a deputy Minister (the "deputy Minister") elected by the Assembly.
 - (2) In this paragraph "devolved policing and justice function" has the same meaning as in section 21A (see subsection (8) of that section).

Modification of section 16A

- 11B (1) Section 16A shall have effect subject to the following modifications.
 - (2) Subsection (2) shall have effect as if, at the end there were inserted "; and the deputy Minister (within the meaning of Part 3A of Schedule 4A) shall cease to hold office."
 - (3) Subsection (3) shall have effect as if, for paragraph (b) (and the word "and" before it) there were substituted—
 - (aa) once those offices have been filled, the relevant Ministerial office (within the meaning of Part 3A of Schedule 4A) and the deputy Ministerial office (within that meaning) shall be filled by applying paragraph 11E(2)(b) and (3) to (8) of that Schedule; and

(b) once those offices have been filled, the other Ministerial offices to be held by Northern Ireland Ministers shall be filled by applying section 18(2) to (6).

Section 18 not to apply to relevant Minister

- 11C (1) Subject to sub-paragraphs (2) to (5), section 18 (Northern Ireland Ministers) shall not apply in relation to—
 - (a) the relevant Minister; or
 - (b) the Ministerial office held by the relevant Minister (the "relevant Ministerial office"),

and paragraphs 11E to 11G shall apply instead.

- (2) The references to Ministerial offices in subsection (1)(c) and (d) of section 18 shall be taken to include the relevant Ministerial office.
- (3) In the application of section 18(5) to a political party which is entitled to two or more Ministerial offices, the reference to Ministerial offices (in the definition of M)—
 - (a) at any time when the number of Ministerial offices held by members of the party (apart from the relevant Ministerial office) is nil, shall be taken not to include the relevant Ministerial office; but
 - (b) at any time when the number of Ministerial offices held by members of the party (apart from the relevant Ministerial office) is one or more, shall be taken to include the relevant Ministerial office.
- (4) In the application of section 18(5) to any other political party, that reference to Ministerial offices shall be taken to include the relevant Ministerial office.
- (5) For the purposes of this paragraph, a political party is entitled to two or more Ministerial offices if the nominating officer of the party would be entitled to nominate persons to hold two or more Ministerial offices under section 18, assuming that—
 - (a) on each occasion on which a nominating officer of a political party is entitled to exercise the power conferred by section 18(2), he does so within the period mentioned in section 18(3)(a);
 - (b) the nominated person, in each case, takes up the selected Ministerial office within that period; and
 - (c) the reference in section 18(5) to Ministerial offices (in the definition of M) is taken to include the relevant Ministerial office.

Section 19 not to apply to deputy Minister

- 11D (1) The deputy Minister is to be treated for the purposes of this Act as if he were a junior Minister, but the provisions of section 19 (junior Ministers) shall not apply in relation to—
 - (a) him; or
 - (b) the office held by him (the "deputy Ministerial office"),

(so that, in particular, the deputy Ministerial office shall not count for the purposes of any formulae or other rules mentioned in section 19(2)); and the following provisions of this Part of this Schedule shall apply instead.

(2) The functions exercisable by virtue of the deputy Ministerial office shall be those determined in relation to that office by the relevant Minister and the deputy Minister acting jointly.

(3) The relevant Minister and the deputy Minister shall consult the First Minister and the deputy First Minister before making any determination under sub-paragraph (2).

Provisions relating to relevant Minister and deputy Minister

- 11E (1) When devolved policing and justice functions are first transferred to, or conferred on, the department mentioned in paragraph 11A, the relevant Ministerial office and the deputy Ministerial office shall be filled by applying sub-paragraphs (3) to (8) within a period specified in standing orders.
 - (2) The relevant Ministerial office and the deputy Ministerial office shall be filled by applying sub-paragraphs (3) to (8)—
 - (a) before section 18(2) to (6) is applied in relation to the other Ministerial offices; and
 - (b) before the procedures specified in any determination under section 19 are applied in relation to the junior Ministerial offices.
 - (3) Any member of the Assembly may stand as a candidate for election as—
 - (a) the relevant Minister; or
 - (b) the deputy Minister.
 - (4) But a member of the Assembly may not stand for election to either of those offices unless—
 - (a) he belongs to the largest or the second largest political designation (see paragraph 11H);
 - (b) he is nominated by another member of the Assembly; and
 - (c) if he is a member of a political party, the nominating officer of the party consents to his nomination within a period specified in standing orders.
 - (5) A candidate shall not be elected to either of those offices by the Assembly without the support of—
 - (a) a majority of the members voting in the election;
 - (b) a majority of the designated Nationalists voting; and
 - (c) a majority of the designated Unionists voting.
 - (6) A candidate shall not be elected to hold office as deputy Minister unless—
 - (a) the relevant Ministerial office is filled; and
 - (b) the candidate and the relevant Minister belong to different political designations.
 - (7) A person elected to the office of relevant Minister or deputy Minister shall not take up office until he has affirmed the terms of the pledge of office.
 - (8) If a person elected to either office does not take up the office within a period specified in standing orders, his election shall be deemed to be ineffective.
 - (9) The relevant Minister or the deputy Minister shall cease to hold office if—
 - (a) he resigns by notice in writing to the First Minister and the deputy First Minister;
 - (b) he ceases to be a member of the Assembly otherwise than by virtue of a dissolution;

- (c) where consent to his nomination was required under sub-paragraph (4)(c), he is dismissed by the nominating officer who consented (or that officer's successor) and the Presiding Officer is notified of his dismissal.
- (10) If the relevant Minister or the deputy Minister ceases to hold office at any time, otherwise than by virtue of section 16A(2), the office shall be filled by applying subparagraphs (3) to (8) within a period specified in standing orders.
- (11) But if—
 - (a) the relevant Ministerial office is filled by virtue of sub-paragraph (10); and
 - (b) the person appointed as the relevant Minister belongs to the same political designation as the deputy Minister,

the deputy Minister shall cease to hold office and the deputy Ministerial office shall be filled by applying sub-paragraphs (3) to (8) within a period specified in standing orders.

(12) Standing orders may make provision with respect to the holding of elections under this paragraph.

 - (b) the total number of Ministerial offices held by members of a political party decreases,

all other Northern Ireland Ministers shall cease to hold office and those Ministerial offices shall be filled by applying section 18(2) to (6) within a period specified in standing orders.

- (2) But sub-paragraph (1) shall not apply if—
 - (a) the former Minister ceased to hold office by virtue of being dismissed by a nominating officer under paragraph 11E(9)(c); and
 - (b) before the relevant Ministerial office was filled, either of the conditions in sub-paragraph (3) was satisfied in relation to each member of the Assembly who was a member of the political party of the nominating officer.
- (3) The conditions are that—
 - (a) another member of the Assembly sought to nominate the member under paragraph 11E(4)(b) for the relevant Ministerial office but consent to his nomination was not given in accordance with paragraph 11E(4)(c); or
 - (b) the member was elected to the relevant Ministerial office, but the member did not take up the office within the period specified in standing orders by virtue of paragraph 11E(8).

Interpretation

- 11H (1) In this Part of this Schedule "nominating officer" has the same meaning as in section 18.
 - (2) For the purposes of this Part of this Schedule, a member of the Assembly is to be taken—
 - (a) to belong to the political designation "Nationalist" if he is a designated Nationalist;
 - (b) to belong to the political designation "Unionist" if he is a designated Unionist;
 - (c) otherwise, to belong to the political designation "Other";

and the size of each of the political designations "Nationalist", "Unionist" and "Other" is to be determined in accordance with section 16C(4) and (5).

NORTHERN IRELAND ASSEMBLY COMMISSION

Membership

A person appointed under standing orders made under section 40(2)(b) shall hold office until another member of the Assembly is appointed in his place, unless he previously resigns or ceases to be a member of the Assembly otherwise than by virtue of a dissolution.

Staff

- 2 (1) The Commission may appoint staff.
 - (2) The persons appointed by the Commission are referred to in this Act as the staff of the Assembly.
 - (3) It is for the Commission to determine the terms and conditions of appointment of the staff of the Assembly, including arrangements for the payment of pensions, gratuities or allowances to, or in respect of, any person who has ceased to be a member of the staff of the Assembly.
 - (4) Accordingly, the Commission may—
 - (a) make contributions or payments towards provision for such pensions, gratuities or allowances;
 - (b) establish and administer one or more pension schemes.
 - (5) The power conferred by sub-paragraph (1) includes power to make arrangements for administrative, secretarial or other assistance to be provided for the Commission by

officers of the civil service of Northern Ireland or the civil service; and the reference in sub-paragraph (2) to persons appointed by the Commission shall be construed accordingly.

Powers

- 3 (1) Subject to sub-paragraph (4), the Commission may do anything which appears to it to be necessary or expedient for the purpose of or in connection with the discharge of its functions.
 - (2) That includes, in particular—
 - (a) holding property;
 - (b) charging for goods or services;
 - (c) entering into contracts;
 - (d) investing sums not immediately required in relation to the discharge of its functions; and
 - (e) accepting gifts.
 - (3) The Commission may sell goods or provide services, and may make arrangements for the sale of goods or provision of services, to the public.
 - (4) The Commission may borrow sums in sterling by way of overdraft or otherwise for the purpose of meeting a temporary excess of expenditure over sums otherwise available to meet that expenditure.
 - (5) The Commission may borrow money only under sub-paragraph (4) and may borrow under that sub-paragraph only with the special or general approval of the Assembly.

Delegation

The Commission may delegate any of its functions to the Presiding Officer or a member of the staff of the Assembly.

Proceedings and business

- 5 (1) The validity of any acts of the Commission shall not be affected by any vacancy among the members, or by any defect in the appointment, or qualification for membership, of any member.
 - (2) The Commission may determine its own procedure.
 - (3) The Presiding Officer shall preside at meetings of the Commission, but the Commission may appoint another of its members to preside if the office of Presiding Officer is vacant or the Presiding Officer is for any reason unable to act.

Crown status

- 6 (1) Her Majesty may by Order in Council provide for the Commission to be treated to any extent as a Crown body for the purposes of any enactment.
 - (2) In particular, the Order may for the purposes of any enactment provide—
 - (a) for employment under the Commission to be treated as employment under the Commission as a Crown body;

- (b) for land held, used or managed by the Commission, or operations carried out by or on behalf of the Commission, to be treated (as the case may be) as land held, used or managed, or operations carried out by or on behalf of, the Commission as a Crown body.
- (3) For the purposes of this paragraph, "Crown body" means a body which is the servant or agent of the Crown, and includes a government department.
- (4) A statutory instrument containing an Order in Council under this paragraph shall be subject to annulment in pursuance of a resolution of either House of Parliament.

STANDING ORDERS: FURTHER PROVISION

Preservation of order

- 1 (1) The standing orders shall include provision for preserving order in the proceedings of the Assembly, including provision for—
 - (a) preventing conduct which would constitute a criminal offence or contempt of court; and
 - (b) a sub judice rule.
 - (2) Such provision may provide for excluding a member of the Assembly from proceedings and for withdrawing his rights and privileges as a member for the period of his exclusion.

Proceedings to be in public

- 2 (1) The standing orders shall include provision requiring the proceedings of the Assembly to be held in public, except in such circumstances as the standing orders may provide.
 - (2) The standing orders may include provision as to the conditions to be complied with by any member of the public attending the proceedings, including provision for excluding from the proceedings any member of the public who does not comply with those conditions

Reporting and publishing proceedings

The standing orders shall include provision for reporting the proceedings of the Assembly and for publishing the reports.

Committees

- 4 (1) The standing orders shall include provision for ensuring that, in appointing members to committees, regard is had to the balance of parties in the Assembly.
 - (2) The standing orders may include provision for excluding from the proceedings of a committee a member of the Assembly who is not a member of the committee.

GENERAL

Introduction

- 1. (1) Part 2 of this Schedule requires the Secretary of State to initiate the democratic consent process in relation to each new continuation period.
 - (2) Part 3 of this Schedule establishes, for the purposes of Article 18 of the Protocol as read with the unilateral Declaration, the default democratic consent process referred to in paragraphs 3 and 4 of the unilateral Declaration.
 - (3) Part 4 of this Schedule establishes, for the purposes of Article 18 of the Protocol as read with the unilateral Declaration, the alternative democratic consent process referred to in paragraphs 5 and 6 of the unilateral Declaration.
 - (4) Part 5 of this Schedule makes provision about procedural matters and the outcome of the democratic consent process.
 - (5) Part 6 of this Schedule makes provision about an independent review into the functioning of the Protocol.
 - (6) To the extent that the standing orders of the Assembly are inconsistent with this Schedule, this Schedule (rather than the standing orders) is to have effect.
 - (7) For the purposes of this Schedule, a motion that is tabled and then withdrawn is to be regarded, at times after its withdrawal, as not having been tabled.
 - (8) In this Schedule—

"alternative democratic consent process" means the democratic consent process established by Part 4 of this Schedule;

"default democratic consent process" means the democratic consent process established by Part 3 of this Schedule;

"democratic consent process" means the process by which—

- (a) democratic consent in Northern Ireland to the continued application of Articles 5 to 10 of the Protocol is to be sought, and
- (b) a decision expressing that democratic consent is to be made;

"notification of the start of the democratic consent process" has the meaning given in paragraph 4;

"Protocol" means the Protocol on Ireland/Northern Ireland to the EU withdrawal agreement;

"unilateral Declaration" means the declaration by Her Majesty's Government concerning the operation of the 'Democratic consent in Northern Ireland' provision of the Protocol made on 17 October 2019.

Meaning of "consent resolution" and effect if consent resolution rejected

2. (1) In this Schedule "consent resolution" means a resolution of the Assembly in this form—

"That Articles 5 to 10 of the Protocol on Ireland/Northern Ireland to the EU withdrawal agreement should continue to apply during the new continuation period (within the meaning of Schedule 6A to the Northern Ireland Act 1998)."

- (2) This Schedule ceases to apply at the end of a particular current period if—
 - (a) by that time, the Assembly has decided the question on a motion for a consent resolution which relates to the new continuation period, but
 - (b) the Assembly did not pass the consent resolution.

Meaning of "continuation period", "current period" etc

3. (1) In this Schedule—

"continuation period" means—

- (a) the period of four years or eight years (as determined in accordance with sub-paragraph (2)) that begins with the day that follows the last day of the initial period;
- (b) each subsequent period of four years or eight years (as determined in accordance with sub-paragraph (2)) that begins with the day that follows the last day of the preceding continuation period;

"current period", in relation to a new continuation period, means—

- (a) the initial period, in the case where that period immediately precedes the new continuation period, or
- (b) the continuation period which immediately precedes the new continuation period, in any other case;

"initial period" means the period of four years that begins with the day that follows IP completion day;

"new continuation period" means, at any particular time, the first continuation period that is to begin after that time.

(2) The duration of a continuation period is to be—

- (a) four years if the consent resolution which relates to that continuation period was passed by a majority of the members voting but not with cross-community support;
- (b) eight years if the consent resolution which relates to that continuation period was passed with cross-community support.
- (3) In this Schedule, a period set out in an entry in the first column of this table has the meaning given in the corresponding entry in the second column of the table—

Period	Meaning
"final two months of the current period"	the period of two months ending with the last day of that current period
"final one month of the current period"	the period of one month ending with the last day of that current period
"final 25 days of the current period"	the period of 25 days ending with the last day of that current period
"final 15 days of the current period"	the period of 15 days ending with the last day of that current period
"final 5 days of the current period"	the period of 5 days ending with the last day of that current period

PART 2 U.K.

DUTY OF SECRETARY OF STATE TO INITIATE THE DEMOCRATIC CONSENT PROCESS

Duty to give notification of the start of the democratic consent process

- 4. (1) The Secretary of State must give a notification of the start of the democratic consent process in relation to each new continuation period.
 - (2) The notification relating to a new continuation period must be given on the day immediately before the start of the final two months of the current period.
 - (3) The notification must be given in accordance with Part 3 (if that Part is applicable) or Part 4 (if that Part is applicable).
 - (4) The "notification of the start of the democratic consent process" that relates to a new continuation period is a written notification that—
 - (a) states the date of the first day of the new continuation period, and
 - (b) states that, before that date, Her Majesty's Government in the United Kingdom must notify the European Commission of the outcome of the democratic consent process established by this Schedule in relation to the continued application of Articles 5 to 10 of the Protocol during the new continuation period.

PART 3 U.K.

DEFAULT DEMOCRATIC CONSENT PROCESS

Application

5. This Part applies if the First Minister and the deputy First Minister hold office (including if another Northern Ireland Minister is exercising the functions of either office in accordance with section 16A(11)) at the beginning of the day on which the Secretary of State is required to give the notification of the start of the democratic consent process in relation to a new continuation period.

Giving the notification of the start of the democratic consent process

- 6. (1) The Secretary of State must give the notification of the start of the democratic consent process to—
 - (a) the First Minister and the deputy First Minister, and
 - (b) the Presiding Officer.
 - (2) The notification of the start of the democratic consent process must state that the default democratic consent process applies.

Presiding Officer to inform members of the Assembly

7. On receipt of a notification of the start of the democratic consent process under this Part, the Presiding Officer must take such steps as the Presiding Officer considers necessary to bring the notification to the attention of the members of the Assembly.

Consent resolution: motion by First Minister and deputy First Minister

- 8. (1) This paragraph applies where the Secretary of State gives a notification of the start of the democratic consent process under this Part in relation to a new continuation period.
 - (2) Before the start of the final one month of the current period, the First Minister and the deputy First Minister acting jointly may table notice of a motion for a consent resolution which relates to the new continuation period.
 - (3) No other member of the Assembly may table notice of a motion for a consent resolution which relates to the new continuation period before the final one month of the current period.
 - (4) If they have tabled notice of a motion under this paragraph, the First Minister and the deputy First Minister acting jointly must provide the members of the Assembly with such explanatory materials as it is reasonable to provide in order to assist them when deciding the question.

Consent resolution: motion by any member of the Assembly

- 9. (1) This paragraph applies where—
 - (a) the Secretary of State gives a notification of the democratic consent process under this Part in relation to a new continuation period, and

- (b) before the start of the final one month of the current period, the First Minister and the deputy First Minister acting jointly have not tabled notice of a motion for a consent resolution which relates to the new continuation period.
- (2) Before the start of the final 25 days of the current period, any member of the Assembly may table notice of a motion for a consent resolution which relates to the new continuation period.
- (3) Sub-paragraph (2) does not prevent any other members of the Assembly—
 - (a) from adding their names to the notice of the motion that has been tabled, or
 - (b) having done so, from moving the motion,

in accordance with the standing orders or practice of the Assembly.

(4) If a member of the Assembly has tabled notice of a motion for a consent resolution in accordance with sub-paragraph (2), the Secretary of State must take reasonable steps to provide the members of the Assembly with such explanatory materials as it is reasonable to provide in order to assist them when deciding the question.

Consent resolution: consideration of motion

- 10. (1) This paragraph applies if—
 - (a) notice of a motion for a consent resolution which relates to the new continuation period has been tabled by the First Minister and deputy First Minister acting jointly in accordance with paragraph 8(2), or
 - (b) notice of a motion for a consent resolution which relates to the new continuation period has been tabled by a member of the Assembly in accordance with paragraph 9(2),

and, before the start of the final 15 days of the current period, the question on that motion is not decided by the Assembly.

- (2) The Assembly must sit at noon on the required sitting day (whether or not the Assembly would otherwise be sitting on that day or at that time, and whether or not that day falls during a recess).
- (3) The motion for the consent resolution is to be proceeded with in the Assembly on the required sitting day—
 - (a) as the first business on that day; or
 - (b) where the election of the Presiding Officer or any deputy or deputies is, by virtue of this Act, any other enactment or the standing orders of the Assembly, required to be the first business on that day, as the first business after the election of the Presiding Officer or deputy or deputies.
- (4) The Presiding Officer must move the motion for the consent resolution if no other member of the Assembly moves it when it is required to be proceeded with in accordance with sub-paragraph (3).
- (5) The question on the motion for the consent resolution (if not already put) is to be put—
 - (a) at 6:00pm on the required sitting day, if the motion is proceeded with as the first business on the required sitting day (in accordance with subparagraph (3)(a));
 - (b) six hours after the motion is moved, if the motion is proceeded with as the first business after the election of the Presiding Officer or the deputy or

deputies on the required sitting day (in accordance with sub-paragraph (3) (b)).

- (6) The Assembly may not be adjourned on the required sitting day until after the declaration of the result of the division or vote on the question on the motion for the consent resolution.
- (7) Accordingly, no motion for the adjournment of the debate on the motion for the consent resolution, or of the Assembly, may be taken on the required sitting day until after the declaration of that result.
- (8) If the question on the motion for the consent resolution is not put as required by sub-paragraph (5), and is not put at any later time on the required sitting day, then—
 - (a) the earliest day after that day that is not an excluded day is to be regarded as the required sitting day for the purposes of this paragraph, and
 - (b) sub-paragraphs (2) to (7) and this sub-paragraph are to apply again accordingly.
- (9) In this paragraph—

"excluded day" means—

- (a) Saturday,
- (b) Sunday,
- (c) Christmas Day,
- (d) Good Friday, and
- (e) any day that is a public holiday in Northern Ireland;

"required sitting day" means the earliest day during the final 15 days of the current period that is not an excluded day.

PART 4 U.K.

ALTERNATIVE DEMOCRATIC CONSENT PROCESS

Application

11. This Part applies if the offices of the First Minister and the deputy First Minister are vacant (and their functions are not otherwise being exercised by another Northern Ireland Minister in accordance with section 16A(11)) at the beginning of the day on which the Secretary of State is required to give the notification of the start of the democratic consent process in relation to a new continuation period.

Giving the notification of the start of the democratic consent process

- 12. (1) The Secretary of State must give the notification of the start of the democratic consent process to
 - (a) the Presiding Officer, and
 - (b) the clerk to the Assembly.
 - (2) The notification of the start of the democratic consent process must state that the alternative democratic consent process applies.
 - (3) As soon as practicable after giving notice under sub-paragraph (1), the Secretary of State must take reasonable steps to provide the members of the Assembly with

- such explanatory materials as it is reasonable to provide in order to assist them when deciding the question on the motion for a consent resolution.
- (4) In this paragraph "the clerk to the Assembly" means the person who holds or exercises the functions of that office in accordance with the standing orders or practice of the Assembly.

Presiding Officer to inform members of the Assembly

On receipt of a notification of the start of the democratic consent process under this Part, the Presiding Officer must take such steps as the Presiding Officer considers necessary to bring the notification to the attention of the members of the Assembly.

Consent resolution: motion by a member of the Assembly

- 14. (1) Where the Secretary of State has given a notification of the start of the democratic consent process under this Part in relation to a new continuation period, any member of the Assembly may table notice of a motion for a consent resolution which relates to the new continuation period.
 - (2) Sub-paragraph (1) does not prevent any other members of the Assembly—
 - (a) from adding their names to the notice of the motion that has been tabled, or
 - (b) having done so, from moving the motion,

in accordance with the standing orders or practice of the Assembly.

Consent resolution: requirement to consider motion

- 15. (1) This paragraph applies in either of the following cases.
 - (2) Case A is where—
 - (a) the Secretary of State gives a notification of the start of the democratic consent process under this Part in relation to a new continuation period, and
 - (b) before the start of the final one month of the current period, no member of the Assembly has tabled notice of a motion for a consent resolution which relates to the new continuation period.
 - (3) Case B is where—
 - (a) the Secretary of State gives a notification of the start of the democratic consent process under this Part in relation to a new continuation period,
 - (b) before the start of the final one month of the current period, a member of the Assembly tables notice of a motion for a consent resolution which relates to the new continuation period, and
 - (c) before the start of the final 25 days of the current period, the question on that motion is not decided by the Assembly.
 - (4) The Assembly must sit at noon on the required sitting day (whether or not the Assembly would otherwise be sitting on that day, or at that time, and whether or not that day falls during a recess).
 - (5) If, before the start of the required sitting day, a member of the Assembly has not tabled notice of a motion for a consent resolution which relates to the new continuation period, the Presiding Officer must table such a motion.
 - (6) Sub-paragraph (5) does not prevent any other members of the Assembly—

- (a) from adding their names to the notice of the motion that has been tabled as soon as practicable on that day, or
- (b) having done so, from moving the motion,

in accordance with the standing orders or practice of the Assembly.

- (7) The fact that a motion tabled by the Presiding Officer in accordance with subparagraph (5) is tabled on the required sitting day does not prevent the motion from being proceeded with on that day in accordance with this paragraph.
- (8) The motion for the consent resolution is to be proceeded with in the Assembly on the required sitting day—
 - (a) as the first business on that day; or
 - (b) where the election of the Presiding Officer or any deputy or deputies is, by virtue of this Act, any other enactment or the standing orders of the Assembly, required to be the first business on that day, as the first business after the election of the Presiding Officer or deputy or deputies.
- (9) The Presiding Officer must move the motion for the consent resolution if no other member of the Assembly moves it when it is required to be proceeded with in accordance with sub-paragraph (8).
- (10) The question on the motion for the consent resolution (if not already put) is to be put—
 - (a) at 6:00pm on the required sitting day, if the motion is proceeded with as the first business on the required sitting day (in accordance with subparagraph (8)(a));
 - (b) six hours after the motion is moved, if the motion is proceeded with as the first business after the election of the Presiding Officer or the deputy or deputies on the required sitting day (in accordance with sub-paragraph (8) (b)).
- (11) The Assembly may not be adjourned on the required sitting day until after the declaration of the result of the division or vote on the question on the motion for the consent resolution.
- (12) Accordingly, no motion for the adjournment of the debate on the motion for the consent resolution, or of the Assembly, may be taken on the required sitting day until after the declaration of that result.
- (13) If the question on the motion for the consent resolution is not put as required by subparagraph (10), and is not put at any later time on the required sitting day, then—
 - (a) the earliest day after that day that is not an excluded day is to be regarded as the required sitting day for the purposes of this paragraph, and
 - (b) sub-paragraphs (4) to (12) and this sub-paragraph are to apply again accordingly.
- (14) This paragraph has effect subject to paragraph 16.
- (15) In this paragraph and paragraph 16—

"excluded day" means—

- (a) Saturday,
- (b) Sunday,
- (c) Christmas Day,

- (d) Good Friday, and
- (e) any day that is a public holiday in Northern Ireland;

"required sitting day" means the earliest day during the final 25 days of the current period that is not an excluded day.

Election of an interim Presiding Officer

- 16. (1) This paragraph applies if on the required sitting day—
 - (a) the election of a Presiding Officer or any deputy or deputies is, by virtue of this Act, any other enactment or the standing orders of the Assembly, required to be the first business on that day, and
 - (b) the Assembly does not elect from among its members a Presiding Officer or any deputy or deputies.
 - (2) The Assembly must elect from among its members an interim Presiding Officer.
 - (3) Neither section 39 nor section 42 applies to the election of the interim Presiding Officer (nor is the election of any deputy or deputies required).
 - (4) Accordingly, the interim Presiding Officer is to be elected by a majority of those members of the Assembly voting.
 - (5) The proceedings for the election of an interim Presiding Officer are to be chaired by the oldest member of the Assembly present.
 - (6) But if the oldest member present is also seeking election as interim Presiding Officer then the next oldest member present is to chair the proceedings instead, and so on.
 - (7) An interim Presiding Officer—
 - (a) holds office only for the purposes of business relating to a motion for a consent resolution which relates to the new continuation period, and
 - (b) ceases to hold office once written notification of the matters mentioned in paragraph 19(2) has been given to the Secretary of State.
 - (8) Standing orders may make further provision in connection with the election of an interim Presiding Officer.
 - (9) In its application in a case where this paragraph applies, paragraph 15 has effect as if—
 - (a) the following were substituted for paragraph 15(8)—
 - "(8) The motion for the consent resolution is to be proceeded with as the first business after the election of the interim Presiding Officer.":
 - (b) the reference to the Presiding Officer in paragraph 15(9) were a reference to the interim Presiding Officer;
 - (c) the following were substituted for paragraph 15(10)—
 - "(10) The question on the motion for the consent resolution (if not already put) is to be put six hours after the motion is moved.".
 - (10) In sub-paragraph (1) the reference to "the required sitting day" is to the first such day.

PART 5 U.K.

PROCEDURAL MATTERS AND OUTCOME

Application

17. This Part applies in relation to any motion for a consent resolution whether the default democratic consent process or the alternative democratic consent process is applicable.

Procedural matters relating to motions for consent resolutions

- 18. (1) A motion for a consent resolution is to be decided without amendment.
 - (2) The question on a motion for a consent resolution is to be decided by a majority of those members of the Assembly voting.
 - (3) Where a consent resolution is passed by a majority of the members voting, the Presiding Officer must—
 - (a) determine whether the resolution has also been passed with cross-community support; and
 - (b) announce the determination of that question.
 - (4) For provision about the consequences of a consent resolution also being passed with cross-community support, see paragraph 3(2).
 - (5) Section 42 does not apply in relation to a motion for a consent resolution.
 - (6) Once the Assembly has decided the question on a motion for a consent resolution which relates to a continuation period (whether the Assembly has passed the motion or not), further notice of a motion for a consent resolution which relates to that continuation period may not be tabled, or if already tabled, may not be proceeded with.
 - (7) A reference in this paragraph or in paragraph 19 or 20 to the Presiding Officer has effect as a reference to the interim Presiding Officer if a person is holding that office in accordance with paragraph 16.

Outcome of process: Presiding Officer to notify Secretary of State

- 19. (1) This paragraph applies when the Assembly decides the question on a motion for a consent resolution which relates to a new continuation period.
 - (2) The Presiding Officer must give the Secretary of State written notification of the following matters—
 - (a) whether or not the Assembly passed the consent resolution;
 - (b) if the Assembly passed the consent resolution, whether the Assembly passed it—
 - (i) by a majority of the members voting but not with cross-community support, or
 - (ii) with cross-community support.
 - (3) The notification must be given before the start of the final 5 days of the current period.

Outcome of process: Secretary of State to notify European Commission

- 20. (1) This paragraph applies when the Presiding Officer gives the Secretary of State the notification required by paragraph 19 in relation to a motion for a consent resolution which relates to a new continuation period.
 - (2) The Secretary of State must give the European Commission written notification of the following matters—
 - (a) whether or not the Assembly passed the consent resolution;
 - (b) if the Assembly passed the consent resolution, whether the Assembly passed it—
 - (i) by a majority of the members voting but not with cross-community support, or
 - (ii) with cross-community support.
 - (3) The notification must be given on or before the final day of the current period.

PART 6 U.K.

INDEPENDENT REVIEW

Independent review into the functioning of the Protocol

- 21. (1) This paragraph applies where the Presiding Officer notifies the Secretary of State that the Assembly has passed a consent resolution by a majority of the members voting but not with cross-community support.
 - (2) [F381] Within one month of receiving the notification, the Secretary of State must commission an independent review into the functioning of the Protocol in accordance with paragraphs 7 to 9 of the unilateral Declaration.

[The review may include consideration of any effect of the Windsor Framework in F382(2A) the withdrawal agreement on—

- (a) the constitutional status of Northern Ireland, and
- (b) the operation of the single market in goods and services between Northern Ireland and the rest of the United Kingdom.
- (2B) The person commissioned by the Secretary of State to carry out the review must provide to the Secretary of State a report of its conclusions no later than six months after having been commissioned.
- (2C) Upon receipt of a report by the Secretary of State in accordance with subparagraph (2B), a Minister of the Crown must—
 - (a) lay a copy of that report before Parliament, and
 - (b) transmit a copy of that report to the Presiding Officer.
- (2D) The Presiding Officer must lay before the Assembly a copy of any report received in accordance with sub-paragraph (2C)(b).
- (2E) A Minister of the Crown must raise in the Joint Committee any issues raised or recommendations made by a report received by the Secretary of State in accordance with sub-paragraph (2B).

- (2F) No later than six months after receiving the report, the Secretary of State must publish a written response to any recommendations made by that report.
- (2G) A response published in accordance with sub-paragraph (2F) must contain information about the Secretary of State's response to any representations made about the report—
 - (a) by either House of Parliament or a committee thereof, or
 - (b) by the Assembly.]
 - (3) The reference in [F383 sub-paragraph (1)] to the Presiding Officer has effect as a reference to the interim Presiding Officer if a person is holding that office in accordance with paragraph 16.

[In this paragraph, "Joint Committee" has the same meaning as in the European Union F384(4) (Withdrawal) Act 2018.]]

PART 1 U.K.

GENERAL

Introduction and Interpretation

- 1. (1) Part 2 of this Schedule establishes a new Windsor Framework Democratic Scrutiny Committee of the Assembly.
 - (2) Part 3 of this Schedule sets out, for the purposes of Article 13 of the Windsor Framework, the process by which members of the Assembly may seek to prevent the application of a replacement EU act under the Framework.

- (3) Part 4 of this Schedule makes provision relating to the position of the United Kingdom in the Joint Committee with respect to the proposed application of EU acts under the Windsor Framework.
- (4) To the extent that the standing orders of the Assembly are inconsistent with this Schedule, this Schedule (rather than the standing orders) is to have effect.
- (5) For the purposes of this Schedule, a motion that is tabled and then withdrawn is to be regarded, at times after its withdrawal, as not having been tabled.
- (6) In this Schedule—

"Article 13(3a) declaration" means the unilateral declaration by His Majesty's Government concerning the involvement of the institutions of the 1998 Agreement as annexed to the decision of the Joint Committee which lays down arrangements relating to the Windsor Framework;

"clerk to the Assembly" has the same meaning as in Schedule 6A;

"Committee" means the committee established by paragraph 2;

"Framework" means the Windsor Framework;

"Joint Committee" has the same meaning as in the European Union (Withdrawal) Act 2018;

"new EU act" means a new EU instrument which has been notified to the United Kingdom in accordance with Article 13(4) of the Windsor Framework;

"replacement EU act" means an EU instrument which amends or replaces any of the EU instruments referred to in the third subparagraph of Article 5(1) of the Windsor Framework, the first indent of heading 1 of Annex 2 to the Framework or headings 7 to 47 of Annex 2 to the Framework;

"scrutiny period" means the period of two months beginning with the day on which a replacement EU act is published;

"Windsor Framework" has the same meaning as in the joint declaration of the United Kingdom of Great Britain and Northern Ireland and the European Union in the Joint Committee which reflects the arrangements in the decision of that Joint Committee laying down the arrangements relating to the Windsor Framework.

PART 2 U.K.

WINDSOR FRAMEWORK DEMOCRATIC SCRUTINY COMMITTEE

Windsor Framework Democratic Scrutiny Committee

2. A committee of the Assembly, to be known as the Windsor Framework Democratic Scrutiny Committee, is established.

Purpose and functions of the Committee

- 3. (1) The purpose of the Committee is to assist with the observation and implementation of Article 13(3a) and (4) of the Framework.
 - (2) In order to fulfil its purpose, the functions of the Committee include—
 - (a) the examination and consideration of new EU acts and replacement EU acts,

- (b) the conduct of inquiries and publication of reports in relation to replacement EU acts,
- (c) engagement with businesses, civil society and others as appropriate in relation to replacement EU acts,
- (d) engagement with His Majesty's Government in the United Kingdom in relation to replacement EU acts,
- (e) engagement with Ministers and Northern Ireland departments in relation to replacement EU acts,
- (f) the collation and publication of evidence collected as part of its other activities, and
- (g) dealing with other matters (including legislative proposals which may become new EU acts or replacement EU acts) which the Committee considers to be connected with its purpose or other functions.

Membership of the Committee

4. Membership of the Committee is to be determined in accordance with the standing orders of the Assembly which are to apply in the same way as they apply to a standing committee.

Powers of the Committee

- 5. (1) Subject to sub-paragraph (2), the power in section 44(1) may be exercised by the Committee as if the Committee had been expressly authorised to do so in accordance with section 44(6).
 - (2) Subsection (2) of section 44 has effect in relation to the Committee as if for paragraphs (a) and (b) there were substituted "the purpose or functions of the Windsor Framework Democratic Scrutiny Committee".

Notification of the Committee

- 6. (1) The Committee may be notified under this paragraph if—
 - (a) a new EU act or a replacement EU act has been proposed by the European Commission, or
 - (b) a replacement EU act has been published by the European Union.
 - (2) A notification is made under sub-paragraph (1) if His Majesty's government in the United Kingdom provides the notification to—
 - (a) the chair of the Committee,
 - (b) the clerk of the Committee,
 - (c) the clerk to the Assembly, or
 - (d) the Presiding Officer.

Committee Monitoring

7. (1) Following receipt of a notification under paragraph 6(1)(a), the Committee may monitor the progress of the proposed new EU act or replacement EU act and publish any interim reports which the Committee considers appropriate.

Status: This version of this Act contains provisions that are prospective.

Changes to legislation: There are currently no known outstanding effects

for the Northern Ireland Act 1998. (See end of Document for details)

(2) If the Committee decides to monitor the progress of a proposed new EU act or replacement EU act in accordance with sub-paragraph (1), the Committee may also decide to hold an inquiry into that EU act.

Committee Inquiries: Initiation

- 8. (1) Following receipt of a notification under paragraph 6(1)(b) the Committee must decide—
 - (a) whether or not to hold an inquiry into the replacement EU act which was the subject of the notification, or
 - (b) whether or not to continue an inquiry begun in accordance with paragraph 7(2) in relation to the replacement EU act which was the subject of the notification.
 - (2) In reaching a decision under sub-paragraph (1), the Committee—
 - (a) must have regard to whether it appears likely that the replacement EU act—
 - (i) significantly differs (in whole or in part) from the content or scope of the EU instrument which it amends or replaces, and
 - (ii) would have a significant impact specific to everyday life of communities in Northern Ireland in a way that is liable to persist, and
 - (b) may have regard to any other matters the Committee considers appropriate.
 - (3) A decision under sub-paragraph (1) must be made no later than five working days after the day on which the notification is made.
 - (4) The Committee must publish any decision made in accordance with this paragraph.
 - (5) A failure to make a decision in accordance with this paragraph is to be treated as a decision not to hold an inquiry or not to continue an inquiry which had already begun, as the case may be.

Committee Inquiries: Procedure

- 9. (1) A Committee inquiry held in accordance with paragraph 7 or 8 may consider any matters which the Committee considers appropriate.
 - (2) In conducting an inquiry, the Committee must seek substantive discussion and engagement with—
 - (a) His Majesty's government in the United Kingdom,
 - (b) a Minister or Northern Ireland department, and
 - (c) to the extent the Committee considers appropriate, representatives of businesses and civil society affected by the new EU act or replacement EU act (or who would be so affected if the act enters into force).
 - (3) A Minister or Northern Ireland department must comply with any reasonable request for information made by the Committee which is relevant to an inquiry of that Committee.

Committee Inquiries: Reports

10. (1) The Committee must publish a report of the conclusions of an inquiry into a replacement EU act no later than fifteen working days before the end of the scrutiny period that relates to that EU act.

- (2) A report issued in accordance with sub-paragraph (1) may include any information which the Committee considers appropriate.
- (3) The Committee must also publish the following no later than fifteen working days before the end of the scrutiny period—
 - (a) minutes of all Committee meetings relevant to the inquiry,
 - (b) minutes of any discussion or engagement conducted in accordance with paragraph 9(2), and
 - (c) any other evidence collected in the course of the inquiry (whether or not such evidence was relied upon for the production of any report).
- (4) Minutes and evidence published in accordance with sub-paragraph (3) may be subject to such redactions or omissions as the Committee considers appropriate.

PART 3 U.K.

PROCEDURE BY WHICH MEMBERS OF THE ASSEMBLY MAY SEEK TO PREVENT THE APPLICATION OF A REPLACEMENT EU ACT

Initiating the procedure to prevent the application of a replacement EU act

- 11. (1) The process under this Part of this Schedule for members of the Assembly to seek to prevent a replacement EU act from applying under the Framework is initiated if the Presiding Officer is provided with a written notification which gives detailed reasons for seeking to prevent the application of that EU act with reference to the requirements in paragraph 1(c) of the Article 13(3a) declaration.
 - (2) A notification made under sub-paragraph (1) must be agreed to by no fewer than 30 members of the Assembly and these must include—
 - (a) one member who belongs to a political party and one member who belongs to a different political party,
 - (b) one member who belongs to a political party and one member who does not belong to a political party and did not belong to a political party when returned as a member of the Assembly, or
 - (c) two members who do not belong to a political party and did not belong to a political party when returned as members of the Assembly,

but must not include the Presiding Officer or a deputy Presiding Officer.

(3) A notification under this paragraph must be provided to the Presiding Officer no later than ten working days before the end of the scrutiny period.

Time period for making the notification

12. Upon receipt of a notification which satisfies the conditions in paragraph 11(2) and (3), the Presiding Officer must provide that notification to the Secretary of State as soon as possible and no later than nine working days before the end of the scrutiny period.

 - (2) Such a decision does not prevent a separate notification from being made in relation to the same replacement EU act in accordance with this Part of this Schedule.
 - (3) The Presiding Officer must, as soon as possible, provide any reasons given in accordance with sub-paragraph (1) to the members who have agreed to the notification under paragraph 11.

MINISTERIAL CONSIDERATION OF NEW EU ACTS IN THE JOINT COMMITTEE

Meaning of "applicability motion"

17. In this Part, an "applicability motion", in relation to the application of a new EU act, means a motion of the Assembly tabled in this form—

"That [x] should be added to the Windsor Framework by the United Kingdom and the European Union within the Joint Committee in accordance with Article 13(4) of that Framework."

where "[x]" is to be substituted with the title of the new EU act.

Restrictions relating to a decision to add new EU acts

- 18. (1) A Minister of the Crown must not agree to the adoption of a decision by the Joint Committee to add a new EU act to the relevant annex in accordance with Article 13(4) of the Framework unless the Assembly has indicated support for the application of that EU act by passing an applicability motion.
 - (2) But the Minister of the Crown may agree to the adoption of such a decision if the Minister considers that—
 - (a) there are exceptional circumstances that justify the adoption of the decision in the absence of an applicability motion having been passed, or
 - (b) the new EU act would not create a new regulatory border between Great Britain and Northern Ireland.
 - (3) Before proceeding under sub-paragraph (2), the Minister of the Crown must make a statement to Parliament explaining why the Minister is of the opinion that the condition in either sub-paragraph (2)(a) or (2)(b) is met.
 - (4) Sub-paragraph (1) does not apply to a new EU act which was the subject of any European Commission proposal of 27 February 2023 relating to the Framework.
 - (5) In this paragraph—

"exceptional circumstances" includes circumstances in which the Assembly has, as its first business, failed to elect from among its members a Presiding Officer and deputies or there is no First Minister and deputy First Minister in office, and

"a new regulatory border" means regulatory requirements relating to the movement of goods that would—

- (a) materially divert trade, or
- (b) materially impair the free flow of goods.

Requirements relating to the applicability motion

- 19. (1) No applicability motion may be tabled in relation to a new EU act until a notification has been made under sub-paragraph (2) in relation to the same new EU act.
 - (2) A notification under this paragraph may be made if a new EU act is being considered by the Joint Committee under Article 13(4) of the Framework.
 - (3) A notification is made under sub-paragraph (2) if His Majesty's government in the United Kingdom provides the notification to—
 - (a) the chair of the Committee,
 - (b) the clerk of the Committee,
 - (c) the clerk to the Assembly, or
 - (d) the Presiding Officer.
 - (4) The First Minister and the deputy First Minister acting jointly may table an applicability motion within a period of two weeks beginning with the day on which a notification is made in accordance with sub-paragraph (2).
 - (5) No other member of the Assembly may table an applicability motion unless the two-week period expires with no such motion having been tabled.

(3) A public authority shall, before the end of the period of five years beginning with the submission of its current scheme, or the latest review of that scheme under this subparagraph, whichever is the later, review that scheme and inform the Commission of the outcome of the review.

Duties arising out of equality schemes

- 9 (1) In publishing the results of such an assessment as is mentioned in paragraph 4(2)(b), a public authority shall state the aims of the policy to which the assessment relates and give details of any consideration given by the authority to—
 - (a) measures which might mitigate any adverse impact of that policy on the promotion of equality of opportunity; and

Any appointment made by Her Majesty under section 36(1)(d) of the M122Northern Ireland Constitution Act 1973 before the appointed day shall on and after that day

have effect as if it had been an appointment made by Her Majesty on the nomination of the Assembly under section 65.
