Powers to gather information

165 [F¹Regulators] power to require information [F²: authorised persons etc].

- (1) [F³Either regulator] may, by notice in writing given to an authorised person, require him—
 - (a) to provide specified information or information of a specified description; or
 - (b) to produce specified documents or documents of a specified description.
- (2) The information or documents must be provided or produced—
 - (a) before the end of such reasonable period as may be specified; and
 - (b) at such place as may be specified.
- (3) An officer who has written authorisation from the [F⁴regulator] to do so may require an authorised person without delay—
 - (a) to provide the officer with specified information or information of a specified description; or
 - (b) to produce to him specified documents or documents of a specified description.
- (4) This section applies only to
 - [F⁵(a)] information and documents reasonably required in connection with the exercise by [F⁶either regulator] of functions conferred on it by or under this Act [F⁷, and
 - (b) in relation to the exercise by the PRA of the powers conferred by subsections (1) and (3), information and documents reasonably required by the Bank of England in connection with the exercise by the Bank of its functions in pursuance of its financial stability objective.]
- (5) [F⁸The regulator in question] may require any information provided under this section to be provided in such form as it may reasonably require.
- (6) [F⁹The regulator in question] may require—
 - (a) any information provided, whether in a document or otherwise, to be verified in such manner, or
 - (b) any document produced to be authenticated in such manner,as it may reasonably require.
- (7) The powers conferred by subsections (1) and (3) may also be [F¹⁰exercised—
 - (a) by either regulator, to impose requirements on a person who is connected with an authorised person;
 - (b) by the FCA, to impose requirements on an operator, trustee or depositary of a scheme recognised under section ^{F¹¹...} [F¹²271A or] 272 who is not an authorised person;
 - (c) by the FCA, to impose requirements on a recognised investment exchange;
 - (d) by the FCA, to impose requirements on a person who is connected with a recognised investment exchange.]

Conduct of investigations

170 Investigations: general.

- (1) This section applies if an investigating authority appoints one or more competent persons (“investigators”) under section 167 or 168(3) or (5) to conduct an investigation on its behalf.
- (2) The investigating authority must give written notice of the appointment of an investigator to the person who is the subject of the investigation (“the person under investigation”).

176 Entry of premises under warrant.

- (1) A justice of the peace may issue a warrant under this section if satisfied on information on oath given by or on behalf of the Secretary of State, [^{F110}either regulator] or an investigator that there are reasonable grounds for believing that the first, second or third set of conditions is satisfied.
