#### TRIAL AND PUNISHMENT OF OFFENCES

### 28 Provisions supplementary to ss. 26 and 27

FIF2F3(1) Where any of Her Majesty's forces incurs costs in respect of the exercise by the [<sup>F1</sup>Director of Service Prosecutions ("the Director") of his] functions as a party to proceedings [<sup>F3</sup>before a court mentioned in section 27(1)], those costs shall, subject to any provision made by virtue of subsection (2), be taken for the purposes of sections 26 and 27 to have been incurred by the [<sup>F2</sup>Director].

<sup>F4</sup>(2) Regulations under section 26 or 27 may make provision—

- (a) as to the costs incurred by any of Her Majesty's forces which are or are not to be taken for the purposes of that section to have been incurred by the [<sup>F4</sup>Director], and
- (b) as to the person to whom, or account into which, any payment in respect of costs incurred by the [<sup>F4</sup>Director] is to be made.
