Administration and enforcement: pay

## 14 Supply of information held by the Secretary of State

- (1) This section applies to information which is held for the purposes of functions relating to [F1 statutory paternity pay,] statutory adoption pay[F2, statutory shared parental pay or statutory parental bereavement pay]—
  - (a) by the Secretary of State or the Department, or
  - (b) by a person providing services to the Secretary of State or the Department, in connection with the provision of those services.
- (2) Information to which this section applies may be supplied—
  - (a) to the Board, or
  - (b) to a person providing services to the Board,

for use for the purposes of functions relating to [F3 statutory paternity pay,] statutory adoption pay[F4, statutory shared parental pay or statutory parental bereavement pay].
