OTHER TRANSFERS UNDER SECTION 1(2) SCHEMES

Continuity in relation to loan relationships

- 18 (1) For the purposes of the application of [F1Part 5 of the Corporation Tax Act 2009] (loan relationships) in relation to a relevant transfer, the transferee and the transferor are to be treated as if, at the time of the transfer, they were members of the same group.
- (2) In sub-paragraph (1), the reference to being members of the same group must be construed in accordance with [F2section 335(6) of] that Act.
