Notes

1. This table shows the origin of the company law provisions of the Companies Act 2006 by reference to the enactments in force on the date that Act received Royal Assent (subject to the note to the origins for Part 28). The Act received Royal Assent on 8 November 2006. Where an enactment had been amended before that date, the reference is to the text at that date; the table does not show the source of such amendments.
2. The origin of a provision of the Companies Act 2006 in the Companies (Northern Ireland) Order 1986 is acknowledged where it makes significantly different provision in relation to Northern Ireland than in relation to England and Wales or, as the case may be, Great Britain.
3. In the table –
 - “1985” means the Companies Act 1985 (c. 6);
 - “IA 1986” means the Insolvency Act 1986 (c. 45);
 - “1986” means the Companies (Northern Ireland) Order 1986 (S.I. 1096/1032 (N.I. 6));
 - “ICTA” means the Income and Corporation Taxes Act 1988 (c. 1);
 - “1989” means the Companies Act 1989 (c.40).
4. The entry “drafting” indicates a new provision of a mechanical or editorial nature - for example, a provision defining an expression to avoid repetition or indicating where other relevant provisions are to be found.
5. A reference followed by “(changed)” means that the provision referred to has been re-enacted with one or more changes. In general, a change is noted only in the primary context affected and not in every provision where a consequential change results. The table does not show changes in the maximum penalties for offences.
6. The entry “new” indicates a provision which has no predecessor in the repealed legislation or which is fundamentally different from its predecessor.
7. The entries in the table are intended only as a general indication of what has changed and what is new. They should not be read as expressing any view as to the application or otherwise of any provision relating to enactments repealed and re-enacted.
