Interaction with other authorities

70 Co-operation between the Commission and [^{F1}NHS England]

[^{F2}(1) The Commission must co-operate with [^{F3}NHS England] in the exercise of their respective functions.]

[^{F4}(2) In particular the Commission must—

- (a) give [^{F5}NHS England] any information the Commission has about the provision of health care which the Commission or [^{F5}NHS England] considers would assist [^{F5}NHS England] in the exercise of [^{F6}—
 - (i) its regulatory functions, within the meaning given by section 13SB(2) of the National Health Service Act 2006, or
 - (ii) its functions under section 27A of the National Health Service Act 2006 (NHS trusts: oversight and support)]
- (b) make arrangements with [^{F7}NHS England] to ensure that—
 - (i) a person applying to be both registered under Chapter 2 and for a licence under the Health and Social Care Act 2012 may do so by way of a single application form, and
 - (ii) such a person is granted a registration under Chapter 2 and a licence under that Act by way of a single document, and

- (c) seek to secure that the conditions on a registration under Chapter 2 in a case within paragraph (b) are consistent with the conditions included in the person's licence under that Act.]
- (3) Without prejudice to subsection (2)(a) the Commission must, on request, provide the [F8NHS England] with any material relevant to—
- (a) a review under section 46^{F9}...
 - (b) a review or investigation under section 48, or
 - (c) a study promoted, or undertaken, by the Commission under section 54,
- so far as the material relates to the provision of health care by [F10a person who holds a licence under the Health and Social Care Act 2012]
- [F11(4) In this section, a reference to a licence under the Health and Social Care Act 2012 is a reference to a licence under Chapter 3 of Part 3 of that Act.]
