271 Subsidiary and associate

- (1) A company is a “subsidiary” of a person if any of the following conditions is satisfied.
- (2) Condition 1 is that the person—
- is a member of the company, and
 - has power, independent of any other person, to appoint or remove all or a majority of the board of directors.
- (3) Condition 2 is that the person holds more than half in nominal value of the company's equity share capital.
- (4) Condition 3 is that the company is a subsidiary, within the meaning of the Companies Act 2006 (c. 46) or [^{F4}Part 7 of the Co-operative and Community Benefit Societies Act 2014], of a company which is a subsidiary of the person by virtue of Condition 1 or 2.
- (5) In relation to a company which is [^{F5}a registered society] a reference to the board of directors is a reference to the committee of management.
- (6) “Associate” of a provider means—
- a body of which the provider is a subsidiary, and
 - any other subsidiary of that body.

272 Family

- (1) For the purposes of this Part one person is a member of the family of another if—
- they are, or live together as if they were, spouses or civil partners, or
 - one is the parent, grandparent, child, grandchild, brother, sister, uncle, aunt, nephew or niece of the other.
- (2) For those purposes—
- a relationship by marriage or civil partnership shall be treated as a relationship by blood (and, in particular, P's stepchild shall be treated as P's child), and
 - a relationship by half-blood shall be treated as a relationship by whole blood.
