 - (b) the following provisions are repealed—
 - (i) in ITA 2007, paragraph 379 of Schedule 1;
 - (ii) in FA 2010, paragraph 14 of Schedule 6.

Gifts of money for relief in poor countries ("Millennium Gift Aid")
