LABOUR MARKET

Supplementary provision

33 Interpretation of Chapter 1

In this Chapter—

"the Director" has the meaning given by section 1;

"enactment" includes-

- (a) an enactment contained in subordinate legislation within the meaning of the Interpretation Act 1978;
- (b) an enactment contained in, or in an instrument made under, an Act of the Scottish Parliament;
- (c) an enactment contained in, or in an instrument made under, a Measure or Act of the National Assembly for Wales;
- (d) an enactment contained in, or in an instrument made under, Northern Ireland legislation;

"enforcing authority" has the meaning given by section 14;

"financial year" means a period of 12 months ending with 31 March;

"HMRC Commissioners" means the Commissioners for Her Majesty's Revenue and Customs;

"labour market enforcement functions" has the meaning given by section 3; "LME order" has the meaning given by section 18;

"LME undertaking" has the meaning given by section 14;
