



# Prevention of Crime Act 1953

## 1953 CHAPTER 14 1 and 2 Eliz 2

An Act to prohibit the carrying of offensive weapons in public places without lawful authority or reasonable excuse. [6th May 1953]

**[<sup>F1</sup>1 Prohibition of the carrying of offensive weapons without lawful authority or reasonable excuse.**

- (1) Any person who without lawful authority or reasonable excuse, the proof whereof shall lie on him, has with him in any public place any offensive weapon shall be guilty of an offence, and shall be liable—
- (a) on summary conviction, to imprisonment for a term not exceeding [<sup>F2</sup>six months] or a fine not exceeding [<sup>F3</sup>£200], or both;
  - (b) on conviction on indictment, to imprisonment for a term not exceeding [<sup>F4</sup>four] years or a fine not exceeding one hundred pounds, or both.
- (2) Where any person is convicted of an offence under subsection (1) of this section the court may make an order for the forfeiture or disposal of any weapon in respect of which the offence was committed.

[ A constable may arrest without warrant any person whom he has reasonable cause<sup>F7</sup>(3) to believe to be committing an offence under subsection (1) of this section, if the constable is not satisfied as to that person’s identity or place of residence, or has reasonable cause to believe that it is necessary to arrest him in order to prevent the commission by him of any other offence in the course of committing which an offensive weapon might be used.]

(4) In this section “ public place ” includes any highway [<sup>F8</sup>, or in Scotland any road within the meaning of the Roads (Scotland) Act 1984 ] and any other premises or place to which at the material time the public have or are permitted to have access, whether on payment or otherwise; and “ offensive weapon ” means any article made or adapted for use for causing injury to the person, or intended by the person having it with him for such use by him [<sup>F9</sup> or by some other person ].]

### [<sup>F11</sup>1A Offence of threatening with offensive weapon in public

- (1) A person is guilty of an offence if that person—
- (a) has an offensive weapon with him or her in a public place,
  - (b) unlawfully and intentionally threatens another person with the weapon, and
  - (c) does so in such a way that there is an immediate risk of serious physical harm to that other person.

- (2) For the purposes of this section physical harm is serious if it amounts to grievous bodily harm for the purposes of the Offences against the Person Act 1861.
- (3) In this section “ public place ” and “ offensive weapon ” have the same meaning as in section 1.
- (4) A person guilty of an offence under this section is liable—
  - (a) on summary conviction, to imprisonment for a term not exceeding 12 months or to a fine not exceeding the statutory maximum, or to both;
  - (b) on conviction on indictment, to imprisonment for a term not exceeding 4 years or to a fine, or to both.
