



# Electricity Act 1957

1957 CHAPTER 48 5 and 6 Eliz 2

An Act to provide for the dissolution of the Central Electricity Authority and the establishment of a Central Electricity Generating Board and an Electricity Council, and for the transfer of functions of the said Authority to that Board or Council or to the Minister of Power; to make further provision as to other matters relating to the supply of electricity; and for purposes connected with the matters aforesaid. [17th July 1957]
