An Act to consolidate certain enactments relating to persons under the age of eighteen years. [13th April 1933]

#### PART I

PREVENTION OF CRUELTY AND EXPOSURE TO MORAL AND PHYSICAL DANGER

#### Offences

#### 1 Cruelty to persons under sixteen.

- (1) If any person who has attained the age of sixteen years and [<sup>F1</sup>has responsibility for] any child or young person under that age, wilfully assaults, ill-treats, neglects, abandons, or exposes him, or causes or procures him to be assaulted, ill-treated, neglected, abandoned, or exposed, in a manner likely to cause him unnecessary suffering or injury to health (including injury to or loss of sight, or hearing, or limb, or organ of the body, and any mental derangement), that person shall be guilty of a misdemeanor, and shall be liable—
  - (a) on conviction on indictment, to a fine . . . <sup>F2</sup> or alternatively, . . . <sup>F3</sup>, or in addition thereto, to imprisonment for any term not exceeding [<sup>F4</sup>ten] years;
  - (b) on summary conviction, to a fine not exceeding [<sup>F5</sup>£400] pounds, or alternatively, ... <sup>F3</sup>, or in addition thereto, to imprisonment for any term not exceeding six months.

(2) For the purposes of this section—

- (a) a parent or other person legally liable to maintain a child or young person [<sup>F6</sup>, or the legal guardian of a child or young person,] shall be deemed to have neglected him in a manner likely to cause injury to his health if he has failed to provide adequate food, clothing, medical aid or lodging for him, or if, having been unable otherwise to provide such food, clothing, medical aid or lodging, he has failed to take steps to procure it to be provided under [<sup>F7</sup>the enactments applicable in that behalf];
- (b) where it is proved that the death of an infant under three years of age was caused by suffocation (not being suffocation caused by disease or the presence of any foreign body in the throat or air passages of the infant) while the infant was in bed with some other person who has attained the age of sixteen years, that other person shall, if he was, when he went to bed, under the influence of drink, be deemed to have neglected the infant in a manner likely to cause injury to its health.

(3) A person may be convicted of an offence under this section—

- (a) notwithstanding that actual suffering or injury to health, or the likelihood of actual suffering or injury to health, was obviated by the action of another person;
- (b) notwithstanding the death of the child or young person in question.
- (7) Nothing in this section shall be construed as affecting the right of any parent, teacher, or other person having the lawful control or charge of a child or young person to administer punishment to him.

#### **3** Allowing persons under sixteen to be in brothels.

(1) If any person having [<sup>F11</sup>responsibility for] a child or young person who has attained the age of four years and is under the age of sixteen years, allows that child or young person to reside in or to frequent a brothel, he shall be [<sup>F12</sup>liable on summary conviction to a fine not exceeding [<sup>F13</sup>level 2 on the standard scale]], or alternatively ... <sup>F14</sup> or in addition thereto, to imprisonment for any term not exceeding six months.

#### 4 Causing or allowing persons under sixteen to be used for begging.

(1) If any person causes or procures any child or young person under the age of sixteen years or, having [<sup>F16</sup>responsibility for] such a child or young person, allows him to be in any street, premises, or place for the purpose of begging or receiving alms, or of inducing the giving of alms (whether or not there is any pretence of singing, playing, performing, offering anything for sale, or otherwise) he shall, on summary conviction, be liable to a fine not exceeding [<sup>F17</sup>level 2 on the standard scale], or alternatively, ... <sup>F18</sup> or in addition thereto, to imprisonment for any term not exceeding three months.

- (2) If a person having [<sup>F16</sup>responsibility for] a child or young person is charged with an offence under this section, and it is proved that the child or young person was in any street, premises, or place for any such purpose as aforesaid, and that the person charged allowed the child or young person to be in the street, premises, or place, he shall be presumed to have allowed him to be in the street, premises, or place for that purpose unless the contrary is proved.
- (3) If any person while singing, playing, performing or offering anything for sale in a street or public place has with him a child who has been lent or hired out to him, the child shall, for the purposes of this section, be deemed to be in that street or place for the purpose of inducing the giving of alms.

#### 5 Giving intoxicating liquor to children under five.

If any person gives, or causes to be given, to any child under the age of five years any intoxicating liquor, except upon the order of a duly qualified medical practitioner, or in case of sickness, apprehended sickness, or other urgent cause, he shall, on summary conviction, be liable to a fine not exceeding [<sup>F19</sup>level 1 on the standard scale].

#### 7 Sale of tobacco, &c. to persons under sixteen.

- (1) Any person who sells to a person [<sup>F21</sup>...] under the age of sixteen years any tobacco or cigarette papers, whether for his own use or not, shall be liable, [<sup>F22</sup>on summary conviction to a fine not exceeding level 4 on the standard scale.]
- [<sup>F23</sup>(1A) It shall be a defence for a person charged with an offence under subsection (1) above to prove that he took all reasonable precautions and exercised all due diligence to avoid the commission of the offence.]
  - (2) If on complaint to a court of summary jurisdiction it is proved to the satisfaction of the court that any automatic machine for the sale of tobacco kept on any premises [<sup>F24</sup>has been used by any person] under the age of sixteen years, the court [<sup>F25</sup>shall] order the

owner of the machine, or the person on whose premises the machine is kept, to take such precautions to prevent the machine being so used as may be specified in the order or, if necessary, to remove the machine, within such time as may be specified in the order, and if any person against whom such an order has been made fails to comply therewith, he shall be liable, on summary conviction, [<sup>F26</sup>to a fine not exceeding level 4 on the standard scale.]

- (3) It shall be the duty of a constable and of a park-keeper being in uniform to seize any tobacco or cigarette papers in the possession of any person apparently under the age of sixteen years whom he finds smoking in any street or public place, and any tobacco or cigarette papers so seized shall be disposed of, if seized by a constable, in such manner as the police authority may direct, and if seized by a park-keeper, in such manner as the authority or person by whom he was appointed may direct.
- (4) Nothing in this section shall make it an offence to sell tobacco or cigarette papers to, or shall authorise the seizure of tobacco or cigarette papers in the possession of, any person who is at the time employed by a manufacturer of or dealer in tobacco, either wholesale or retail, for the purposes of his business, or is a boy messenger in uniform in the employment of a messenger company and employed as such at the time.
- (5) For the purposes of this section the expression "tobacco" includes cigarettes [<sup>F27</sup>any product containing tobacco and intended for oral or nasal use] and smoking mixtures intended as a substitute for tobacco, and the expression "cigarettes" includes cut tobacco rolled up in paper, tobacco leaf, or other material in such form as to be capable of immediate use for smoking.

#### 11 *†*Exposing children under seven to risk of burning.

If any person who has attained the age of sixteen years, having [<sup>F31</sup>responsibility for] any child under the age of [<sup>F32</sup>twelve] years, allows the child to be in any room containing an open fire grate [<sup>F33</sup>or any heating appliance liable to cause injury to a person by contact therewith] not sufficiently protected to guard against the risk of his being burnt or scalded without taking reasonable precautions against that risk, and by reason thereof the child is killed or suffers serious injury, he shall on summary conviction be liable to a fine not exceeding [<sup>F34</sup>level 1 on the standard scale]:

Provided that neither this section, not any proceedings taken thereunder, shall affect any liability of any such person to be proceeded against by indictment for any indictable offence.

#### 12 Failing to provide for safety of children at entertainments.

- (1) Where there is provided in any building an entertainment for children, or an entertainment at which the majority of the persons attending are children, then, if the number of children attending the entertainment exceeds one hundred, it shall be the duty of the person providing the entertainment to station and keep stationed wherever necessary a sufficient number of adult attendants, properly instructed as to their duties, to prevent more children or other persons being admitted to the building, or to any part thereof, than the building or part can properly accommodate, and to control the movement of the children and other persons admitted while entering and leaving the building or any part thereof, and to take all other reasonable precautions for the safety of the children.
- (2) Where the occupier of a building permits, for hire or reward, the building to be used for the purpose of an entertainment, he shall take all reasonable steps to secure the observance of the provisions of this section.
- (3) If any person on whom any obligation is imposed by this section fails to fulfil that obligation, he shall be liable, on summary conviction, to a fine not exceeding, in the case of a first offence fifty pounds, and in the case of a second or subsequent offence one hundred pounds, and also, if the building in which the entertainment is given is licensed . . . <sup>F35</sup> under any of the enactments relating to the licensing of theatres and of houses and other places for music or dancing, the licence shall be liable to be revoked by the authority by whom the licence was granted.
- (4) A constable may enter any building in which he has reason to believe that such an entertainment as aforesaid is being, or is about to be, provided, with a view to seeing whether the provisions of this section are carried into effect, and an officer authorised for the purpose by an authority by whom licences are granted under any of the enactments referred to in the last foregoing subsection shall have the like power of entering any building so licensed by that authority.
- (5) The institution of proceedings under this section shall—
  - (a) in the case of a building [<sup>F36</sup>licensed by a local authority] under [<sup>F37</sup>section 1 of the Cinemas Act 1985], or under the enactments relating to the licensing of theatres or of houses and other places for music or dancing, be the duty of [<sup>F36</sup>that local authority]; and
  - (b) in any other case, be the duty of the police authority.

#### 12A Restricted premises orders

- (1) This section applies where a person ("the offender") is convicted of a tobacco offence ("the relevant offence").
- (2) The person who brought the proceedings for the relevant offence may by complaint to a magistrates' court apply for a restricted premises order to be made in respect of the premises in relation to which that offence was committed ("the relevant premises").
- (3) A restricted premises order is an order prohibiting the sale on the premises to which it relates of any tobacco or cigarette papers to any person.
- (4) The prohibition applies to sales whether made—
  - (a) by the offender or any other person, or
  - (b) by means of any machine kept on the premises or any other means.
- (5) The order has effect for the period specified in the order, but that period may not exceed one year.
- (6) The applicant must, after making reasonable enquiries, give notice of the application to every person appearing to the applicant to be a person affected by it.
- (7) The court may make the order if (and only if) it is satisfied that—
  - (a) on at least 2 occasions within the period of 2 years ending with the date on which the relevant offence was committed, the offender has committed other tobacco offences in relation to the relevant premises, and
  - (b) the applicant has complied with subsection (6).
- (8) Persons affected by the application may make representations to the court as to why the order should not be made.
- (9) If—
  - (a) a person affected by an application for a restricted premises order was not given notice under subsection (6), and
  - (b) consequently the person had no opportunity to make representations to the court as to why the order should not be made,

the person may by complaint apply to the court for an order varying or discharging it.

- (10) On an application under subsection (9) the court may, after hearing—
  - (a) that person, and
  - (b) the applicant for the restricted premises order,

make such order varying or discharging the restricted premises order as it considers appropriate.

- (11) For the purposes of this section the persons affected by an application for a restricted premises order in respect of any premises are—
  - (a) the occupier of the premises, and
  - (b) any other person who has an interest in the premises.

#### 12B Restricted sale orders

- (1) This section applies where a person ("the offender") is convicted of a tobacco offence ("the relevant offence").
- (2) The person who brought the proceedings for the relevant offence may by complaint to a magistrates' court apply for a restricted sale order to be made in respect of the offender.
- (3) A restricted sale order is an order prohibiting the person to whom it relates—
  - (a) from selling any tobacco or cigarette papers to any person,
  - (b) from having any management functions in respect of any premises in so far as those functions relate to the sale on the premises of tobacco or cigarette papers to any person,
  - (c) from keeping any cigarette machine on any premises for the purpose of selling tobacco or permitting any cigarette machine to be kept on any premises by any other person for that purpose, and
  - (d) from having any management functions in respect of any premises in so far as those functions relate to any cigarette machine kept on the premises for the purpose of selling tobacco.
- (4) The order has effect for the period specified in the order, but that period may not exceed one year.
- (5) The court may make the order if (and only if) it is satisfied that, on at least 2 occasions within the period of 2 years ending with the date on which the relevant offence was committed, the offender has committed other tobacco offences.
- (6) In this section any reference to a cigarette machine is a reference to an automatic machine for the sale of tobacco.

#### 12C Enforcement

- (1) If—
  - (a) a person sells on any premises any tobacco or cigarette papers in contravention of a restricted premises order, and
  - (b) the person knew, or ought reasonably to have known, that the sale was in contravention of the order,

the person commits an offence.

- (2) If a person fails to comply with a restricted sale order, the person commits an offence.
- (3) It is a defence for a person charged with an offence under subsection (2) to prove that the person took all reasonable precautions and exercised all due diligence to avoid the commission of the offence.

- (4) A person guilty of an offence under this section is liable, on summary conviction, to a fine not exceeding £20,000.
- (5) A restricted premises order is a local land charge and in respect of that charge the applicant for the order is the originating authority for the purposes of the Local Land Charges Act 1975.

#### 12D Interpretation

(1) In sections 12A and 12B a "tobacco offence" means—

- (a) an offence committed under section 7(1) on any premises (which are accordingly "the premises in relation to which the offence is committed"), or
- (b) an offence committed under section 7(2) in respect of an order relating to any machine kept on any premises (which are accordingly "the premises in relation to which the offence is committed").
- (2) In sections 12A to 12C the expressions "tobacco" and "cigarette" have the same meaning as in section 7.
- (3) In sections 12A and 12B "notice" means notice in writing.]

#### 14 Mode of charging offences and limitation of time.

- (1) Where a person is charged with committing any of the offences mentioned in the First Schedule to this Act in respect of two or more children or young persons, the same information or summons may charge the offence in respect of all or any of them, but the person charged shall not, if he is summarily convicted, be liable to a separate penalty in respect of each child or young person except upon separate informations.
- (2) The same information or summons <sup>F40</sup>... may charge him with the offences of assault, ill-treatment, neglect, abandonment, or exposure, together or separately, and may charge him with committing all or any of those offences in a manner likely to cause unnecessary suffering or injury to health, alternatively or together, but when those offences are charged together the person charged shall not, if he is summarily convicted, be liable to a separate penalty for each.
- (4) When any offence mentioned in the First Schedule to this Act charged against any person is a continuous offence, it shall not be necessary to specify in the information, summons, or indictment, the date of the acts constituting the offence.

- (1) For the purposes of this Part of this Act, the following shall be presumed to have responsibility for a child or young person—
  - (a) any person who—
    - (i) has parental responsibility for him (within the meaning of the Children Act 1989); or
    - (ii) is otherwise legally liable to maintain him; and
  - (b) any person who has care of him.

#### 18 **Restrictions on employment of children.**

- (1) Subject to the provisions of this section and of any byelaws made thereunder no child shall be employed—
  - $[^{F45}(a)$  so long as he is under the age of  $[^{F46}$  fourteen years]]; or

    - (ii) which is not a Sunday; or
    - (h) for more than thirty-five hours or, if he is under the age of fifteen years, for more than twenty-five hours in any week in which he is not required to attend school; or
    - (i) for more than four hours in any day without a rest break of one hour; or
    - (j) at any time in a year unless at that time he has had, or could still have, during a period in the year in which he is not required to attend school, at least two consecutive weeks without employment.]
- (2) A local authority may make byelaws with respect to the employment of children, and any such byelaws may distinguish between children of different ages and sexes and between different localities, trades, occupations and circumstances, and may contain provisions—
  - (a) authorising—

> hour before the commencement of school hours on any day on which they are required to attend school;

- (b) prohibiting absolutely the employment of children in any specified occupation;
- (c) prescribing—
  - (i) the age below which children are not to be employed;
  - (ii) the number of hours in each day, or in each week, for which, and the times of day at which, they may be employed;
  - (iii) the intervals to be allowed to them for meals and rest;
  - (iv) the holidays or half-holidays to be allowed to them;
  - (v) any other conditions to be observed in relation to their employment;

so, however, that no such byelaws shall modify the restrictions contained in the last foregoing subsection save in so far as is expressly permitted by paragraph (a) of this subsection, and any restriction contained in any such byelaws shall have effect in addition to the said restrictions.

# 21 Penalties and legal proceedings in respect of general provisions as to employment.

(1) If a person is employed in contravention of any of the foregoing provisions of this Part of this Act, or of the provisions of any byelaw [<sup>F63</sup> or regulation] made thereunder,

the employer and any person (other than the person employed) to whose act or default the contravention is attributable shall be liable on summary conviction to a fine not exceeding [<sup>F64</sup>twenty pounds][<sup>F65</sup>£50] or, in the case of a second or subsequent offence, not exceeding [<sup>F64</sup>fifty pounds][<sup>F66</sup>£100]:

Provided that, if proceedings are brought against the employer, the employer, upon information duly laid by him and on giving to the prosecution not less than three days' notice of his intention, shall be entitled to have any person (other than the person employed) to whose act or default he alleges that the contravention was due, brought before the court as a party to the proceedings, and if, after the contravention has been proved, the employer proves to the satisfaction of the court that the contravention was due to the act or default of the said other person, that person may be convicted of the offence; and if the employer further proves to the satisfaction of the court that he has used all due diligence to secure that the provisions in question should be complied with, he shall be acquitted of the offence.

- (2) Where an employer seeks to avail himself of the proviso to the last foregoing subsection,
  - (a) the prosecution shall have the right to cross-examine him, if he gives evidence, and any witness called by him in support of his charge against the other person, and to call rebutting evidence; and
  - (b) the court may make such order as it thinks fit for the payment of costs by any party to the proceedings to any other party thereto.

#### 24 Restrictions on training for performances of a dangerous nature.

(1) No [<sup>F76</sup>child] under the age of twelve years shall be trained to take part in performances of a dangerous nature, and no [<sup>F77</sup>child who has attained that age] shall be trained to take part in such performances except under and in accordance with the terms of a licence granted and in force under this section; and every person who causes or

# 25 Restrictions on persons under eighteen going abroad for the purpose of performing for profit. E+W

- (1) No person having [<sup>F83</sup>responsibility for] any [<sup>F84</sup>child] shall allow him, nor shall any person cause or procure any [<sup>F84</sup>child], to go abroad [<sup>F85</sup>(a)] for the purpose of singing, playing performing, or being exhibited, for profit, [<sup>F86</sup>or
  - <sup>F86</sup>(b) for the purpose of taking part in a sport, or working as a model, where payment in respect of his doing so, other than for defraying expenses, is made to him or to another person,]

unless . . . <sup>F87</sup> a licence has been granted in respect of him under this section:

Provided that this subsection shall not apply in any case where it is proved that the [<sup>F84</sup>child] was only temporarily resident within [<sup>F88</sup>the United Kingdom].

(2) A [<sup>F89</sup>justice of the peace] may grant a licence in such form as the Secretary of State may prescribe, and subject to such restrictions and conditions as the [<sup>F89</sup>justice of the

peace] thinks fit, for any [<sup>F90</sup>child who has attained the age of fourteen years] to go abroad [<sup>F91</sup>for any purpose referred to in subsection (1) of this section,] but no such license shall be granted in respect of any person unless the [<sup>F89</sup>justice of the peace] is satisfied—

- (a) that the application for the licence is made by or with the consent of his parent or guardian;
- (b) that he is going abroad to fulfil a particular engagement;
- (c) that he is fit for the purpose, and that proper provision has been made to secure his health, kind treatment, and adequate supervision while abroad, and his return from abroad at the expiration or revocation of the licence;
- (d) that there has been furnished to him a copy of the contract of employment or other document showing the terms and conditions of employment drawn up in a language understood by him.
- (3) A person applying for a licence under this section, shall, at least seven days before making the application, give to the chief officer of police for the district in which the person resides to whom the application relates, notice of the intended application together with a copy of the contract of employment or other document showing the terms and conditions of employment, and the chief officer of police send that copy to [<sup>F92</sup>a justice of the peace] and may make a report in writing on the case to him or may appear, or instruct some person to appear, before him and show cause why the licence should not be granted, and [<sup>F92</sup>the justice of the peace] shall not grant the licence unless he is satisfied that notice has been properly so given:

Provided that if it appears that the notice was given less than seven days before the making of the application, [<sup>F92</sup>the justice of the peace] may nevertheless grant a licence if he is satisfied that the officer to whom the notice was given has made sufficient enquiry into the facts of the case and does not desire to oppose the application.

- (4) A licence under this section shall not be granted for more than three months but may be renewed by a [<sup>F89</sup>justice of the peace] from time to time for a like period, so, however, that no such renewal shall be granted, unless the [<sup>F89</sup>justice of the peace]—
  - (a) is satisfied by a report of a British consular officer or other trustworthy person that the conditions are being complied with;
  - (b) is satisfied that the application for renewal is made by or with the consent of the parent or guardian of the person to whom the licence relates.
- (5) A [justice of the peace]—
  - (a) may vary a licence granted under this section and may at any time revoke such a licence for any cause which he, in his discretion, considers sufficient:
  - (b) need not, when renewing or varying a licence granted under this section, require the attendance before him of the person to whom the licence relates.
- (6) The [<sup>F89</sup>justice of the peace] to whom application is made for the grant, renewal or variation of a licence shall, unless he is satisfied that in the circumstances it is unnecessary, require the applicant to give such security as he may think fit (either by entering into a recognisance with or without sureties or otherwise) for the observance of the restrictions and conditions in the licence or in the licence as varied, and the recognisance may be enforced in like manner as a recognisance for the doing of some matter or thing required to be done in a proceeding before a court of summary jurisdiction is enforceable.

- (7) If any case where a licence has been granted under this section, it is proved to the satisfaction of a [<sup>F89</sup>justice of the peace] that by reason of exceptional circumstances it is not in the interests of the person to whom the licence relates to require him to return from abroad at the expiration of the licence, then, notwithstanding anything in this section or any restriction or condition attached to the licence, [<sup>F93</sup>the justice of the peace] may by order release all persons concerned from any obligation to cause that person to return from abroad.
- (8) Where a licence is granted, renewed or varied under this section, the [<sup>F89</sup>justice of the peace] shall send the prescribed particulars to the Secretary of State for transmission to the proper consular officer, and every consular officer shall register the particulars so transmitted to him and perform such other duties in relation thereto as the Secretary of State may direct.

(10) This and the next following section extend to Scotland and to Northern Ireland.

- (4) A licence under this section shall not be granted for more than three months but may be renewed by a [<sup>F351</sup>justice of the peace] from time to time for a like period, so, however, that no such renewal shall be granted, unless the [<sup>F351</sup>justice of the peace]—
  - (a) is satisfied by a report of a British consular officer or other trustworthy person that the conditions are being complied with;
  - (b) is satisfied that the application for renewal is made by or with the consent of the parent or guardian of the person to whom the licence relates.
- (5) A [<sup>F351</sup>justice of the peace]—
  - (a) may vary a licence granted under this section and may at any time revoke such a licence for any cause which he, in his discretion, considers sufficient:
  - (b) need not, when renewing or varying a licence granted under this section, require the attendance before him of the person to whom the licence relates.
- (6) The [<sup>F351</sup>justice of the peace] to whom application is made for the grant, renewal or variation of a licence shall, unless he is satisfied that in the circumstances it is unnecessary, require the applicant to give such security as he may think fit (either by entering into a recognisance with or without sureties or otherwise) for the observance

of the restrictions and conditions in the licence or in the licence as varied, and the recognisance may be enforced in like manner as a recognisance for the doing of some matter or thing required to be done in a proceeding before a court of summary jurisdiction is enforceable.

- (7) If any case where a licence has been granted under this section, it is proved to the satisfaction of a [<sup>F351</sup>justice of the peace] that by reason of exceptional circumstances it is not in the interests of the person to whom the licence relates to require him to return from abroad at the expiration of the licence, then, notwithstanding anything in this section or any restriction or condition attached to the licence, [<sup>F355</sup>the justice of the peace] may by order release all persons concerned from any obligation to cause that person to return from abroad.
- (8) Where a licence is granted, renewed or varied under this section, the [<sup>F351</sup>justice of the peace] shall send the prescribed particulars to the Secretary of State for transmission to the proper consular officer, and every consular officer shall register the particulars so transmitted to him and perform such other duties in relation thereto as the Secretary of State may direct.

(10) This and the next following section extend to Scotland and to Northern Ireland.

## 26 Punishment of contraventions of last foregoing section and proceedings with respect thereto.

(1) If any person acts in contravention of the provisions of subsection (1) of the last foregoing section he shall be guilty of an offence under this section and be liable, on summary conviction, to a fine not exceeding [<sup>F95</sup>level 3 on the standard scale], or, alternatively, , . . . <sup>F96</sup> or in addition thereto, to imprisonment for any term not exceeding three months:

Provided that if he procured [<sup>F97</sup>the child in question] to go abroad by means of any false pretence or false representation, he shall be liable on conviction on indictment to imprisonment for any term not exceeding two years.

- (2) Where, in proceedings under this section against a person, it is proved that he caused, procured, or allowed [<sup>F98</sup>a child] to go abroad and that
  - [<sup>F99</sup>(a)] [<sup>F100</sup>that child] has while abroad been singing, playing, performing, or being exhibited, for profit, [<sup>F101</sup>or
  - <sup>F101</sup>(b) that child has while abroad taken part in a sport, or worked as a model, and payment in respect of his doing so, other than for defraying expenses, was made to him or to another person,]

the defendant shall be presumed to have caused, procured, or allowed him to go abroad for that purpose, unless the contrary is proved:

Provided that where the contrary is proved, the court may order the defendant to take such steps as the court directs to secure the return of  $[^{F102}$ the child] to the United Kingdom, or to enter into a recognisance to make such provision as the court may direct to secure his health, kind treatment, and adequate supervision while abroad, and his return to the United Kingdom at the expiration of such period as the court may think fit.

- (3) Proceedings in respect of an offence under this section or for enforcing a recognisance under this or the last foregoing section may be instituted at any time within a period of three months from the first discovery by the person taking the proceedings of the commission of the offence or, as the case may be, the non-observance, of the restrictions and conditions contained in the licence, or, if at the expiration of that period the person against whom it is proposed to institute the proceedings is outside the United Kingdom, at any time within six months after his return to the United Kingdom.
- (4) In any such proceedings as aforesaid, a report of any British consular officer and any deposition made on oath before a British consular officer and authenticated by the signature of that officer, respecting the observance or non-observance of any of the conditions or restrictions contained in a licence granted under the last foregoing section shall, upon proof that the consular officer, or deponent, cannot be found in the United Kingdom, be admissible in evidence, and it shall not be necessary to prove the signature or official character of the person appearing to have signed any such report or deposition.

#### 28 Powers of entry.

(1) If it is made to appear to a justice of the peace by the local authority, or by any constable, that there is reasonable cause to believe that the provisions of this Part of this Act, other than those relating to employment abroad, or of a byelaw [<sup>F106</sup> or regulation] made under the said provisions, are being contravened with respect to any person, the justice may by order under his hand addressed to an officer of the local authority, or to a constable, empower him to enter, at any reasonable time within forty-eight hours of the making of the order, any place in or in connection with which the person in question is, or is believed to be, employed, or as the case may be, in which he is, or is believed to be, taking part in [<sup>F107</sup>a performance], [<sup>F108</sup>being trained, taking part in a sport, or working as a model,] and to make enquiries therein with respect to that person.

[<sup>F109</sup>(2) Any authorised officer of the said authority or any constable may—

#### General Provisions as to Proceedings in Court

## 36 Prohibition against children being present in court during the trial of other persons.

No child (other than an infant in arms) shall be permitted to be present in court during the trial of any other person charged with an offence, or during any proceedings preliminary thereto, except during such time as his presence is required as a witness or otherwise for the purposes of justice; and any child present in court when under this section he is not to be permitted to be so shall be ordered to be removed:

Provided that this section shall not apply to messengers, clerks, and other persons required to attend at any court for purposes connected with their employment.

# **37** Power to clear court while child or young person is giving evidence in certain cases.

(1) Where, in any proceedings in relation to an offence against, or any conduct contrary to, decency or morality, a person who, in the opinion of the court, is a child or young person is called as a witness, the court may direct that all or any persons, not being members or officers of the court or parties to the case, their counsel or solicitors, or persons otherwise directly concerned in the case, be excluded from the court during the taking of the evidence of that witness:

Provided that nothing in this section shall authorise the exclusion of bonâ fide representatives of a newspaper or news agency.

(2) The powers conferred on a court by this section shall be in addition and without prejudice to any other powers of the court to hear proceedings in camerâ.

(2) If any child whose evidence is received [<sup>F136</sup>unsworn in any proceedings for an offence by virtue of section 52 of the Criminal Justice Act 1991]wilfully gives false evidence in such circumstances that he would, if the evidence had been given on oath, have been guilty of perjury, he shall be liable on summary conviction to be dealt with as if he had been summarily convicted of an indictable offence punishable in the case of an adult with imprisonment.

#### **39 Power to prohibit publication of certain matter in newspapers.**

(1) In relation to any proceedings in any court . . . <sup>F137</sup>, the court may direct that—

- (a) no newspaper report of the proceedings shall reveal the name, address or school, or include any particulars calculated to lead to the identification, of any child or young person concerned in the proceedings, either as being the person [<sup>F138</sup>by or against] or in respect of whom the proceedings are taken, or as being a witness therein:
- (b) no picture shall be published in any newspaper as being or including a picture of any child or young person so concerned in the proceedings as aforesaid;

except in so far (if at all) as may be permitted by the direction of the court.

(2) Any person who publishes any matter in contravention of any such direction shall on summary conviction be liable in respect of each offence to a fine not exceeding [<sup>F139</sup>level 5 on the standard scale].

#### 41 Power to proceed with case in absence of child or young person.

Where in any proceedings with relation to any of the offences mentioned in the First Schedule to this Act, the court is satisfied that the attendance before the court of any child or young person in respect of whom the offence is alleged to have been committed is not essential to the just hearing of the case, the case may be proceeded with and determined in the absence of the child or young person.

#### 42 Extension of power to take deposition of child or young person.

(1) Where a justice of the peace is satisfied by the evidence of a duly qualified medical practitioner that the attendance before a court of any child or young person in respect of whom any of the offences mentioned in the First Schedule to this Act is alleged to have been committed would involve serious danger to his life or health, the justice may take in writing the deposition of the child or young person on oath, and shall thereupon subscribe the deposition and add thereto a statement of his reason for taking it and of the day when and place where it was taken, and of the names of the persons (if any) present at the taking thereof.

(2) The justice taking any such deposition shall transmit it with his statement—

- (a) if the deposition relates to an offence for which any accused person is already committed for trial, to the proper officer of the court for the trial at which the accused person has been committed; and
- (b) in any other case, to the clerk of the court before which proceedings are pending in respect of the offence.

#### 43 Admission of deposition of child or young person in evidence.

Where, in any proceedings in respect of any of the offences mentioned in the First Schedule of this Act, the court is satisfied by the evidence of a duly qualified medical practitioner that the attendance before the court of any child or young person in respect of whom the offence is alleged to have been committed would involve serious danger to his life or health, any deposition of the child or young person taken under the <sup>M5</sup>Indictable Offences Act 1848, or this Part of this Act, shall be admissible in evidence either for or against the accused person without further proof thereof if it purports to be signed by the justice by or before whom it purports to be taken:

Provided that the deposition shall not be admissible in evidence against the accused person unless it is proved that reasonable notice of the intention to take the deposition has been served upon him and that he or his counsel or solicitor had, or might have had if he had chosen to be present, an opportunity of cross-examining the child or young person making the deposition.

# [<sup>F162</sup>49 Restrictions on reports of proceedings in which children or young persons are concerned.

- (1) The following prohibitions apply (subject to subsection (5) below) in relation to any proceedings to which this section applies, that is to say—
  - (a) no report shall be published which reveals the name, address or school of any child or young person concerned in the proceedings or includes any particulars likely to lead to the identification of any child or young person concerned in the proceedings; and
  - (b) no picture shall be published or included in a programme service as being or including a picture of any child or young person concerned in the proceedings.
- (2) The proceedings to which this section applies are—
  - (a) proceedings in a youth court;
  - (b) proceedings on appeal from a youth court (including proceedings by way of case stated);
  - (c) proceedings under section 15 or 16 of the <sup>M7</sup>Children and Young Persons Act 1969 (proceedings for varying or revoking supervision orders); and
  - (d) proceedings on appeal from a magistrates' court arising out of proceedings under section 15 or 16 of that Act (including proceedings by way of case stated).
- (3) The reports to which this section applies are reports in a newspaper and reports included in a programme service; and similarly as respects pictures.
- (4) For the purposes of this section a child or young person is "concerned" in any proceedings whether as being the person against or in respect of whom the proceedings are taken or as being a witness in the proceedings.
- [ If a court is satisfied that it is in the public interest to do so, it may, in relation to a <sup>F163</sup>(4A) child or young person who has been convicted of an offence, by order dispense to any specified extent with the requirements of this section in relation to any proceedings before it to which this section applies by virtue of subsection (2)(a) or (b) above, being proceedings relating to—
  - (a) the prosecution or conviction of the offender for the offence;
  - (b) the manner in which he, or his parent or guardian, should be dealt with in respect of the offence;

- (c) the enforcement, amendment, variation, revocation or discharge of any order made in respect of the offence;
- (d) where an attendance centre order is made in respect of the offence, the enforcement of any rules made under section 16(3) of the <sup>M8</sup>Criminal Justice Act 1982; or
- (e) where a secure training order is so made, the enforcement of any requirements imposed under section 3(7) of the <sup>M9</sup>Criminal Justice and Public Order Act 1994.
- (4B) A court shall not exercise its power under subsection (4A) above without—
  - (a) affording the parties to the proceedings an opportunity to make representations; and
  - (b) taking into account any representations which are duly made.]
  - (5) Subject to subsection (7) below, a court may, in relation to proceedings before it to which this section applies, by order dispense to any specified extent with the requirements of this section in relation to a child or young person who is concerned in the proceedings if it is satisfied—
    - (a) that it is appropriate to do so for the purpose of avoiding injustice to the child or young person; or
    - (b) that, as respects a child or young person to whom this paragraph applies who is unlawfully at large, it is necessary to dispense with those requirements for the purpose of apprehending him and bringing him before a court or returning him to the place in which he was in custody.
  - (6) Paragraph (b) of subsection (5) above applies to any child or young person who is charged with or has been convicted of—
    - (a) a violent offence,
    - (b) a sexual offence, or
    - (c) an offence punishable in the case of a person aged 21 or over with imprisonment for fourteen years or more.
  - (7) The court shall not exercise its power under subsection (5)(b) above—
    - (a) except in pursuance of an application by or on behalf of the Director of Public Prosecutions; and
    - (b) unless notice of the application has been given by the Director of Public Prosecutions to any legal representative of the child or young person.
  - (8) The court's power under subsection (5) above may be exercised by a single justice.
  - (9) If a report or picture is published or included in a programme service in contravention of subsection (1) above, the following persons, that is to say—
    - (a) in the case of publication of a written report or a picture as part of a newspaper, any proprietor, editor or publisher of the newspaper;
    - (b) in the case of the inclusion of a report or picture in a programme service, any body corporate which provides the service and any person having functions in relation to the programme corresponding to those of an editor of a newspaper,

shall be liable on summary conviction to a fine not exceeding level 5 on the standard scale.

(10) In any proceedings under section 15 or 16 of the <sup>M10</sup>Children and Young Persons Act 1969 (proceedings for varying or revoking supervision orders) before a magistrates' court other than a youth court or on appeal from such a court it shall be the duty of the

magistrates' court or the appellate court to announce in the course of the proceedings that this section applies to the proceedings; and if the court fails to do so this section shall not apply to the proceedings.

(11) In this section—

"legal representative" means an authorised advocate or authorised litigator, as defined by section 119(1) of the <sup>MII</sup>Courts and Legal Services Act 1990;

"programme" and "programme service" have the same meaning as in the <sup>M12</sup>Broadcasting Act 1990;

"sexual offence" has the same meaning as in section 31(1) of the <sup>MI3</sup>Criminal Justice Act 1991;

"specified" means specified in an order under this section;

"violent offence" has the same meaning as in section 31(1) of the Criminal Justice Act 1991;

#### 53 **Punishment of certain grave crimes.**

## 56 Power of other courts to remit juvenile offenders to [<sup>F184</sup>youth courts].

#### 99 Presumption and determination of age.

- (1) Where a person, whether charged with an offence or not, is brought before any court otherwise than for the purpose of giving evidence, and it appears to the court that he is a child or young person, the court shall make due inquiry as to the age of that person, and for that purpose shall take such evidence as may be forthcoming at the hearing of the case, but an order or judgment of the court shall not be invalidated by any subsequent proof that the age of that person has not been correctly stated to the court, and the age presumed or declared by the court to be the age of the person so brought before it shall, for the purposes of this Act, be deemed to be the true age of that person, and, where it appears to the court that the person so brought before it has attained [<sup>F237</sup>the age of eighteen] years, that person shall for the purposes of this Act be deemed not to be a child or young person.
- (2) Where in any charge or indictment for any offence under this Act or any of the offences mentioned in the First Schedule to this Act [<sup>F238</sup>except as provided in that Schedule], it is alleged that the person by or in respect of whom the offence was committed was a child or young person or was under or had attained any specified age, and he appears to the court to have been at the date of the commission of the alleged offence a child or young person, or to have been under or to have attained the specified age, as the case may be, he shall for the purposes of this Act be presumed at that date to have

been a child or young person or to have been under or to have attained that age, as the case may be, unless the contrary is proved.

- (3) Where, in any charge or indictment for any offence under this Act or any of the offences mentioned in the First Schedule to this Act, it is alleged that the person in respect of whom the offence was committed was a child or was a young person, it shall not be a defence to prove that the person alleged to have been a child was a young person or the person alleged to have been a young person was a child in any case where the acts constituting the alleged offence would equally have been an offence if committed in respect of a young person or child respectively.
- (4) Where a person is charged with an offence under this Act in respect of a person apparently under a specified age it shall be a defence to prove that the person was actually of or over that age.

## 105 Variation of Orders in Council.

An Order in Council under this Act may be revoked or varied by any subsequent Order in Council.

#### 106 Provisions as to documents, &c.
