### Offences

# 1 Cruelty to persons under sixteen. E+W

- (1) If any person who has attained the age of sixteen years and [FI has responsibility for] any child or young person under that age, wilfully assaults, ill-treats, neglects, abandons, or exposes him, or causes or procures him to be assaulted, ill-treated, neglected, abandoned, or exposed, in a manner likely to cause him unnecessary suffering or injury to health (including injury to or loss of sight, or hearing, or limb, or organ of the body, and any mental derangement), that person shall be guilty of a misdemeanor, and shall be liable—
  - (a) on conviction on indictment, to a fine . . . <sup>F2</sup> or alternatively, . . . <sup>F3</sup>, or in addition thereto, to imprisonment for any term not exceeding [F4ten] years;
  - (b) on summary conviction, to a fine not exceeding [F5£400] pounds, or alternatively, . . . F3, or in addition thereto, to imprisonment for any term not exceeding six months.
- (2) For the purposes of this section—
  - (a) a parent or other person legally liable to maintain a child or young person [<sup>F6</sup>, or the legal guardian of a child or young person,] shall be deemed to have neglected him in a manner likely to cause injury to his health if he has failed to provide adequate food, clothing, medical aid or lodging for him, or if, having been unable otherwise to provide such food, clothing, medical aid or lodging, he has failed to take steps to procure it to be provided under [<sup>F7</sup>the enactments applicable in that behalf];
  - (b) where it is proved that the death of an infant under three years of age was caused by suffocation (not being suffocation caused by disease or the presence of any foreign body in the throat or air passages of the infant) while the infant was in bed with some other person who has attained the age of sixteen years, that other person shall, if he was, when he went to bed, under the influence of drink, be deemed to have neglected the infant in a manner likely to cause injury to its health.
- (3) A person may be convicted of an offence under this section—
  - (a) notwithstanding that actual suffering or injury to health, or the likelihood of actual suffering or injury to health, was obviated by the action of another person:
  - (b) notwithstanding the death of the child or young person in question.

#### Causing or allowing persons under sixteen to be used for begging. E+W 4

# 7 Sale of tobacco, &c. to persons under [F23 eighteen]. E+W

- (1) Any person who sells to a person [F24. . .] under the age of [F25eighteen] years any tobacco or cigarette papers, whether for his own use or not, shall be liable, [F26on summary conviction to a fine not exceeding level 4 on the standard scale.]

# †Exposing children under seven to risk of burning. E+W

If any person who has attained the age of sixteen years, having [F37 responsibility for] any child under the age of [F38 twelve] years, allows the child to be in any room containing an open fire grate [F39 or any heating appliance liable to cause injury to a person by contact therewith] not sufficiently protected to guard against the risk of his being burnt or scalded without taking reasonable precautions against that risk, and by reason thereof the child is killed or suffers serious injury, he shall on summary conviction be liable to a fine not exceeding [F40] level 1 on the standard scale]:

Provided that neither this section, not any proceedings taken thereunder, shall affect any liability of any such person to be proceeded against by indictment for any indictable offence.

# Failing to provide for safety of children at entertainments. E+W

- (1) Where there is provided in any building an entertainment for children, or an entertainment at which the majority of the persons attending are children, then, if the number of children attending the entertainment exceeds one hundred, it shall be the duty of the person providing the entertainment to station and keep stationed wherever necessary a sufficient number of adult attendants, properly instructed as to their duties, to prevent more children or other persons being admitted to the building, or to any part thereof, than the building or part can properly accommodate, and to control the movement of the children and other persons admitted while entering and leaving the building or any part thereof, and to take all other reasonable precautions for the safety of the children.
- (2) Where the occupier of a building permits, for hire or reward, the building to be used for the purpose of an entertainment, he shall take all reasonable steps to secure the observance of the provisions of this section.
- (3) If any person on whom any obligation is imposed by this section fails to fulfil that obligation, he shall be liable, on summary conviction, to a fine not exceeding, in the case of a first offence fifty pounds, and in the case of a second or subsequent offence one hundred pounds <sup>F41</sup>. . . .
- (4) A constable may enter any building in which he has reason to believe that such an entertainment as aforesaid is being, or is about to be, provided, with a view to seeing whether the provisions of this section are carried into effect, and an officer authorised for the purpose by an authority by whom licences are granted under any of the enactments referred to in the last foregoing subsection shall have the like power of entering any building so licensed by that authority.
- (5) The institution of proceedings under this section shall—

# 12A Restricted premises orders E+W

- (1) This section applies where a person ("the offender") is convicted of a tobacco [F47 or nicotine] offence ("the relevant offence").
- (2) The person who brought the proceedings for the relevant offence may by complaint to a magistrates' court apply for a restricted premises order to be made in respect of the premises in relation to which that offence was committed ("the relevant premises").
- (3) A restricted premises order is an order prohibiting the sale on the premises to which it relates of any tobacco [<sup>F48</sup> or cigarette papers][<sup>F48</sup>, cigarette papers or nicotine product] to any person.
- (4) The prohibition applies to sales whether made—
  - (a) by the offender or any other person, or
  - (b) by means of any machine kept on the premises or any other means.
- (5) The order has effect for the period specified in the order, but that period may not exceed one year.
- (6) The applicant must, after making reasonable enquiries, give notice of the application to every person appearing to the applicant to be a person affected by it.
- (7) The court may make the order if (and only if) it is satisfied that—
  - (a) on at least 2 occasions within the period of 2 years ending with the date on which the relevant offence was committed, the offender has committed other tobacco [F49 or nicotine] offences in relation to the relevant premises, and
  - (b) the applicant has complied with subsection (6).

  - (b) any other person who has an interest in the premises.

# 12B Restricted sale orders E+W

# Penalties and legal proceedings in respect of general provisions as to employment. E+W

(1) If a person is employed in contravention of any of the foregoing provisions of this Part of this Act, or of the provisions of any byelaw [F95] or regulation] made thereunder, the employer and any person (other than the person employed) to whose act or default the contravention is attributable shall be liable on summary conviction to a fine not exceeding [F96] twenty pounds][F97£50] or, in the case of a second or subsequent offence, not exceeding [F96] fifty pounds][F98£100]:



# Power of Secretary of State to send certain juvenile offenders to approved schools. E+W

# F26880 Provision of approved schools by local authorities. E+W

(1) A local authority may, with the approval of the Secretary of State, undertake, or combine with any other local authority in undertaking, or contribute such sums of money upon such conditions as they may think fit towards, the purchase, establishment, building, alteration, enlargement, rebuilding or management of an approved school:

Provided that, before giving his approval, the Secretary of State shall satisfy himself that the proposed expenditure is reasonable and, where it is proposed to purchase, build or establish a new school, that there is a deficiency of approved school accommodation which cannot properly be remedied in any other way.

(2) In the event of a deficiency of approved school accommodation, it shall be the duty of every local authority concerned to take, either alone or in combination with other local authorities, appropriate steps under this section to remedy the deficiency.



  - (3) The derogation condition is satisfied where the institution of proceedings—
    - (a) is necessary for the purposes of the public interest objective,
    - (b) relates to an information society service that prejudices that objective or presents a serious and grave risk of prejudice to that objective, and
    - (c) is proportionate to that objective.
  - (4) "The public interest objective" means the pursuit of public policy.

### Exceptions for mere conduits

- 3 (1) A service provider is not capable of being guilty of an offence under section 39 in respect of anything done in the course of providing so much of an information society service as consists in—
  - (a) the provision of access to a communication network, or
  - (b) the transmission in a communication network of information provided by a recipient of the service,

if the condition in sub-paragraph (2) is satisfied.

- (2) The condition is that the service provider does not—
  - (a) initiate the transmission,
  - (b) select the recipient of the transmission, or
  - (c) select or modify the information contained in the transmission.
- (3) For the purposes of sub-paragraph (1)—
  - (a) the provision of access to a communication network, and
  - (b) the transmission of information in a communication network,

includes the automatic, intermediate and transient storage of the information transmitted so far as the storage is solely for the purpose of carrying out the transmission in the network.

    - (b) the condition in sub-paragraph (3) is satisfied.
  - (3) The condition is that the service provider—
    - (a) does not modify the information,
    - (b) complies with any conditions attached to having access to the information, and
    - (c) where sub-paragraph (4) applies, expeditiously removes the information or disables access to it.
  - (4) This sub-paragraph applies if the service provider obtains actual knowledge that—
    - (a) the information at the initial source of the transmission has been removed from the network,
    - (b) access to it has been disabled, or
    - (c) a court or administrative authority has ordered the removal from the network of, or the disablement of access to, the information.

### Exception for hosting

- 5 (1) A service provider is not capable of being guilty of an offence under section 39 in respect of anything done in the course of providing so much of an information society service as consists in the storage of information provided by a recipient of the service if sub-paragraph (2) or (3) is satisfied.
  - (2) This sub-paragraph is satisfied if the service provider had no actual knowledge when the information was provided that it consisted of or included matter whose inclusion in a publication is prohibited by a direction under section 39.
  - (3) This sub-paragraph is satisfied if, on obtaining such knowledge, the service provider expeditiously removed the information or disabled access to it.
  - (4) Sub-paragraph (1) does not apply if the recipient of the service is acting under the authority or control of the service provider.

### Interpretation

- 6 (1) This paragraph applies for the purposes of this Schedule.
  - (2) "Publication" has the meaning given in section 39.

  - (a) a service provider is established in England and Wales or in a particular EEA state, if the service provider—
    - (i) effectively pursues an economic activity using a fixed establishment in England and Wales or that EEA state, for an indefinite period, and
    - (ii) is a national of an EEA state or a company or firm mentioned in Article 54 of the Treaty on the Functioning of the European Union;
  - (b) the presence or use in a particular place of equipment or other technical means of providing an information society service does not, of itself, constitute the establishment of a service provider;

## Superannuation of Officers
