#### 23 **Prohibition against persons under sixteen taking part in performances endangering life or limb.**

No [<sup>F2</sup>child] shall take part in any [<sup>F3</sup>performance to which section 37 of the<sup>M1</sup>Children and Young Persons Act 1963 applies and] in which his life or limbs are endangered and every person who causes or procures [<sup>F4</sup>a child], or being his parent or guardian allows him, to take part in such a performance, shall be liable on summary conviction to a fine not exceeding [<sup>F5</sup>£50]; or in the case of a second or subsequent offence, not exceeding [<sup>F5</sup>£100]:

Provided that no proceedings shall be taken under this subsection except by or with the authority of a chief officer of police.

**24 Restrictions on training for performances of a dangerous nature.**

- (1) No [<sup>F6</sup>child] under the age of twelve years shall be trained to take part in performances of a dangerous nature, and no [<sup>F7</sup>child who has attained that age] shall be trained to take part in such performances except under and in accordance with the terms of a licence granted and in force under this section; and every person who causes or procures a person, or being his parent or guardian allows him, to be trained to take part in performances of a dangerous nature in contravention of this section, shall be liable on summary conviction to a fine not exceeding [<sup>F8</sup>£20] or, in the case of a second or subsequent offence, not exceeding [<sup>F8</sup>£50].
- (2) A [<sup>F9</sup>local authority] may grant a licence for a [<sup>F10</sup>child who has attained the age of twelve years] to be trained to take part in performances of a dangerous nature.

- (4) A licence under this section shall specify the place or places at which the person is to be trained and shall embody such conditions as are, in the opinion of the [<sup>F12</sup>authority], necessary for his protection, but a licence shall not be refused if the [<sup>F12</sup>authority] is satisfied that the person is fit and willing to be trained and that proper provision has been made to secure his health and kind treatment.
