41 Special provisions as to Scotland.

- (1) For the purpose of providing institutions for the treatment of tuberculosis or any such other disease as the [F3Secretary of State], with the approval of the Treasury, may appoint, a county council in Scotland shall have power to borrow . . . F4 such sums as may be required, and shall have power to acquire, purchase, or take on lease any land; [F5 and may be authorised by the Secretary of State to purchase land compulsorily for the said purpose.]
- (3) A county council in Scotland that has been authorised by the [F3Secretary of State] to provide an institution in terms of section sixty-four subsection (2) of the principal Act shall have the same powers of providing treatment for all persons suffering from
