



Marine And Aviation Insurance (War Risks) Act 1952

7 †Exemption of certain instruments from provisions of Stamp Act 1891, and Marine Insurance Act 1906.

(1) None of the following instruments shall . . . ^{F1} be inadmissible in evidence by reason only that it is not embodied in a marine policy in accordance with the ^{M1}Marine Insurance Act 1906, that is to say:—

- (a) an agreement for re-insurance made in pursuance of section one of this Act between the [^{F2}Board] and any other authority or person, and a policy of re-insurance issued by the [^{F2}Board] in pursuance of such an agreement;
- (b) an agreement entered into by a body to which this paragraph applies, being an agreement for the re-insurance of a risk insured by another person which may be again re-insured by the [^{F2}Board], and a policy issued in pursuance of such an agreement, being a policy for the re-insurance only of such a risk as aforesaid;
- (c) a contract of insurance entered into by the [^{F2}Board] in exercise of the powers conferred on him by section two of this Act, and a policy of insurance and a certificate of insurance issued by the [^{F2}Board] in connection with any such contract.

(4) Paragraph (b) of subsection (1) of this section applies to any body of persons for the time being approved for the purposes of this Act by the [^{F4}Board], being a body the objects of which are or include the carrying on of business by way of the re-insurance of risks which may be re-insured under any agreement for the purpose mentioned in paragraph (b) of subsection (1) of section one of this Act.
