1860 CHAPTER 93 23 and 24 Vict

An Act to amend and further extend the Acts for the commutation of tithes in England and Wales. [13th August 1860]

Wherever a sum or rate per head shall be in arrear, the arrears shall be recoverable by distress and impounding of any cattle, stock, goods, or chattels belonging to the person in respect of whose cattle or stock such sum or rate per head is in arrear, wherever the same may be found.
