Alteration of date of expiration of certain game licences. **U.K.**

Every licence or certificate to kill game now in force, or to be taken out under the ^{M1}Game Licences Act, 1860, which expires, or would expire, under the provisions of that Act on the fifth day of April, shall expire on the thirty-first day of July, and wherever in such provisions the fifth day of April is mentioned or referred to, the same shall be read as if the thirty-first day of July had been therein inserted in lieu of the said fifth day of April.

A licence or certificate to kill game may be taken out under the provisions of the Game Licences Act, 1860, for a continuous period of fourteen days to be specified in such licence or certificate, and there shall be granted and paid thereon the duty of [^{F4}two pounds.]
