1886 CHAPTER 15 49 and 50 Vict

An Act to amend the Law as to the Rating of Lands occupied for Sporting purposes in Scotland. [10th May 1886]

**6 Valuation of shootings and deer forests.**

In order to ascertain and assess under the Valuation Acts the yearly value of shootings and deer forests in Scotland, it shall be the duty of the assessor to enter separately for each [<sup>F7</sup>islands area or district], and in respect of each proprietor therein, the yearly value of the shootings over the lands and of the deer forests belonging to him in so far as situated within such [<sup>F7</sup>islands area or district].
