



# Public Works Loans Act 1887

1887 CHAPTER 37 50 and 51 Vict

An Act to grant money for the purpose of certain Local Loans; and for other purposes relating to Local Loans. [16th September 1887]

**1 Short title.**

This Act may be cited as the Public Works Loans Act 1887.

(2) As regards Scotland:—

- (a) any local authority under [<sup>F4</sup>the <sup>M2</sup>Public Health (Scotland) Act 1897], and the Acts amending the same; and
- (b) ...<sup>F3</sup> any representative county body created by Act of Parliament.
