1894 CHAPTER 36 57 and 58 Vict

An Act to amend the Valuation of Lands (Scotland) Acts in regard to the duties of the Assessor of Railways and Canals. [17th August 1894]

For the purposes of [^{F6}the valuation roll to be made up][^{F6}any valuation made] by the assessor of railways and canals . . . ^{F7} the provisions of sections twenty to twenty-nine inclusive of the ^{M1}Lands Valuation (Scotland) Act, 1854, and of any Act amending the same, and of this Act, shall extend to and include such railways, tramways, canals, waterworks, gasworks, and other undertakings belonging to, or leased or occupied by, any corporation, burgh commissioners, trustees, or local authority as are referred to
