

The Import of Goods (Control) (Amendment) Order, 1954

Made - - - - 13th May, 1954
Coming into Operation 20th May, 1954

The Board of Trade, in exercise of the powers conferred upon them by Section 1 of the Import, Export and Customs Powers (Defence) Act, 1939(a), and all other powers enabling them in that behalf, do hereby order as follows:—

1. The Import of Goods (Control) Order, 1954(b), shall have effect as if there were added—

(a) as Article 7A thereof the following:—

“7A. The operation of each of the Enactments, Orders in Council and Orders specified in the Schedule hereto is hereby suspended.”;
and

(b) as the Schedule thereto, the Schedule to this Order.

2.—(1) The Interpretation Act, 1889(c), shall apply to the interpretation of this Order as it applies to the interpretation of an Act of Parliament and as if this Order and the Order hereby revoked were Acts of Parliament.

(2) The Import of Goods (Prohibition) (No. 1) Order, 1939(d), is hereby revoked.

3. This Order may be cited as the Import of Goods (Control) (Amendment) Order, 1954, and shall come into operation on the 20th day of May, 1954.
