# The Children and Young Persons Act 1963 (Commencement No. 2) Order 1963

Made - - - 16th December 1963

In exercise of the powers conferred on me by section 65(6) of the Children and Young Persons Act 1963(a), I hereby make the following Order:—

- 1. The provisions of the Children and Young Persons Act 1963 specified in the first column of the Schedule hereto (which relate to the matters specified in the second column of the said Schedule) shall come into operation on 1st February 1964.
- 2. This Order may be cited as the Children and Young Persons Act 1963 (Commencement No. 2) Order 1963.
