RATING AND VALUATION

The Valuation (Water Undertakings) (Scotland) (No. 1) Order 1967

Made - - - 13th March 1967

Laid before the Commons
House of Parliament 16th March 1967

Coming into Operation 13th April 1967

In exercise of the powers conferred on me by paragraph 2 of Schedule 2 to the Local Government (Scotland) Act 1966(a) and of all other powers enabling me in that behalf, and after consultation with such associations of local authorities and other bodies and associations as appear to me to be concerned, I hereby make the following order:—

- 1. This order may be cited as the Valuation (Water Undertakings) (Scotland) (No. 1) Order 1967 and shall come into operation on the day following the day on which it is approved by a resolution of the Commons House of Parliament.
- 2.—(1) The Interpretation Act 1889(b) shall apply for the interpretation of this order as it applies for the interpretation of an Act of Parliament.
 - (2) In this order-

"valuation roll" includes a supplementary valuation roll made up under section 11 of the Valuation and Rating (Scotland) Act 1956(c) and the roll made up by the Assessor of Public Undertakings (Scotland).

- 3.—(1) For the purposes of determining the cumulo rateable value of lands and heritages occupied for the purposes of a water undertaking for the year 1967-68 and subsequent years the national average rateable value per unit per day shall be determined by the Secretary of State by dividing the aggregate rateable value of all lands and heritages so occupied in 1964-65, according to the valuation rolls for that year, by the number of units in the aggregate potential daily output of all such undertakings for that year; and increasing the dividend by the percentage increase in the aggregate rateable value of all lands and heritages in Scotland for 1966-67 over the aggregate rateable value of all such lands and heritages for 1965-66.
- (2) For the purposes of the preceding sub-paragraph, the factors to be used in the relevant calculations shall in each case be taken as the best estimates of such factors available to the Secretary of State, at the date of making of this order, that is to say—
 - (i) the aggregate rateable value of all lands and heritages occupied by water undertakings for 1964-65: £2,040,474.

- (ii) the aggregate potential daily output of water undertakings for 1964-65: 482,229.18 units.
- (iii) the aggregate rateable value of all lands and heritages in Scotland for 1966-67: £142,384,172.
- (iv) the aggregate rateable value of all lands and heritages in Scotland for 1965-66; £108,233,926, and
- (v) the percentage increase of (iii) over (iv): 31.6 per cent.

EXPLANATORY NOTE

(This Note is not part of the order.)

This order sets out the method of determining the norm (the national average rateable value per thousand gallons of water per day) which is to be used in calculating the cumulo rateable values of water undertakings for 1967-68 and subsequent years. (The figure resulting from the calculations described in the order is £5.568.)
