## PRICES AND INCOMES

### The Temporary Restrictions on Prices and Incomes (Consents) (Amendment) Regulations 1967

<i>Made - - - -</i>	17th April 1967
<i>Laid before Parliament</i>	17th April 1967
<i>Coming into Operation</i>	18th April 1967

The Secretary of State, in exercise of the powers conferred on him by section 21 of the Prices and Incomes Act 1966(a) as applied by section 25(6) of that Act and of all other enabling powers, hereby makes the following Regulations:—

1.—(1) These Regulations, which may be cited as the Temporary Restrictions on Prices and Incomes (Consents) (Amendment) Regulations 1967, shall come into operation on 18th April 1967.

(2) The Interpretation Act 1889(b) shall apply for the interpretation of these Regulations as it applies for the interpretation of an Act of Parliament, and as if for the purposes of section 38 of that Act these Regulations were an Act of Parliament and the Regulations revoked by Regulation 3 of these Regulations were an Act of Parliament thereby repealed.

2. The Temporary Restrictions on Prices and Incomes (Consents) Regulations 1966(c) as amended(d) shall have effect as though for Regulation 3 there were substituted the following Regulation:—

“ 3.—(1) Except as provided in the following paragraphs of this Regulation, the appropriate Minister for the purposes of sections 28(2) and 29(4) of the Prices and Incomes Act 1966 (that is to say, the Minister who may give consent to an increase of remuneration restricted under those sections) shall be the Minister of Labour.

(2) In the case of remuneration for work performed by persons employed as architectural or engineering draughtsmen under the Receiver for the Metropolitan Police District the appropriate Minister for the purpose of the said section 28(2) shall be the Secretary of State.

(3) In the case of remuneration paid for work performed under any contract of employment by the provost, magistrates and councillors of the Royal Burgh of Rothesay to their administrative, professional, technical and clerical staff the appropriate Minister for the purpose of the said section 29(4) shall be the Secretary of State.”

3. The Temporary Restrictions on Prices and Incomes (Consents) (Amendment) Regulations 1966 are hereby revoked.

### EXPLANATORY NOTE

*(This Note is not part of the Regulations.)*

These Regulations amend the Temporary Restrictions on Prices and Incomes (Consents) Regulations 1966 (which, inter alia, specify the Minister of Labour as the appropriate Minister for the purpose of giving consents to increases in pay restricted under sections 28(2) and 29(4) of the Prices and Incomes Act 1966) by providing that in the case of remuneration paid to persons employed under the Receiver for the Metropolitan Police District as architectural or engineering draughtsmen the appropriate Minister for the purpose of the said section 28(2) shall be the Secretary of State (which in practice will usually be the Secretary of State for the Home Department) and in the case of remuneration paid for work performed under any contract of employment by the provost, magistrates and councillors of the Royal Burgh of Rothesay to their administrative, professional, technical and clerical staff the appropriate Minister for the purpose of the said section 29(4) shall be the Secretary of State (which in practice will usually be the Secretary of State for Scotland).
